CALAMBA CITY, Laguna (PIA) — The Philippine Information Agency (PIA) has urged the youth to use their influence in the fight against the proliferation of fake news on social media. PIA Director-General Katherine De Castro, speaking at the West Philippine Sea Symposium in Calamba City, held Laguna, on March 19 stressed that the youth, who have a strong voice on social media, also bear a great responsibility to ensure that truth prevails.

She warned that these deceptive tactics are designed to manipulate public discourse and create confusion among Filipinos. De Castro stressed that fake news is being spread to divide public opinion, propagate misinformation, manipulate democracy, most importantly, and. attempt to control perspectives on the West Philippine Sea dispute. ## ENROLL FOR INTERNET VOTING, COMELEC URGES FILIPINOS OVERSEAS

MANILA - The Commission Elections (Comelec) on Thursday opened the on enrollment period for those who will be using the online voting and counting system (OVCS) in the May 12 midterm polls.

Comelec Chairperson George Garcia reminded the over 1.2 million registered overseas voters to start enrolling for the internet voting.

"This marks the first day of enrollment through our website and we can accomplish this in less than two minutes. From today until May 7, let us take the time to get enrolled. Even if you are a registered overseas voter, if you aren't enrolled, you cannot cast your vote," he said in an interview. Garcia said the enrollment is

necessary for the poll body to verify the identity of voters. "We need to be sure that it is

you voting, and give you your password to be able to use the (internet voting) system," he added.

Garcia also urged families of Filipinos abroad to encourage their loved ones overseas to enroll for the OVCS.

The Comelec said enrollment may be done using the voter's own internet-capable device during the pre-voting period. Another way to enroll is through the voting kiosks set-up at the Philippine posts during the overseas voting

period

A total of 77 posts abroad will be using the OVCS, while the remaining 16 Philippine Embassies (PE) and Philippine Consulates General (PCG) will use the automated counting machines (ACMs).

The overseas voting period will be from April 13 to May 12. They will be voting for national positions only or 12 senators and one party-list group.

Data from the poll body showed there are a total of 1,241,690 overseas registered voters.

On the other hand, the Comelec, in a social media post, said those who would like to enroll may visit its official website: https://comelec. gov.ph/ or the official social media accounts of Comelec, Philippine Embassies and Consulates.

"Overseas voters are strongly advised to remain vigilant against fraudulent websites, emails, and social media posing as official pages sources. To ensure the security and integrity of your internet voting enrollment, always verify that you are accessing the official enrollment link. For further inquiries and official updates, please contact your respective Philippine Post or visit Comelec's official website," it said. (PNA) By Ferdinand Patinio

MANILA – The Philippines and

India are working on a possible state visit by President Ferdinand R. Marcos Jr. to the South Asian nation "as soon as possible this year" in time for the 75th anniversary of diplomatic relations between the two states.

In a television interview in India on Wednesday (local time), Foreign Affairs Secretary Enrique Manalo said Manila is hoping to see a number of "concrete deliverables" and agreements signed should the visit pushes through.

"We're working on that visit, we're hoping that it can be done as soon as possible early this year, so we're working on the dates," he said.

Manalo and Indian Minister of External Affairs Jaishankar previously discussed the visit in a meeting on the sidelines of the Raisina Dialogue held in India from March 17 to 19.

The Filipino top diplomat did not provide specifics about bilateral deals currently in the works but said Manila and New Delhi are working to improve cooperation on a number of areas, including in the maritime sphere.

## Cavite Police Arrest High-Value Drug Suspect, Seize P340K Worth of Shabu in Dasmariñas Operation

Members of the Cavite PNP Drug Enforcement Unit of the Cavite Police Provincial Office, together with the Dasmariñas Component City Police Station, seized Php 340,000.00 worth of suspected shabu and arrested a High-Value Individual (HVI) in a buy-bust operation on March 19, 2025, at Brgy. Datu Esmael, Dasmariñas, Cavite. According to the report, at around 6:00 PM on the said date, combined operatives of the PDEU of Cavite PPO and Dasmariñas CCPS conducted an anti-illegal drug operation that led to the arrest of alias "Nune," 26, a male resident of Waling Waling Street, Brgy. Datu Esmael, Dasmariñas City, Cavite, who is listed as a High-Value Individual in the Cavite PPO's Drug Watchlist.

## BOC SEIZES P95-M UNREGISTERED VAPE **PRODUCTS AT MANILA PORT**

MANILA - The Bureau of Customs (BOC) has seized 112,750 unregistered vape products worth more than PHP95.7 million at the Port of Manila.

BOC Commissioner Bienvenido Rubio said these items were confiscated in separate inspections on March 18, the bureau said in a news release Thursday.

He said the first shipment was flagged based on derogatory information received by the BOC's Enforcement Group, prompting the issuance of a Pre-Lodgement Control Order (PLCO) requested by Deputy Commissioner Teddy Raval that led to the inspection of two 40-foot-high cube containers.

The examination uncovered 233 cartons containing 46,600 assorted flavored vape products worth PHP23.3 million and supposed duties and taxes amounting to PHP30.2 million.

Port of Manila District Collector Alexander Gerard Alviar is set to issue a Warrant of Seizure and Detention against the shipments for violation of Section 1113 in relation to Section 1400 of the Customs

## PALACE WON'T LET DELA ROSA HIDE FROM POSSIBLE ARREST

MANILA - Malacañang on Thursday expressed dismay over Senator Ronald dela Rosa's plan to go into hiding to evade possible arrest because of his involvement in former president Rodrigo Duterte's war on illegal drugs. In a Palace press briefing, Presidential Communications Office Undersecretary and Palace Press Officer Claire Castro said it is surprising that such statement came from Dela Rosa, who was a former chief of the Philippine National Police.

Castro said dela Rosa is setting a bad precedent, as his fellow Filipinos might think that evading arrest is acceptable.

"Iyan po ba ang gusto niya ring ipahiwatig sa taumbayan na kapag may warrant of arrest ay dapat magtago (Is that what he also wants to convey to the people that when there is an arrest warrant, one should hide),' Castro asked.

"Hindi natin sinasangayunan ang ganoong klaseng paniniwala at kaniyang nais gawin. Hindi po ito makakabuti sa mga kababayan natin na mismong lider natin ay hindi haharapin ang anumang kaso o complaint na naisampa o maisasampa sa kanya (We do not agree with that kind of belief and what he wants to do. This will not be good for our countrymen that our own

Meanwhile, the Customs Intelligence and Investigation Service - Port of Manila team requested the issuance of a PLCO against three additional suspected shipments of containing unmanifested goods.

Raval said the shipments arrived from China and were declared as "plastic insulation."

The BOC, in coordination with the Department of Trade and Industry, Bureau of Internal Revenue, and Philippine National Police, continues to enforce RA 11900 to uphold product standards and prevent minors' access to vape products.(PNA)By Ferdinand Patinio

# MALACAÑANG EXPECTS ' CREDIBLE' 2025 POLLS, CALLS FOR ORDERLY CAMPAIGN

MANILA – Malacañang on Thursday called on local candidates in the upcoming May 12 elections to be "calm" and ensure "orderly" campaigning.

Presidential Communications Office Undersecretary and Palace Press Officer Claire Castro made the call, ahead of the start of the campaign period for local bets on March 28. In a press briefing, Castro said the Palace is expecting a "credible" 2025 elections, considering the decline in the number of areas facing poll-related threats.

"Tayo po ay iyan din ang ninanais ng administrasyon. Makipagtulungan tayo sa lahat ng ahensiya para po magkaroon tayo, especially sa election, maging credible po ang mangyayaring election sa susunod na May 2025 (That is what the administration wants. Let's cooperate with all agencies so that we can have, especially in the election, a credible election in May 2025)," Castro said.

"Ang nais lamand ро natin ay maging mahinahon sa kanilang pangangampanya, maging maayos, maging

makatotohanan sa kanilang mga sasabihin. Huwag po sana silang magsagawa ng ano mang pananalita na magke create pa ng kaguluhan (All we want is for them to be calm in their campaigning, to be orderly, to be truthful in what they say. I hope they don't make any statements that will create more chaos)," she added.

The number of areas under the red category or with serious threat of election-related violence has decreased from 38 to 36, according to the latest data from the Commission on Elections (Comelec).

Areas under the red include category 30 from the Bangsamoro Autonomous Region in Muslim Mindanao, two in the Negros Island Region, and one each in Northern Mindanao, Eastern Visayas, Bicol Region, and Cagayan Valley.

The Comelec, however, is expecting an increase in election-related incidents, when the campaign period for local candidates begins. (PNA) By Ruth Abbey Gita-Carlos

### P272-M SHABU CONCEALED AS 'FREEZE-DRIED DURIAN' SEIZED, SUSPECT NABBED

MANILA - Philippine Drug Enforcement Agency (PDEA) agents have arrested a suspect and seized PHP272 million worth of suspected shabu concealed in 40 black gold foil packs labeled as "freeze-dried durian" in Chinese characters.

In a statement on Thursday, PDEA Director General Isagani Nerez said the suspect, alias Ronald, was arrested by joint elements of PDEA and the Philippine National Police Drug Enforcement Unit in a buy-bust operation at Rizal Cement Village Pantok, in Barangay Binangonan, Rizal late Wednesday night. Nerez said each of the 40 black gold foil packs contained one kilogram of shabu.

He said the arrested suspect will be charged with violation of Section 5 (Sale of Illegal Drugs) and Section 11 (Possession of Illegal Drugs), Article II of Republic Act 9165, or The Comprehensive Dangerous Drugs Act of 2002.

"Operation of this magnitude dealt a major blow to the supply chain of illegal drugs in the streets. There are more to come." Nerez said. (PNA) By Christopher Lloyd Caliwan

LAWYER SEES QUICK **RESOLUTION OF FPRRD CASE DUE** TO SUBSTANTIAL EVIDENCE

MANILA lawyer accredited with the International Criminal Court (ICC) on Thursday said the proceedings against former president Rodrigo Duterte before the Netherlandsbased tribunal may be completed sooner than expected due to substantial evidence against the former chief executive.

"The case against Mr. Duterte may be completed in as little as a year considering the evidence at hand," trial lawyer Joel Butuyan told reporters at the Meet the Manila Press forum.

Butuyan made the comment when asked if the proceedings would take as long as the case of another client of lawyer Nicholas Kaufman who has been named as the lead defense counsel for Duterte.

They are referring to Kaufman's client, incumbent Congo deputy prime minister Jean Pierre Bemba, arrested in 2008 and spent ten years in prison at the Hague before the verdicts against him were overturned on appeal in 2018.

Butuyan pointed out that Duterte not similarly is situated as the charges and evidence against him are "much more robust."

In an earlier interview, Butuyan said the evidence gathered and relied upon by the prosecutors in applying for the warrant of arrest is replete with many videos of the many declarations of Duterte where he encouraged police officers to kill drug suspects, promised rewards and promotion, and for the public to kill drug suspects. He added that the ICC will also determine all available evidence in ruling whether to grant interim liberty for Duterte.

"The fact that he was arrested with a warrant of arrest may help determine whether he is a flight risk."

Butuyan said the decision of Duterte to withdraw from the Rome Statute when he was president was "clearly a case of conflict of interest." "That should be evidence of his plans." (PNA) By

## PHILHEALTH LIFTS 45-DAY BENEFIT LIMIT

MANILA The Philippine Health Corp. Insurance (PhilHealth) has lifted the 45-day benefit limit to ensure its services remain unhampered.

"The 45-day benefit limit is an outdated cost-containment strategy. Naiintindihan natin kung bakit ito inilagay noon, ngunit, sa pagbabago ng ating payment mechanism, napapanahon na rin talagang repormahin ito (We understand why this was placed before, but with the change of our payment mechanism, it is timely to reform this)," PhilHealth President and Chief Executive Officer Edwin Mercado said in a news release Thursday. He noted that medical needs cannot "always be predicted or scheduled."

"Marami ring serbisyo mga ang kinakailangan ng higit sa 45 days na coverage. Kaya naman nagpapasalamat tayo sa (There are many services that need more than 45 days of coverage. So, we thank the) PhilHealth Board for approving this policy update," he added. Earlier, the state insurer recognized that certain conditions need to cover more than 45 days.

Hence, the extension of the number of sessions covered by its hemodialysis benefit packages - from the initial 90 to the current 156 sessions.

PhilHealth reminds members that the availment of the benefits must be based on proper indication, medical necessity, and alignment with the patient's treatment plan.

It must also adhere to widely accepted of care, standards Practice Clinical Guidelines approved by the Department of Health (DOH), and PhilHealth Circulars on quality standards.

То ensure the responsible and effective implementation of this policy, the state will monitor insurer patient admissions, readmissions, and utilization benefit exceeding 45 days. Health facility compliance

with clinical standards reimbursement and rules will be assessed through the Health Care Providers Performance Assessment System.

Meanwhile, Health Secretary and PhilHealth Board Chair Teodoro Herbosa said the move is in line with the directive of President Ferdinand R. Marcos Jr. to ensure that all members receive appropriate healthcare services continuously.

## DA REPORTS LOWER RICE IMPORTS AMID LOCAL PALAY HARVEST

MANILA - The Department of an international economist's Agriculture (DA) on Thursday reported lower rice import arrivals amid the local palay harvest in the Philippines. As of March 13, only 640,915 metric tons (MT) of imported rice have arrived since January, according to the DA. This is much lower than 1 19 million MT which arrived for the same period last year. Only 933 out of the 1,428 approved sanitary and phytosanitary import clearance (SPSIC) have been utilized for the said period.

In an interview, spokesperson Assi DA Assistant Secretary Arnel de Mesa said this drop shows the adjustment of the market considering recent importation and the local harvest.

"Ibig sabihin, mababa. Ibiq sabihin ito, malaki talaga yung pumasok na imported na bigas last year. Plus iyong expectation na magiging maganda iyong harvest this vear. So makikita natin na nag-a-adjust iyong importation (That means, low, This means, the imported rice that came in last year was really big. Plus the expectation that the harvest will be good this year. So we can see that the importation is adjusting)," he said.

The country logged more than 4.8 million MT rice import arrivals as of Dec. 31, 2024. De Mesa also underscored

## PBBM VETOES BILL Declaring Pampanga As Ph Culinary Capital

MANILA Ferdinand R. Marcos Jr. has vetoed a bill that sought to declare Pampanga as the "Culinary Capital of the Philippines."

In a letter to the House Representatives of dated March 12, Marcos explained that while Pampanga's culinary contributions are widely recognized, officially designating it as the country's culinary capital could undermine the diversity of Philippine cuisine.

"It cannot be denied that Pampanga is celebrated for its diverse and flavorful dishes, traditional cooking methods, and a strong culture of food innovation," Marcos said in his veto message.

"This is consistent with the policy of the government to conserve, promote, and popularize the nation's historical and cultural heritage and resources, as well as artistic creations," he added.

The President, however, noted that the bill lacked a historical basis and key performance indicators to justify such declaration. warning that it could offend other provinces with similarly rich culinary traditions.

"I cannot ignore the regarding concerns the declaration's lack of historical basis, the absence of a thorough study that shows key performance indicators for such designation, and the possibility that the bill may offend sensibilities in other provinces that are equally proud of their culinary contributions," Marcos said.

Marcos stressed that Filipino cuisine reflects the country's cultural and geographic diversity, shaped by the distinct culinary traditions of its regions.

Our regions contribute their indigenous dishes certain recipes that with are best done in the areas of origin of their ingredients. All our culinary variations reflect the rich cultural diversity of a group of people scattered among the Philippine islands," he

President said as he underscored the importance of preserving this diversity.

At a Palace briefing on Thursday, Palace Press Officer and Presidential Communications Office Undersecretary Claire Castro confirmed that Marcos vetoed Senate Bill No. 2797 and House Bill No. 10634 titled "An act declaring the province of Pampanga as the culinary capital of the Philippines." "Maganda kasi po 'yung bill, pero magke-create ito ng discrimination (The bill is good, but it may create discrimination)," Castro

said. The bill, authored by Pampanga lawmakers including former President Gloria Macapagal-Arroyo, aimed to recognize Pampanga's culinary heritage.

Arroyo earlier said the declaration would benefit local communities by attracting more visitors and creating economic opportunities.

Despite the veto, Ivan Secretary-Henares, General of the UNESCO National Commission of the Philippines and Commissioner of the National Commission for Culture and the Arts, said the decision does not diminish Pampanga's culinary significance but recognizes that the country's strength lies in its regional diversity.

"I hope our kabalens understand the wisdom behind this veto. It is not saying that Kapampangan cuisine is not good. It just acknowledges that in a nation as diverse as ours, no one region can claim to have the best food," Henares wrote in a Facebook post.

"We should not be competing with each other for bragging rights and empty titles. Focus on sustainable programs (such as policies on geographical indication), not just trivial things. Let's determine 'kev performance indicators' and work towards those, he added. (PNA) By Filane Mikee Cervantes and Ruth Abbey Gita-Carlos

#### DOH: ROAD SAFETY A PUBLIC HEALTH ISSUE, ESSENTIAL IN SUSTAINABLE DEV'T

MANILA – The Department of Health (DOH) on Wednesday said road safety is a public health issue that must be addressed as it is essential to the country's sustainable development.

According to the World Health Organization, road traffic injuries are the leading cause of death among children and young adults aged five to 29 years.

DOH Secretary Teodoro Herbosa cited that a total of 12,241 deaths due to road crashes have been recorded by the Philippine Statistics Authority in 2022. "This is a death rate of 11 per 100,000 individuals, which is moving us further from the target of four (deaths) per 100, 000 (individuals)," he said at the 2025 Philippine Road Safety Summit in Quezon City.

"The regression is unacceptable, and we must strengthen our efforts to reverse this trend."

In the past 10 years, Herbosa said road crashes nationwide increased by 25.6 percent every year. He said about 25,000 of the 296,000 injuries per year are related to drunk driving.

About 72 percent of them involved males (young children and young adults) and happened mostly at night.

The DOH has prioritized road safety as one of its health outcomes list to ensure safe roads for children who need to go to school, and to gain access to healthcare without fear.

"Our strategy includes strengthening multisectoral collaboration with government agencies, local government units, and civil society organizations; integrating road safety policies into national and local frameworks; enhancing health promotion to instill a culture of safety; and equipping local government units with the capacity to respond effectively to road crashes,' Herbosa said.

He said the department also strengthened healthcare facilities for trauma services and implemented a trauma registry in all health facilities to ensure realtime monitoring and datadriven interventions.

Herbosa also urged all concerned agencies and stakeholders to take part in the government's efforts to make roads nationwide safer, especially for children, to strengthen the country's economy, reduce burdens, and build stronger communities. (PNA) By Ma. Teresa Montemayor

#### MORE CORDILLERA VILLAGES SEE GAINS FROM TOURISM

BAGUIO CITY – La Diyang Haven in Tuba, Benguet used to be a stand-alone eco-tourism destination that had been collaborating with nearby attractions for a holistic tourism experience. But thanks to a search spearheaded by the Department of Tourism-Cordillera, more villages have become destinations, drawing visitors who want to experience tranquility from nature.

"We offer loop tourism service so that there will be more activities for the visitors and there will be more of us to benefit aside from sharing our practices," Cristina Tolero, who heads the La Diyang Haven ecotourism village, said in a conversation with the Philippine News Agency.

The collective destination now gives visitors an experience where they can commune with nature by walking through a virgin forest, munching on food growing from the ground and enjoy a "slow food" meal of fruits, vegetables, fish and livestock that are naturally grown.

naturally grown. "We can serve 'watwat' and the pinuneg (blood sausage) of the Ibaloi tribe of Benguet," Tolero said. Cultural presentations are also prepared for tourists whose visits are scheduled, showing the Ibaloi dancers garbed in their traditional attires.

Tolero said, "We always vie for the Best Tourism Village search because it makes us strive to continue to improve what we offer to tourists and by vying, we continue to sustain what we have started. If we win, we also have additional funds for development and improvement of our destination."

DOT-CAR Regional Director Jovita Ganongan, meanwhile, said in a private message to the PNA: "We are happy that our villagers are accepting tourism and opening their places for the appreciation of tourists."

She noted that DOT-CAR's search for "The Best Tourism Village" is making even the Indigenous Peoples (IPs) more open to promoting the beauty of their places and their unique culture to the outside world. She said that while there are several beautiful attractions in the six provinces and two cities of the region, inviting tourists to visit these places requires the readiness of the local residents.

She noted that sustainability requires community acceptance and willingness.

"The issue of acceptance and opening up is already addressed in the search because it is the community members themselves that come out and say they are ready to accept outsiders and show the beauty of their places," Ganongan said.

She said that the DOT-CAR spearheaded and organized the "Best Tourism Village" award to help the communities make their areas tourist destinations.

"Aside from technical assistance, the prize money of PHP1 million for the first place will be used for programs, projects and activities geared towards an environmentally sound, sustainable and complete with community participation," Ganongan said.

From about 12 villages during the first year in 2023, the 2024 search generated 19 competing villages.

"We have announced the 2025 search with the deadline in June 2025 hoping to receive more participation of village destinations," the official said.

Standard for excellence The judges spend time to visit each participating village, look into their operation, the offering, sustainability, and community benefits, which account for 25 percentage points each.

The United Nations World Organization Tourism (UNWTO) defines tourism villages as rural tourism destinations with recognized cultural and natural assets that preserve and promote rural community-based and values, products and lifestyles and have a clear commitment to innovation and sustainability in all aspects of economic, social and environment. MANILA – Bargain hunting helped the local bourse rebound on Wednesday while the peso continued to move sideways against the US dollar.

The Philippine Stock Exchange index (PSEi) rose 0.45 percent to 6,313.12 points, along with All Shares, which increased by 0.71 percent to 3,749.35.

"The local market bounced back as investors hunted for bargains supported by appreciation for corporate fundamentals," Philstock Financials research manager Japhet Tantiangco said.

Four sectors closed in the green with the highest gains from Financials, up 1.35 percent.

Industrial inched up by 1 percent, along with Property, 0.41 percent, and Holding Firms, 0.01 percent.

Mining and Oil, as well as Services, meanwhile, declined by 1.26 and 0.81 percent, respectively. Gainers led losers at 93 to 88, leaving 63 unchanged. Meanwhile, the peso closed flat at 57.30 to the US dollar.

It opened at 57.25 and traded between 57.17 and 57.32 to the greenback, averaging 57.24.
