MANILA - The Bureau of Jail Management and Penology (BJMP), in partnership with the Dasmariñas City government, will construct a modernized prison facility designed to significantly reduce the city's jail congestion rate from 3,333 percent to just 46 percent. In a statement on Wednesday, BJMP Chief Jail Director Ruel Rivera said the new Dasmariñas City jail facility is a testament to the bureau's unwavering commitment to jail decongestion and humane treatment of persons deprived of liberty (PDLs).

CALABARZON POLICE NABS 8 HIGH VALUE INDIVIDUALS,4.3M WORTH OF SHABU AND FIREARMS SEIZED IN SEPARATE DRUG OPS

Camp BGen Vicente The Drug Unit of Lim – Enforcement ice Regional CALABARZON Police the Office successfully seized Php 4,338,400.00 worth of shabu and arrested eight high-value individuals in separate drug bust operations conducted in Bacoor City, Cavite; San Pedro City, Laguna; and Taytay, Rizal, on March 25-26, 2025.

Based on the report, The Station Drug Enforcement Team of Taytay Municipal Police Station in coordination with PDEA, conducted a successful buy-bust operation against a High Value Individual known as alias Khads" resulting to the arrest of the drug suspect and seizure of illegal drugs amounting to Php204,000.00. and a .38 caliber revolver, and three live ammunition.

Alias "Maki," 38, a highvalue individual from San Pedro, Laguna, was arrested at approximately 12:16 AM on March 26, 2025, in Barangay Cuyab, San Pedro City, by the Drug Enforcement Team of San Pedro Component City Police Station. During the operation,

During the operation, authorities seized three plastic sachets of suspected shabu weighing approximately 108 grams, with a standard drug price value of Php 734,400.00, along with buy-bust money.

Similarly, at around 03:00 AM in Brgy. Molino, Bacoor City, Cavite, the joint operatives from PDEU/PIU CAV PPO and BACOOR CCPS arrested six highvalue individuals (HVIs) involved in the illegal drug

DOST PUSHES FOR EXPANSION OF SCHOLARSHIP PROGRAMS OS BAÑOS, Laguna (PIA) The Department of Science

LOS BAÑOS, Laguna (PIA) – The Department of Science and Technology (DOST) in Calabarzon believes that the department's scholarship programs can be expanded further to provide additional services and benefits for their scholars.

DOST Quezon provincial director Maria Esperanza Jawili acknowledges the wide implementation of the program, but she believes that it can be further expanded to cater to more deserving students.

"The DOST scholarship programs are already wideranging. However, they still need to be expanded because we see that there are even greater benefits that our current and future trade. The suspects—alias "Boy," 48; "Reymart," 30; "Joedel," 20; "Matt," 33; "JP," 42; and "Jerwin," 48—were all listed as HVIs on the Cavite PPO's Drugs Watchlist. Authorities seized over 500 grams of suspected shabu, valued at Php3,400,000.00.

In addition to the drug charges, firearms were found in violation of Republic Act 10591 and the COMELEC Gun Ban. Seized firearms included a 1911 caliber .45, an improvised Thompson .45, a caliber .22 firearm, magazines, and ammunition for both calibers.

PBGEN Paul Kenneth T. Lucas, Regional Director of PRO CALABARZON, assured the public of the police force's commitment to the campaign against illegal drugs and "PRO firearms. loose CALABARZON is fully committed to intensifying our efforts against illegal drugs and loose firearms. We will continue to work tirelessly to dismantle criminal networks. confiscate illegal weapons and ensure the safety and security of every citizen in CALABARZON, especially during the upcoming National and Local Elections," he stated.

Meanwhile, the arrested suspects will face charges for Violation of Sec. 5 and Sec. 11 of R.A. 9165 also known as the Comprehensive Dangerous Drugs Act of 2002 and RA 10591 in relation to Batas Pambansa blg 881 (Omnibus Election Code of the Philippines) (**RPIO4A**)

PLTCOL Chester Noel R Borlongan, Chief of the Provincial Intelligence Unit (PIU), identified the suspects as alias Boy, 48 years old, and presently residing in Brgy. Molino 4, Bacoor City, Cavite; alias Joedel, 20 years old, and presently residing in Brgy. Molino, 4, Bacoor City, Cavite; alias Matt, 33 years old, and presently resided in Villa Adella Subd., Imus City, Cavite; alias Reymart, 30 years old, and presently resided in Dona Carmen St., Makati City; alias Johnpaul, 42 years old and presently resided in Brgy. Cavite. The operation resulted in the arrest of the six (6) High Value Individuals (HVIs) for violating Republic Act 9165 (Comprehensive Dangerous Drugs Act of 2002) and Violation of RA 10591 in Relation to Omnibus Code COMELEC (Gun Ban).

During the operation, authorities seized a significant quantity of illegal substances, further disrupting the local drug trade and enhancing community safety. Evidences recovered during the said operation were the following: four (4) pieces knot-tied transparent ice bags and two (2) pieces heat-sealed transparent

Data released by DOST Calabarzon said that there are 4,071 scholars under the Republic Act No. 7687 or the Science and Technology Scholarship Act of 1994; 2,755 scholars under the Republic Act No. 2067 or the DOST-SEI Merit Scholarship Program; plastic sachets containing a white crystalline substance suspected to be shabu of more or less 500 grams with a standard drug price value of Php3,400,000; one (1) piece unit of 1911 cal. 45; one (1) piece cal. 45 magazine (inserted to 1911); one (1) piece improvised Thompson cal. 45; one (1) piece cal. 45 magazine (inserted to improvised Thompson); six (6) pieces live ammunition cal. 45; one (1) piece cal. 22; one (1) piece cal. 22 magazine; one (1) piece live ammunition cal. 22.

The entire operation was documented using an Alternative Recording Device (ARD) to ensure transparency and adherence to proper law enforcement procedures.

The arrested suspects and the confiscated evidence were brought to the Bacoor Component City Police Station for proper documentation and the filing of appropriate charges.

This successful operation underscores the police force's dedication to maintaining law and order and reinforces their commitment to the safety and security of the community.

PCOL DWIGHTE ALEGRE, Acting Provincial Director of Cavite PPO, expressed his gratitude to the joint operatives for their prompt and rigorous response to illicit drug activities in Cavite. "I commend the unwavering efforts of our operatives to combat illegal drugs in the province. DOTR CHIEF: RECENT AIRPORT BULLET INCIDENTS NOT

MANILA – Transportation Secretary Vince Dizon assured the public on Friday that the recent incidents involving passengers allegedly carrying ammunition at airports are not cases of "tanim bala" or bulletplanting schemes.

Dizon was referring to three separate incidents: on March 20 and 24 at Ninoy Aquino International Airport (NAIA), where two passengers were caught with one and four bullets, respectively, and on March 27 at Clark International Airport, where a passenger was found with ammunition sealed in a can of shrimp paste.

At a press conference, Dizon said he would not tolerate wrongdoings among the agency's personnel.

However, he said, initial investigations by the police and the Office for Transportation Security (OTS), along with video footage, confirmed that OTS personnel did not plant the bullets.

"We will not let it pass when passengers, deliberately or not, carry prohibited items like ammunition," Dizon He said videos showed that the ammunitions in the latest incidents were not

placed by OTS personnel, as they were detected during the x-ray screening. He added the passengers involved admitted they were either unaware of the bullets in their possession or claimed someone had asked them to carry the items.

While denying the presence of bulletplanting schemes, Dizon vowed to crack down on any wrongdoing by transportation personnel.

"We will not tolerate any form of abuse or misconduct. I won't hesitate to fire anyone involved in such schemes," he said.

He revealed that four OTS personnel were recently terminated for their alleged involvement in a March 6 incident at NAIA, where a woman was wrongly accused of carrying an amulet or bullet.

To express remorse, Dizon and OTS Administrator Arthur Bisnar personally met with the woman over lunch to apologize. (PNA) By Ma. Cristina Arayata

DEPED RECOVERS FUNDS AS SHS VOUCHER PROBE WIDENS

ΜΑΝΙΙ Α Department of Education (DepEd) has recovered approximately PHP65 million from 40 of the 54 private schools flagged for irregularities in the Senior High School Voucher Program (SHS-VP) for School Years 2021-2022 and 2022-2023

In a statement Wednesday, DepEd said that out of the 54 schools removed from the SHS-VP, 38 have fully refunded the government, while two have made partial payments.

It said 14 schools have yet to return the disbursed the funds, prompting issuance of final demand letters.

The agency said it is still determining whether the flagged irregularities amount to fraud. as investigations remain ongoing.

For the current school year, 12 schools are under review by DepEd's Investigation Division. Additionally, three other institutions have been referred to the National Bureau of Investigation (NBI) following findings by the Government Assistance and Subsidies Service (GASS).

The To curb further misuse of public funds, DepEd, in partnership with the Private Education Assistance Committee (PEAC), is implementing this school year stricter monitoring measures that include cross-verification of records, full system audits, and random field visits to participating private schools.

"The Armed Forces of the Philippines, Philippine National Police, National Intelligence Coordinating Agency, and other law enforcement intelligence remain units vigilant against any attempts by the Communist Party of the Philippines – New People's Army to regain a foothold in Calabarzon," Alcudia said during the Kapihan sa Bagong Pilipinas forum on March 18.

He reiterated that achieving sustainable and inclusive security requires a collective effort, aligning with the objectives of Executive Order No. 70. which institutionalized а whole-of-nation approach rather than just a whole-ofgovernment approach. "It is crucial that we work

together to resolve the problem of insurgency. This is not just the responsibility of the government; it is the responsibility of every Filipino," he said.

8 TOWNS IN CALABARZON TAGGED AS 'AREAS OF CONC is the only municipality

CALAMBA CITY (PIA) — The Police Regional Office in Southern Tagalog has identified eight election hotspots or areas of concern for public security ahead of the 2025 National and Local Elections.

During a meeting with the Calabarzon Regional Peace and Order Council (RPOC) on March 20, police identified several municipalities in Laguna, Batangas, and Quezon as Election Areas of Concern (EAC)

Police identified the towns of Sta. Maria in Laguna; Mataas na Kahoy, San Jose, Taal, and Tanauan City in Batangas; and Candelaria and San Francisco Quezon in Province as "yellow" election areas of concern. Meanwhile, Tagkawayan

placed under the Orange category. Meanwhile, the remaining 128 areas in the Calabarzon region were classified as

green areas, indicating no security concerns and a relatively peaceful and orderly environment for the upcoming elections.

Under Comelec Resolution No. 11067 stated that the Philippine National Police (PNP) and Armed Forces of the Philippines (AFP) are authorized to classify all areas in the country under four categories: green, yellow, orange, and red.

The areas under the green areas have no security concerns and are relatively peaceful and orderly for conducting elections. Yellow areas are those that

Forces of the Philippines (AFP) on Thursday reiterated its loyalty to the Constitution and its mandate of protecting the people and the state even as some groups question its role and responsibilities. In a statement, the AFP emphasized that it remains steadfast in its sworn duty to protect the Filipino people, defend the Constitution, and uphold democracy.

"In light of recent discussions questioning the AFP's role and responsibilities, we affirm the following: The 1987 Constitution is clear – the Armed Forces is a nonpartisan institution. Section 5(3)," it said.

The military also noted that Article XVI of the Constitution explicitly prohibits its personnel from engaging in political activities.

MANILA – The Armed Forces of the Philippines (AFP) on Thursday reiterated its loyalty to the Constitution and its Any deviation from this principle will "undermine bound to protect," the AFP said.

"The AFP's role is to defend the country and uphold stability, not to interfere in political matters. Any concerns about governance should be resolved through lawful and democratic means," it added.

DA TO CUT FURTHER MSRP ON IMPORTED RICE TO P45 PER KILO

MANILA – Agriculture Secretary Francisco Tiu Laurel Jr. on Wednesday announced that the maximum suggested retail price (MSRP) for imported rice will be reduced anew on March 31 to PHP45 per kilo, following a continued decline in global rice prices.

"At this level, the retail price of imported rice has now decreased by P19 per kilo compared to its price before we implemented the MSRP on January 20," Tiu Laurel said in a news release.

Before the MSRP was introduced, imported rice was sold for PHP64 per kilo, despite global rice prices softening, tariff reductions, and a stronger peso.

The Philippine Statistics Authority had recognized the MSRP as a key factor in reducing rice prices and helping to tame inflation.

The implementation of the MSRP followed consultations with industry stakeholders to ensure that price reductions would not destabilize the rice industry or compromise food security. This initiative fully reflects the decision of President Ferdinand R. Marcos Jr. to approve a reduction in rice tariffs—from 35 percent to 15 percent—effective July 2024.

In September of last year, India lifted its year-long ban on the export of non-Basmati rice, contributing to a global increase in rice supply.

As a result, rice prices have dropped to their lowest levels in over two years, with some varieties now priced below USD380 per metric ton.

Prior to the MSRP reduction to PHP49 per kilo on March 1, the price of good-quality rice from Vietnam—those with 5 percent broken grains had already decreased to USD490 per metric ton, approximately USD200 cheaper than in December. Vietnam is the Philippines' main source of imported rice.

Data from Food Terminal Inc. revealed that the landed cost of imported rice for March 2025 for DT8 variety is PHP32 to PHP34 per kilo. *(PR)*

MANILA The Metropolitan Manila **Development Authority** (MMDA) on Wednesday apprehended 15 drivers of traditional public utility (PUJs) jeepneys for blocking Connecticut Street in San Juan City on the third day of Manibela's transport strike.

In a Facebook post the MMDA said the 15 jeepney drivers were issued with traffic violation tickets for illegal parking and obstruction near a building of the Department of Transportation (DOTr). WARMER DAYS AHEAD AS **PAGASA DECLARES START OF DRY SEASON**

MANILA - The weather bureau announced on Wednesday the official end of the northeast monsoon or amihan and the start of

the dry season. "Warmer days ahead, but occasional thunderstorms may still occur," the Atmospheric, Philippine Geophysical and Astronomical Services Administration (PAGASA) said in an advisory.

The public is urged to take precautionary measures to minimize heat stress and optimize the daily use of water for personal and domestic consumption.

In Tuesday's episode of Bagong Pilipinas Ngayon, PAGASA's Climate Monitoring and Prediction Section chief Ana Liza Solis said a heat index reaching 52°C is possible. She said PAGASA has so far logged heat indices or what the temperature feels like to the human body when relative humidity is combined with the air, of around 46°C to 47°C in conventions held last year, Romero said.

"These numbers confirm our position as Mindanao's destination, premier she said. "With improved air connectivity and attractions coming new online, we're confident in achieving our 2.5 million visitor goal for 2025."

Romero said the new developments in the scenic Marilog and Paquibato districts have expanded ecotourism options, now accounting for nearly onefifth of total visits. Three additional nature sites are scheduled to open by September 2025 as part of sustainability efforts. Regional data from the

Department of Tourism showed Davao Region overall attracted 4.1 million visitors in 2024, generating PHP34.7 billion in tourism revenue.

MANILA Airlines will be required to integrate the Advance Passenger Information System (APIS) into their system once the phased implementation becomes successful. Malacañang said on Friday. The Bureau of Immigration earlier launched (BI) the APIS, in line with President Ferdinand Marcos Jr.'s directive to enhance national security through digital transformation. "Once everything is smooth,

Castro said the APIS is a globally recognized system that allows authorities to conduct advance screening of passengers before their arrival, enabling enhanced risk assessment and streamlined immigration procedures.

Castro said the Philippine Airlines (PAL) and other air carriers are set to follow, as part of the ongoing trials.

The BI earlier said the APIS aims to screen passengers in advance, in an effort to improve risk assessment and expedite the processing of legitimate travelers.

The BI conducted connectivity tests with the International Criminal Police Organization's (Interpol) I-24/7 database ensuring access to global watchlists security for enhanced monitoring.

The agency is also working closely with the Interpol, airline representatives, and the United Nations Office of Counter-Terrorism to ensure seamless integration and operational efficiency. (PNA) By Ruth Abbey Gita-Carlos

"The candidates are required to remove them immediately even if they have not received the letter yet or if they receive the letter, they must be removed immediately. It is very difficult to have a case with the Comelec. We are not joking with this warning. We have to start filing cases," he said.

The 45-day campaign period for local candidates began Friday. A day before, the Comelec was able to remove truckloads of illegal campaign materials all over the country.

"Our first day of the campaign went well, although of course we removed tons of garbage and materials from various parts of the country," Garcia said. At the same time, he urged local government units (LGUs) to enact an ordinance that would penalize those violating campaign posters guidelines.

"As for the Comelec, we are limited to what is stated in the law. Maybe in the future, our LGUs will be able to have an ordinance, whether there is an election or not, that will increase the penalties, if not increase the fines that they can impose," Garcia said.

In Manila, reelectionists Mayor Honey Lacuna and Vice Mayor Yul Servo held their proclamation rally in front of Our Lady of Loreto Church in Sampaloc District.

They also went houseto-house, joined by 4th District Edward Maceda whose wife, Dr. Giselle Maceda, will eye to replace him.

In her brief rally speech, Lacuna touted her accomplishments.

"We have accomplished so much and we will not allow anyone to belittle or insult us. Even though it is not perfect, our Manila is not a failure. Our Manila is full of promise and hope," Lacuna said. (PNA) By Ferdinand Patinio

PNR CONFIRMS PROGRESS ON SOUTH LONG HAUL PROJECT

QUEZON CITY, (PIA) — Philippine National Railways (PNR) General Manager Engr. Deovanni S. Miranda assured that the South Long Haul Project remains on track, with rightof-way and site acquisitions already underway.

"Mayro'n kasing parte ng project na deliverables ng government of the Philippines at saka 'yong commitment naman ng gobyerno at pag-pu-push ng leadership natin ngayon from the President going to our secretary na tuloy pa rin 'yong project na 'yan," he said.

He added that some areas, including the planned depot site in San Pablo, Laguna, have already been acquired. Once informal settlers are relocated, the area will be secured to prepare for implementation. The priority alignment of the project will span 380 kilometers from Laguna to Daraga, Albay, with future extensions to Batangas and Manila. Regarding the right-of-way for the project, Miranda said that the PNR plans to use a new alignment instead of the old PNR route.

"As of now iyon ang direction na nakita naming talaga na mas magiging benefits para sa project na gamitin 'yong bagong alignment," he said

The original alignment would have affected around 120,000 informal settlers, whereas the new route reduces this number to approximately 30,000.

However, he acknowledged that purchasing new land for the railway is necessary. It can be recalled that the PNR South Long Haul project, also known as the Bicol Express, is a proposed 560-kilometer (386 km for the first package) rail line connecting Metro Manila to the Bicol Region, aiming to reduce travel time from 14-18 hours to 4-6 hours. MANILA – The Department of Trade and Industry (DTI) is planning to launch within the week, a handbook that will help improve access to the United Kingdom (UK) market.

""So we're launching a guidebook on how to access the UK market, leveraging on the DCTS (Developing Countries Trading Scheme)," DTI Export Marketing Bureau Director Bianca Sykimte said during the recent UK-Southeast Asia Tech Week in Manila.

The DCTS reduces tariffs. removes conditions and simplifies trading rules for 65 developing countries.

On June 7, 2023, the UK government launched the DCTS in Manila, allowing Philippine exports to the UK to benefit from significant tariff reductions. Sykimte said the DTI is pushing for improved utilization rate under the UK DCTS.

She said the utilization rate is currently at 68 percent. This is slightly lower than the over 70 percent utilization rate under the EU Generalized System of Preferences.

"So we're hoping the same for the UK DCTS," she added.

Sykimte said the DTI also recently had discussions with the UK government on relaxing some of the rules for sectors that have underutilized utilization, specifically for garments. "The UK has also had

COIN DEPOSIT MACHINE COLLECTIONS REACH P1.37-B MANILA - The Bangko These are located at Sentral ng Pilipinas (BSP) said PHP1.372 billion worth of coins have been deposited through its coin deposit machines (CoDM) as of March 17.

In a social media post on Monday, the BSP said the amount is equivalent to 339.84 million pieces of coins from 311,858 transactions.

CoDM The project, launched in June 2023, allows customers to conveniently deposit their legal tender coins to be credited to their GCash or Maya electronic wallet accounts, or converted into shopping vouchers.

The coin deposit machines support the BSP's Coin Recirculation Program to put idle coins back in circulation to serve the country's currency needs. To date, the BSP has deployed CoDMs in partner retail establishments across the Greater Manila Area.

ECONOMIST SEES CONTINUED DECLINE IN UNEMPLOYMENT RATE

MANILA – The country's unemployment rate could further improve to around 3 percent as of end-February this year, an economist said Thursday. "Philippine unemployment rate as of February 2025 could ease/improve to a range of 3.3 to 3.8 percent amid better weather conditions so far in early 2025 that could improve employment in agriculture and many other industries," Rizal Commercial Banking Corporation chief economist Michael Ricafort told the Philippine News Agency.

Unemployment rate went down to 4.3 percent in January this year from 4.5 percent in the same month last vear.

The preliminary result of the February labor force survey is scheduled to be released on April 8.

Ricafort is expecting some pick-up in production and inventory-building in

preparation for the Holv Week and the midterm elections.

"The midterm election campaign would also require more jobs for the candidates and for the industries that supply the candidates' electionrelated spending," he said. Ricafort said increased government spending on infrastructure and other projects especially before the election ban would also benefit their respective supply chains.

He noted that this would all entail more jobs.

"Philippine employment data [which is] among the best in nearly 20 years or since revised records started in 2005, would remain a bright spot and a major source of growth for the Philippine economy amid the country's favorable demographics," Ricafort said. (PNA) By Anna Leah Gonzales



FIFA ANNOUNCES BUMPER PRIZE MONEY FOR CLUB WORLD CUP

GENEVA – FIFA, world football's governing body, announced details of the 2025 Club World Cup's USD1 billion prize money on Wednesday, with the tournament champion set to receive up to USD 125 million.

The inaugural 32-team FIFA Club World Cup will take place in the United States from June to July 2025.

FIFA stated its new flagship tournament is projected to generate USD2 billion in revenue, with USD 1 billion allocated to participating clubs and an additional USD250 million going to a global solidarity fund for club football.

"The distribution model of the FIFA Club World Cup reflects the pinnacle of club football and represents the biggest-ever prize money for a football tournament comprising a seven-match



participating teams, while the remaining USD475 million will be distributed based on tournament performance.

The 32 clubs will receive varying participation fees determined by a ranking system incorporating sporting and commercial criteria. Top European clubs could earn up to USD38.19 million just for participating, while Oceania's Auckland City would receive a minimum of USD3.58 million.
