

DASMARIÑAS CITY, Cavite (PIA) - The initial rollout of the 'Benteng Bigas Meron Na' initiative in Dasmariñas City, Cavite has received public support as members of the vulnerable sectors welcome the government's efforts to ensure rice accessibility and food security.

Vilma Menezes was one of the first senior citizens who waited outside the covered court at Barangay Salitran III. Her breakfast in hand, Vilma did not mind waiting for an hour outside of the covered court. In fact, she was the first to stand up when the caretaker opened the gates that divided her and the other residents from the big sacks of rice to be sold on Friday, May 16.

Vilma was one of the many residents who availed of the P20 Rice Program, purchasing 10 kilos of rice-enough to feed her family of five when combined with the rice her bedridden husband also bought.

"I left my husband at home to buy rice. I am very thankful to the organizers. I hope that there will be more [P20 rice programs] where we can buy [affordable] rice.'

Dubbed 'Benteng Bigas Meron Na', the P20 rice program is part of the Marcos Jr. administration's bid to make rice more affordable especially to the vulnerable sector, including senior citizens, Persons With Disability (PWD), and pregnant mothers.

Jennifer Ibayan, City Agriculturist, said they were prepared to cater to the senior citizens who needed more assistance.

"Barangay Salitran 3 is just a sample where a lot of residents wanted to avail the P20 rice. We are expecting to make stops at other barangays in the coming weeks, if we have rice to sell."

Raul Valles, barangay captain of Barangay Salitran III, said there are more than 2,500 residents who are part of the vulnerable sector in their community: of which 2,000 are senior citizens, more than 100 solo parents, and more than 400 PWDs.

Valles, over the microphone, announced that they will prioritize their residents and will cater other barangays once they are sure that his kabarangays have bought rice

#### for their families.

"There are already more than 2,000 senior citizens in our barangay alone. I think we would not be able to cater to everyone if we will also cater to those from other barangays," Valles admitted.

Barangay Salitran III has prepared for the expected influx of residents who will buy the P20 rice, barangay peacekeepers to keep the lines organized. Barangay Health Workers and emergency medical personnel were also on standby in case senior citizens needed their assistance.

"Our lupong tagapamayapa, our medics, BHWs, and tanod are on standby outside to assist in managing the traffic flow around this place."

According to the City Agriculturist Office, Barangay Salitran 3 was the first among the many barangays in the city to host the P20 Rice Program. (PB/PIA4A) BY PATRICIA BERMUDEZ



MARTIRES Cavite (PIA) -Drug Philippine Agency reaffirmed its commitment to intensify the government's war against illegal drugs as it destroyed ₱5.32 billion worth of dangerous drugs on Tuesday, May 20. Atotal of 2,227.76 kilograms of solid drugs and 3,447.09 milliliters of liquid narcotics

were incinerated via thermal decomposition or thermolysis during a public destruction ceremony held at the Integrated Waste Management, Inc. (IWMI) facility in Barangay Aguado.

Among the drugs destroyed were 404.95 kilograms of shabu seized during a major interdiction operation at the Port of Manila last January 23, in a joint effort by PDEA, the National Bureau of Investigation (NBI), and the Bureau of Customs (BOC). PDEA Director-General Usec. Isagani R. Nerez, who led the destruction emphasized ceremony, that public drug destruction activities are a cornerstone the agency's efforts of to build trust under the administration's "Bagong governance Pilipinas" agenda.

"These drug consignments, many of which were ordered by the courts to be destroyed, were securely incinerated beyond This recovery. public destruction reinforces the integrity of our justice system and assures the public that seized narcotics are not being recycled,' Nerez said.

"We are showing the Filipino people that we act with utmost diligence and integrity. They deserve nothing less," he added.

from the Officials Dangerous Drugs Board (DDB), Department of Justice (DOJ), Department of the Interior and Local Government (DILG), Philippine National Police (PNP), various local government non-government units, organizations, and media



representatives witnessed the destruction as part PDEA's commitment of transparency to and accountability.

According PDEA to Calabarzon, it has intensified anti-drug enforcement operations in the region, arresting highvalue drug personalities through buy-busts, seaport interdictions, and entrapment operations conducted from May 9 to 19.

These efforts led to the arrest of several suspects and the confiscation of illegal drugs. In Bacoor City, Cavite, 15 suspects, including three high-value drug personalities, were apprehended in multiple entrapment operations.

In another operation, PDEA conducted a seaport interdiction at the Port of Batangas City, arresting a suspect during a preboarding inspection for a trip bound for Calapan. The suspect was allegedly carrying around five grams of suspected shabu valued at ₱34,000, along with marked buy-bust money.

Meanwhile, in Antipolo, Rizal. authorities discovered an abandoned clandestine shabu laboratory containing liquid and powderv substances, as well as plastic sachets with traces of white crystalline material suspected to be shabu.

Though the shabu laboratory found was abandoned, its owners and operators have been identified. It is only a matter of time before they are caught by the long arm of the law," Nerez said.

He added that charges will be filed against the arrested suspects for violating various provisions of Republic Act No. 9165, or the Comprehensive Dangerous Drugs Act of 2002. The suspects are currently in detention.

The operations align with the enhanced Philippine anti-illegal drugs strategy in pursuit of "Bagong Pilipinas" under the administration of President Ferdinand R. Marcos Jr., which promotes transparent law enforcement in combating illegal drugs. (RBF/KAA/ PDEA4A) BY FRANCISCO RUEL

#### **4PS BENEFICIARIES TAPPED FOR DISASTER-PROOFING PROGRAM**

**CALAMBA CITY, Laguna** (**PIA**) — The Department of Social Welfare and Development (DSWD) in Calabarzon continues to mobilize members of the Pantawid Pamilyang Pilipino Program (4Ps) in its efforts to mitigate the erratic effects of climate change.

One of these initiatives Project Local is the Adaptation to Water Access (LAWA) and Breaking Insufficiency through Nutritious Harvest for the Impoverished (BINHI), which aim to combat hunger and reduce the economic vulnerability of communities by addressing water scarcity and food insecurity worsened natural disasters. bv particularly those linked to climate change.

Across various provinces in the Calabarzon region, the DSWD has implemented cash-forwork activities under the Risk Resiliency Program through Projects LAWA and BINHI.

Jasmin Lirio, a parent leader of the 4Ps in Rosario, Batangas, shared that 400 individuals from their community have begun participating in a communal garden project. In a Facebook post, Lirio said the program benefits them by supporting environmental efforts while also providing financial assistance for daily needs.

"As a member of [4Ps], I am grateful—along with my fellow members to everyone behind the LAWA and BINHI Projects for including us in this initiative. We will continue to dedicate ourselves and offer our support to the programs of the DSWD," Lirio said.

She emphasized that the project plays a crucial role in building climate- and disasterresilient communities by promoting local adaptation strategies that improve water access and increase food production through sustainable farming practices.

"The project is a huge help because Project LAWA and BINHI aim to build climate- and disasterresilient communities by establishing water systems and gardening projects to address the challenges of drought and heavy rains."

In Montalban, Rizal, 100 residents have recently expressed interest in joining the program. Meanwhile, in Batangas, participants will undergo a 20-day training and work on establishing communal gardens and rehabilitating or installing small farm reservoirs. # PDLS IN BATANGAS JOIN AIDS CANDLELIGHT MEMORIAL

**BATANGAS CITY (PIA)** Persons Deprived of Liberty (PDLs) in Batangas City joined the global observance of the AIDS Candlelight Memorial on May 20, an initiative aimed at raising awareness HIV and sexually on infections transmitted (STIs), as well as honoring the lives lost to these diseases.

The event carried the theme "We Remember, We Rise, We Lead", highlighting solidarity and commitment to ending the stigma around HIV/AIDS.

Participating PDLs formed a ribbon-shaped candle formation, symbolizing support and remembrance for those who have passed due to HIV/AIDS.

Vicky Atienza of the City Health Office (CHO) led an HIV 101 session, discussing strategies for effective implementation of HIV/AIDS programs and ways to reduce new cases and related deaths.

She emphasized the three primary modes of HIV transmission: unprotected sexual contact, exposure to infected blood or blood products, and the sharing of needles.

Participants were also

given updates on Republic Act 11166, also known as the HIV and AIDS Law, as well as STI Prevention and Control Programs to help deepen their understanding of the health issue.

According to Dr. Allen Evangelio-Santos, CHO Medical Program Manager for the HIV-STI Prevention Program, Batangas Province ranks 4th in CALABARZON in terms of confirmed HIV cases.

"From the five provinces of Region IV-A, Batangas is in fourth rank. In Batangas City alone, we have 639 recorded cases as of the moment. We need to continuously inform Batangueños on ways to avoid getting infected," said Santos.

The CHO urged the public to remain vigilant, undergo regular screening and testing, and promptly consult health centers to ensure early detection and treatment.

Health officials emphasized that that HIV awareness and prevention campaigns are for everyone, not just members of the LGBTQIA+ community, but especially for individuals who are sexually active. (MDC, PIA Batangas) **BY MAMERTA DE CASTRO**

# SSS INTENSIFIES RACE CAMPAIGN VS DELINQUENT EMPLOYERS

CALAMBA CITY, Laguna (PIA) The Social Security System (SSS) intensified the Run After Contribution Evaders (RACE) campaign in Calabarzon to continuously protect the rights of private-sector employees from delinquent employers who fail to remit mandatory monthly contributions.

Under the Social Security Act, all employers are mandated to register their businesses and remit monthly contributions for their employees' social security protection benefits.

In a round of surprise visits in Santa Rosa City, Laguna, 10 establishments were given show-cause orders. According to the SSS, these non-compliant employers owe up to ₱6.02 million, which includes principal and penalties. SSS Luzon 1 Division Vice President Edwin Igharas said the RACE campaign is effective in encouraging non-compliant employers to fulfill their legal obligations.

"It is a big help that employers see a team visiting with SSS account officers, officials, media, and sometimes with police assistance, they will not ignore us," he added.

Moreover, delinquent employers were given a 15day grace period to comply with their legal duties and to explain their reasons for non-remittance.

Igharas explained, "We understand that some employers go through economic and financial difficulties, we are giving them ways to pay their delinquencies."

He also advised employees to regularly check their monthly contributions online through their MySSS accounts to ensure that these are accurately posted.

"We always tell employees to be vigilant about their contributions. For faster verification, they can check through the SSS website. And if they see discrepancies, they can file a complaint with our office, and we will immediately act on it and make the employers pay the contributions."

Meanwhile, in Bacoor, Cavite, several random businesses were also issued written notices. According to SSS Bacoor City Acting Head Ms. Lourdes B. Verbo, before the issuance of formal notices, establishments received billing letters and were given ample time to settle their obligations.

She also stressed, "Employers are accountable for the social security protection of their workers."

Meanwhile, the SSS Luzon South 1 Division is targeting to collect ₱135 million in unpaid contributions this year. Section 22 of the Social Security Act allows the issuance of a Warrant of Distraint, Levy, and Garnishment (WDLG) for the collection of unpaid including contributions, penalties, from delinquent (RBF/ employers. # NEW 10K NON-TEACHING Posts to ease teachers' Workloads – DBM

#### MANILA

Department of Budget and Management (DBM) has approved 10,000 new nonteaching positions across the country to ease the administrative workload of public school teachers and allow them to focus more on quality instruction.

In a statement released Thursday, DBM Secretary Amenah Pangandaman said the initiative fulfills a campaign promise of President Ferdinand R. Marcos Jr. to support teachers and reduce their administrative burdens.

This development comes soon after the order to create 16,000 additional teaching posts for School Year 2025–2026, part of the government's continuing efforts to strengthen the education sector.

The new positions will be classified as Administrative Officer II with Salary Grade 11 and will be deployed across elementary, junior high, and senior high schools in all regions nationwide.

"Actually, this is a campaign promise fulfilled by our beloved President. Noong una pa lang po, pinangako na ni Pangulong Bongbong Marcos na bibigyan niya ng kinakailangang suporta ang ating mga guro para padaliin ang kanilang mga trabaho (From the very beginning, President Bongbong Marcos promised to provide the necessary support for our teachers to make their jobs easier)," Pangandaman said.

She said the President wanted teachers to concentrate on delivering quality education rather than being overwhelmed by clerical tasks.

"Gusto n'ya na makapagfocus sila sa pagbibigay ng dekalidad na pagtuturo. "The ocean of opportunities for women in the maritime industry means nothing if gender barriers will remain ingrained in maritime education, training, recruitment, placement, promotion, allocation of benefits and opportunities, and in the language and behavior of people who make up the industry," she said.

A recent survey conducted by the International Maritime Organization and the Women's International Shipping and Trading Association showed that the shipping industry remains "overwhelmingly male-dominated."

Women only make up 19 percent of the total maritime workforce surveyed, with 1 percent of them working at sea.

Meanwhile, a study by the National Maritime Polytechnic (NMP) in 2022 revealed that only 44 percent, or 28 out of 64 surveyed shipping companies, have established formal policies on gender equality.

The NMP said this indicates a significant gap in the institutional support necessary to foster a more inclusive and equitable maritime industry.

The study also showed that women remain underrepresented in shipboard roles, and their participation is primarily seen within the steward or catering departments at 402, or 42 percent of 953 Filipino women seafarers. Moreover, only 100, or 11 percent, of 940 female employees within crewing and shipping companies hold senior management positions.

"Having more women in the industry means nothing if discrimination, harassment, and denial of opportunities will persist," Valdeavilla said.

DSWD "The whole call supports the of President Marcos for swift and efficient delivery of government services order to effectively in address the immediate and day-to-day needs of the poor, vulnerable and marginalized groups,' Gatchalian said.

The DSWD chief said the agency now has a total of 3,000,658 boxes of family food packs (FFPs) which have been prepositioned across the agency's warehouses nationwide --the highest stockpile recorded so far in the department's history.

"This record reflects the DSWD's untiring dedication to bolster year-round preparation for disasters and calamities. This is in line with the President's directive toward a more 'omnipresent' government response to disasters and calamities."

Based on the report of the DSWD's Disaster Response Management Group (DRMG), 2,207,124 FFPs have already been delivered and prepositioned at various hubs, spokes, and lastmile facilities across the country.

Under the Assistance to Individuals in Crisis Situation (AICS) program, DSWD's Central the Office and Field Offices nationwide continue to provide cash and guarantee letters to families and individuals who are undergoing crisis and are in need of medical, burial, transportation and food assistance.

The Walang Gutom Program (WGP) provides food-poor families with PHP3,000 monthly food subsidy in the form of Electronic Benefit Transfer (EBT) cards. Some 750,000 food-poor families have been targeted under the WGP by 2027.

The Walang Gutom Kitchen in Pasay City, meanwhile, continues to address involuntary hunger by providing free, hot meals during breakfast and lunch to all those who want to eat.

The Pantawid Pamilyang Pilipino Program (4Ps), the government's flagship program in breaking intergenerational poverty, continues to cater to more than 4 million householdbeneficiaries by providing them with cash grants for the education and health of children from 0-18 years old.

For the last 20 years, the Kapit-Bisig Laban sa Kahirapan-Comprehensive and Integrated Delivery of Social Services (KALAHI-CIDSS) has helped poor communities build projects such as school buildings, water systems, foot paths, and improvement of roads. The Panahon ng Pagkilos modality of KALAHI-CIDSS was recently approved implementation by for the National Economic Authority Development (NEDA) Board and will officially start in 2026 until 2030 in 500 municipalities in 49 provinces nationwide. # DTI VOWS CONTINUED SUPPORT FOR PH CEMENT INDUSTRY

**MANILA** – Department of Trade and Industry (DTI) Secretary Cristina Roque recently met with senior executives of Taiheiyo Cement Corporation in Tokyo, Japan, to reaffirm the Philippine government's strong support for the cement industry.

In a statement Thursday, DTI said the meeting was held on May 19, centered on Taiheiyo's ongoing construction of a PHP3.72 billion Luzon Distribution Terminal in Calaca City, Batangas.

The facility scheduled to start operations early next year, can supply up to 700,000 tons of cement annually to Luzon.

Taiheiyo will utilize this terminal to distribute blended cement, a more environmentally friendly alternative that uses industrial by-products like fly ash, slag, or pozzolana to reduce carbon emissions and promote circularity in construction.

The company said the shift to blended cement is not only a response to the rising market demand, but also part of its broader carbon reduction roadmap. Taiheiyo Cement Philippines, Inc. (TCPI), the group's local subsidiary based in Cebu, currently

# AIRASIA RECORDS 85% LOAD FACTOR; BOOSTS TAIPEI FLIGHTS IN JULY

MANILA – Low-cost carrier AirAsia Philippines reported strong performance on Wednesday, registering an average of 85 percent load factor for the first months of 2025, and hitting almost three million passengers for the first half, including forward bookings.

Airline spokesperson Steve Dailisan said 80 percent of the load factor comprised domestic travelers, with Puerto Princesa as the top local destination.

"This strong performance signals positive growth for local tourism. We remain focused on supporting this through initiatives like the AirAsia Fiesta Series and promotional campaigns tied to local festivals, encouraging Filipinos to explore and take part in the cultural festivities across the country," Dailisan said in a statement.

Taipei emerged as the top choice for international travelers.

Starting July 1, AirAsia will increase services to Taipei from 14 to 17 times weekly. The increase seeks to enhance connectivity and offer greater flexibility for both leisure and business travelers.

Meanwhile, to further entice travelers, AirAsia has an ongoing seat sale, enabling passengers to book one-way base fare for as low as PHP185.

**MANILA** – The Contact Center Association of the Philippines (CCAP) has expressed strong support for the government's new Enterprise-Based Education and Training (EBET) law, as this will help in addressing the skills gap in the workforce.

In a press conference in Makati City Wednesday, CCAP president Haidee Enriquez lauded government the for recognizing the crucial role of enterprises in ensuring a competitive talent pool, especially for the contact center sector wherein the workforce should be regularly upskilled and reskilled amid fast-paced technologies.

In a statement Wednesday, PDIC said deposits in these banks are insured in the same manner as conventional deposits up to the maximum deposit insurance coverage (MDIC) of PHP1 million per depositor, per bank.

"The expansion of deposit insurance to include Islamic deposits guarantees that depositors of Islamic banks have the same level of protection as those of conventional banks, thereby fostering confidence in the Islamic banking system," PDIC President and CEO Roberto Tan said.

"This aligns with the national government's pursuit of promoting financial inclusion and strengthening of the Islamic banking sector in the country as this encourages more individuals and businesses to save in banks."

As of end-December last year, there were 12,514 Islamic deposit accounts in the banking system.

IBs and IBUs offer financial products and services, including deposits, which are compliant with Shari'ah Law focusing on ethical financing, risk-sharing, and socially responsible practices. (PNA) BY ANNA LEAH GONZALES

MANILA - Filipino boxing icon Manny Pacquiao has announced his return to the ring almost four years after his last fight.

Pacquiao announced on social media that he will face WBC welterweight champion Mario Barrios on July 19 at the MGM Grand in Las Vegas.

"I'm back," Pacquiao declared.

At 46 years old, "Pacman" is looking to turn back time and overcome his own feat as boxing's oldest welterweight world champion. He currently holds the record, when he beat Keith Thurman in 2019 to claim the WBA (Super) world title at age 40.

Pacquiao's announcement came a week after his failed return bid to the Philippines' Senate.

In his last bout, Pacquiao lost on points against Yordenis Ugas in August 2021.
