**MANILA** – Philippine National Police (PNP) chief Gen. Nicolas Torre III on Friday said he will impose a stricter firearms proficiency policy for all police officers to prevent the loss of innocent lives during operations.

In an interview on Friday, Torre said he plans to revisit the firearms proficiency of officers in top leadership positions by July, and later encompass personnel from the patrolman to general ranks.

I will be very, very strict. firearms Mayroong proficiency standards ang ating DHRDD (Directorate for Human Resource and Development) Doctrine Our DHRDD has firearms proficiency standards). For quite a while, parang hindi masyado siniseryoso yan (it seemed that it was not being taken seriously), but I'll personally see to it and lead the test, exams. Kung bumagsak ako, edi magreretire ako (If I fail. I will retire)." Torre told reporters at the sidelines of the 3nd PNP Press Corps (PC) Invitational Shootfest in Camp Karingal, Quezon City on Friday.

"Walang sini-sino yung standards. proficiency Walang pinagkaiba sa PFT (physical fitness test) yan. Next month na yan, July, magkakaroon muna ako ng proficiency standards sa lahat muna nag-o-occupy ng top leadership position. Kapag tinest sila at bagsak sila sa marksmanship, aba'y tatanggalin ko ang commanders na mda hindi makakapasa sa ating proficiency testing (Nobody is exempted from proficiency standards. It is no different from the PFT. Next month, July, I will have proficiency standards for everyone who occupies top leadership positions. If they fail in marksmanship, I will fire the commanders who cannot pass our proficiency testing)," he said.

The PNP chief pointed out that the law enforcement agency's Training Service offers simulations to help officers learn how to use their guns.

"Proficiency and efficiency

in the use of firearms, very, very important yan sapagkat buhay and Kapag nakatava rito. ginamit mo at hindi mo alam kung paano gamitin, paano kung ang intended target, hindi mo tamaan, at ang tatamaan ay inosenteng tao, ayaw natin nun (because lives are at stake here. When you use it and you don't know how to use it, what if you miss the intended target and hit an innocent person instead, we don't want

that)," he explained. Torre also said he had ordered the procurement of more bullets for police officers to use for firearm proficiency practice.

"I signed a procurement contract para sa bala. Hindi magkukulang ang bala sa pulis. ibibigay namin sa pulis ang balang kailangan nila para makapag practice sila. Pababantayan ko lang sila, sayang ang bala ang mahal mahal tapos imimiss mo lang. Pero you know we have sufficient resources para i-train ang ating mga pulis (for bullets. There will be no shortage of bullets for the police. We will give them what they need so they can practice. We will just have to monitor them. Bullets are expensive and it's a waste if you just miss the target. But you know, we have sufficient resources to train our policemen)," he said.

Meanwhile, the PNP Press Corps shootfest, which runs until Sunday, will also serve as a fundraising activity for emergency financial assistance for members in the event of harassment and attacks. It is a Level 1 Philippine Practical Shooting (PPSA)-Association sanctioned match with five stages and 120 rounds for handguns and pistol caliber carbine (PCC). Physical fitness Torre also ordered a

dedicated physical fitness program for mobile force personnel with "brokenhour" shifts from 8 a.m. to 5 p.m. "I am dedicating Tuesday

# PH MONITORING FILIPINOS, DEV'T IN IRAN AFTER ISRAELI ATTACK

**MANILA** – The Department of Foreign Affairs (DFA) said Friday it is monitoring the developments in Iran, where more than 1,000 Filipinos are residing, after Israel launched a military strike on Tehran, eliciting

(for their) chosen physical fitness program. They can go swimming, they can go badminton, they can even golf for as long as they use only that time for athletics kasi free tayo sa choice niyan (because they are free to make that choice)," he said.

The dedicated program, however, comes with the expectation of passing the PNP's mandatory physical fitness test, Torre stressed. He also warned personnel who will administer the tests to accurately report officers' results.

"Kapag ako ay nagduda at nasalubong ko 'yang pinasa niyo at pina-pushup ko at hindi kaya ang 40 push-ups, hahanapin ko kung sino ang nagpapasa sa kanya at makita natin kung sino yung kasama sa ating idi-dismiss (If I get suspicious and I meet the guy you passed, and I make him do 40 push-ups and he can't do it, I will find who passed the guy and we'll see who we will also be dismissed)," he said.

Torre has earlier ordered that all police personnel should pass a PFT and have a normal body mass index (BMI).

For most adults, an ideal BMI ranges from 18.5 to 24.9. A range of 25 to 29.9 is considered overweight, while those having 30 and above are considered obese.

PNP spokesperson Brig. Gen. Jean Fajardo said those failing to get the required BMI would be denied schooling, one of the main requirements for promotion.

She said Torre's directive to pass the PFT and BMI covers all police officers and is aimed at professionalizing the organization. (PNA) BY CHRISTOPHER LLOYD CALIWAN fears of retaliation and

wider regional conflict. Pending a final embassy report, DFA Undersecretary Eduardo Jose De Vega said Filipino authorities are currently discussing measures to take, including the possibility of new advisories in both states.

"We are discussing it and awaiting the update from our embassy in Tehran," he said in a text message. In a separate interview at

PTV's Bagong Pilipinas Ngayon, De Vega said Filipinos affected may reach out to the Philippine embassies in Tehran and Tel Aviv for assistance.

"Matitiyak ng ating mga Pilipino na 'yong ating mga tanggapan will assist them. Complicated lang sa Iran dahil baka hindi sila payagang makalabas ng kanilang mga asawa dahil mga Iranian citizens na sila (They can rest assured that our foreign service posts will assist them. It's just a bit complicated in the case of Filipinos who are already Iranian citizens in Iran)," he said.

Based on the latest DFA data, there are 30,742 Filipinos in Israel and at least 1,180 in Iran, most of whom are married to Iranian nationals.

Israel Prime Minister Benjamin Netanyahu on Friday confirmed that Israel launched "Operation Rising Lion," a targeted military operation he said was aimed to "roll back the Iranian threat to Israel's very survival."

Israel earlier accused Iran of producing thousands of kilograms of enriched uranium to advance its nuclear weapon program. Netanyahu warned that the Israeli military strike would "continue for as many days as it takes" to remove threats on Israel.

On Friday afternoon, the Israel Defense Forces confirmed that the chief of staff of the Iranian Armed Forces, the commander of the Islamic Revolutionary Guard Corps, and the of Iran's commander Emergency Command were "all eliminated" in the Israeli strikes. (PNA) BY JOYCE ANN L. ROCAMORA

# SENATE DENIES 'KILLING' WAGE HIKE BILL, LAMENTS HOUSE DELAY

MANILA \_ Senate President Francis "Chiz" Escudero and key senators on Friday pushed back against criticism that the upper chamber "killed" the wage hike bill, saying that the House of Representatives had over a year to act on it but waited until the final days of the session.

"This is a classic case of passing the buck," Escudero said in a statement, adding that the Senate passed its version of a bill seeking a PHP100 daily wage increase for private sector workers as early as February 2024.

"Bakit ba kung kailan huli biglang sasabihin dine-delay namin at wala kaming oras para i-adopt 'yung kapapadala lang nila (Why are they suddenly blaming us for delays when they only sent their version at the last minute)?" he said.

Escudero stressed that if the House had wanted to adopt the Senate version, it only needed to manifest this in plenary — a process that would have allowed the bill to be transmitted directly to Malacañang for the President's signature.

Senator Joel Villanueva, chair of the Senate Committee on Labor, confirmed that both he and Escudero met with House leaders and were told the lower chamber was amenable to adopting the Senate version.

But instead of formalizing this, Villanueva said the House only transmitted the required third reading copy of its PHP200 version on June 11, the last day of the session.

"We passed this measure more than a year ago. We were able to get the official third reading copy of the House of Representatives 48 hours before we would adjourn," Villanueva pointed out.

Senator Juan Miguel Zubiri, who originally filed the Senate's wage hike bill, expressed frustration over the House's insistence on a PHP200 daily increase without data to support its feasibility.

"We would like to inform our workers that the Senate did its best to fight for the rights and fiscal incentive of having another PHP100 a day increase. Obviously, if we adopt the PHP200 minimum wage bill, mabiveto ni Presidente 'yan (the President will veto that), and if that will be vetoed, you torpedo the measure and it looks bad on everyone," Zubiri said. Senate President Pro Tempore Jinggoy Estrada echoed the sentiment, saying the House had more than 16 months to act on the measure but only did so two days before sine die adjournment.

"She should do a lot of research before opening her mouth," Estrada said, referring to House spokesperson Princess Abante, who had earlier accused the Senate of "killing" the PHP200 version.

"We passed our version more than a year ago. It was the House that waited until the last minute," he said.

Estrada said he even advised TUCP Rep. Raymond Mendoza to simply adopt the Senate version to avoid bicameral delays, but the House allegedly declined.

Senators stressed that time constraints could have been avoided if the House had acted earlier. They also pointed out that adoption of the other chamber's version without a bicam is not unprecedented.

Senate Bill No. 2534, approved in February 2024, sought a PHP100 wage hike based on committee hearings and economic studies.

Escudero reiterated that both chambers must now refile their respective versions in the next Congress. (PNA) BY WILNARD BACELONIA

# PMA WELCOMES 340 NEW CADETS FOR CLASS 2029

**BAGUIO CITY (PIA)** — The Philippine Military Academy formally welcomed and received 340 incoming cadets to compose the PMA Class of 2029 during the reception rites at Fort Del Pilar, Baguio City.

PMA Superintendent Vice Admiral Caesar Bernard Valencia, in welcoming the 274 male and 66 female incoming cadets from across the nation, emphasized that they are no longer ordinary citizens as they stepped into the hallowed grounds of Fort Del Pilar to begin a new chapter in their lives.

"From here on, you are no longer ordinary citizens. The next step you make, you do so as PMA cadets. On your shoulders, lie the trust and expectations of your families, communities. and most importantly, the Filipino people at large. You now belong to an institution built on honor, courage, unshakable and an commitment to the Filipino people," Valencia said in his message.

The new entrants had undergone a competitive selection process, from a total of 37,295 applicants, 21,796 qualified to take the competitive entrance examination where only 1,701 passed. After a series of competitive complete physical and medical screening processes, only 340 have been admitted. They will have the rank of fourth class cadets in the Cadet Corps Armed Forces of the Philippines (CCAFP) and will undergo three months of Basic Cadet and Military Training before they start their academic education.

Over three months, the plebe cadets go through a rigid process of adapting to the system and the life of a cadet and military, including changing their posture from slouching to having a good "bearing" or having a straight back to look more dignified. They will then be incorporated as members

of the CCAFP in rites called "incorporation".

The new batch will be the pioneering class that will undergo the recentlyapproved enhanced Bachelor of Science Management major in Studies in Security curriculum which focuses on integration of territorial defense and modern warfare domains in its core subjects. #### DEPED TO WELCOME 47,000 Learners for School Year 2025-2026 in Quirino

CABARROGUIS, Quirino - The Department (PIA) òf Éducation – Schools Division Office (DepEd-SDO) Quirino has announced its readiness to open the 2025–2026 welcoming school year, 47,000 approximately across learners 204 starting June schools 16, 2025, in line with the national return to the traditional June school opening.

According to Information Officer Arnold Saballa, enrollees the expected include around 3,300 in kindergarten, 23,000 in elementary, 14,000 in junior high school, and 7,000 in senior high school. He also noted that the SDO Quirino library has a collection of learning resources comparable to those found in countries like South Korea.

Saballa also announced that this year's Brigada Eskwela will run from June 9 to 13, with the theme "Brigada Eskwela: Sama-sama sa Bayang Bumabasa" (Together for a Nation that Reads).

This year's activities will emphasize literacy and reading comprehension alongside the usual classroom cleaning, repairs, and beautification efforts.

NOCPPO public information officer Police Captain Judesses Catalogo said thev are augmenting their patrols not only in areas of convergence, such as public markets and plazas, but also on highways, as police presence thwarts criminality, at the same time, prompts motorists to be extra cautious on the road.

"We performing are sang gusto sang aton nga Presidente. Sa aton sa NOCPPO, ginapalapad naton ang deployment plan sang aton personnel. Kag, kung makita niyo, nagablink ang [emergency] patrol lights sang [vehicles] sa checkpoints para mabatyagan gid ang presensya sang kapulisan," he noted.

(We are performing the directive of our President. At NOCPPO, we are expanding the deployment plan for police personnel. And, as you may have seen, the [emergency] lights of police vehicles at checkpoints are on, so the people can feel our presence.)

Apart from these, Catalogo added that the police are employing "crime clocks" to study the frequency of crimes at a specific time, allowing them to effectively and efficiently optimize police presence in various locations and enabling them to immediately respond to police calls.

"Understandably, kung ara ang pulis naton sa palibot, wala sang krimen nga nagakatabo," the Catalogo stressed.

(Understandably, there is no criminality where our police personnel are present.)

Meanwhile, for the part of the BCPO, Deputy City Director for Operations Lieutenant Colonel Lester Leada said that City Director Col. Joeresty Coronica has instructed the police chiefs to enhance police presence in Bacolod City.

To ensure that police personnel use location sharing under the Integrated Police Deployment Plan (IPDP) to monitor the location of mobile patrols in real time and enable their swift deployment as soon as required.

"[Naga-serbe ini] nga sort of monitoring or audit [mechanism] nga indeed ang police naton ara sa ila respective areas [of assignment]," Leada said. (This serves as a monitoring or auditing mechanism for us in ensuring that our police officers are indeed in their respective areas of assignment.)

Despite traffic congestion on city streets, Catalogo added that they are striving to implement the "three-minute response time" to guarantee public safety and order in the community. (AGP/BPS/ PIA Negros Occidental) BY BERNARD CEASAR SUSBILLA

# INDUSTRY, INFRA KEY DRIVERS TO CALABARZON ECONOMY — DEPDEV

**CALAMBA CITY (PIA)** – Ongoing infrastructure programs and a growing industrial sector continue to drive economic growth in the CALABARZON region as it remains in its position as a top contributor to the national economy.

Ray Michael Abuso, Supervising Economic Development Specialist at the Department of Economy, Planning, and Development (DepDev) — formerly the National Economic and Development Authority (NEDA) — noted that ongoing infrastructure developments in the provinces of Laguna, Cavite, and Batangas significantly have bolstered the Regional Gross Domestic Product, valued at Php 3.10 trillion.

"All provinces in the region showed positive economic growth, reflecting growth-based economic momentum." Cavite Province recorded the highest growth rate in the region with 6.7 Meanwhile, percent. the City of Lucenathe region's only highly urbanized city-posted an even higher growth rate at 8.9 percent.

DepDev reported that the industry sector valued at Php 1.53 trillion—contributes the largest share in the Gross Regional Domestic Product, followed by the services sector at Php 1.42 trillion and the agriculture, forestry, and fishing sector at Php 138 billion.

"Economic performance in the provinces is slightly influenced manufacturing, by infrastructure development, and sector diversification With their industry-based economy, Laguna and Cavite, offer opportunities for residential

and commercial development."

Meanwhile, Batangas Province which hosts several power plants supplying the region also shows increasing growth potential in the tourism sector.

"Overall, the CALABARZON region's economic growth is shaped by infrastructure and industry focused in the urban expansion."

To sustain economic growth, DepDev recommended longprovinceterm and specific solutions. These include expediting critical infrastructure projects, diversification of economic activities, comprehensive economic partnerships, and modernizing the agriculture sectorparticularly in the provinces of Laguna and Cavite.

Meanwhile, the provinces of Batangas and Quezon were encouraged to invest further in the agriculture sector by modernizing agricultural practices, developing value-added processing, upgrading farm-related infrastructure, and establishing agribusiness and agro-biotechnology centers.

On the other hand, Rizal Province—known for its burgeoning industry-may tourism further boost its growth by enhancing tourism infrastructure and integrating modern techniques and practices agricultural into its activities.

### GATCHALIAN URGES DOH ACTION ON DISEASE SPREAD IN PAOCC DETENTION

**MANILA–** Senator Sherwin Gatchalian on Friday called on the Department of Health (DOH) to swiftly contain the reported spread of contagious diseases among Philippine offshore gaming operator (POGO) workers held in a government detention facility.

"The spread of contagious diseases among POGO workers in PAOCC custody demands urgent action from the DOH, including immediate containment, quarantine protocols, and the provision of proper healthcare to prevent further transmission," Gatchalian said in a statement.

"Alternative facilities must be identified to ensure humane detention and effective disease control," he added.

Authorities recently reported a surge of infections inside а holding facility managed Presidential by the Anti-Organized Crime (PAOCC), Commission where hundreds of foreign nationals allegedly involved in illegal POGO

operations are being detained.

Gatchalian said the government must treat the outbreak seriously but warned against using it as a reason to delay law enforcement efforts.

"This health issue, however, must not be used as an excuse to suspend anti-POGO operations. Once cleared by the DOH, these POGO workers must be immediately deported," he said.

Gatchalian underscored the urgency of sustaining the crackdown against illegal POGOs, many of which have been linked to crimes such as human trafficking, cyber fraud, and illegal detention.

" K i n a k a i l a n g a n g ipagpatuloy ang kampanya laban sa mga POGO nang walang humpay upang tuluyang mapuksa ang kanilang ilegal na gawain (We must continue the campaign against POGOs without letup in order to completely dismantle their illegal activities)," the senator said. ### LTFRB SUMMONS BUS FIRM OVER VIRAL ASSAULT ON PWD

MANILA – Public utility bus (PUB) operator Precious Grace Transport will be summoned to explain the assault of a person with disability (PWD) by a bus conductor and some passengers, the Land Transportation Franchising and Regulatory Board (LTFRB) said Friday. In a statement, LTFRB

chairperson Teofilo Guadiz III said the incident was caught on video and went viral on social media after it occurred inside one of the buses of PGT that ply the Epifanio Delos Santos Avenue (EDSA) Busway. According to an investigation initial by the Department of Transportation's (DOTr) Surveillance and Action Information Coordinating Team (SAICT), the bus was registered with license plate no. NDQ 2615, driven by Mark Ivan Ramos, with conductor Francis Sauro. Guadiz said the SCO would be issued in line with President Ferdinand R. Marcos Jr.'s directive protect vulnerable to commuters and ensure accountability among public utility vehicle (PUV) operators.

He said PGT would have to explain why their CPC

should not be suspended or revoked after the incident.

"We will not tolerate any act of violence, discrimination, or abuse, especially against persons with disability. Public utility operators are duty-bound to ensure the safety and dignity of all passengers," he said.

In addition, the LTFRB ordered a 30-day suspension against 10 bus units of the company operating in the EDSA Bus Carousel.

"The DOTr, through the LTFRB and with the assistance of the Philippine Coast Guard (PCG) and SAICT and Coast Guard-Investigation and Detection Management Service (CG-IDMS), is now coordinating with the bus company's management to secure full cooperation from the identified personnel," he said.

An investigation is underway to gather testimonies and verify the authenticity of the video footage.

"The LTFRB assures the public that swift and appropriate sanctions will be imposed," he said.

PUV He reminded operators and commuters that any acts that violate the rights of passengers, especially against the most vulnerable, will face "serious consequences, the administration as continues to champion dignified, safe, and inclusive public transport for all." ### OVER 3K HIRED ON THE SPOT IN INDEPENDENCE DAY JOB FAIRS – DOLE

MANILA - Over 3,000 have secured employment on the spot during the simultaneous nationwide job fairs conducted by the Department of Labor and Employment (DOLE) on Thursday in celebration of the 127th Proclamation of Philippine Independence. Based on the preliminary report released bv the Bureau of Local Employment on Friday, a total of 3,364 applicants were hired on the spot (HOTS) for the positions of cashier, service crew, production operator. ËSL teacher, bagger, associate, sales clerk. production crew, loan officer, and store clerk.

It also said 25,876 job seekers registered in the 50 job fair sites nationwide jointly organized by the DOLE Regional Offices and the Public Employment Service Offices.

On the other hand, 4,676 job seekers were classified as near-hires pending final evaluations or document submission, while 21,419 were deemed fully qualified for the available positions.

Vulnerable groups also benefited, with 274 senior high school graduates, one person with a disability, and 10 beneficiaries of the Tulong Panghanapbuhay sa Ating Disadvantaged Workers (TUPAD) Program hired on the spot. The DOLE also said 55 private company interns and 37 Government Internship Program (GIP) beneficiaries were hired. A total of 1,573 employers participated in the event, offering 153,187 local and overseas job vacancies.

The nationwide event also featured a onestop shop of government services to assist in issuing pre-employment documents. Participating agencies also provided Auxiliary Jobseeker Services, including career development support, labor consultation, and programs on livelihood, skills training, and entrepreneurship.

As a result, 1,150 job seekers received career development support to improve job readiness and career prospects; 940 expressed interest in skills enhancement training; 323 availed of livelihood assistance; 79 explored entrepreneurship opportunities; and 9,142 accessed government services from agencies such as Pag-IBIG, Social Security System, and PhilHealth.

DOLE said it expects the numbers to increase as it will monitor and verify job fair data from its regional offices.

Meanwhile, the department is organizing a related job fair on June 19 at Ayala Malls Circuit Makati.

This initiative reflects President Ferdinand R. Marcos, Jr.'s commitment to uplifting the lives of Filipinos by generating employment opportunities and enhancing accessibility through regular job fairs. (PNA) **BY FERDINAND PATINIO** 

### CHR, DMW INK DEAL FORENHANCED PROTECTION OF PINOY MIGRANT WORKERS

MANILA – The Commission on Human Rights (CHR) and the Department of Migrant Workers (DMW) have signed a memorandum of agreement (MOA) to institutionalize a more robust and rights-based framework for the protection and empowerment of Filipino migrant workers and their families.

In a news release on Friday, CHR Chairperson Richard Palpal-latoc underscored the invaluable contributions of Filipino migrant workers to the economic growth and that they deserve tangible and sustainable programs that ensure their protection and meaningful participation in nation-building.

"Allow me to reaffirm that the Commission on Human Rights is steadfast in its commitment to ensure that Filipino migrant workers are not forgotten and left behind -- but recognized, celebrated, and protected. Their rights are not mere declarations and principles on paper. Instead, these are acknowledged, exercised, and upheld at all times," he said.

The MOA, signed on June 7, aims to strengthen human rights protection through increased awareness efforts, the provision of free legal and psychosocial services via legal clinic caravans, and the delivery of timely assistance in cases involving abuse, exploitation, or trafficking. Italsoincludes mechanisms for joint quick response operations in the event of human rights violations, collaborative research. and policy development to inform new programs, and inclusive consultations to ensure that Filipino migrant workers' voices are meaningfully represented in policymaking.

DMW Secretary Hans Leo Cacdac noted that a rightsbased approach is vital in ensuring the welfare of migrant workers.

"Pagsulong ng karapatan ng OFWs, iyan ay likas sa bawat tao -- ang karapatang pantao. Kaya't kailangang galangin at respetuhin, at kung nilabag, kailangan maghanap ng solusyon o remedyo (Promotion of rights of OFWs, that is innate in every person -the human rights. # **PNP EYES STREAMLINING GUN PERMIT RENEWALS**

**MANILA –** The Philippine National Police (PNP) is pushing to streamline and make more accessible the process of renewing permits to carry firearms. In an interview on Friday, PNP chief Gen. Nicolas Torre III said he wants to fully computerize the process of renewing the license to own and possess firearm and firearm registration for gun owners.

To date, applicants still have to personally go to Camp Crame to avail of this service.

"I will be talking to the CSG (Civil Security Group) to make the renewal and even the procurement, then the permit to carry firearms outside of residence for our kababayans to be more accessible because while it is not explicitly stated that it is a right to own firearms, it is certainly a privilege. Those interested to own and possess firearms and even carry it outside of their residence, once they pass the stringent requirements of the law, well, I see no reason for them to be denied of that privilege," Torre said on the sidelines of the 3rd PNP Press Corps Invitational Shootfest in

Camp Karingal, Quezon City on Friday.

The CSG is the PNP office in charge of administrative and operational control in regulating firearms, explosives, and private security industries.

"Nationwide naman at lahat ng mga regions naman meron, tapos sa mga big cities, big provinces meron din mga front offices ang ating FEO (All our regions nationwide, in big cities, and big provinces, we have front offices of the Firearms and Explosives Office)," he added. ### BSP CHIEF ELATED OVER PH'S REMOVAL FROM EC'S HIGH-RISK COUNTRIES

MANILA – Bangko Sentral ng Pilipinas (BSP) Governor Eli Remolona Jr. on Wednesday considered as welcome news the European Commission's (EC) decision to remove the Philippines from its list of high-risk countries in terms of financial crime.

"That's certainly good news. But the EU (European Union) Parliament will still need to confirm the EC decision," he said.

This, after the Belgiumbased EC, in a press release issued June 10, said eight countries, including the Philippines, were delisted but several countries were added.

The move, it said, was made "to protect the EU financial system."

It said the latest decision "takes into account the work of the Financial Action Task Force (FATF) and in particular its list of 'Jurisdictions under Increased Monitoring'".

"As a founding member of FATF, the Commission is closely involved in monitoring the progress of the listed jurisdictions, helping them to fully implement their respective action plans agreed with FATF. Alignment with FATF is important for upholding the EU's commitment to promoting and implementing global standards," it added.

Last Feb. 21, FATF, in а statement, released an updated list of highrisk and other monitored jurisdictions and announced the Philippines' removal from the list because of "significant progress in improving its AML/CFT (anti-money laundering/countering the terrorism) financing of regime."

It said the Philippine government showed risk-based effective supervision of Designated Non-Financial Businesses Professions, and demonstrated supervisors AML/CFT were using controls to address risks casino junkets, with implemented new registration requirements for money or value transfer services, and applied sanctions to unregistered and illegal remittance operations, among others. #### **DOE: POWER COOP TO IMPROVE SITUATION IN SIQUIJOR WITHIN THE WE** MANILA – Siquijor Island assess the situation.

Power Cooperative (SIPCOR), the power supplier in the province, committed to improve the power situation within week. Department the (DOE) of Energy Undersecretary and incoming officer in charge Sharon Garin said Friday. "There was a commitment from SIPCOR themselves that they will fix the gensets (generator sets),' Garin said in a briefing at the DOE office in Taguig City.

Siquijor was earlier placed under a state of calamity due to long hours of power outages.

"At that time, there was five only running out of the nine gensets. For so many reasons. And that is still under evaluation. Pero what we needed was that the SIPCOR will commit na ayusin nila within the week (But what we needed was SIPCOR committed that they fix this within the week)," Garin said.

Garin said two generator sets already arrived in Siquijor.

"We are expecting SIPCOR to have their two gensets arrive. I think one arrived yesterday and another one arrived today. Let's see if they can connect that already to the system by this weekend," she said.

Garin assured that government agencies are working together to address the power crisis in the province.

"NEA (National E I e c t r i f i c a t i o n Administration) is also working on it. All the agencies, all hands are on deck para ma-regularize naman 'yung sitwasyon sa Siquijor (All the agencies, all hands are on deck to regularize the situation in Siquijor)," Garin said.

President Ferdinand R. Marcos Jr. earlier visited Siquijor to personally

Garin, meanwhile, said that after almost two decades, the passage of the PhilATOM bill marks a historic turning point for the Philippines. "We will now have the

necessary legal and institutional foundations to guide the development of nuclear energy infrastructure with oversight for the highest standards of safety and security," Garin said.

"This is a critical step forward in strengthening our long-term energy security while ensuring that every action we take is anchored on responsibility, transparency, and public trust."

The Philippine National Nuclear Energy Safety Act was approved on third and final reading by the Senate on June 9, 2025. The House of Representatives earlier approved its counterpart measure in November 2023.

Garin said having a clear and legal nuclear framework will help encourage global investors to tap the country's nuclear potential.

### BIR EXTENDS OPERATIONS FOR ESTATE TAX AMNESTY PAYMENTS

**MANILA** – The Bureau of Internal Revenue (BIR) said its district offices would extend their work hours until midnight to accommodate taxpayers who will avail of the estate tax amnesty.

"As long as taxpayers arrive in the district office on or before 5 p.m., the district office will entertain their application for estate tax amnesty whatever time they may finish, even if the district office has to extend beyond normal office hours," BIR Commissioner Romeo Lumagui said in a statement on Friday. The estate tax amnesty deadline under Republic Act No. 11213, as amended, encourages taxpayers to settle their estate liabilities computed at a flat rate of 6 percent and all penalties, surcharges, and interest are waived.

# PH HOPEFUL IN BILLIE JEAN KING CUP CAMPAIGN

**MANILA** – The Philippines has to hurdle Malaysia, Indonesia and Uzbekistan in a bid for promotional ranking in the Billie Jean King (BJK) Cup next week.

Shaira Hope Rivera and Alexa Joy Milliam the University from of Western Alabama, and Philippine Tennis Academy members Tennielle Madis and Stefi Marithe Aludo make up the national team that will see action in the BJK Cup Asia/Oceania Group 2 scheduled from June 16 to 21 at the National Tennis Centre in Kuala Lumpur, Malaysia.

"Uzbekistan, Malaysia, and Indonesia are going to be the strongest teams," said Dy the Philippine during Sportswriters Association (PSA) Forum on Tuesday at the Philippine Sports Commission (PSC) conference hall inside the Rizal Memorial Sports Complex on Tuesday.

Also in Group 2 are Northern Marian Islands, Iran, Pacific Oceania, Kyrgyzstan, Singapore, and Mongolia.

The team will leave on Saturday, while the tournament draw is on Sunday.

Rivera, who was part of the team that played in Group 3 last December in Bahrain, is a member of the NCAA All-American Team Division II, while Milliam was named Intercollegiate Tennis Association-ITA National Freshman of the Year.

"I'm very excited to play again (for the Philippines). We have a good chance to win because (we) already know the players from other countries," said the 25-year-old Rivera, an interdisciplinary management student.

The Filipinas are drawing inspiration from world's No. 77 Alexandra Eala, a graduate of the Rafael Nadal Academy in Mallorca, Spain.

The 20-year-old, playing as a wild card, beat former French Open champion Jelena Ostapenko in the second round, 7-6-7-5; No. 5 and reigning Australian Open champion Madison Keys in the third round, 6-4, 6-2, and No. 2 and five-time Grand Slam champion Iga Swiatek in the quarterfinals, 6-2, 7-5 to reach the semifinal of the WTA1000 Miami Open in Florida in the United States last March. Despite her 6-7 (3), 7-5, 3-6 loss to fourth seed American Jessica Pegula in the semifinal round, Eala became the first Filipina in the Open era to beat a player in the WTA Top 5. She is also the first Filipina to break into the Top 100, reaching a career-high No. 75 world ranking.

Dy, a mixed doubles gold medalist at the Southeast Asian Games (SEAG) in Indonesia (2011) and Singapore (2015), is excited about her new role as coach.

"It's always an honor to serve my country, and now in a different capacity. I have faith in the team and I'm looking forward to great matches knowing that my players will do their best," said Dy, who teamed up with fellow Fil-American Treat Huey at the 2019 SEAG. Dy, who also serves as head coach of Fresno State University, will be assisted by PTA head coach Bobie Angelo, a veteran of the Davis Cup, in the BJK Cup.

"Both Tennielle and Stefi are ready, they've been playing in the ITF Junior Circuit. I expect them to perform well in the BJK Cup," said Angelo, who also won medals in the SEAG.

The BJK Cup Asia/ Oceania Group 2 format includes two round-robin pools of five (Pools A, B). The top two in each pool advance to the promotional play-offs (A1 v B2, B1 v A2).

The two winners of those play-offs will be promoted to Asia/Oceania Group I next year, while the bottom nation in each group (A5, B5) will be relegated to Group 3.

Philippine Tennis (PHILTA) Association Board member Dyan Castillejo and executive director Tonette Mendoza also attended the weekly session presented by San Miguel Corporation, Philippine Sports Commission, Philippine Committee, Olympic MILO, Smart/PLDT, and the country's 24/7 app ArenaPlus.
