"We want our students to keep pace with global trends and equip our teachers with the skills to harness technology in the classroom," the mayor said. "Next year, we plan to install air conditioning units in every classroom to ensure that these devices operate efficiently and create a more

### LAGUNA BREAKS GROUND FOR CALAMBA-BAY **BYPASS ROAD**

BAY, Laguna (PIA)- Amorado said. much-awaited The Calamba-Bay bypass road project, which will provide an alternate route to motorists long saddled by traffic woes on the national road from Calamba City and the towns of Los Baños and Bay, finally broke ground on June 11.

Spanning 15 kilometers and a four-lane toll road from Calamba to Bay, the road project is designed to reduce travel time from Canlubang-Cadre road in Calamba to Masapang highway in Bay to only 20 minutes from more than an hour, the Laguna provincial government has reported.

The provincial government had initiated the project and partnered with private firm Ecotoll Road Development Corporation (ERDC) to ease the congested national road and economic accelerate growth in Laguna's eastern towns.

Mayor Romeo Amorado said the farming town of Majayjay will benefit from the project as farmers will now have better access to transport their products to Metro Manila.

"This project will allow our farmers to deliver our vegetables to markets faster and fresher. While there may be a toll fee, we can slightly adjust prices to cover the cost. You see, when products come from Majayjay as well as from Liliw and Nagcarlan, the cost of transport is cheaper because the distance is shorter, and we use less fuel. So even with the added toll fee, the bypass road will be a big help for us farmers, allowing us to sell our products more quickly,"

For Leonard Derecho. Majajay resident а and studying law at Pamantasan ng Lungsod ng Maynila, the project will be highly beneficial since he travels home every week.

"A lot of time that should have been spent studying or resting is wasted due to traffic from Los Baños to Calamba," Derecho added.

Additionally, the project is expected to improve access to health services for remote towns by making it easier to transport patients to hospitals in nearby cities and in Metro Manila.

The road project is designed to have an interchange entry and exit point in Los Baños while the entry and exit ramps will be located in two different areas minimize traffic to congestion the on existing barangay road.

Funded entirely through a public-private partnership with ERDC, the project benefited from technical assistance provided by the provincial government throughout its planning, construction, and implementation phases.

bypass road The proposal was submitted to the National Economic Development and Authority back in 2011 for review.

Once established, the ERDC will operate and maintain the bypass road project for 50 years while the provincial government will share the gross revenue at 0.5 percent for the first eight years of operation until the traffic projection reaches 700,000 vehicles per day. ## HALT IN OFW DEPLOYMENT TO AREAS NEAR IRAN, ISRAEL URGED

MANILA – Senator-elect Erwin Tulfo on Friday urged concerned government agencies to temporarily suspend the deployment of overseas Filipino workers (OFWs) to areas near Israel and Iran amid their armed conflict.

At a news forum, Tulfo called on the Department of Migrant Workers, the Department of Foreign Affairs, and the Bureau of Immigration to hold for the meantime the sending of OFWs to the "surrounding areas of Iran and Israel."

"Not all of the Middle East, but the surrounding areas of Iran and Israel like Saudi Arabia, Qatar and Bahrain, and there are also Jordan and Egypt," he said during the monthly Balitaan sa Harbor View organized by the Manila City Hall Reporters' Association.

"Now, if we keep sending (OFWs) and the war might

escalate, we will have a hard time because we have millions of OFWs in the Middle East. Maybe we can hold them for now because our countrymen are in danger."

The incoming senator said the deployment could resume once there is a ceasefire or the war has concluded.

Anadolu News Agency reported that tensions between the two nations have escalated since June 13, when Israel launched coordinated airstrikes on multiple sites across Iran, including military and nuclear facilities, prompting Tehran to launch retaliatory strikes.

Israeli authorities said at least 24 people have been killed and hundreds injured in Iranian missile attacks since then. (PNA) BY FERDINAND PATINÍO

### 2 FILIPINO SEAFARERS HELD Hostage in haiti back in ph

MANILA – Two Filipino seafarers who were held hostage by suspected pirates in Port-au-Prince Anchorage in Haiti in early April this year are now back in the Philippines following their safe release.

Department The of Migrant Workers (DMW), in a news release Friday, said the two were among the crew members of the MV Century Royal, which was raided in early April. "The President was very glad to hear of your safe release. His words were, 'Very good.' Nandito ang government (the government is here), rest assured you will be supported and will be provided assistance for your recovery and reintegration," Migrant Workers Secretary Hans Cacdac told the Leo seafarers during their visit to the DMW central office in Mandaluyong City on

Thursday.

In May, 14 Filipino crew members from the Panama-flagged bulk carrier had already been repatriated. The DMW said the

repatriated seafarers arrived separately last May 23 and June 17. The two Filipino seafarers each received PHP75,000 in immediate financial assistance from the AKSYON Fund of the DMW.

Additional support from the Overseas Workers Administration Welfare (OWWA) is also underway as additional support, especially for their children.

The DMW is also closely coordinating with the seafarers' manning agency to ensure their full recovery and provide necessary support to them. (PNA) BY MARITA MOAJE

### **MIAA VOWS FULL PROBE** OF ALLEGED NAIA EXTORTION SCHEME

MANILA – Regulator Manila International Airport Authority (MIAA) on Friday vowed a full investigation into the alleged extortion scheme imposed on taxi drivers at the Ninoy Aquino International Airport (NAIA).

MIAA's statement came after at least five airport police were relieved from their posts for allegedly getting 40 percent of taxi drivers' earnings.

The Department of Transportation said the extortion scheme forces the drivers to charge exorbitant fees as they would be apprehended or not allowed at NAIA premises if they don't give in to the demands.

The MIAA said it is working with the Land Transportation Office (LTO) to verify reports of questionable ticket violations allegedly issued to taxi drivers.

"The MIAA underscores its commitment to ensuring that the investigation is conducted with full transparency, due process and fairness," it said in a statement.

An investigating committee under the Intelligence and Division Investigation was formed to gather conduct evidence. interviews and submit formal recommendations that to ensure those responsible are held accountable.

Philippine News Agency on Friday, MIAA General Manager Eric Ines said he doesn't recall any taxi driver that was sent to jail under his administration.

Another CFO program that Ang highlighted under LINKAPIL is the "Balikturo" program, which he said brings Filipino teachers based in the US back to the Philippines to teach during visits, as well as plans to expand partnerships with the Department of Science and Technology under the Balik Scientist Program.

**MANILA** – The Supreme Court has ruled that to prove salary payment through banks, employers must show the payroll was submitted to and received by the bank.

This ruling was contained in a 36-page decision of the SC First Division on April 5 when sent back to the National Labor Relations Commission (NLRC) for a case involving the 1998 strike by 49 Philippine Airlines (PAL) pilots, according to a news release Friday.

The ruling, penned by Chief Justice Alexander Gesmundo, affirmed the Court of Appeals ruling that PAL did not sufficiently prove payment of salaries and 13th month pay to its former employees.

"The Payroll Listing and 13th Month Pay Payroll Register presented by PAL were not enough, as they did not provide proof of actual receipt of payment by the employees," the SC said.

In their complaint file before the NLRC, the PAL pilots alleged illegal dismissal, unfair labor practice and non-payment of various monetary benefits, such as salaries, allowances and bonuses.

The labor arbiter dismissed the claims of illegal dismissal and unfair labor practice.

As for the monetary claims, PAL presented

payroll documents to prove payment, which were accepted by both the arbiter and the NLRC. CA However, the reversed it, stating that the documents were not sufficient proof of payment. In affirming the CA, the SC emphasized that payroll records and vouchers can only be considered strong proof of payment if they clearly show that the employees actually received the money and when the payment was made.

For bank-based salary payments, the SC noted there were three stages: preparing the payroll, submitting it to the bank and crediting the salaries to the employees' bank accounts.

"Thus, to prove payment, employers must show evidence of the second stage: That they transmitted a copy of the payroll or advisory to the bank and that the bank received it," the SC said.

The tribunal noted that in the PAL case, the documents indicated payroll preparation but did not show submission to or receipt by the bank, failing to demonstrate actual payment.

The SC returned the case to the NLRC to determine the exact amount owed to the former employees. (PNA) **BY BENJAMIN PULTA**  Officer Claire Castro told reporters.

#### IMPROVED NFA WAREHOUSES TO HELP LOCAL FARMERS, HIKE PALAY BUYING –DA

MANILA – The Department of Agriculture (DA) on Friday underscored the Friday underscored importance of refurbished National Food Authority warehouses (NFA) helping local farmers and increasing the volume of local palay (unhusked rice) procurement in the country At least seven NFA warehouses in Northern Luzon have been rehabilitated in line with President Ferdinand R. Marcos Jr.'s directives to intensify support for local farmers and help reduce the country's postharvest losses agri-infrastructure through and modernization.

"I'm very happy na nakakita ako ng bagong refurbished na warehouse ng NFA. Kung nakita niyo ho yung panahon na before refurbishment, talagang napabayaan po ng panahon (I'm very happy that I saw newly-refurbished NFA warehouse. If you have seen it before the refurbishment, it has been neglected through time)," Agriculture Secretary Francisco Tiu Laurel Jr. told journalists at the sidelines of the inspection of an NFA warehouse in Roxas, Isabela.

The refurbished warehouses include those in Burgos, Roxas, and Tumauini, all in the province of Isabela. These warehouses can store up to 148,000 50-kilogram bags of rice in total. Other refurbished

warehouses include those in Bagabag and Bayombong in Nueva Vizcaya, which has a capacity of 160,620 50-kg bags; and in Alfonso Lista

and Lagawe in Ifugao, with 28,880 50-kg bags capacity. The warehouses' upgraded features include new roofs, improved ventilation systems and pest control systems, reinforced walls, and strengthened flooring. chief agriculture The said opening of more rehabilitated NFA warehouses around the country will follow to help farmers protect from unscrupulous traders who take advantage of them by buying rice at low prices.

"I'm very happy na nagopen tayo nito. There are 134 na bubuksan na kaya't makikinabang dito iyong farmers. At makakabili tayo ng mas maraming palay sa kanila ngayon (I'm very happy that we have opened these refurbished warehouses. There are 134 more that will be opened and farmers will benefit from it. And we can buy more palay from them)," he said.

In a separate statement, the DA disclosed that farmgate price of palay fell to as low as PHP10 per kilogram in some areas in the country, lower than the estimated production cost of PHP12-PHP14 per kilo.

The NFA's average buying price, however, is set at PHP18/kg of fresh and wet palay, and PHP24/kg for clean and dry palay.

NFA Administrator Larry Lacson also said opening of rehabilitated NFA warehouses will allow them to "accommodate more palay from farmers who have waited in line for NFA to buy their harvest." (PNA) BY STEPHANIE SEVILLANO

#### PNP SPOX FAJARDO NAMED NEW COMPTROLLER

MANILA – Philippine National Police (PNP) Gen. Nicolas Torre III has designated Police Regional Office (PRO) 3 (Central Luzon) chief and police spokesperson Brig. Gen. Jean Fajardo as the new chief of the Directorate for Comptrollership effective Friday.

Fajardo, as Director for Comptrollership, will assist the Office of the Chief PNP in the administration and management of the police force's financial resources. She will replace Maj Gen. Neil Alisañgan, who will now head the Area Police Command-Eastern Mindanao.

It was not immediately clear if Fajardo will remain as PNP spokesperson.

Meanwhile, Brig. Gen. Rogelio Peñones was named PRO 3 officer-incharge while Brig. Gen. Gerry Villas Protacio, Brig. Gen. Josefino Ligan and Brig. Gen. Dindo Reyes were named officers in charge of PROs 2 (Cagayan Valley), 6 (Western Visayas) and 1 (Ilocos), respectively.

They are among dozens of senior police officials who received new assignments under the latest leadership reshuffle.

Torre III earlier said the reshuffle aims to strategically position officials.

#### ABANDONED PARCELS YIELD P16-M DRUGS AT NAIA

**MANILA** – Over PHP16 million worth of illegal drugs were discovered in three abandoned parcels at the Central Mail Exchange Center (CMEC) in Pasay City, the Bureau of Customs – Ninoy Aquino International Airport (BOC-NAIA) said Friday.

The drugs — 3,025 grams of ketamine approximately worth PHP15,125,000 and 858 grams of "kush" or high-grade marijuana worth PHP1,201,200 were discovered during the physical examination of the parcels. The physical examination was conducted after x-ray scans showed suspicious images, the BOC-NAIA said.

One parcel arrived from the United States containing 240 grams of "kush" while another came from Thailand with 618 grams of "kush."

Meanwhile, a third parcel shipped from Poland contained five plastic bags of ketamine inside a coffee maker.

The BOC-NAIA said no

one claimed the parcels, which were turned over to the Philippine Drug Enforcement Agency (PDEA) on Thursday for disposition and laboratory examination.

"This operation is part of the agency's intensified border protection efforts and supports the national government's campaign against illegal drugs, in line with the directive of President Ferdinand R. Marcos Jr.," the BOC-NAIA said. (PNA) **BY FERDINAND PATINIO** 



#### IMPROVED GARBAGE MANAGEMENT IN ABRA'S CAPITAL TOWN EYED

BANGUED, Abra (PIA) – Abra Congressmanelect Cong. JB Bernos and Bangued Mayorelect Perfecto Cardenas disclosed plans to improve the garbage collection and management in the capital town.

In a Facebook live, Bernos committed the La Paz temporary landfill to cater to the garbage collected in the municipality of Bangued.

"Dadiay pagbasura yo i-cater mi pay lang idiay La Paz. Dadiay temporary landfill idiay La Paz, isu pay laeng ti usaren ti Bangued," he said.

Bernos also shared that the municipality of La Paz can also lend one garbage compressor truck to help in garbage collection in Bangued where most businesses, offices, schools, and restaurants are located.

Meanwhile, Cardenas assured that a garbage collection system will be in place with ongoing repairs of the two local government unit-owned garbage trucks. "Panggep ti pannakakoleta ti basura, aramiden tayo met ti garbage collection system wenno schedule and iadado tayo ti truck nga aghakot ti basura ti aglawlaw, kayat tayo nga maaramid daytoy the soonest possible time," he assured.

The newly elected officials seek the cooperation and discipline of the public to improve waste management in the municipality.

"Idawdawat tayo kadakayo nga kakailian nga saan tayo nga tila komporme ti pangibasuraan tayo, ipadamag minto to husto nga schedule ken wagas ti pannakakolekta ti basura," Cardenas urged.

For a long time, Bangued was not able to implement a garbage collection and management system resulting in improper waste disposal such as burning of waste and throwing of garbage everywhere.

#### DENR UNCOVERS 160 -HECTARE SEAGRASS BED

**ROXAS CITY, Capiz** (**PIA**)—The Department of Environment and Natural Resources (DENR), during an underwater dive into the Tucad Reef in Pilar town as part of the preparatory activities for the Protected Area Suitability Assessment (PASA) has discovered a 160-hectare seagrass bed.

The seagrass, locally known as "lusay," plays a vital ecological role as a sediment stabilizer and primary producer, while serving as feeding and nursery grounds for various marine species.

"In our initial dive, we stumbled upon about 160 hectares of seagrass," said DENR Capiz OIC Provincial Environment and Natural Resources Officer Ernest Federiso during a Kapihan program of the Capiz Government Information Center of the Philippine Information Agency.

Federiso added that a proposal will be made for funding to protect one of the widest seagrasses in the country. The data gathered from the dive will be crucial in completing the PASA and supporting the recommendation to include Tucad Reef under the National Integrated Protected Areas System (NIPAS).

Federiso noted that the Environment Month in Celebration the province kicked off in Pilar town through the local government unit's PlanTree For The Planets, tree planting and coastal clean-up, eco-thrill biking and competition, а jamming session with the environment.

"For now, DENR is always engaged with Pilar because it is also a pilot site for the Foreshore Survey and Delineation that is underway to identify and map the area where the tide alternately covers and uncovers the shore," said Federiso.

The process helps in managing and understanding coastal resources, particularly for purposes like land use planning, resource protection, and conflict resolution.

#### PCG MAINTAINS PROFESSIONALISM AMID CHINA'S HARASSMENT IN WPS

**TUGUEGARAO** CITY, Cagayan (PIA)-Despite repeated harassment by the China Coast Guard (CCG), the Philippine Coast Guard (PCG) has remained committed professionalism, to restraint, and adherence to international law in protecting the country's sovereign rights in the West Philippine Sea (WPS).

According to Commodore Jay Tristan Tarriela, PCG spokesperson for the WPS, three PCG vessels were recently deployed to install 20 floating fish aggregating devices, or payaw, in the West Philippine Sea as part of the government's ongoing efforts to support Filipino fisherfolk and assert maritime rights.

During the mission, the PCG again experienced harassment by the CCG, which deployed three of its vessels. The Chinese ships conducted dangerous maneuvers and issued aggressive radio challenges in an attempt to disrupt the PCG operation. However, the Philippine Coast Guard completed its mission, with all 20 payaw units deployed as planned.

"Despite the harassment, we do not respond with unlawful or emotional actions. What we do is report the incidents to the National Task Force for the West Philippine Sea and document them through photos and videos. It is then up to the Department of Foreign Affairs and the Department of Justice, which are part of the task force, to recommend or carry out appropriate actions in response to the illegal behavior of the government," Chinese Tarriela said. He added that all PCG

He added that all PCG personnel undergo thorough briefings

and training before deployment, especially in Palawan. They are instructed to uphold professionalism and not respond emotionally, in line with the directive of President Ferdinand Marcos Jr. to engage with China peacefully and diplomatically while firmly protecting Philippine interests.

"We ensure that our actions are always aligned with international law," he said.

Tarriela also addressed public sentiment, acknowledging the anger and frustration many Filipinos feel when witnessing these acts of intimidation on television or social media.

"If ordinary Filipinos feel anger over what they see, they must also understand that our Coast Guard personnel onboard feel twice as much. But because of their professionalism and respect for the president's guidelines, and knowing this is what's best for the country, we choose to maintain composure and not retaliate. We stand firm in our duty without compromising our values," he said.

Tarriela further clarified that the West Philippine Sea's resources and rights are not dictated by any foreign power.

"The wealth of the West Philippine Sea is not dictated by anyone. We are not being dictated by foreign countries. Ferdinand President Marcos Jr. has already made it clear that we think and act independently as a sovereign nation. The West Philippine Sea issue is not just a government concern-it is the concern of every Filipino." he said. (OTB/MFJ/PIA Region 2) BY MARY JOY F. JAVIER

#### NIA UPGRADES IRRIGATION CAPABILITIES WITH NEW FLEET IN ORIENTAL MINDORO

**CALAPAN CITY, Oriental Mindoro (PIA)** — The National Irrigation Administration (NIA) in MIMAROPA works to strengthen its operations with the recent deployment of a new fleet of vehicles and heavy equipment in Oriental Mindoro.

NIA MIMAROPA noted that the delivery was in time with the simultaneous ceremonial turnover of equipment led by President Ferdinand R. Marcos Jr. held in Taguig City on June 2, marking the latest phase of the agency's ongoing Re-fleeting Program, said in an agency's press release.

The third tranche of the initiative delivered a range of operational and maintenance vehicles to the MIMAROPA regional office, which arrived at the agency's facilities in Bayanan II, Calapan City.

The newly acquired equipment includes a minibus, a survey vehicle, a motor grader, three loaders with backhoe, seven dump trucks and two self-loading trucks.

# ARTA: PH'S COMPETITIVENESS RANKING INDICATION OF REGULATORY REFORMS BSP: MAY 2025 GIR REMAINS HEALTHY MANILA – The Bangko trade deficit for January to

MANILA The Philippines' improved ranking in the 2025 World Competitiveness Yearbook is an indication of the country's ongoing commitment to regulatory reform and enhancing public sector performance, the Anti-Red Tape Authority (ARTA) said.

The Philippines recently ranked 51st out of 69 economies in the 2025 Competitiveness World (WCY) Yearbook bv the Switzerland-based International Institute for Management Development (IMD).

This was an improvement from the previous 52nd ranking.

"This positive trajectory reflects our unwavering commitment to reform, resilience, and progress," ARTA said in a statement on Friday.

The Government Efficiency pillar -one of the four core components of the WCY framework- continues to be a fundamental strength for the Philippines.

ARTA said that while the country's ranking experienced a slight adjustment from 49th to 51st, the performance remains stable amid intensifying global competition.

"Encouragingly, significant strides have been made government's in the management of taxes and public funds. These improvements underscore efforts to sustain economic stability, ensure prudent fiscal management, and guarantee that public services effectively reach those who need them most," ARTA said.

"At the same time, we recognize the structural challenges that remain." The 2025 WCY highlighted concerns, particularly in start-up procedures (67th), bureaucracy (60th), and rule of law (62nd).

ARTA said these rankings reinforce the urgency of strengthening regulatory transparency, minimizing administrative burdens. and enhancing institutional accountability.

According to ARTA, policy interventions are already underway.

Executive Order No. 59. which streamlines permitting processes for flagship infrastructure projects, and Executive Order No. 18, which establishes Green Lanes for strategic investments, are crucial steps in creating a more investorfriendly business climate.

ARTA, in collaboration government with institutions, the private sector, and international partners development such as the World Bank Group, also developed the Philippine Ease of Doing Business (EODB) Reform Guidebook, a policy document that provides a comprehensive roadmap for optimizing the business regulatory landscape.

The Guidebook identifies and prioritizes critical affecting reforms the business climate: provides а detailed implementation roadmap. responsible including agencies, timelines, deliverables; and key and serves as a unified reference document for policymakers, regulators, and development partners drive sustained to improvements the in business country's environment.

"We call on all branches and levels of government and the private sector to reaffirm their commitment reform. Through to whole-of-government collaboration, strategic policy coherence, and unwavering political will, we can elevate the Philippines' global standing -not just in rankings, but in the real, tangible progress felt by our entrepreneurs, citizens, and investors in the Bagong Pilipinas," ARTA said. MANILA - The Bangko Sentral ng Pilipinas (BSP) said the country's balance of payments (BOP) position recorded a deficit in May but the gross international reserves (GIR) remain healthy.

In a statement late Thursday, the BSP said the country's BOP posted a deficit of USD298 million, reflecting the national government's drawdowns on its foreign currency deposits with the BSP to service external debt obligations.

The BOP summarizes a country's economic transactions with the rest of the world for a specific period.

The overall position can be in surplus, deficit, or balance.

As a result, the year-todate BOP shifted from a USD1.6 billion surplus in January to May 2024 to a USD5.8 billion deficit in January to May 2025.

"Preliminary data indicate that the year-to-date BOP deficit was largely due to the continued trade in goods deficit," the BSP said.

Based on preliminary data from the Philippine Statistics Authority, the trade deficit for January to April settled at USD15.91 billion.

The BSP, however, said the decline was partly muted by the sustained net inflows from personal remittances from overseas Filipinos, foreign borrowings by the national government, and foreign portfolio investments.

position The BOP mirrored the slight drop in the country's GIR, which decreased from USD105.3 billion in April to USD105.2 billion in May.

"Despite the modest decline, the GIR level remains a strong external liquidity buffer, sufficient to cover 7.1 months' worth of imports of goods and payments of services and primary income," the BSP said.

"Additionally, it covers approximately 3.3 times the country's short-term external debt based on residual maturity."

The GIR is viewed to be adequate if it can finance at least three months' worth of the country's imports goods and payments of of services and primary income. (PNA) BY ANNA LEAH GONZÁLES

### PH ECONOMY REMAINS RESILIENT DESPITE GEOPOLITICAL TENSIONS – BPI

MANILA - The Philippine economy remains resilient despite renewed geopolitical tensions in the Middle East, BPI Securities Corporation said.

In a report on Thursday, BPI Securities said improved domestic supply conditions and stable inflation would help anchor investor sentiment.

"Tensions between Israel and Iran undoubtedly pose risks to the global economy," BPI Securities president and chief executive officer Mark Race said.

"As a major oil importer, the Philippines is exposed to price shocks. However, we take a measured view-year-to-date, the key inflation drivers for the early second quarter reflect moderation, particularly in food and utility costs, and easing transport prices."

Race said improved rice supply helped temper food inflation.

"Year-on-year rice prices are down by more than 11%, and that has a meaningful impact on overall inflation expectations for the rest of the year," he said.

On the equities front, Race said that despite external pressures, the Philippine Stock Exchange index (PSEi) remains technically supported.

"We continue to trade above the 6,300 level, with 6,500 acting as immediate resistance. Over the next two weeks, we expect the PSEi to remain within this band. However, our longerterm outlook is constructive

-we maintain our yearend target of over 7,000, underpinned by projected core earnings growth of 8%," he said.

Race is confident that the Philippine market remains attractive to global investors.

"Foreign holdings in Philippine stocks have declined in recent years. which has actually helped reduce the scale of during periods sell-offs of volatility. But more importantly, the Philippines is a consumption-driven economy with strong fundamentals. Combined with the possibility of lower interest rates, this remains a compelling proposition for select foreign funds," he added. (PNA) BY ANNA LEAH GONZALES

Speaking at the celebration institution's the of anniversary fifth on Wednesday, Department of Budget and Management (DBM) Secretary Amenah Pangandaman said the facility will house up to 400 promising athletes in quad-sharing rooms with separate male and female wings—ensuring thev have the safe, supportive environment needed to level up their training and studies.

"Malaking bagay po ito sa ating mga atleta (This will benefit our athletes). This facility is a major investment in the future of our youth and national athletes," Pangandaman

said in a news release Thursday.

"I really enjoy playing padel and I have been taking things one step at a time - trying out national tournaments, then trying regional ones and then now the FIP circuit this year. I feel really blessed that I'm able to get this far. Hopefully, I can still get better and reach the top 150 within the year," said Agra, a member of the Philippine Padel Association (PPA) founded by Alenna Dawn Magpantay.

Agra's next tournament is the FIP Bronze Reap Phuket by Asia Padel Events in Thailand this weekend. She will team up with Russian Anastasiia Ryzhova.

Agra was a quarterfinalist at the FIP Silver Melbourne (January), FIP Bronze Hong Kong and FIP Bronze Manila (March), and FIP Silver Dubai (April) this year.

She took the No. 1 spot in the Asia Pacific Padel Tour rankings in June 2024 with 2980 points after a runnerup finish with Spanish Maria Mayoral Estrada at the Bali Open in Indonesia.
