

MANILA – The Department of Migrant Workers (DMW) on Wednesday shut down an illegal recruitment agency fronting as a beauty salon and training center in Imus, Cavite.

DMW Assistant Secretary Jerome Alcantara led the closure operation of VMJ Beauty Salon and the Jef & Eds Learning Center, in coordination with the city government and the Imus Police Station.

"Nandito tayo ngayon sa bisa ng kapangyarihan ng DMW sa pamamagitan ng RA (Republic Act) 11641 na nagbigay sa amin ng mandato at sa direktiba rin ng Pangulo Bongbong Marcos Jr. at Secretary Hans Leo Cacdac na paigtingin ang kampanya natin laban sa illegal recruitment at human trafficking (We are here today by virtue of the power of the DMW through RA (Republic Act) 11641 which gave us the mandate and also the directive of President Bongbong Marcos Jr. and Secretary Hans Leo Cacdac to intensify our campaign against illegal recruitment and human trafficking)," Alcantara said.

The closure operation was launched after the DMW's Migrant Workers Protection Bureau (MWPB) received a request from the National Bureau of Investigation (NBI) Cavite North District to investigate the two establishments based on complaints of illegal recruitment.

The MWPB conducted three surveillance operations on June 5, 11, and July 1

"Nagpositibo ang VMJ Salon ng paniningil ng PHP15,000 sa mga aplikante para umano kanilang training hairstyling at spa pag-refer mga sa trainee sa kontak na recruitment agency para makapagtrabaho sila sa Saudi Arabia na may buwanang suweldo na PHP35,000 (It was found out that the VMJ Salon was charging applicants PHP15,000 for their hairstyling and spa training, and then referring trainees to a recruitment agency so they could work in Saudi Arabia with a monthly salary of PHP35,000)," the DMW said.

The DMW, together with police operatives, made the simultaneous raids of the VMJ Beauty Salon located at the Golden Market, Diamond Golden City, and of Jef & Eds Learning Center inside the Richlane Subdivision in Imus.

Operatives found a beautician at the salon while a caretaker with three applicants was at the so-called learning center, which allegedly also served as accommodation for recruits.

Owners of the two establishments now face charges for violation of RA 8042, or the Migrant Workers and Overseas Filipinos Act.

The DMW also will recommend the their cancellation of business registration certificates with the local government and the Department of Trade and Industry.

These closures bring to 18 the total number of illegal recruitment fronts shut down by the DMW so far this year.

LAGUNA LGUS INTENSIFY FLOOD CONTROL EFFORTS

CALAMBA CITY, Laguna (PIA)—Government leaders in Laguna have started ramping up flood control efforts to prepare for the onset of the rainy season.

Re-elected San Pedro City Mayor Art Joseph Francis Mercado signed Executive Order No. 1 enjoining all barangay officials in the city to prioritize clean-up of clogged drainage systems, creeks, water inlets, and other waterways.

Mercado said the city often experiences flashfloods and that the clean-up of waterways is just one of the solutions eyed to solve the perennial problem of flooding.

"We are all aware of the news reports about places that get flooded even with just short periods of rainfall. We are listening to your concerns. The entire city government and I are taking action to find solutions to this problem. This is just the beginning of a series of steps to address the issues that are burdening our community," Mercado said.

He directed barangay chairpersons, coordination with the City Environment and Natural Resources Office, City Health Office, and the City Disaster Risk Reduction and Management Office, and other national government agencies to start the operations by July 5 and every second and fourth Saturdays of the month.

Mercado said public participation is crucial to the cause of making the city clean, safe, and orderly.

"A reminder to all our fellow constituents: you have an important role to play in this. Let's start with the simple discipline of proper disposal. Every waste drain we keep clean is a step away from disaster." In Biñan City, officials have announced the commencement of operations, pumping particularly in Barangay Dela Paz and Malaban. to siphon off the floods in some areas.

Mayor Angelo Alonte said in a press conference that they are using pumps donated by the private sector while the city government is in the process of procuring their own pumps.

"We've already activated the pumping station to help siphon the water. We also have trucks that extract water and temporarily release it into our lake. We're just fortunate right now that Laguna de Bay's water level isn't too high yet and it can still absorb the rainwater."

Vice Mayor Jonalina Reyes then voiced her support for the Executive-Legislative Agenda of Alonte that includes the rehabilitation of the city's drainage systems and construction of new antiflooding facilities.

"Even before, we have already been working on projects to address the flooding problem, such as rehabilitating the drainage systems in Biñan and constructing riprap along our rivers."

Biñan officials noted that dredging of Laguna de Bay remains the long-term solution to flooding. They expressed the hope that Congress and national government agencies involved will support the measure.

"We will also need the help of our Lone District Cong. Representative. Dimaguila, Arman to coordinate with the government national encourage the and representatives of all the towns surrounding Laguna Lake to work together on Mayor Gel's proposed dredging project in Laguna Lake," Reyes adds.

Meanwhile, Governor Sol Aragones said in a statement that she will propose the improvement of waste management policies, modern urban planning, and the enactment of modern ecofriendly initiatives as part of a plan for the Laguna de Bay rehabilitation to lessen incidents of flooding in

QUEZON LGU TIGHTENS ENFORCEMENT OF 'NO BALANCE BILLING POLICY' IN PUBLIC HOSPITALS

LUCENA CITY, Quezon (PIA)—The provincial government of Quezon intensifying implementation of the "No Balance Billing and No Out of Pocket Expense" policy to ensure that residents, especially the most vulnerable, can access public hospital services without financial burden.

Under this policy, patients admitted to basic accommodations or ward sections of public hospitals are not required to pay any fees

Governor Angelina Tan said the initiative aims to ease the financial burden of medical expenses, especially for senior citizens, persons with disabilities, solo parents, and beneficiaries of the Pantawid Pamilyang Pilipino Program (4Ps).

"Bevond upgrading hospital facilities and equipment, modernizing we are committed to fully enforcing the no balance billing and no out of pocket expense policies across public hospitals in Quezon, so that every Quezonian in need of medical care can focus on recovery rather than worry about expenses," Tan said.

The move supports the Philippine Health Insurance Corporation's (PhilHealth) push for equitable healthcare access through the Universal Health Care Law, which encourages hospitals to fully implement no balance billing for

communities.

"Through infrastructure projects and the strengthening of solid waste management programs, residents will achieve а more comfortable, cleaner, and prosperous way of life. "Thank you very much to Quezon Medical Center for the free medicine, kind doctors and nurses, and the staff of PhilHealth and Malasakit. Through the no balance billing policy, my husband was able to receive treatment."

Tan added that the provincial government is also working to upgrade equipment and improve facilities across Quezon's public hospitals under the Quezon Provincial Health Network to ensure quality healthcare services.

Now serving her second term as governor, Tan vowed to continue the province's health programs under her HEALING Quezon governance agenda, ensuring that no Quezonian is left behind due to financial constraints in accessing healthcare.

She added that her administration's efforts are already producing results, with more citizens now actively seeking medical care.

PALACE: NOT INSINUATING MARK VILLAR BEHIND RISE IN PRIMEWATER DEALS

MANILA - Malacañang on Tuesday clarified that it is not insinuating that former Public Works Secretary and incumbent Senator Mark Villar was behind the ioint venture deals entered into by PrimeWater with local water districts.

In a press briefing, Officer Palace Press Claire Castro addressed auestions regarding the timing of the deals, which increased around 2019 when Villar was head of the Department of Public Works and Highways (DPWH), then the supervising agency of the Local Water Utilities Administration (LWUA).

"Ang pagkaka-describe lang naman natin ay mas dumami noong 2019 at noong ito'y na-attach nga sa DPWH, 'yung LWUA (What we noted is that the number increased in 2019, when LWUA was attached to DPWH)," Castro said.

"Hindi tayo nagbibigay ng insinuation na dahil kay Sec. Mark Villar at the time. Nagkataon kasi siya 'yung namumuno sa DPWH (We are not making any insinuation that this was because of Secretary Mark Villar. It just happened he was leading DPWH at the time)," she added.

PrimeWater, owned by Villar's brother and part of

the Villar family's business group, is currently under government investigation following consumer complaints over service interruptions and inconsistent supply in various parts of the country

It operates under joint venture agreements with several local water districts. Villar said he had no direct or indirect stake in PrimeWater and had no role in any transactions involving the firm during his time as DPWH chief.

PANGILINAN SEEKS TO CAYETANO PUSHES FOR REVISIT KEY FOOD, FISHERIES, NATIONWIDE ESTABLISHMEN OF ELDERLY CARE CENTERS

MANILA – Senator Francis "Kiko" Pangilinan Senator on Wednesday filed a set of Senate resolutions seeking urgent legislative of landmark agriculture and fisheries policies, saying reforms must be made to ensure that farmers and fisherfolk are not left behind.

resolutions lead The the second batch of his legislative priorities for the 20th Congress and aim to assess the effectiveness of the Sagip Saka Act, the impact of the Rice Tariffication Law, the effect of commercial fishing in municipal waters on small-scale fishers.

"These are issues I heard directly from our farmers and fisherfolk during the campaign. We need to make sure the laws we passed are truly working for them," Pangilinan said. The first resolution calls for an investigation into the status of the Sagip Saka Act, a 2019 law authored by Pangilinan to link farmers fisherfolk directly to markets, especially government procurement. The senator said some local government units have yet to fully implement the law.

The second resolution urges the Senate to revisit the Rice Tariffication Law. including the possibility of restoring the regulatory and market intervention powers of the National Food Authority (NFA). The move comes amid persistent concerns over unstable rice prices and the law's impact on local palay (unhusked rice) producers. A third resolution seeks to evaluate the effects of allowing commercial fishing within the 15-km. municipal waters, a zone traditionally reserved for small-scale fisherfolk. Pangilinan said complaints from coastal communities raise the need to determine whether policy changes are undermining the livelihood and rights of small fishers. "These are not just policy issues—they affect the daily lives and incomes of our most vulnerable workers," Pangilinan said. He added that all three resolutions are consistent with his campaign promise to advocate for food security, farmer and fisher welfare and pro-poor policy reforms.

The senator also filed a new set of bills alongside the resolutions, including political measures on dynasty prevention, bank deposit transparency, land use planning, and environmental protection. However, he emphasized that the resolutions reflect his priority to hold the government accountable for the implementation and impact of already existing laws. (PNA) BY WILNARD BACELONIA

MANILA - Senator Alan Peter Cayetano has filed a bill seeking to establish wellness and care centers for senior citizens in every city and municipality in the country, citing the growing need to institutionalize elderly care as the population continues to age.

Cayetano said Wednesday that Senate Bill No. 107, or the proposed Center for the Elderly in All Cities and Municipalities Act, mandates the creation of Local Centers for the Elderly that will serve as wellness hubs, safe spaces, and access points for health care, social services, and recreational activities.

"Our senior citizens deserve more, and it is the duty of the State to prioritize them and ensure that our programs and services truly respond to their needs and protect their right to live safely and Cayetano comfortably," said.

The measure directs the Department of Social Welfare and Development (DSWD) to lead the rollout of the centers in coordination with local government units. LGUs and private groups may also establish additional or satellite centers based on the needs of their senior populations.

said Cayetano proposal aims to modernize the existing 1995 law on senior citizen centers, which has yet to meet current demands. At present, there are only 76 residential care facilities across the country, most of which serve multiple vulnerable sectors and not just the elderly.

The bill also provides tax and tariff exemptions for imported equipment and supplies needed to build and operate the centers. A Special Committee on Local Centers for the Elderly will be formed oversee to program implementation and ensure each facility meets minimum standards.

To promote excellence, a Seal of Excellence Awards system will be established to recognize outstanding local centers.

Cayetano cited Taguig City, which in 2019 opened a five-story, disabled-friendly Center for the Elderly as a model. He said the facility has been effective in providing care to seniors with low-risk conditions and should be replicated nationwide.

NBI RAID YIELDS P8-M FAKE BABY POWDER, BODY CLEANSERS

MANILA - The National Bureau of Investigation (NBI) on Wednesday announced the seizure of PHP8 million worth of fake baby powder and body cleanser products during a raid on a Pasay City establishment.

In a statement, NBI Director Jaime Santiago said units from the NBI-National Capital Region (NBI-NCR) and the Intellectual Property Rights Division (IPRD) implemented two search against the warrants

subject establishment last July 3 for violation of Republic Act 8293 (Intellectual Property Code of the Philippines).

The operation resulted in the discovery and seizure of a total of 9,093 pieces of various counterfeit products, bearing the trademarks "Johnson's," "Johnson's Baby," "Aveeno," "Cetaphil" and "Cetaphil Gentle Clear."

Johnson's and Aveeno are registered trademarks of Kenvue Inc., while Cetaphil is a registered trademark

of Galderma Holdings SA. The search warrants were obtained through the complaint filed by Orion Support, Inc., representing Kenvue Inc., and Galderma Holdings.

"The NBI reminds the public to refrain from patronizing pirated products to give protection to the intellectual property rights owners and enhance our economic growth," Santiago said. (PNA) BY **BENJAMIN PULTA**

DHSUD DIRECTS REGIONAL OFFICES TO BE PROACTIVE IN DISASTER RESPONSE

MANILA – Department of Human Settlements and Urban Development (DHSUD) Secretary Jose Ramon Aliling has instructed the agency's regional offices (RO) to adopt a more proactive and anticipatory approach in leading shelter-related disaster response efforts.

The directive follows the quidance of President Ferdinand R. Marcos Jr. during a recent emergency situational briefing with the National Disaster Risk Reduction and Management Council.

"As lead, you bear the primary responsibility for coordinating, guiding, and facilitating shelter-related activities under your areas of responsibility," Aliling said in a news release on Friday.

Citing that ROs are Regional Shelter Cluster Leads, he emphasized the need for swift, coordinated, and strategic action among them.

"You are to engage with the local government key units. shelter agencies, partners, and stakeholders within your jurisdictions respective to foster a unified and effective response, monitor progress, identify gaps, and ensure that needs are met efficiently and equitably," Aliling said.

He also reminded ROs to ensure timely communication of the Department's shelter programs, assistance particularly the Integrated Disaster Shelter Assistance Program.

All regional units are required to submit daily situational reports to support DHSUD's central disaster operations.

"Let's continue to be proactive and collaborative. Your dedication and hard work are important in ensuring safe shelter for those who need it most,'

On Thursday, the DHSUD released a memorandum where regional units were told to ensure that their disaster response strategies are aligned with national objectives, especially in light of the ongoing typhoon season.

DIGITAL DRIVER'S LICENSE RENEWAL NOW ON EGOVPH APP

MANILA Drivers may now renew their license completely online following the launch of the online driver's license renewal system (ODLRS) integrated with the eGovPH mobile application (app).

During the launch at the Land Transportation (LTO) Central Office Office in Quezon City on Thursday, Department of Transportation (DOTr) Secretary Vince Dizon the new online system makes the renewal process easier and fixer-

"Hindi ka na kailangan pumunta sa LTO office. Hindi ka na mabibiktima ng fixers (You don't need to go to the LTO. And you won't be victimized by fixers)," Dizon said.

The LTO's digitalization efforts are part of President Ferdinand R. Marcos Jr.'s order to improve online accessibility government services.

The launch was made cooperation with the DOTr and the Department of Information Communications Technology (DICT).

LTO Chief, Assistant Secretary Vigor Mendoza II. said the digitalization of their services is intended to

make all transactions in the LTO "fast and comfortable to all our clients."

"We are continuing to evolve to further improve our digital services and expand the reach to all Filipinos even in abroad," Mendoza said.

To renew a license through the eGovPH app, drivers would need to download and install the app on their smartphones, available in both the Apple App Store and Google Play.

Once installed and the user is verified, they would need to find the NGA icon. click LTO, select "Online Driver's Application," and then "Renew Your Driver's License."

The user would be asked to upload a photo of the front and back of their physical driver's license; go through validation, review, and verification of details; and then have their photo taken that abides with the LTO's required standard format.

addition. renewal applicants can also have their medical examination online through the LTO ODLRS portal and book a telemedicine appointment. The LTO's online Driver's Enhancement Program (DEP), a required fivehour education program, is available through the LTO ODLRS portal.

Applicants can also pay for their driver's license renewal online.

advised Mendoza applicants to complete the medical examination and the DEP beforehand as these are requirements that they will need to upload as part of the online license renewal process. the

COMELEC TRIAL OF 'REGISTER ANYTIME, ANYWHERE' PROGRAM **SET IN AUGUST**

MANILA The Commission on Elections (Comelec) will pilot test "Register Anytime, Anywhere" program in the National Capital Region (NCR) when voter registration resumes next month.

"Expect us to conduct voter registration hospitals. selected call centers, transport terminals, airports, and other public places. We will have the registration even at night," Comelec Chairperson George Garcia said in an interview on Thursday.

"Once we have a longer voter registration period, we can adopt this program nationwide."

Though the nationwide voter registration period will be from Aug. 1 to 10, the pilot test in the NCR will be conducted only until Aug. 7.

"We need the last three days to forward those who availed of the 'Register Anywhere Program' to the concerned local Comelec, where they will become registered voters," Garcia explained.

SOLON WANTS GOV'T HOSPITALS TO PURCHASE FOOD DIRECTLY FROM FARMERS

MANILA – Senator Francis Pangilinan on Friday urged the Department of Health (DOH) to fully implement the law seeking all public hospitals to purchase their food directly from local farmers and fisherfolk.

Pangilinan was referring to Republic Act 11321, or the Sagip Saka Act he authored in 2019, which aims to uplift the lives of agricultural workers by guaranteeing market access through direct government procurement.

He said the law's intent is clear - to make the government the biggest and most reliable buver of local produce, ensuring income for producers and nutrition for communities.

Pangilinan said during their meeting on July 8, Health Secretary Teodoro Herbosa committed to issuing a department order for the full implementation of the Sagip Saka Act.

There are 60 public hospitals nationwide, which means there are also 60 canteens or cafeterias operating in every hospital. Pangilinan said he also plans to discuss the enactment of the Sagip Saka Act with agencies and local governments, underscoring the need for their full participation so the law's intended

beneficiaries - the farmers and fisherfolk - can reap the rewards.

"Saan nila binibili ang kanilang pagkain arawaraw? Dapat porsyento niyan direkta ang bili sa mga magsasaka (Where do they buy their daily food? A percentage of that should be directly sourced from farmers)," he said.

Pangilinan warned that he plans to defer the budget approval of agencies that cannot present a concrete plan on implementing the Sagip Saka Act. (LEONEL ABASOLA/PNA)

BACOLOD CITY CALLS FOR CIVIC ACTION IN FLOOD **MITIGATION EFFORTS**

BACOLOD CITY - The city government here enjoined Bacolodnons to take part in flood mitigation efforts after 26 tons of garbage were dredged from Mambuloc Creek on Thursday.

In a statement on Friday, Mayor Greg Gasataya, who personally supervised the initial dredging operation, said civic participation is critical to the long-term success of the initiative.

"I urge everyone to take part in protecting the environment. Maintaining clean waterways is a shared responsibility of the people," he said.

The clean-up drive in waterways is part of the city's flood mitigation efforts targeting vulnerable areas, including Barangays 2, 8, and 10, which are located in the city proper, adjacent to shopping malls and other major business establishments.

SAMAR GOV'T TURNS OVER 17 HOUSES TO EX-REBELS

TACLOBAN The Samar provincial government has completed 17 houses intended for former rebels in two towns in the province as part of the government's efforts to wipe out insurgency.

Ten units were handed over to former members of the New People's Army (NPA) in Calbiga town and seven in San Jose de Buan town.

This is the second batch of houses awarded to beneficiaries in San Jose de Buan. The government held a turnover of the first 10 houses in April 2024.

Each 150-square-meter house costs PHP250,000 to PHP280,000, each unit designed with "amakan" (woven splitbamboo mats) with two bedrooms, a kitchen, and a living room.

In a statement on Friday, Samar Governor Sharee Ann Tan said they have plans to expand the Saad

Balay nga (promised houses) initiative to benefit more former rebels.

"We thank our former rebels for choosing a more peaceful life. They are the living witnesses to how their lives have improved since they abandoned the armed struggle," Tan said.

"The turnover underscores the continued commitment provincial of the government to sustain peace efforts by supporting former rebels as they rebuild their lives and communities," she added. The provincial government, the Philippine Army, the Office of the Presidential Adviser on Peace and Reconciliation, the Unity and Program, other national government agencies kicked off the housing project in San Jose de Buan town in September 2023, targeting to build 17 units.

A similar project was launched in Calbiga town in May 2024, with plans laid out to build 10 houses. In Matuguinao town, the provincial government plans to construct 30 houses.

Using the "bayanihan" concept, the project allows government agencies to actively participate in a program that aims to shelter provide decent to former rebels who surrendered and wanted to live a normal life with their families.

DOE BREAKS GROUND 64-MW PEAK SOLAR POWER IN AJUY, ILOILO

MANILA – Construction of the PHP2.37-billiion, 62-megawatt peak solar power plant in Ajuy, Iloilo started Friday, eventually boosting power capacity in Panay Island while reducing reliance on fossil fuels.

The Ajuy-1 Solar Power Project, located in Tipacla, Ajuy, and covers a 47.86-hectare area, is the province's first major ground-mounted solar facility, being developed by Jin Navitas Solaris, the Department of Energy (DOE) said in a press release.

It will be connected to the Panay Island grid through the Sara—Panit 69 kV transmission line and has already completed the required System Impact Study. It is seen to enhance grid stability in northern

It is part of DOE's Green Energy Auction Program 2 (GEA-2) and is entitled to a green energy tariff of PHP4.35 per kilowatt-hour. It will contribute to the move to increase the share of renewable energy to the country's total energy mix to around 35 percent by 2030 and 50 percent by 2040.

"This groundbreaking initiative not only marks a significant step in reducing our carbon footprint but also empowers local communities by providing them with reliable and renewable energy resources," Energy Secretary Sharon Garin said.

PAGCOR ORDERS TAKEDOWN OF GAMBLING BILLBOARDS

MANILA – The Philippine Amusement and Gaming Corp. (PAGCOR) has ordered the immediate dismantling of all billboards and out-of-home (OOH) gambling advertisements as part of its intensified efforts to regulate gambling-related promotions in public spaces.

In a statement Friday, PAGCOR said it issued a memorandum on July 7, directing all licensees, suppliers, system administrators, and gaming venue operators to take down gambling ad materials, including those displayed on trains, buses, jeepneys, and taxis.

PAGCOR clarified that only institutional or responsible gaming campaigns, which are subject to its approval, will be permitted moving forward.

"We have given all our licensees and stakeholders until Aug. 15 to completely remove all gambling-related ads," said PAGCOR chairperson and CEO Alejandro Tengco.

"Prior to that, stakeholders

must also submit an inventory of their existing billboard and wallscape advertisements by July 16."

Tengco said the inventory must include the size, material, location, rental contract expiration, and the corresponding permit number from the Ad Standards Council (ASC).

"While PAGCOR is mandated to regulate the gaming industry and generate revenues for nation-building, we do not want to encourage a culture of gambling addiction," he said.

"Regulating excessive and pervasive gambling advertisements is a critical step in protecting vulnerable sectors of society, especially the youth."

PAGCOR also warned against replacing the dismantled advertisements with new gambling promotions, adding that non-compliance will be dealt with accordingly. (PNA) BY ANNA LEAH GONZALES

OFFICE MARKET REBOUNDS DESPITE POGO BAN

MANILA - The office leasing market sustained a strong momentum in the first half of 2025, with demand reaching 67 percent of full-year 2024, despite the withdrawal of Philippine Offshore Gaming Operators (POGO), estate advisory firm Leechiu Property Consultants (LPC) said Thursday.

"Demand has been strong for the first half of the year. We believe it will continue. We never know what will happen, but we are optimistic about it," Mikko Barranda, LPC director for Commercial Leasing, said during the presentation of the LPC Q2 2025 Philippine Property Market Report in Makati Citv.

The Information Technology and Business Process Management (IT-BPM) took up 50 percent of the total leasing activity, or 365,000 square meters, in the first half of 2025.

Traditional industries, on the other hand, accounted for 48 percent, or 354,000 sqm, of the demand, while government offices took the rest of the share at 21,000 sqm.

At least 79 percent, or 581,000 sqm, of the overall

demand came from Metro Manila, with Bonifacio Global City representing 146,000 sqm, while provincial demand was at 21 percent to 159,000 sqm, with Cebu covering 81,000 sqm.

Barranda reported that the net demand has breached more than 50 percent to 271,000 sqm of the firm's projection for the year.

"Contractions are tapering off and net take-up in terms of what we have projected back in Q1, which we feel will be at 490,000 sqm levels, were already touching 55 percent," he said.

In the absence of POGOs, LPC Chief Executive Officer David Leechiu said this surge is already the highest since 2017.

"We are all shocked at the amount of leasing activity in the first six months of the year that we have not seen those levels since 2017," he said.

"These numbers are already happening without the POGO steroid factor. So, we can say that is the highest number of leasing activity we've seen since 2017 net of POGO." (PNA) BY JOYCE ANN L. ROCAMORA

(It will be guided by the principles of EPIRA regarding the least cost. It gives our electric power industry participants a choice to enter a contract with a nuclear power project if they see it fit for their needs)," he said in a press briefing.

Aquino explained that the government's nuclear program, which will be discussed during a hybrid public consultation to be hosted by the DOE on July 15, will further expand the country's energy mix to help ensure energy security.

Among the other benefits of using nuclear energy include having environment-friendly power plants that do not have emissions, supports economic growth due in part to a very intensive value chain, and grid harmonization and integration.

Aquino said nuclear power also has competitive pricing.

In an earlier statement, DOE said the release of the draft circular was made ahead of the expected signing into law of the proposed Philippine National Nuclear Energy Safety Act, which establishes the Philippine Atomic Energy Regulatory Authority (PhilAtom).

"Yun po ang ating assurance sa ating mga kababayan na kung tayo po at papasok sa nuclear ito po ay masusunod ang ating safety, security, at safeguards (This is an assurance to the public that if we will go into nuclear, the polices will be heeded for our safety, security, and safeguards)," Aquino added. PH OFFICIALS TO MEET US COUNTERPARTS ON 20% TARIFF

MANILA – Philippine officials will fly to the US next week to discuss with their counterparts the 20 percent tariff imposed by the Trump government on Philippine exports, higher than the 17 percent announced last April.

The tariff rate will be in effect starting Aug. 1, 2025. Trade Secretary Cristina Roque, in a briefing on Thursday, said she has yet to meet other trade and economic officials to discuss how they will negotiate tariff issues.

She declined to elaborate on their next move, saying they only received the letter from the US government

regarding the tariff rate earlier in the day.

"Even the US is open for negotiation, so let's see what happens when we get there. And let's see what will happen when we convene," she said.

"As we mentioned in our statement, the 20 percent rate is the second lowest. But we will have to talk about it."

In a statement, the Department of Trade and Industry (DTI) said it is "concerned" about the tariff rate imposed on Philippine exports, "notwithstanding our efforts and constant engagement."

Despite this, the statement

said the government "remains committed to continuing negotiations in good faith to pursue a better and more comprehensive

bilateral trade agreement."

"We recognize the

concerns of the United States regarding trade imbalances and its desire to strengthen domestic manufacturing. However, global supply chains are deeply interconnected, and unilateral trade impositions will have adverse effects to the global economy. Thus, we believe in the need for constructive engagements to address trade issues," it added. (PNA) BY JOANN VILLANUEVA

MENDOZA TAKES COMMANDING LEAD IN JPGT SOUTH PACIFIC

MANILA Cebuana Denise Mendoza delivered an impressive performance in the opening round of the ICTSI Junior PGT Championship girls' 7-10 division Wednesday in Davao City.

Amid humid conditions and overcast skies, the 10-year-old came up with a 64 after scoring birdies from No. 10 through 15 at the South Pacific Golf and Residential Estates to post a 23-stroke lead over Del Monte leg winner Soleil Molde heading into the final round of the 36-hole competition.

Molde had an 87 while Francesca Geroy registered a 91.

"I was surprised -I really didn't expect to score this low, especially on a course

I've never played before," said Mendoza, following her father's advice to "stay calm and stick to the basics, especially when you hit a bad shot or things start to go wrong."
"Most of the time, my

approach shots left me with easy birdie chances -usually within five feet. That meant I didn't need to make a lot of long putts. I'll just play exactly the same way," the Cebu Learning Center student added.

In the boys division, Jamie Barnes carded a 71 highlighted by clutch birdies at the end of his round to take an eightstroke lead after Davao's Miguel Revilleza finished with a 79.

Cebu's Kvan Alburo placed third with an 80 followed by Shaqeeq Tanog (84) and James Rolida of Cagayan de Oro (90).

"I think I played really well, especially in the last three holes. That made me very happy. I also had a lot of fun out there," the nineyear-old, eyeing a rare three-peat after ruling the Del Monte and Pueblo de Oro legs, said.

"The course is tricky, especially the greens. Some are fast, then some are really slow, and a lot of them have big slopes. But I still managed to get some birdies," Barnes, who studies at Wellington College International in Thailand, said.

PH SENDS 5 ATHLETES TO WORLD AQUATICS CHAMPIONSHIPS IN SINGAPORE

MANILA – Four athletes will see action at the World Aquatics Championships in Singapore, the Philippine Aquatics, Inc. announced Friday. Swimmers

Christopher Santos and Adrian Philipp Eichler, and divers Rose Ocmer Ariana Hannah and Drake are among the 2,500 athletes from 206 countries participating in the tournament held for the first time in Southeast Asia from July 11 to Aug. 3.

Eichler, a Filipino-German, is entered in the 100m and 200m freestyle. His best time in 100m is 0:51.20 (2021). He registered a season best 0:51.34 at the World Aquatics-approved CIJ Luxembourg meet on March 7-9.

In the 200m, Eichler set a personal best and Philippine record 1:50.29 at the German Nationals last May, breaking the 1:50.82 mark of Jessie King Lacuna.

Last year, he set new Philippine records in 400m freestyle (3:51.62) and 4x50m mixed medley (1:46.56) both at the World Aquatics Swimming Championships in Budapest, Hungary in December, and in the 200m freestyle (1:47.98) at German Nationals in November.

Adrian and brother Alexander are members of the Swimming Club Wiesbaden 1911 team that won the 2024 German Premier League.

Like Eichler, Santos qualified for the World Santos Aquatics Championships by achieving Qualifying Times (QT) B.

The Columbia University

student clocked 3:55.61 in 400m freestyle during the Summer National Championships in Irvine, California, last July 2024. "In Singapore, I hope to achieve my best times in both the 400m free and 200m IM events. I committed to intense, rigorous training this summer to proudly represent the country at this competition and I am excited to compete against the best athletes in the world, including Olympians and record holders," said

an interview.

He was born and raised in California. His father is from Pampanga and his mother from Bacolod, Negros Occidental.

Santos bagged one ver (400m IM) and silver three bronzes (200m IM, 1500m freestyle and 4x100m relay) at the 2022 Southeast Asian Age Group Championships in Kuala Lumpur, Malaysia.

He also competed at the 2022 World Junior Championships (Lima, Peru) and 2023 World Championships Junior (Netanya, Israel).

At the 2024 Philippine National tryouts, he won all his events and set two junior national records to earned the Most Valuable Swimmer award.
