## WANTED PERSON FOR QUALIFIED THEFT ARRESTED BY AMADEO PNP

**Camp BGen Pantaleon Garcia, Imus City, Cavite** — A male individual listed as a Provincial Level Most Wanted Person was arrested by the personnel of Amadeo Municipal Police Station during an operation conducted at around 2:30 PM on July 15, 2025, at Purok 06, Brgy. Talon, Amadeo, Cavite.

PMAJ JULIUS R MARQUEZ, Officer-In-Charge, Amadeo MPS, identified the accused as alias GARRY, resident of Brgy. Talon, Amadeo, Cavite.

The arrest was carried out by virtue of a Warrant of Arrest for the crime of Qualified Theft under Article 310 of the Revised Penal Code, under Criminal Case No. 2986-06, issued by Hon. Rocille Aquino Tamasacan, Presiding Judge of the Regional Trial Court, Branch 21, Fourth Judicial Region, Imus City, Cavite, dated July 11, 2025. The warrant carried a recommendation for

service of sentence.

The operation was conducted by the Warrant Section of Amadeo MPS and was properly documented using an Alternative Recording Device, in line with the PNP's policy on operational transparency. The accused was informed of his constitutional rights, which he fully understood.

The suspect is currently under the custody of Amadeo Municipal Police Station while the return of the warrant is being prepared for submission to the issuing court.

In his statement, PCOL DWIGHT E ALEGRE, Provincial Director of Cavite PPO, emphasized, "The arrest of the accused demonstrates our continuous commitment to justice and public safety. We remain firm in our mission to hold accountable those who violate the law and disrupt the peace and security of our communities."

## JOINT POLICE OPERATION LEADS TO ARREST OF REGIONAL-LEVEL MOST WANTED PERSON IN ORIENTAL MINDORO

**Camp BGen Pantaleon Garcia, Imus City, Cavite** — In a successful joint operation, police operatives arrested a Regional-Level Most Wanted Person listed under PRO-4A CALABARZON at around 12:30 PM on July 15, 2025, in Barangay Biga, Oriental Mindoro.

PLTCOL LOUIE DC GONZAGA, Chief of Police of Silang Municipal Police Station, identified the arrested individual as alias "JONAR", a resident of Barangay Malabag, Silang, Cavite, and currently residing in Del Pilar, Naujan, Oriental Mindoro.

The arrest was carried out through a joint police operation led by the Warrant Personnel of Silang MPS, in coordination with PIT Cavite RIU4A (Intel Pocket) and Calapan City Police Station.

The suspect was apprehended by virtue of a Warrant of Arrest issued by Hon. Raquel Ventura Aspiras-Sanchez,

Presiding Judge of the Regional Trial Court, Branch 3 (Family Court), Tagaytay City, Cavite, for two counts of Statutory Rape under Article 266-A of the Revised Penal Code, as amended by R.A. 11848. The charges are docketed under Criminal Case Nos. TG-24-1088 (AS) and TG-24-1089 (AS), both dated November 12, 2024. These cases are classified as non-bailable.

The operation was conducted in accordance with standard procedures and utilized an alternative recording device as part of evidence-gathering and compliance protocols.

The Warrant of Arrest has been returned to the court of origin for appropriate legal action.

PCOL DWIGHT E ALEGRE, Provincial Director of Cavite Police Provincial Office, commended the dedication and coordination exhibited by the operating units.

This accomplishment reflects PRO-4A CALABARZON's unrelenting commitment to its mandate of ensuring public safety and bringing fugitives to justice.

LABOR LAWS  
PROTECTING CHILD  
INFLUENCERS SOUGHT

**CALAMBA CITY (PIA)**—Child labor laws will soon cover influencers aged below 15 years if existing labor laws are expanded to include younger children involved in the creative industry, according to the Department of Labor and Employment (DOLE). Ratified into law in 2003, Republic Act No. 9231 more commonly known as Elimination of Worst Forms of Child Labor Act currently only covers child entertainers but is yet to include online child influencers.

Lawyer Jerommel Gabriel, Bureau of Workers with Special Concerns-Young Workers Development Division chief, said existing labor laws are being updated to expand coverage for children involved in the creative industry.

“This also applies to child artists and models, [who are required] to secure a working child permit. However, it [R.A. 9231] has been 22 years and not much was mentioned regarding [online influencers] since vlogging is very recent because of technological advancements.”

This year, the labor department has been conducting public consultations with the agriculture, construction, manufacturing, and creative industries for possible updating of the law. This includes stakeholders in the National Capital Region, CALABARZON, Central Luzon, Western Visayas, and SOCKARGEN regions who have raised concerns on policies

protecting children involved in the creative and media industries particularly those involved in vlogging –or video blogging –and online selling.

“The last DOLE regulation [on children involved in the creative industry] was signed in 2016, when there were less child influencers unlike today when vlogging has turned into a lucrative job.”

Although a national-scale policy protecting online child influencers is yet to be ratified, local government units –such as Quezon City –have been passing ordinances to protect online influencers aged 15 and below.

“There are existing bills or ordinances for children involved in the digital economy, and we are consulting with stakeholders regarding that.”

Countries have been pushing for policies protecting child influencers against exploitation and abuse.

In 2024, France introduced the Child’s Image Right Law and the Child Image Law to reinforce their right to protection.

Last January, the United States followed suit as California signed child influencer laws where content creators featuring minors in at least 30 percent of their content must deposit 65 percent of the minor’s gross earnings into a trust account. (PB/PIA4A) **BY PATRICIA BERMUDEZ**

CALABARZON’S BIG  
-TICKET ROAD PROJECTS  
IN FULL SWING —DPWH

**CALAMBA CITY, Laguna (PIA)**—The government’s big-ticket road projects in Calabarzon are in full swing to decongest key cities and densely populated communities, the Department of Public Works and Highways said.

In Quezon province, the rehabilitation of key sections of the Maharlika Highway –a critical route connecting Metro Manila to Southern Luzon –is on track, said DPWH Region IV-A Director Jovel Mendoza in an interview with the Philippine Information Agency Calabarzon.

“The improvement of certain sections of the Maharlika Highway makes a significant contribution to the region’s economic growth. As a major transportation route, this highway connects provinces, neighboring regions, and trade centers,” he said.

“Upgrading and rehabilitating it will speed up the flow of goods and services, reduce travel costs and time, and boost tourism,” he added.

According to DPWH Calabarzon, rehabilitation of the Maharlika Highway covers sections from Calamba City in Laguna to Tagawayan in Quezon and requires a total budget of P14.39 billion.

Mendoza indicated no project completion even as he was optimistic that it will be sustained in the succeeding general appropriations.

He said of the estimated P14.39 billion for Maharlika’s improvement, P1.827 billion from the 2023 budget has been completed; P3.833 billion from the 2024 budget is currently under

implementation, while P1.758 billion from the 2025 budget is presently in the bidding process.

In Batangas, the DPWH reported that the recently inaugurated Balagtas flyover has helped ease road congestion in the province.

The flyover serves as an alternative route from the STAR Tollway to the diversion road and city proper and improved access to Batangas Port, one of the country’s busiest seaports.

“The flyover (resulted in) smoother flow of traffic. The number of accidents in Brgy. Balagtas has decreased from 56 incidents to just 38. Travel going to the port and the city proper has also become faster,” Mendoza said.

The DPWH director is hopeful that construction of a flyover in Tagaytay City in Cavite will be completed by August 2025 while opening to motorists is expected by September 2025 providing road convenience for both tourists and locals.

Ahead of the fourth State of the Nation Address of President Ferdinand R. Marcos Jr., Mendoza said the DPWH Calabarzon will continue to uphold best practices in road infrastructure development.

He said planning and pre-construction coordination with local governments and stakeholders are conducted to ensure that projects are tailored to the actual needs of communities and the population they serve. (CH/PIA-Laguna) **BY CHRISTOPHER HEDREYDA**

## DOTR CHIEF ORDERS PROBE INTO MISSING JEWELRY IN NAIA T3

**MANILA** – Transportation Secretary Vince Dizon on Thursday ordered an investigation into the missing and eventual return of a passenger's jewelry box at the Ninoy Aquino International Airport (NAIA) Terminal 3.

In a statement, Dizon ordered the Manila International Airport Authority (MIAA) to conduct an investigation into the incident and to ensure it does not happen again.

"Bilang tugon sa utos ni Pangulong Ferdinand Marcos Jr. na tiyakin ang kaligtasan at seguridad ng mga pasahero, mabilis na narekober at naibalik sa isang pasahero ang kanyang mga alahas na nawala (In line with President Ferdinand Marcos Jr.'s order to ensure the safety and security of passengers, we have quickly recovered and returned the missing jewelry of a NAIA passenger)," he said.

Dizon's statement came after passenger Kimberly Nakamura praised the NAIA Terminal 3 Airport Police Department (APD) and Screening and Surveillance Division (SSD) in a social media

post for swiftly recovering her missing jewelry box after discovering its loss after arriving in Singapore on June 28 from Manila.

In a statement, the MIAA said the jewelry box was first tracked through closed-circuit television footage when it was left unattended at Gate 104 and passed around by more than 10 airline and security personnel.

"Despite multiple chances, none of the staff reported the item to the lost and found section," it said.

The NAIA Terminal 3 APD and SSD managed to recover all items from the jewelry box.

"Airport Police Officers Casey San Juan and Frelyn Leda, along with CCTV analysts, followed every lead, questioned all involved parties, and stayed committed until full recovery," it said.

Nakamura chose not to press formal charges, but the MIAA called on all airlines and security agencies of those personnel involved in the incident to take disciplinary action against those responsible. (PNA) **BY RAYMOND CARL DELA CRUZ**

## DOJ CONFIRMS RECOVERY OF HUMAN REMAINS IN TAAL LAKE

**MANILA** – Department of Justice (DOJ) Secretary Jesus Crispin Remulla on Thursday confirmed that two of the four sacks recovered by the Philippine Coast Guard (PCG) from Taal Lake contained human remains.

"Two sacks were found, I don't know how many people," Remulla told reporters, noting that cursory examination of the contents showed that they were clearly human remains and included "yung ribs ng tao (ribs of persons)."

The other sacks containing sand were believed to have been used as weights.

Remulla said the sacks from the lake were located with the help of boatmen in the area identified by whistleblower Julie Patidongan, alias Totoy.

"Tinuro ng mga bangkerong tinuro n'ya (The location

was pointed by boatmen identified by Patidongan)," he said.

The whistleblower earlier claimed that at least 100 victims were dumped in the lake.

Remulla said the discovery of the two sacks of human remains is "a positive indication that he (Patidongan) knew what he was talking about."

He said police investigators have also recovered three unclaimed cadavers buried at the town's public cemetery allegedly belonging to individuals recovered in the lake in 2020.

The individuals are believed to be among those involved in e-sabong who were abducted in Lipa, Batangas.

"One of them was pregnant," Remulla said, adding that one was identified by the basketball

## SUPER HEALTH CENTERS STRENGTHEN HEALTHCARE ACCESS UNDER MARCOS ADMIN

**MANILA** – With just days before President Ferdinand Marcos Jr. delivers his State of the Nation Address (SONA), the government's continuing rollout of Super Health Centers (SHCs) has become a key highlight in the administration's health agenda.

According to the Department of Health (DOH), over 600 SHCs have already been funded and constructed nationwide since the program began in 2022.

These centers are designed to bring essential medical services closer to communities, especially in far-flung and underserved areas.

Citing that SHCs are part of the government's long-term strategy under Republic Act 11223 or the Universal Health Care (UHC) Law, DOH Secretary Teodoro Herbosa said these facilities are established to decongest hospitals and to provide quality and accessible healthcare at the community level.

They were introduced in 2021, serving as an enhanced version of rural health units equipped with basic to intermediate health services such as laboratory testing, X-ray, ultrasound, electrocardiogram, outpatient consultations, maternal and child services, tuberculosis screening, minor surgeries, ambulatory surgery.

They also serve as satellite vaccination sites, pharmacy dispensaries, and referral systems for more specialized care to date.

In 2022, about 307 SHCs were established nationwide. These were followed by 322 in 2023, and 132 in 2024. The DOH identifies the strategic areas where these centers will be established since they act as a key support layer between barangay-level health units and

This year, additional SHCs were opened in Pangasinan, Eastern Visayas, and Zamboanga City, apart from those already operating in Aklan, Agusan del Sur, Bulacan, Cebu City, Dinagat Islands, Leyte, and Northern Samar, among others.

Last Feb. 27, a groundbreaking ceremony for a super healthcare facility, which will cost PHP187 million, was held at Barangay Iluluan in Camalig, Albay.

DOH officials and the local government unit of Matag-ob in Leyte also led the groundbreaking ceremony of a PHP12-million SHC to be under the DOH Health Facility Enhancement Program last Feb. 28.

On March 24, then Manila Mayor Honey Lacuna led the groundbreaking ceremony for a PHP50-million SHC in Sampaloc.

Senator Christopher "Bong" Go is the main proponent of SHCs under the UHC Law and Republic Act 11959, or the Regional Specialty Centers Act, underscoring their importance in delivering preventive care and early disease detection.

He said the expansion of SHCs reduces hospital crowding and financial burdens from travel experienced by patients while strengthening the country's primary healthcare network.

Local government units have partnered with the DOH for construction and operations, with funding channeled through the Department of Public Works and Highways (DPWH).

The Marcos administration aims to complete hundreds more SHCs in the coming years, with improvements to include expanded diagnostics, mental health support, and digital health integration.

As the country continues to recover from the long-term effects of the coronavirus disease 2019 pandemic, SHCs are expected to play a vital role in building a more resilient, inclusive, and community-based health system. (PNA) **BY MA. TERESA MONTEMAYOR**

## MARINA BACKS DIGITAL PORTAL FOR PH MARITIME WORKFORCE

**MANILA** – The Maritime Industry Authority (MARINA) on Thursday backed the launch of the Philippine Maritime Workforce Portal (PMWP) --a centralized digital platform for data on the Philippine maritime workforce.

In a statement, MARINA Deputy Administrator for Planning Nenita Atienza said the portal has a crucial role in shaping responsive, targeted, and future-ready policies for the maritime sector.

"The PMWP is more than a database --it is a strategic tool that will help us uplift the lives of Filipino seafarers and reinforce the country's maritime strength," Atienza said.

MARINA is among the designated data source agencies for the portal, along with the Commission on Higher Education (CHED), the Philippine Coast Guard (PCG), and the Department of Migrant Workers-- National

Maritime Polytechnic (DMW-NMP).

As a data partner, MARINA will provide data for the portal to ensure the integrity, accuracy, and depth of the information shared through the PMWP. Once completed, the platform will contain data such as seafarer demographics, education and training statistics, employment records, and labor market insights.

"The initiative supports evidence-based planning and aims to align the supply of Filipino maritime professionals with global industry demands," Atienza said.

The portal was launched in a ceremonial signing of the project's memorandum of agreement (MOA) during the Maritime Research Forum in Manila on Tuesday.

## LTO WARNS MOTORISTS VS. USING FAKE PLATES

**MANILA** – The Land Transportation Office (LTO) on Thursday warned motorists against using fake plates due to the intensified crackdown against illegal manufacturers and sellers of fake plates.

In a statement, LTO acting Assistant Secretary Greg Pua Jr. said there is no more reason to use fake plates since the backlog on vehicle plates has been wiped out.

"Lahat may plaka na (All plates have been made), and right now, we are focusing on the immediate distribution of these plates to their owners. In fact, we have already downloaded millions of license plates down to the regional level for distribution," Pua said.

The intensified operation against illegal plates, he said, is in line with President Ferdinand R. Marcos Jr.'s order to run after those who make money through illegal activities in the transportation sector.

To date, the LTO is coordinating with the Philippine National Police (PNP) for its intensified monitoring of sellers of fake plates on social media.

"Titiyakin namin na mananagot kayo, kaya ngayon pa lang, itigil na ninyo ang iligal na gawain ninyo (We will ensure that you will be punished, so, from this moment, stop your illegal activities)," Pua warned.

On Tuesday, Pua and Transportation Secretary Vince Dizon announced that the 11-year backlog on license plates --both for four-wheeled vehicles and motorcycles-- has been wiped out.

Last week, LTO personnel and operatives of the PNP-Criminal Investigation and Detection Group (CIDG) arrested four people for manufacturing and selling fake license plates during an operation in San Ildefonso, Bulacan. (PNA) **BY RAYMOND CARL DELA CRUZ**

## AFP MODERNIZATION FOR PH DEFENSE, NOT OFFENSE

**MANILA** – The Armed Forces of the Philippines (AFP) is being modernized not for offensive purposes but to bolster the country's defensive capabilities, an official said Thursday.

"Just because we have our modernization program does not mean we have any intention to fight another country," Philippine Navy spokesperson for the West Philippine Sea, Rear Admiral Roy Vincent Trinidad, said in an interview with reporters.

"If I may paraphrase the commander-in-chief (President Ferdinand R. Marcos Jr.) in the command conference this morning when he mentioned, and I state, we have no desire to attack anyone."

Trinidad was referring to the AFP Mid-Year Command Conference held earlier in the day at Camp Aguinaldo, Quezon City, which was attended by Marcos, Defense Secretary Gilberto Teodoro Jr., and other ranking Cabinet and military officials.

The Navy official also refuted a retired Philippine

Air Force general's claim that the Philippines is being turned into another Ukraine and used as pawn in the power play between China and the United States.

"We are not preparing the Armed Forces for offense. We are preparing the Armed Forces to defend what is legally and rightfully the Filipinos," Trinidad said, noting that the Philippines is a sovereign state that has its national interests.

The Philippines is locked in a long-running dispute with China over portions of the South China Sea, with the US among its vocal supporters, often calling out China over its aggressive actions against Philippine vessels.

"All the actions of the Armed Forces are in furtherance of this national interest. We will not fight for the interests of another country, nor will we be dictated by them. Standing up for our rights does not mean being subservient to the interests of another country," Trinidad said. (PNA) **BY PRIAM NEPOMUCENO**

## DILG TO LGUS: PASS ORDINANCE TO PUNISH 911 PRANK CALLERS

**MANILA** – Interior Secretary Jonvic Remulla urged all local chief executives to enact ordinances penalizing prank callers to the national emergency hotline, as the Department of the Interior and Local Government (DILG) prepares to roll out the upgraded Emergency 911 system in August.

Reports from the E911 National Office showed that in 2024, nearly 12 million calls were handled by the system, about 60 percent of which were identified as fraudulent, hoax, or prank calls.

"Dapat may ordinance ang lahat ng LGUs na may (All LGUs should have an ordinance that has) monetary fine, jail time basta (if it is a) prank call," Remulla said, emphasizing that prank callers should face real consequences.

He noted that detailed guidelines would follow once the integrated system is fully launched. Remulla warned the public that the new system will have tracking capabilities to quickly identify prank callers.

"May geofence at geo data kasi ang lahat ng tatawag.

So, kung tumawag ka at prank call ka, within five minutes, mahuhuli ka nila (All calls contain geofence and geodata. So, if you make a prank call, within five minutes, you can be caught)," he said.

Currently, individuals who maliciously spread false information may face imprisonment of up to five years, a fine of up to PHP40,000, or both, under Presidential Decree 1727.

The enhanced system will also include language-sensitive capabilities and push-to-talk over cellular (PoC/PTToC) features that allow real-time coordination with more than 1,000 police officers nationwide.

Remulla said the upgraded system is part of the administration's broader push for faster police response in compliance with President Ferdinand R. Marcos Jr.'s directive for improved police visibility and public safety.

"Despite the technology we are using, we are doing very well. Pero sa bagong sistema natin (But in our new system), I think the PNP will have better response time, better quality of response," he said.

He added that all local government emergency systems would be integrated into a single, unified 911 network.

"Ngayon, 34 ang LGU na may sariling 911. Tapos may sarili ang Crame. Ang gagawin natin, magkakaroon tayo ng unified system sa buong Pilipinas (For now, 34 LGUs have their own 911. Then Camp Crame has its own. What we will do [is] we will have a unified system in the whole Philippines)," he said. (PNA) **BY CHRISTOPHER LLOYD CALIWAN**

## DENR TO LGUS: BE PROACTIVE IN ADDRESSING NCR FLOODING

**MANILA** – The Department of Environment and Natural Resources (DENR) on Thursday urged local government units (LGUs) in the National Capital Region, including other urban areas, to include science-based, proactive measures in addressing the worsening flooding amid heavier rainfall due to climate change.

In a statement, the DENR cited the striking increase in rainfall volume attributed to climate change, as indicated in meteorological data issued by the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA).

"This noticeable shift in weather patterns has exacerbated the challenges faced by urban areas like Metro Manila, where heavy rainfall can overwhelm drainage systems and lead to significant flooding," the statement reads.

"It is crucial that LGUs integrate comprehensive flood risk reduction programs into their design and solid waste management plans. By doing so, communities can better protect themselves from the adverse effects of increased rainfall."

The DENR said LGUs could implement several key strategies to effectively

address worsening flooding in Metro Manila.

These include an upgrade on drainage systems, incorporating modern drainage solutions to cope with more intense and frequent downpours, enhancing solid waste management to prevent garbage buildup that eventually blocks floodways, engaging communities in planning and implementing localized flood prevention initiatives, and restoring the ecosystem by implementing green infrastructure to improve water absorption.

The DENR said poor solid waste management remains one of the main contributors to flood-related damage in urban communities, as clogged waterways slow down rainwater discharge.

"As we confront the challenges posed by climate change, it is essential to adapt our urban planning strategies to safeguard our communities," it said.

Meanwhile, as the effects of climate change intensify, the DENR expressed commitment to working closely with the LGUs and the public to promote flood resilience and sustainable urban development. (PNA) **BY MARITA MOAJE**

## DSWD: PARTNERSHIP WITH SHOOLS TO BOOST EDUCATION, EMPLOYMENT OF PWDS

**MANILA** – As the nation marks the National Disability Rights Week from July 17 to 23, the National Council on Disability Affairs (NCDA), an attached agency of the Department of Social Welfare and Development (DSWD), is exploring partnerships with learning institutions to ensure more persons with disabilities (PWDs) can access education and eventually secure employment.

"We have partnership forums with state universities and colleges (SUCs) para makatulong sa researches on ano yung mga need natin na mga move for education sa ating mga (to help in researching what moves we need to do for the education of) persons with disabilities," NCDA Regional Programs Coordinator, lawyer Walter Jason Alava, told reporters in a media forum at the DSWD Central Office in

Quezon City on Thursday.

The proposed collaboration, which aligns with the celebration's theme "Innovation for Inclusion: Building Inclusive Communities Together", aims to bridge the gap between education and employment of persons with disabilities.

Despite the provision of Republic Act 10524 that at least 1 percent of available positions in government agencies, offices or corporations shall be reserved for persons with disabilities, Alava acknowledged that there are still challenges in terms of their qualifications.

"In terms of qualification, doon tayo nagkakaroon ng (that's where we are facing) challenges and gaps because most of our persons with disabilities ay hindi po nakapag-aral (have no education). So, we are moving to forge partnership forums

with SUCs and schools para matulungan tayo to augment yung kakulangan sa education (to help us augment the gaps in education)," he said.

He said the NCDA is now in talks with SUCs and other educational institutions to roll out inclusive programs that will offer scholarships and other opportunities for qualified persons with disabilities.

The NCDA spokesperson said the council also links PWDs to companies offering job opportunities such as business process outsourcing (BPOs), courier services, and restaurants, among others. "Hindi naman tayo [namimili] kung anong klaseng disability. So long as mag-submit sila ng application nila and the company will hire them, we will help them process na makakuha sila ng job (We are not selective as to the nature of their disabilities.

## SC: PROBE UNDERWAY AMID ONLINE THREATS VS. PASIG RTC JUDGES

**MANILA** – The Supreme Court (SC) is working with law enforcement agencies to investigate the online threats against judges of the Pasig Regional Trial Court (RTC).

In a statement Wednesday, the SC confirmed that the judges of the Pasig RTC received online threats sent via email earlier in the day.

"The Court is taking this matter seriously and is closely monitoring the situation. An investigation is underway, in coordination with law enforcement authorities. Appropriate security measures have also been put in place to ensure the safety and protection of the judges, court personnel, court

users, and the general public," SC spokesperson Camille Ting said.

She assured that the Judiciary remains committed to upholding judicial independence.

"Judges will continue to carry out their duties with integrity and calm resolve, guided by fairness and the rule of law," she added.

Among the cases pending before the Pasig RTC are those filed against former Bamban, Tarlac mayor Alice Guo and Kingdom of Jesus Christ pastor Apollo Quiboloy.

## BFAR INITIATIVES SUPPORT SMALL, LOCAL FISHERS OF ANTIQUE

SAN JOSE, Antique (PIA)—The Bureau of Fisheries and Aquatic Resources (BFAR)-Antique reported initiatives to support local fishers, promote sustainable aquatic resource management, and eventually enhance food security in Antique.

BFAR Antique Aquaculturist Aileen Necor-Garcia, speaking on behalf of Provincial Director Rowena Langga, shared the major programs and strategic plans for 2025 of BFAR during the Philippine Information Agency radio program "Pagpaathag" on Radyo Natin San Jose.

These initiatives are in line with the commitment of President Ferdinand Marcos Jr. during last year's State of the Nation Address, making a commitment to support the agriculture sector and ensure food security.

In compliance with this directive, BFAR in Antique has initiated programs both for coastal and inland communities.

BFAR provided motorized boats to seven fisherfolk in the towns of Libertad, Pandan, and Sebastell aimed at improving their fish catch under the National Fisheries Program in the amount of P422,909. Former Mayor Mary Jean Te, now elected Vice Mayor of Libertad, shared gratitude to BFAR for helping small fishers in their locality.

Another important intervention for the fisherfolk in the town of Culasi was the provision of seaweed farm implements, benefiting 180 seaweed farmers in the island barangays of Batbatan and Maningning, Culasi, northern Antique.

Likewise, the group of seaweed farmers in the island town of Caluya received various assistance from BFAR in previous years to boost their productivity.

Through the 2023 Typhoon Rehabilitation and Recovery Program, BFAR distributed 500 sets of seaweed farm implements,

and assistance continued into 2024, with each farmer in Caluya and Culasi receiving 100 kilograms of seaweed seedlings.

"Seaweed farming has become the main livelihood of most coastal residents in Caluya. Despite the damage caused by typhoons, we continue to assist in partnership with the LGUs," said Garcia.

BFAR also provided post-harvest facilities for fish vendors in the towns of San Jose and Patnongon in the combined amount of P130,000, benefiting five fish vendors and one fisherfolk association.

The beneficiaries were also trained on food safety to ensure the safe handling and maintain good quality of fish before selling to their consumers.

BFAR Antique also implements Phase 2 of the Special Area for Agricultural Development (SAAD) program, which has supported the municipalities of Valderrama, Libertad, and Caluya since 2023.

Another notable accomplishment for SAAD is the establishment of the Integrated Demo Farm in Brgy. Binonogan, Valderrama, which features tilapia and catfish ponds and is being developed into a fully integrated agricultural model through joint support from BFAR and the local government. In 2024, BFAR Antique supported 22 aquaculture techno-demo farms provincewide, 16 farmers ventured into tilapia farming, and six into catfish farming, further enhancing aquaculture's contribution to the local economy.

Garcia emphasized that BFAR Antique remains committed to empowering fisherfolk, improving coastal livelihoods, and protecting aquatic ecosystems by working closely with local government units, community organizations, NGAs, NGOs, and other stakeholders. ## PHILHEALTH TO GET OVER P53-B SUBSIDY IN 2026 – RECTO

**MANILA** – Finance Secretary Ralph Recto said state insurer Philippine Health Insurance Corp. (PhilHealth) will receive over PHP50 billion in subsidies next year.

Recto noted this includes a 30 percent to 50 percent increase in benefit packages.

"That should already be a significant improvement in PhilHealth services," he added.

But definitely, we will improve the services of all DOH-run hospitals within the year and next year," he added. ## BIR BEATS H1 TARGET, SEES STRONG GROWTH IN SMALL TAXPAYERS

**MANILA** – The Bureau of Internal Revenue (BIR) has exceeded its revenue collection target for the first half of 2025, reflecting the agency's momentum amid a trimmed full-year goal prompted by slower-than-expected economic growth.

"We are proud to say that we have achieved that PHP1.5 trillion [target] for the first half of the year. So, the BIR is really doing well for the first semester," BIR Commissioner Romeo Lumagui Jr. said in a news release on Thursday.

He said the figure is 0.5 percent higher than the first-half target, the result of the BIR's continued drive to boost compliance and widen the tax base.

"This accomplishment says that the BIR is right on track, that we're going

the right path and what we're doing is good. We just have to continue and improve on a lot of certain things."

The BIR chief noted that growth has been particularly notable in specific sectors.

"For the sectors, we have in terms of growth rate, the percentage, we're looking at the arts, entertainment, and recreation. [They're] doing well in terms of percentage increase compared with the performance last year. We're also looking at administrative and support services. It also is performing well for this year in terms of percentage increase in collections," he said.

Lumagui added that household employment activities saw tax collections double year-on-year, while in terms of absolute numbers, a huge increase was seen in manufacturing and the information and communication industry.

A key highlight for the agency is the surge in contributions from small taxpayers -- those earning gross revenues between PHP3 million and PHP20 million annually.

"We've seen increase of more than 80 percent in tax collection from this taxpayer segment, a promising sign of broadening tax compliance across different income brackets," Lumagui said.

The BIR's first-half performance comes as the Development Budget Coordination Committee (DBCC) revised the 2025 fiscal program in light of a moderated economic outlook.

The DBCC lowered the national revenue target to PHP4.520 trillion from PHP4.644 trillion, with the BIR's collection goal adjusted slightly to PHP3.219 trillion from PHP3.232 trillion.

GDP growth is now projected at 5.5 percent to 6.5 percent, down from the initial 6.5 percent to 7.5 percent range.

Lumagui acknowledged that another recalibration could be possible.

"I think there might be a recalibration of the goal again considering that the assumption is not going to happen. But there's no final figure yet." (PNA)

## PSEI, PESO DOWN FURTHER ON POSSIBLE FED LEADERSHIP CHANGE

**MANILA** – Talks about the possible change in the Federal Reserve's leadership pushed the Philippine Stock Exchange index (PSEi) and the peso deeper Thursday.

For the third straight day, the main stocks gauge slipped and ended the day's trade at 6,295.55 points, down 0.66 percent; and the broader All Shares by 0.67 percent to 3,723.14 points.

Mining and Oil led the sectoral counters with a decline of 2.35 percent, and was trailed by the Holding Firms, 1.41 percent; Industrial, 0.77 percent; Financials, 0.73 percent; Property, 0.61 percent; and Services, 0.59 percent.

Trading volume reached 2.41 billion shares amounting to PHP7.33 billion. Losers led gainers at 112 to 75, while 56 shares were unchanged.

"Philippine shares continue to tumble as concerns surfaced from a rumor regarding a potential Fed leadership change," Luis Limlingan, Regina Capital

Development Corporation head of sales, said.

He said concerns about the Fed rate adjustment, given the rising US inflation rate and its impact on the global market, also affected investors' sentiment.

On the other hand, Limlingan noted the decline in oil prices in the international market on concerns of higher US fuel inventories and the overall impact of the US' tariff policies.

The local currency also weakened further after ending the day at 57.29 against the US dollar, from its 57.08 close a day ago. It opened the day already on a depreciated level of 57.05 from day-ago's 56.85.

The peso improved to 56.95 mid-trade but was also pulled to 57.3. The average level for the day stood at 57.12.

Volume rose to USD1.93 billion from the previous session's USD1.58 billion. (PNA) **BY JOANN VILLANUEVA**

## DOF: NO NEW TAX UNDER CMEPA

**MANILA** – The Department of Finance (DOF) on Thursday clarified that the Capital Markets Efficiency Promotion Act (CMEPA) does not impose a new tax but standardizes the tax rate on interest income to correct an unfair system that favored the wealthy.

In a statement, the DOF said under CMEPA, the tax on interest income was set at 20 percent to simplify compliance, eliminate confusion, and level the playing field for all Filipinos. Prior to the law's passage, the National Internal Revenue Code of 1997 imposes a 20 percent final tax on interest earned from bank deposits with a maturity of less than three years.

The DOF, citing data from the Bangko Sentral ng Pilipinas (BSP), said more than 99.6 percent of total deposits were already subject to the 20 percent tax rate, while only 0.4 percent enjoyed preferential rates. "More specifically, the deposits that benefited from favorable rates are those with a maturity period of more than five years, which are tax exempt, while deposits that mature in 4 to 5 years and 3 to 4 years are subject to just 5% and 12% tax, respectively," said the DOF.

It noted that the special tax treatment favored those who can afford to park

their savings in long-term deposits, making the tax system unfair for short-term depositors who face liquidity issues and need immediate access to their funds.

"The CMEPA merely corrects this outdated and inequitable system that placed a heavier burden on ordinary Filipinos who do not have the extra cash to put in banks for longer periods. With the new law, interest income is now taxed uniformly with a flat rate of 20%, regardless of the maturity period," the DOF said.

The DOF also clarified that the standardized tax rate is not retroactive and does not apply to financial instruments that were issued or transacted before July 1, 2025.

Existing long-term deposits made prior to the effectivity of the law will continue to enjoy the preferential rate until their maturity.

The unified rate also does not apply to provident savings programs under the Social Security System (SSS), Government Service Insurance System (GSIS), and Pag-IBIG such as MP2.

These savings programs remain exempt from tax. Apart from leveling the playing field, the DOF said CMEPA empowers ordinary Filipinos to invest and diversify their sources

of income by reducing the stock transaction tax (STT) rate from 0.6 percent to 0.1 percent, reducing the documentary stamp taxes (DST) on original issuance of shares from 1 percent to 0.75 percent, and removing the DST on collective investment schemes.

CMEPA removed the DST on the original issuance, redemption, or transfer of mutual fund shares, as well as certificates or proof of participation in mutual funds or investment trust funds.

"These measures are seen to cut transaction costs, encourage market participation and financial planning, boost market liquidity, make the country's equities market regionally competitive, and increase capital market growth," the DOF said.

The DOF said CMEPA also imposes a uniform 0.75 percent DST on bonds, debentures, and certificates of stock or indebtedness issued in foreign countries, regardless of jurisdiction.

"The DOF will continue to exercise prudence in formulating sound fiscal policies to eliminate inconsistencies in the system and ensure a more equitable tax environment for the people," the DOF said. (PNA) **BY ANNA LEAH GONZALES**

Wacan finished with a one-over 217 total over 54 holes, beating fellow Davaoño Adrian Bisera, who carded a 74 for a 218 total.

Three-leg winner Alexis Nailga had an 80 to settle for third at 231, while David Teves shot a 75 for fourth with a 232.

"It's a great feeling to win at home. Playing these past two weeks really taught me how to stay light and happy on the course. I've learned not to let distractions or frustration get the better of me, and just enjoy the game," said

the 16-year-old Wacan, who lost to Bisera by 11 strokes in last week's South Pacific leg.

"I know I still have a lot to work on, especially my long game and putting, and I'm determined to keep improving," he added.

AJ's cousin, Merry Rose Wacan, also triumphed in the girls division after beating Del Monte leg winner Zero Plete by seven shots with a 237 total, despite a closing 83.

Despite having to play a new role as coach at least for one day, she said that it was a fulfilling one.
