He emphasized that the Labor department remains hands-on in ensuring that employees across the region receive fair wages, lawful benefits, and a safe working environment.

"When there are complaints [from the workers], we immediately mediate or conciliate conferences to resolve issues quickly and properly through Single Entry Approach or SENA," Aquino said.

"It can also be done online, before filing a case in court or with a labor

arbiter, it is first discussed through a conciliation-mediation conference. The goal of SENA is to resolve issues within just 30 days, without the need for a long process and costs," the director explained.

#### HIGH-VALUE TARGET ARRESTED, P544K WORTH OF SHABU SEIZED IN CAVITE

Camp BGen Pantaleon Garcia, City of Imus, Cavite – In a successful drugs anti-illegal operation conducted joint operatives of Provincial Drug the Enforcement Unit (PDEU) of Cavite Police Provincial Office and Imus City Component Police Station, and coordination with PDEA arrested a High-Value Individual (HVI) at around 6:30 PM on May 7, 2025, in Brgy. Malagasang 2G, Imus City, Cavite.

PLTCOL Chester Noel Borlongan, Chief of the Police Intelligence Unit (C, PIU), identified the arrested individual as alias "PIS", and a resident of Brgy. Malagasang 2, Imus City. The suspect was apprehended during a buy-bust operation after being confirmed to be involved in the illegal drug trade.

Confiscated from suspect the were following items: the Five (5) heat-sealed transparent plastic sachets containing white crystalline substance suspected to be shabu, weighing more or less 80 grams, with a standard drug price value of Php 544,000.00.

The entire operation was properly documented using an Alternative Recording Device, and witnessed by Mr. Ralph Regin Nilooban (media representative) and Hon. Armando Fauni (elected official), ensuring transparency and compliance with operational protocols.

The suspect will be facing charges for Violation of Sections 5 and 11, Article II of Republic Act 9165, also known as the C o m p r e h e n s i v e Dangerous Drugs Act of 2002.

## PH'S FIRST E-JEEPNEY FACTORY OPENS IN BATANGAS

LIPA CITY (PIA) - The electric country's first jeepney (e-jeepney) assembly plant has opened in Lima Park in Lipa City, Batangas.

Owned by the LCS Group of Companies and its South Korean partner Electric Mobility ON (EMON), the factory aims to produce low-cost, environmentally friendly electric jeepneys to help drivers and operators cope with the high costs of other modernized vehicles. Each modern e-jeepney unit is priced at ₱1.2 million which is lower than the usual ₱2.5 million to ₱3 million price range in the market.

This initiative is a result of the collaboration between LCS Group and the EMON, which designed the 27-seater e-jeepney, combining modern technology with the iconic Filipino jeepney design. With this lower cost, the

LCS Group said, drivers are expected to recover their investment within two to three years. The company added that it targets to produce 500 units monthly, with plans to scale up based on demands.

The plant is also expected provide jobs and to opportunities livelihood around 80 workers, to future expansion with planned in the Visayas and Mindanao regions.

The factory is currently awaiting franchise approval from the Land Transportation Franchising Regulatory Board and (LTFRB) to officially deploy e-jeepneys for public transport services.

In an interview with Mai. Gen. Rudolph Dimas regional director of LTRB IV-A. the establishment of the assembly plant will create a nice atmosphere and good competition between companies offering e-jeepney.

í is Íthe first "This manufacturing company in the Philippines. It is ecofriendly and cheaper for the price of ₱1.2 million each unit compared to the ₱2.5- ₱4 million worth from others offering the same . It is very advantageous to the operators since the said company noted that in two or three years time they will be able to get back their capital," Dimas noted. He also mentioned that conducted thev have initial coordinations and meetings with the company and requested that a unit of this e-jeepney be tested in Tagaytay with the operators to see if the units produced can traverse high slopes or terrain.

#### **NEW SOLAR-POWERED IRRIGATION SYSTEM IN UEZON TO BOOST**

Water remains a vital resource for agriculture as it supports healthy plant growth and boosts crop vields.

In Quezon Province. the National Irrigation Administration (NIA) recently achieved another milestone following the directive and mandate of President Ferdinand R. Marcos Jr. of instituting development programs for agriculture.

The official turnover of Castañas Centro the Irrigation Communal Solar System Pump Irrigation Project is to transform expected the lives of 33 farmerbeneficiaries by irrigating 50 hectares of agricultural land in Sariaya town.

For Edgardo Valdoria, a 46-year-old farmer from Barangay Castañas and president of the local irrigators association, farming has been his livelihood and main source of income since childhood, which is why he often laments reduced earnings due to fluctuating diesel prices used in traditional irrigation systems.

#### DMW WARNS PUBLIC VS ILLEGAL RECRUITERS

CALAMBA CITY, Laguna (PIA) — The Department of Migrant Workers (DMW) warned Overseas has Filipino Workers (OFWs) and job seekers to be vigilant in dealing with recruitment agencies, following an incident of illegal recruitment in Baras, Rizal.

In an interview with the Usapang PIA radio program, Assistant Regional Director Karen M. Quilao emphasized the importance of validating an agency's legitimacy through the DMW website and official platforms.

"If OFWs or job seekers applying abroad want to know if a recruitment agency has a license or valid job order, they may visit our official websites, all updates are there, Quilao explained.

She also reminded job applicants to avoid recruiters who immediately ask for a placement fee without issuing an official receipt or who promise quick deployment through a tourist visa.

Quilao emphasized: "If you're applying abroad, make sure you have an Employment Overseas Certificate (OEC), a legal employer, and the correct exit permit and clearance." She encouraged victims of illegal recruiters to seek help at any DMW office to receive the necessary assistance.

"If you are not available to visit in person, you can send an email, and DMW personnel will immediately contact you to provide assistance and the legal advice needed."

Following the illegal

recruitment incident in Rizal, Quilao said that they will expand the antiillegal recruitment drive to strengthen public awareness and ensure safety against illegal recruiters.

Last April 28, the National Bureau of Investigation (NBI) and DMW officials conducted an entrapment and closure operation at a church involved in the illegal recruitment of workers in Baras, Rizal.

According to the NBI, the illegal recruiter charged victims P50,000 each for processing fees and documents and promised jobs in Japan, Korea, and Papua New Guinea, with salaries ranging from P36,000 to P120,000.

The NBI added that some victims were offloaded, others were deployed, save up to approximately Php80,000 in operating costs per cropping season. "I hope we will earn more now through the project, unlike before when we used to spend around P40,000 to P50,000 just on diesel, not including the amount we paid someone to help deliver the irrigation water to us. Even after harvesting, there was very little left for our family, Valdoria explained.

Frederico Meanwhile. Alday, a local farmer and also an IA President in neighboring Barangay Castañas, the solarpowered irrigation system will inspire more farmers to rekindle their passion for agriculture and dream again for a better life.

Alday stated: "Little by little, I see the enthusiasm of our farmer returning back to life. We're not just working hard to survive anymore; we're beginning to hope and dream again.'

The irrigation project, funded through the Fiscal Year Establishment of Irrigation Project Pump (EPIP) with a budget of Php50 million, is seen as a viable offer reliable and renewable water source, crucial for areas with limited supply.

#### DOJ, PNP TO SEEK MORE TIME TO ANSWER OMBUDSMAN OVER DUTERTE ARREST

MANILA Justice Secretary Jesus Crispin Remulla met with Philippine National Police Criminal Investigation and Detection Group (PNP-CIDG) officials led by Maj. Gen. Nicolas Torre on Friday to map out their reply to the charges filed before the Office of the Ombudsman in connection with the arrest of former president Rodrigo Duterte.

In an interview with reporters, Remulla said they plan to ask the Ombudsman for more time to answer the charges.

He said among the matters they plan to bring up are the pending cases before the Supreme Court (SC) which may pose a prejudicial question on the Ombudsman cases.

"We just agreed that we'll adopt, we'll just have one answer for all procedural issues, aside from the other allegations that are individual. Then we have an answer for everyone for the commonly held issues," Remulla said.

#### CFO TO FILIPINOS: AVOID INDIA-PAKISTAN BORDER AMID RISING TENSION

They should also maintain contact with employers, coordinators, the Philippine Embassy, Assistance-to-Nationals (hotline +92 333 5244 762).

The advisory followed India's Operation Sindoor, a coordinated air strike targeting alleged militant sites in Pakistanadministered Azad Kashmir, following an April 22 terror attack that killed 26 people in Pahalgam, Jammu and Kashmir.

India and Pakistan have fought multiple wars and skirmishes over the disputed Kashmir region. The region has seen renewed unrest in recent years, and the current strikes mark one of the most serious escalations since the 2019 Pulwama crisis.

The CFO assured continuous close monitoring of the situation, together with the Department of Foreign Affairs.

In a Radyo Pilipinas interview on Thursday, Philippine Ambassador to India Josel Ignacio assured readiness to assist Filipinos in case the situation worsens.

#### AIRPORT EXEC: NO ADVERSE FINDINGS AGAINST NAIA BOLLARDS PROJECT

**MANILA** – The fatal crash at Ninoy Aquino International Airport (NAIA) Terminal 1 that killed two people and injured four others on May 4 triggered renewed scrutiny of the airport's bollard system, the protective barriers meant to prevent vehicles from breaching critical areas.

The PHP8-million project, completed in 2019, failed to stop the vehicle that crashed into the departure area, raising questions about the effectiveness and integrity of the installation.

Manila International Airport Authority (MIAA) General Manager Eric Ines, in an interview with the Philippine News Agency, traced the origins of the project to international security audits.

In 2017, the United Kingdom's Department for Transport flagged the absence of "hostile vehicle mitigation measures" at NAIA, including bollards or concrete planters, citing risks of vehicle-borne attacks.

The audit came amid then-active flights between Manila and London operated by Philippine Airlines

Despite the warning, bollards were not installed until 2019, following a second audit held 2018 by Australian Homeland Security which echoed the same concerns across all NAIA terminals.

That year, Kontrak Enterprises was awarded the project to install bollards at Terminals 1 to 4.

Pressed on accountability, Ines declined to secondguess decisions made by his predecessor, former MIAA General Manager Ed Monreal.

"I can't say, 'It should have been done differently,' without evidence," he said. In the wake of the incident, the airport's current operator, New NAIA Infra Corp. (NNIC), began implementing corrective measures.

These include reinforcing bollard foundations and modifying the Terminal 1 drop-off layout from diagonal to parallel to enhance pedestrian and passenger safety.

"They are also evaluating other options to strengthen bollard performance," Ines said.

In a statement released May 6, NNIC said the changes, including increased police presence, are part of a broader effort to provide "an added layer of protection" for travelers, airport staff and visitors. (PNA) BY MA. CRISTINA ARAYATA

#### NAPOLCOM EYES ZERO CASE BACKLOG BY DECEMBER 2025

MANILA – The National Police Commission (Napolcom) said Friday it targets to clear its case backlog against erring police officers by December this year.

In a press conference at the Department of the Interior and Local Government (DILG) main office in Quezon Napolcom City. Vice Chairperson and Executive Officer (VCEO) Rafael Calinisan said Vicente another 39 cases this week added to the thousands of pending cases before the commission.

commission must be resolved within 60 to 90 days from filing. Calinisan said they

are looking to hire more lawyers, set tight deadlines and hold lawyers accountable for delays in cases.

"It's just a matter of planning and discipline. Ang pinakaimportanteng (The most important) word, if ever, is accountability not just for those being sued but also for those who are handling those cases," he said.

Calinisan also called for a more stringent application process for aspiring police officers to prevent misfits from joining the ranks.

"We have also look on the recruitment process of the PNP maybe, there's something that we are missing so what we are looking into of two things --psychological problem, neuro psychological problem," he added.

Meanwhile, Calinisan reiterated that there is no place for rogue cops in the PNP.

He also announced that Napolcom is set to confer the Police Executive Service Eligibility (PESE) Certificate on 209 Police Commissioned Officers (PCOs) from various police offices and units.

The PESE is a requisite eligibility for appointment to the third level ranks of Police Colonel, Police Brigadier General, Police Major General, Police Lieutenant General, and Police General as provided under Napolcom

Resolution No. 2006-082. The program is designed to evaluate the analytical, leadership, and valuesbased competencies of senior police officers, ensuring a pool of qualified candidates for executive positions within the PNP. (PNA) BY CHRISTOPHER LLOYD CALIWAN



#### BI NABS 31 FOREIGNERS IN MAKATI SCAM HUB RAID

**MANILA** – The Bureau of Immigration (BI) on Friday reported the arrest of 31 foreign nationals, most of them Chinese, suspected of engaging in online scam operations following a raid in Makati City earlier this week.

In a statement, BI intelligence division chief Fortunato Manahan Jr. said the raid took place Monday evening on the 11th floor of a commercial building along Ayala Avenue.

He said operatives discovered dozens of foreigners manning computer workstations allegedly used for fraudulent activities targeting individuals abroad.

To hide its illegal operations in the building, the company allegedly displayed the name of a popular insurance firm on its entrance.

Of the arrested foreign nationals, 24 were Chinese, two were Taiwanese, three were Malaysian, and two were from Myanmar. All were found to be working without the necessary permits in violation of the conditions of their stay, and have been tagged as undesirable.

The suspects are now detained at the Bureau's Warden Facility in Camp Bagong Diwa, Taguig City, pending investigation and deportation proceedings.

The BI said the operation is aligned with President Ferdinand R. Marcos Jr.'s directive to safeguard national security and protect the country from becoming a base of operations for international cybercrime syndicates.

Commissioner Joel Anthony Viado said these arrests send a strong signal to criminal elements that the Philippines will not be used as a safe haven for foreign-led cybercrime operations.

"This operation reflects our firm commitment to Marcos' directive to secure our borders and uphold the rule of law," he said.

"Foreign nationals who exploit our systems, abuse our hospitality, and engage in illegal acts will be dealt with decisively." (PNA) BY FERDINAND PATINIO

#### TEODORO WANTS TO SEE Exercise Line-UP, Terrain For 'Balikatan' 2026

**MANILA** – Department of National Defense (DND) Secretary Gilberto Teodoro Jr. said he wants to see the choices of exercises and terrain for next year's 'Balikatan' drills, as the annual exercise between Filipino and American military forces formally concluded Friday.

"Now, this being the 40th iteration which culminated in the full battle exercise, what the President (Ferdinand R. Marcos Jr.), (National Security Adviser) Secretary (Eduardo) Año, and I would want to see is not only the execution of next year's exercises, but more importantly the choice of exercises, what you are going to be doing and where you are going to be doing them, what terrain you are going to operate in, what environments you are going to operate in," he said in his speech during the exercise's closing rites at Camp Aguinaldo, Quezon City.

Aside from this, Teodoro also wants to see how "Balikatan" 2026 will interact with the civil infrastructure works, supply routes, and other civilian infrastructure.

He added that this is necessary to determine whether the exercises are aligned with the needs of the Armed Forces of the Philippines (AFP) and the plans of the Philippine government for the institution next year.

"So, next year will not merely be an exercise in execution and choice of exercises, but we will go deep down into the assumptions on why you training shoulderare to-shoulder to do a particular activity. And I think that will enhance our interoperability, not only (on) the tactical level, but more importantly on the operational and of course, on the strategic levels too," the DND chief stressed. capabilities Deterrence

#### EU WANTS TO SPEED UP FTA WITH PH AMID TARIFF UNCERTAINTIES

**MANILA** – The European Union (EU) is interested in fast-tracking a free trade agreement (FTA) with the Philippines in the wake of global trade uncertainties fueled by the new tariff policies of the United States.

EU Ambassador to the Philippines Massimo Santoro on Thursday night said both the Philippines and the bloc have a "political wish" to speed up talks on the deal, which is seen to blunt the possible impact of the Trump administration's new tariffs imposed on its partners.

"It's not the tariffs in itself that are impacting the negotiation, but it's the fact that when all those countries in the world, like us, the Philippines and many others, see that somebody wants to bring in tariff, etc.- what we consider obstacles to international free trade— it comes as a normal political response that we have even a stronger wish to have this FTA done faster," he told reporters at the Europe Day 2025 reception in Makati City.

"It's a way for us to protect our markets. The best way to protect markets is to make them free. This is the quintessence of our

"We do not put artificial deadlines, but I must also observe that it is with the current (Marcos) administration that these negotiations are particularly fruitful. We have still, of course, some rounds to go," he added.

The first negotiation for a Philippine-EU FTA was launched in December 2015, with the first round in May 2016 and the second in February 2017.

This was stalled after the EU raised concerns on humanitarian issues in the Philippines during those years.

The two sides' workinglevel experts concluded a series of stock-taking discussions in December 2023 after the Manila visit of European Commission President Ursula von der Leyen, where she and President Ferdinand Marcos Jr. announced their intention to re-launch the FTA negotiations.

#### DND CHIEF SEES MORE AGGRESSION FROM CHINESE NAVAL FORCES IN WPS

MANILA - Department of National Defense (DND) Secretary Gilberto Teodoro Jr. said he expects an increased aggression from Chinese maritime forces toward Filipino naval vessels patrolling Shoal Scarborough (also known as Bajo de Masinloc) and other parts of the West Philippine Sea. "We have to expect more of the same," he said in an ambush interview shortly after the closing ceremonies of this year's "Balikatan" drills held at Camp Aguinaldo, Quezon City on Friday.

The DND chief's remarks came following the May 5 incident where Chinese frigates and coast guard vessels conducted "aggressive and unsafe" actions against the offshore patrol vessel BRP Emilio Jacinto (PS-35), which was then conducting a routine maritime patrol some 11.8 nautical miles southeast of Bajo de Masinloc.

Teodoro, however, said Manila remains undeterred by these acts of Beijing, stressing that Filipino naval forces will continue patrolling the area as it is part of the country's jurisdiction.

"We have to expect those things to happen. Sinasabi ko kanina, there is a price to pay for freedom. Ngayon, ano ang price? Kung magdesisyon tayo madali, appease, na capitulate. Ngayon, kung tinatawag natin ang sarili natin na republika at makasarinlan , stand up, nasa stand up tayo, ang cost nun mangyayari to (Like what I said earlier, there is a price to pay (for) freedom. Now, what is the price, if we decide to do the easy part, we can appease and capitulate. Now, if we call ourselves a Republic and a sovereign one, we

stand up, we are standing up right now)," the DND chief said.

"Sila (China) ba (ang) nagdidikta ng batas ng mundo? (Are they the ones dictating the laws for the whole world?)," he quipped.

Teodoro, however, refused to comment on whether the Philippine military will make adjustment amid China's actions, saying it is an operational matter.

National Security Adviser (NSA) Eduardo Año earlier said "security challenges" in the South China Sea are unlikely to be reduced anytime soon.

Año attributed the tensions to China's baseless, excessive, and expansive territorial claims, militarization, and confrontations with its neighbors, which he said cannot be disregarded. (PNA) BY PRIAM NEPOMUCENO



# ILOCOS SPURS COMMUNITY GROWTH WITH P11.6-B GOV'T PROJECTS

SAN FERNANDO CITY, La Union (PIA) - The government continues to improve the lives of the llocos people in Region through P11.62 billion worth of public projects in 2024, boosting infrastructure. health services, education, and livelihoods.

These projects, monitored by the Department of Economy, Planning, and Development (DepDev) Region 1 in through Regional Project the Monitoring and Evaluation (RPMES), System reached a 98.68 percent completion rate.

A total of 138 projects were tracked in 2024, with 102 completed and 36 still ongoing.

These projects include roads, bridges, irrigation systems, and flood control structures.

Projects in this area helped support farming, job training, small businesses, cooperatives. and comprising the bulk of the 8,206 jobs reported in the region.

Resources (DENR), with P17.32 million in funding, was used for forest protection, tree planting, and environmental cleanups.

The governance sector, which includes the Department of the Interior and Local Government (DILG), P85.65 used million for projects to help improve local government operations and transparency.

Of those employed through these projects, 85 percent (7,004) were male and 15 percent (1,202) were female.

These jobs helped families earn income and gain experience, especially in rural areas.

DepDev Region 1 Director Regional Project and Committee Monitoring (RPMC) Chairperson Stephanie Christiansen emphasized that these results are part of a bigger effort to involve both government and citizens in development.

'Online dissemination of RPMES reports is important in apprising stakeholders and our development partners status on the of implementation of priority programs and projects in the region," Christiansen said.

# LEYTE WATER DISTRICT TO HEED MOUNTING CALLS TO END CONTRACT WITH PRIMEWATER

TACLOBAN CITY (PIA) -Several local government units (LGUs) and water districts in the Philippines have recently taken steps to terminate or reconsider joint their venture agreements (JVAs) with PrimeWater Infrastructure Corp. due to mounting complaints about poor service quality.

Among them is the Leyte Metropolitan Water District (LMWD) in Tacloban City which is in full agreement to the Local Water Utilities Administrationled investigation into the allegedly poor water services of the Villarowned Prime Water.

LMWD General Manager Ronnie Cornico said they have just recently concluded а detailed review, five years into the contract, and the review team found out several undelivered required agreements which were specifically stipulated in the contract.

"They have not delivered what were expected of them based on the contract. On top of that are the persistent issues which have been mounting,' Cornico said.

He pointed to an aging infrastructure, with many of the pipelines leaking resulting to non-revenue water, and the lack of longterm investment.

PrimeWater, which operates over 70 water districts nationwide,

had promised improved infrastructure and more efficient service - but for many LGUs, including those serviced by the LMWD, the reality hasn't met expectations.

PrimeWater is servicing the towns of Palo, Tanauan, Tolosa, Dagami, Pastrana, Sta. Fe, Babatngon, and the City of Tacloban in Leyte.

Among the continuous complaints of

concessionaires are the inconsistent and low water supply in majority of the areas in Tacloban City. Feeling the brunt, the slowto-none water flow is the city's downtown area and northern barangays.

Across many areas in the LMWD coverage, residents are experiencing daily disruptions. Some stay late into the night just to catch a trickle from the tap and bring to a full a pail or two. Others have resorted to buying expensive refilled water or relying on deep wells, which aren't always safe.

Lorna Sabusap, who lives in a unit inside the Kapuso Village in the city's northern barangay together with seven of her family members, said most of the time they do not have water supply, yet they are paying a monthly bill which they think is more than they have consumed. Sabusap is in full agreement with the recent order of President Ferdinand R. Marcos Jr. to investigate into the services of PrimeWater.

Water, she said, is a fundamental human right, essential not only for drinking and hygiene but for sustaining livelihoods.

#### PH TO BECOME \$2-T ECONOMY BY 2050

**MANILA** – The Philippines sustained its strona growth economic and momentum will likely become a USD2 trillion economy by 2050 barring external shocks, according to Department of Economy, Planning, and Development (DEPDev) Arsenió Secretary Balisacan.

Speaking at the Philippine Economic Dialogue in Milan, Italy, on Tuesday, Balisacan presented the country's robust economic performance, investorfriendly policies, and longterm vision to European business leaders and financial stakeholders.

Balisacan highlighted the economy's desirable market features, citing its USD392 billion economic size, remarkable progress as a rising middle-income country, and a population of 114 million with a median age of 27.

"At our current growth trajectory—and barring significant external shocks—we anticipate reaching a USD2 trillion economy by 2050," he said.

#### IFPB TO REVIEW THE ANNUAL BLOCK GRANT FORMULA FOR BARMM

Intergovernmental Fiscal Policy Board (IFPB) has resolved to commence the review of the Annual Block Grant (Block Grant) formula for the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM).

In a statement on Friday, the Department of Finance (DOF) said the move would promote greater fiscal autonomy and development in the region. The IFPB is co-chaired by Finance Secretary Ralph Recto for the government national and Minister of Finance, Budget and Management Ubaida Pacasem for the Bangsamoro government. The review is in accordance with Section 22, Article 12 of Republic Act 11054 or the Bangsamoro Organic Law (BOL), which requires the review of the Block Grant formula every five years.

The Block Grant is equivalent to 5 percent of the net national internal revenue tax collection and the net collection of the BOC from the third fiscal year immediately preceding the current fiscal year.

The IFPB is tasked to review the ABG formula five years after its effectivity, and every five years thereafter, to consider, among others, the fiscal needs of the Bangsamoro government and the actual revenue it shall be able to generate to ensure that all block grant expenditures are transparent and performance-based.

Consultations will be held with development partners and ASEAN valuable countries with knowledge and expertise in the administration, management, and implementation of block grants or similar fiscal transfer mechanisms.

The IFPB aims to conclude the review by the first quarter of 2026 to ensure that the ABG amount, based on the agreed computation, will be included in the preparation for the 2027 national budget.

"I am optimistic that this review will result in a more responsive and effective Block Grant formula that will further strengthen the BARMM towards a just and lasting peace as well as inclusive development in the Bangsamoro region," Recto said.

In 2024, the Bangsamoro government received a total of PHP70.51 billion as Block Grant from the national government.

From 2020 to 2024, the total Block Grant received by the Bangsamoro government amounted to PHP337.53 billion.

The DOF said Minister Pacasem welcomed the joint review and expressed his appreciation for the national government's proactive approach. (PNA) BY ANNA LEAH GONZALES
