NEW 4PH HOUSING PROJECT TO RISE IN BACOOR



BACOOR, CAVITE—Anew chapter in Bacoor's journey toward inclusive and sustainable housing has begun with the groundbreaking of the Salinas-Bacoor housing project under the national government's flagship Pambansang Pabahay para sa Pilipino Program (4PH).

Key officials from the city government and the Department of Human Settlements and Urban Development recently broke ground, signaling the start of the project's construction.

Situated on a 1.9-hectare property in Barangay Salinas I, the development is set to offer approximately 2,000 housing units. Each unit will feature two bedrooms and will be offered at a package price of Php 1,800,000.00—a significant step toward addressing the housing backlog and improving the living conditions of Bacooreños.

In his message, Mayor Strike Revilla described the project as a "lifelong dream finally realized" for the city.

He extended heartfelt thanks to Secretary Acuzar, the Pag-IBIG Fund, and all government and private stakeholders whose collaboration made the project possible.

"This is more than a construction project. This is about building hope, dignity, and opportunity for the people of Bacoor," he said.

The event was attended by officials from the Department of Human Settlements and Urban Development (DHSUD), led by Undersecretary Avelino Tolentino III, who represented Secretary Jose Rizalino Acuzar. He was joined by Assistant Secretary Krsnadasi De Leon in officially launching the project, which aims to transform lives through decent and affordable housing.

Alcudia added: "Unfortunately, 22 years into the implementation of the NSTP [law], we have not seen the NSRC wherever there are calamities and disasters. This is the thrust of the Office of Civil Defense." "Because of the absence of the NSRC. in many cases it is the graduates of the ROTC who provide the augmentation to local

government units for disaster response." Citing Resolution No. 2025-003 of the CALABARZON Regional Peace and Order Council, Alcudia stated that Region 4A has been designated as the pilot area for the initiative, which will be spearheaded by city

and municipal treasurers. "There is a need right now to look back on the intent of the law, so we can look at how we can tap the graduates of NSTP for disaster the response missions. This is because of the current developments in the security environment, and the Armed Forces of the Philippines and our reserve force are more into military defense preparedness and training.

The official noted: "We need to have a civilian reserve that our local government units can rely on during times of disaster and calamities."

DAR CANCELS OVER P500K UNPAID AMORTIZATIONS FOR 220 CEBU FARMERS

MANILA – A total of 220 agrarian reform beneficiaries (ARBs) in Cebu province were relieved from paying some PHP502,468 in unpaid amortizations under the condonation program of the Department of Agrarian Reform (DAR).

In a news release on Thursday, Agrarian Reform Secretary Conrado Estrella III said the condonation covered a total of 170.382 hectares of agricultural land across municipalities the of Pinamungajan, with 157 ARBs; Toledo City, with 52 ARBs; and Aloguinsan, with 11 ARBs.

"This is not just about land, it's about giving our farmers a better life," he said.

Estrella stressed the importance of empowering farmers by freeing them from decades of debt.

Farmer Bienvenido

Tango-an of Pinamungajan was among those who celebrated the milestone. "Malipay gyud ko. Sa wakas, dili na mi mobayad sa Land Bank (I'm truly happy. Finally, we don't have to pay to the Land Bank of the Philippines anymore)," he said.

The debt relief is part of the implementation of Republic Act 11953, or the New Agrarian Emancipation Act, which was signed into law by President Ferdinand R. Marcos Jr. on July 7, 2023. The law aims to condone over PHP57 billion in unpaid amortizations, benefitting more than 600,000 ARBs across the country.

NEW LAW ADDRESSES CHILD DEATHS WITH EARLY CARE ACCESS

MANILA – A lawmaker on Thursday said the newly signed Early Childhood Care and Development System (ECCD) Act will help reduce infant and child mortality by ensuring access to proper health and nutrition from pregnancy through early childhood.

Las Piñas Representative Camille Villar lauded President Ferdinand R. Marcos Jr.'s signing of Republic Act No. 12199, which aims to institutionalize a comprehensive approach to early childhood care.

"This law will boost our government's policies in nurturing our children, from birth to toddler years. I am glad that this law saw the light of day," Villar said. Villar, who is one of the law's principal authors in the House of Representatives, said the new law would ensure that adequate health and nutrition programs are accessible to young children and their parents and parent-substitutes, from the prenatal period throughout the early childhood year.

"The development of children, from birth to their toddler years, is important. Sadly, many Filipino families are unable to fully take care of these needs due to various reasons," she said. RA No. 12199, according

to Villar, aims to safeguard and promote the right of every child to holistic well-being, growth, and dedicated care, recognizing the ageappropriate stages of development.

Under the new law, the government commits to create nurturing environments for children that ensure a healthy and sustainable program for nutrition, age-appropriate development, and special protection with full recognition of the nature of childhood.

It also assigns primary i m p I e m e n t a t i o n responsibilities to local government units, including creating ECCD offices, establishing plantilla positions for child development teachers (CDTs) and workers (CDWs), and providing essential resources.

To address the longstanding issues of underemployment and low pay, RA 12199 mandates p r o f e s s i o n a l i z i n g ECCD workers, setting qualifications, training, certification, and salary standards.

Villar is poised to join the Senate in the 20th Congress based on partial unofficial results of the May 12 elections as of Thursday afternoon. (PNA) BY FILANE MIKEE CERVANTES **MANILA** – The Philippine National Police (PNP) said six big casinos terminated the operations of the two junket operators linked to the kidnapping of businessman Anson Que.

In a press briefing at Camp Olivas in San Fernando City, Pampanga on Thursday, PNP spokesperson Brig. Gen. Jean Fajardo said the six casinos made the decision due to the junket operators' possible violation of laws.

The PNP previously that junket alleged Dynasty operators 9 Group and White Horse Club facilitated a money laundering operation involving approximately PHP200 million ransom paid for the release of Que, also known as Anson Tan.

On Monday, the Anti-Money Laundering Council (AMLC) said it has started a probe into the alleged money laundering of the ransom money paid.

The AMLĆ said the ransom monies were originally paid in Philippine peso and US dollars but were later converted to cryptocurrency. Que and his driver,

Que and his driver, Armanie Pabillo went missing on March 29 after leaving the former's office in Valenzuela City. The following day, Que's family received a ransom demand of USD20 million through a phone chat application.

NEW RULES ON CLAIMS FOR VICTIMS OF VIOLENT CRIMES, UNJUST IMPRISONMENT

MANILA – The Department of Justice (DOJ) on Thursday announced the adoption of the revised implementing rules and regulations (IRR) of the Board of Claims (DOJ-BOC) for victims of unjust imprisonment and victims of violent crimes.

Justice officials said the need to fine tune the coverage of the program is long overdue as Republic Act No. 7309, which created the DOJ-BOC, was passed in 1992.

The revision in the IRR broadens the scope of crimes and beneficiaries covered within the law while streamlining the process of claims for victims of unjust imprisonment/ detention and other forms of injustices attuned to the demands of modern times. Under the DOJ-BOC's Compensation Victims among those Program, qualified for compensation are those accused and detained and who were subsequently cleared on those unjustly appeal; detained without being charged; victims of forced detention by authorities; victims of violent crimes, involuntary disappearances. and online sexual abuse or exploitation of children; trafficked persons; and victims of torture.

Aclaimant or spouse, child, parent or sibling must file a claim with the DOJ or the nearest regional, provincial or city prosecutor within six months after being freed from detention or from the date where the crime or injury was experienced.

"Those whose lives were disrupted, freedoms taken and security violated would have a mechanism that adopts, listens and responds to their evolving needs," Justice Secretary Jesus Crispin Remulla said in a message read by Undersecretary Raul Vasquez at the DOJ building in Manila.

"The collective efforts towards the effective implementation of RA 7309 ensures that compensation processes are more transparent and inclusive consistent with the DOJ's mantra of providing real justice in real time. Remulla said.

FTI, NFA ADDRESS LOGISTICS HICCUPS FOR P20/KG RICE PROGRAM EXPANSION

MANILA – The Food and Terminal Inc. (FTI) and the National Food Authority (NFA) on Thursday assured that efforts are in place to resolve "logistics hiccups" for the expansion of the PHP20 per kilogram rice program in the country.

The program, dubbed "Benteng Bigas Meron Na," is being rolled out in 32 Kadiwa ng Pangulo (KNP) Centers and stalls in Metro Manila and nearby provinces.

The rollout in Luzon started on May 13 after the Department of Agriculture (DA) adhered to the assistance ban 10 days before the May 12 midterm elections.

The pilot rollout of the P20/kg rice program was held in Cebu on May 1.

In a media interview, FTI president Joseph Lo said they are continuously procuring trucks and other vehicles for easier delivery of NFA rice stocks from warehouses to KNP sites. "Ongoing naman po iyong mga improvements na ginagawa natin katulad sa mga meetings natin weekly (The improvements that we are doing like in our weekly meetings are ongoing)," he said

To date, he said, 15 out of the 30 target vehicles have already been purchased for the three-phase implementation of the program nationwide.

For Luzon alone, Lo said they need 30 drivers; while talks with other local government units (LGUs) are underway to plan logistics setup in Visayas and Mindanao. For its part, the NFA said it is working on the flexibility

is working on the flexibility of shipment delivery for NFA rice stocks.

"So, I'm making the contract na medyo (somehow) flexible. So kung manggagaling ng Mindoro, dapat pwede siyang maka-deliver kahit saan (So, if it will come from Mindoro, it should be allowed to deliver anywhere else)," said NFA Administrator Larry Lacson, citing that shipment of NFA stocks is part of their operational costs.

The NFA has started unloading 35,000 bags of NFA soon-to-age and aging well-milled rice in Cebu port from Mindoro, with the next batch of the same volume being prepped.

To date, Lacson said there are 400,000 bags of NFA rice allocated for the pilot rollout in the Visayas region, while some 248,000 bags are available in the Valenzuela warehouse for the distribution in Metro Manila and nearby provinces.

The DA said it will expand the program in 55 KNP sites in Metro Manila in June and roll out its Phase 2 and Phase 3 in July and September, respectively, which will include areas in Mindanao. (PNA) BY STEPHANIE SEVILLANO

LTO SUSPENDS LICENSE OF BUS DRIVER IN EDSA MULTIPLE COLLISION

MANILA – The Land Transportation Office (LTO) has temporarily suspended the license of a bus driver involved in a multiple vehicle collision near EDSA Quezon Avenue on Wednesday.

In a statement on Thursday, Department of Transportation (DOTr) Secretary Vince Dizon said the suspension is in line with President Ferdinand R. Marcos Jr.'s directive to ensure the safety and comfort of commuters and other road users.

He warned other public utility vehicles (PUV) drivers and operators that endangering commuters and other road users will face heavy penalties.

At around 6 a.m. on Wednesday, a multiple collision occurred near EDSA Quezon Avenue involving a motorcycle, a UV Express, and a passenger bus.

NBI RAIDS YIELD P55-M IN COUNTERFEIT LUXURY GOODS

MANILA – The National Bureau of Investigation Intellectual Property Rights Division (NBI-IPRD) on Thursday reported that PHP55 million worth of counterfeit products have been seized in a series of operations conducted on May 6-7 in Parañaque, Malabon and Manila.

The seizures followed multiple search warrants served for violation of Section 155 (Trademark Infringement) and Section 168 (Unfair Competition) in relation to Section 170 of Republic Act 8293 or the Intellectual Property Code of the Philippines.

The cases stemmed from complaints filed by lawyers and representatives of Oakley, Gucci and Yves Saint Laurent.

PUBLIC URGED TO STOP USING WATERWAYS AS GARBAGE DUMP

CAGAYAN DE ORO CITY (PIA) — The Department of Public Works and Highways - Cagayan de Oro 1st District Engineering Office (DPWH-CDO 1st DEO) is reiterating its call for public cooperation in addressing flooding, pointing to improper waste disposal in waterways as a contributing factor.

"The public plays a crucial role in maintaining our waterways. No matter how often we clean, if garbage continues to be dumped irresponsibly, flooding will persist," said District Engineer Ana Lee M. Manzano.

The call came after a clean-up operation on May 3, during which maintenance crews removed approximately 15 cubic meters of waste and debris from Sapang Creek. The creek passes through Barangays Patag and Kauswagan, which are identified as flood-prone areas, particularly along Butuan-CDO-Iligan the Road (BCIR). The BCIR serves as a main route for commuters and freight traffic bound for lligan City, where flooding frequently causes transportation delays and road damage. Waste materials collected included plastic bottles, tree branches, and discarded household items. These obstruct drainage and can lead to elevated water levels during rainfall.

"This operation is part of our ongoing efforts to ensure that our drainage systems and waterways remain clear, especially ahead of the rainy season.

By doing so, we help prevent flooding that not only disrupts road transport but also endangers nearby communities," Manzano said.

The DPWH confirmed that monitoring and maintenance activities will continue in identified floodprone roads and adjacent water bodies, including Sapang Creek. The office is also coordinating with local government units and community groups to identify long-term flood management measures.

PH ENERGY SECTOR GROWS TO P3.3-T

energy sector has grown into a PHP3.3-trillion industry, up from PHP630 billion in 2022, according to the Department of Energy (DOE).

DOÉ Secretary Raphael Lotilla said Thursday the figure was based on updated data from the Energy Regulatory including Commission. audited financial new statements as of March 2025.

"This more updated figure can give you a better view of how large, how healthy, and how vibrant the (Philippine) power sector," he said at a press briefing in Taguig City.

"What it, of course, underlines is that the energy sector as a whole is indeed an important contributor to the economy."

Lotilla said the industry value reflects the rising energy assets, including generation, transmission, and distribution.

"If the power sector does not grow, then that means that we will remain stuck in the doldrums. Our economy won't be able

MANILA - The country's to grow for as long as our per capita consumption of energy is low," he said. Lotilla said an economy

growing by 6 percent annually requires growth in the power sector at around 5.2 percent.

Moreover, to further lower the cost of electricity, government the is expanding renewable energy, investing in power transmission, and pushing for hybrid systems in offgird areas to replace diesel with solar or liquefied natural gas.

"We are looking at increasing the share of energy sources indigenous to our country, which we have greater control over when it comes to the availability of supply, as well as pricing," Lotilla said. Lotilla said the projects

"So, as more power supply is made available and there are less transmission constraints, then prices can, in fact, go down," he added. (PNA) BY KRIS CRISMUNDO



MANILA – The local stock market continued to decline as investors were on a profittaking activity for two straight days, while the peso rebounded on Thursday's trading.

The Philippine Stock Exchange index (PSEi) fell to 6,400-level, shedding 1.30 percent to 6,466.86, with All Shares down by 0.80 percent to 3,768.44.

Except for Holding Firms, which increased by 0.54 percent to 5,478.70, the rest of the counters closed in the red territory.

Biggest losses came from Mining and Oil sector, plunging by 3.34 percent to 8,903.61; followed by Financials, down by 2.97 percent to 2,421.43; Property, down by 2.46 percent to 2,272.20; Services, down by 0.40 percent; and Industrial, down by 0.29 percent.

"The PSEi corrected lower for the second straight trading day, considered a healthy profit-taking after gaining for most days over the month," Rizal Commercial Banking Corp. chief economist Michael Ricafort said. Losers outnumbered winners at 108 to 77, with 61 counters left unchanged.

Meanwhile, the Philippine peso gained during Thursday's trade, closing at 55.75 to the US dollar from a 55.86 finish on Wednesday.

Peso started at 55.80 before trading between 55.71 and 55.84, with an average rate of 55.78 to the greenback.

MONDE NISSIN AIMS TO Open New Luzon Biscuit Plant in Next 2 years

MANILA – Listed snack manufacturer food Monde Nissin Corp. is set to break ground soon on a major manufacturing plant in northern Luzon, with parts of the facility expected to begin operations by 2026 or 2027.

In a virtual briefing Wednesday, chief financial officer Jesse Teo said the upcoming plant aims to boost its production capacity for the company's biscuit brands, including SkyFlakes and Graham amid rising local and international demand.

"We're still finalizing the plans for the new plant. I think the building will start soon and the spending will accelerate in the next few months, next few quarters, as we target to start up some parts of the new plant, northern Philippines plant, sometime in 2026 and 2027," Teo said.

Monde Nissin has earmarked PHP7.55 in billion capital expenditures for 2025, of which PHP6.6 billion will go to its Asia Pacific branded food business. including the new biscuit plant.

For the first quarter of the year, the food company increased its revenues by 2.8 percent to PHP20.9 billion from PHP20.3 billion in the first quarter of 2024.

Its core net income for the first quarter of 2025 also rose 1.5 percent to PHP2.9 billion from PHP2.88 billion in the same period last year. (PNA) BY KRIS CRISMUNDO

MANILA Drilling operations under Phase 4 of the Malampaya gas-topower project are set to begin soon as the drillship is scheduled to arrive at its site off northwest Palawan by second half of June 2025.

"Timeline for rig arrival in the Philippines has moved to second half June from the initial estimated end of May schedule. This has come about due to delays in completion of the current drilling of the rig in Malaysia," the Department of Energy (DOE) said.

DOE Undersecretary Alessandro Sales said in a press briefing in Taguig City Thursday that the drillship Noble Viking and three other support vessels are currently at the port in Labuan, Malaysia for final inspections and loading of materials.

The drillship is set to arrive

at the northwest Palawan, with drilling of three wellstwo for production and one for exploration—to follow.

Sales said the drilling would take around 150 days, which is expected to conclude by the last quarter of this year.

If successful, the output from the new wells could extend Malampaya's operations by 2034, up from the current projection of 2029.

"The actual hookup and pipelining to connect the two new wells to the existing production facilities will be undertaken immediately after, to begin in the last quarter of this year," Sales added.

Malampaya currently supplies 1.2 to 1.3 (GW) gigawatts of electricity, below its former output due to declining reserves.

The energy department

hopes to boost the Malampaya natural gas production to 1.5 to 1.7 GW.

"The third well being drilled is an exploration well, and hopefully with the good results on the exploration well called the 'Bagong Pag-asa', this will provide additional volumes for the field to be produced," Sales said.

Meanwhile, imported liquefied natural gas (LNG) is being used to fill the shortfall through two LNG terminals in Batangas.

The Marcos administration considers natural gas as a vital strategy to long-term energy transition, making it a transition fuel from coal to renewable energy.

In 2023, natural gas accounted for 22 percent of power generation.

"Right now, the country's total primary energy supply, more than half, or 54 percent, is imported," DOE Secretary Raphael Lotilla said.

Lotilla noted that coal makes up 63 percent of the Philippines' power generation, with 83 percent of coal supply being imported — 99.5 percent of which came from Indonesia.

"So, the diversification of fuels, including renewable energy and natural gas, are important elements in this (energy transition). And of course, the remaining movement to the potential for future contributions even of nuclear power," the energy chief said.

Aside from Malampaya, the DOE is ramping up exploration activities in other parts of the country, including the East Palawan and Sulu Sea basins, where up to five service contracts are in various stages of award. (PNA) BY **KRIS CRISMUNDO**

GILAS DRAWS TOUGH GROUP WITH AUSTRALIA, NZ IN WORLD CUP QUALIFIERS

MANILA – Gilas Pilipinas is facing a daunting path in the 2027 FIBA World Cup Asian Qualifiers after being drawn into a stacked Group A alongside world No. 7 Australia, No. 22 New Zealand, and Guam.

The draw was held Tuesday night (Manila time) in Doha, Qatar.

The qualifiers begin this November and will follow a home-and-away, double round-robin format across three windows — November 2025, February 2026, and July 2026.

The top three teams from each group advance to the second round.

Group A teams will merge with those from Group C, which includes perennial contender Iran, Jordan, Syria, and Iraq.

In the second round, teams play only the qualifiers from the other group, with results from the first round carrying over. These games will be held in August 2026, November 2026, and February 2027.

The top three teams from each second-round group, along with host nation Qatar and the best fourthplaced team, will qualify for the FIBA World Cup 2027, set for Aug. 27 to Sept. 12. In other World Cup draw results: Group B features Japan, China, Korea, and Chinese Taipei, while Group D includes Lebanon, Saudi Arabia, India, and Qatar.

Ranked No. 34 in the world, Gilas will also meet New Zealand in the FIBA Asia Cup group stage in Jeddah, Saudi Arabia, which is set from Aug. 5–17.

The Philippines splits its two previous meetings with the Tall Blacks in the FIBA Asia Cup Qualifiers.
