### ALL VICTIMS RECOVERED IN TAGAYTAY LANDSLIDE: RESCUE OPERATIONS **CONCLUDE SUCCESSFULLY**

**BGen Pantaleon** Imus Garcia, Cavite -In a successful culmination of search and rescue operations, all four victims of the tragic landslide incident in Brgy. Iruhin West, Tagaytay City have been recovered composite rescue teams. The remains of the deceased were respectfully retrieved in accordance with established disaster response protocols.

The landslide occurred at around 10:00 AM on July 24, 2025, when a perimeter wall at a construction site collapsed, burying a workers' barracks under

and debris. construction workers were reported trapped during the incident.

PLTCOL JEFFERSON P ISON, Chief of Police of Tagaytay Component City Police Station, identified the victims by their aliases as Jose, Nonong, Armond, and Mark—all of legal age residents of Brgy. and Iruhin West, Tagaytay City. the first day On operations, one worker was successfully rescued and immediately brought to the Ospital ng Tagaytay medical for attention. Sadly, one fatality was also confirmed on the same

The families of the victims were kept informed of developments through close coordination with the City Investigation and Traffic Function (CITF) of Tagaytay and the Silang LGU. Heavy equipment, including a twelve-wheeler truck and backhoe, was deployed to support excavation efforts.

By midday on July 25, 2025, the third and fourth victims were successfully located and retrieved.

Although the rescue phase has concluded, the area remains unstable and dangerous. Continued presence may disrupt post-operation assessments, cleanup activities, and ongoing safety inspections. For everyone's safety, full cooperation is earnestly requested.

TRECE MARTIRES CITY, Cavite (PIA) - The provincial government has placed Cavite under a state of calamity on Tuesday, July 22 to hasten government aid for residents affected by Severe Tropical Storm Crising and the southwest monsoon (habagat).

Governor Francisco Gabriel Remulla signed a resolution for the declaration amid the rising number of residents affected by flooding due to continuous heavy rains.

In a statement, Remulla said the state of calamity will allow the provincial government to use its calamity and quick response funds for relief operations.

'This declaration aimed to expedite government response in strengthening quick response and ensuring the safety and protection of Caviteños."

The resolution came after a meeting of the Provincial Disaster Risk Reduction and Management Office (OPDRRMO) and the Office of the Provincial Social Welfare and Development Officer (OPSWDO) to map out the local government's measures to provide aid for residents amid the heavy rains brought by the typhoon.

On July 22, the Cavite OPDRRMO reported that around 496 families and 1,744 individuals from 12 local government units were evacuated.

Authorities also noted 138 related incidents, including fallen trees, flooding, landslides, soil erosion, collapsed structures, and vehicular accidents which caused partial damages to eight houses and other infrastructures, while five houses were completely damaged.

Damages to agricultural products included high-value crops amounting to Php 3,175,875.00 in Alfonso, Naic, and Tanza; Php 1,464,297.43 worth of damaged rice in the cities of General Trias and Imus and Naic town and; Php 407,500.00 worth of damaged corn in the towns of Alfonso and Tanza. ### SWIFT POLICE ACTION LEADS TO ARREST OF ROBBERY SUSPECTS IN BACOOR

The Bacoor Component City Police Station successfully apprehended three suspects involved in a robbery that occurred in the early morning of July 25, 2025, at jewelry shop in Brgy. Zapote 1, Bacoor City, Cavite.

ALEXIE A PLTCOL DESAMITO, Officer-in-Charge of Bacoor CCPS. identified the arrested individuals by their aliases as Nico, Lando, Glenda—all res and residents of Las Piñas City. They were arrested in Sitio Kawayanan, Brgy. Zapote 3, Bacoor City, following a swift hot pursuit operation conducted by Bacoor CCPS investigators and operatives.

According to initial investigation, the suspects forcibly entered the jewelry shop at around 4:00 AM by destroying the padlocks of its roll-up door with an unidentified tool. Once inside, they stole approximately ₱170,000.00 in cash and assorted jewelry worth around ₱200,000.00 before fleeing.

#### CONSTRUCTION WORKERS TRAPPED IN TAGAYTAY LAND SLIDE INCIDENT; AUTHORITIES INTENSIFY RESCUE EFFORTS

Camp BGen Pantaleon Garcia, Imus City, Cavite – Rescue operations are underway following a landslide that occurred at around 10:00 AM today, July 24, 2025, in Brgy. Iruhin West, Tagaytay City, which caused a perimeter wall to collapse and bury a construction workers' barracks. Four workers were reportedly trapped during the incident.

PLTCOL JEFFERSON P ISON, Chief of Police of Tagaytay Component City Police Station, identified the victims by their aliases as Jose, Nonong, Armond, and Mark—all of legal age, construction workers, and residents of Brgy. Iruhin West, Tagaytay City.

Rescue and retrieval operations are being jointly conducted by BFP Tagaytay, Tagaytay City Rescue, Tagaytay City LGU, Tagaytay CCPS, Silang MPS, Silang LGU, CPMFC Cavite, Barangay Officials of Cabangaan, Silang, BFP Silang, and Silang Rescue. All teams are working around the clock to locate and retrieve the remaining victims.

As of this report, one victim has been pronounced dead, one

has been successfully rescued and brought to Ospital ng Tagaytay for medical treatment, while retrieval operations for the remaining two victims are still ongoing.

Further coordination with the LGUs of Silang and Tagaytay confirmed that the collapsed perimeter wall is located within Brgy. Cabangaan, Silang, Cavite, while the affected construction barracks fall under Brgy. Iruhin West, Tagaytay City.

In anticipation of weatherrelated hazards, the Tagaytay Component City Police Station, under the leadership of PLTCOL Ison, also conducted preemptive measures, including increased patrols and inter-agency coordination, in landslide- and floodprone areas. This proactive initiative forms part of the station's ongoing disaster preparedness efforts, aimed at ensuring public safety and enhancing community resilience during emergencies.

Authorities are strongly urging the public to stay clear of the incident site to ensure the safety of everyone and to allow emergency responders to conduct search, rescue, and retrieval operations without obstruction. The presence of onlookers or unauthorized individuals may impede the movement personnel equipment, delay critical rescue efforts, and pose additional risks. Public cooperation is essential to the success of ongoing operations and to prevent further incidents or injuries.

# PH, CANADA PLEDGE STRONGER CYBER DEFENSE COOPERATION

MANILA - The Philippines and Canada reiterated commitment beefing up their cyber defense cooperation, the Department of National Defense (DND) said on Friday.

Filipino and Canadian representatives made the pledge during a bilateral meeting held on the sidelines of the Digital Defense Symposium 2025 in Singapore on July 22, DND spokesperson Secretary Assistant Arsenio Andolong said in a news release.

"Representing the DND Philippines, Atty. Odessa Rossilyz L. Magisa, officer in charge, Office for DND Information Security, met with Mr. Hani Nasser, Director of Domains and Technology Policy of the Department of National Defense of Canada. Both sides explored practical areas for collaboration, including capacity-building information-sharing programs," he added.

Andolong said the bilateral engagement is part of the broader partnership defense between the Philippines and Canada, anchored on the Memorandum of Understanding on Defense Cooperation signed in January 2024.

This was reaffirmed by the conclusion of the negotiations for the Status of Visiting Forces Agreement (SOVFA) in March this year.

Earlier this month, Manila and Ottawa also convened a high-level bilateral cyber working group meeting in the Philippines.

# SOKOR'S RICE DONATION TO BOOST DISASTER RESPONSE EFFORTS - ROMUALDEZ

MANILA - Leyte 1st District Rep. Ferdinand Martin Romualdez on thanked South Friday Korea for its generous rice donation to the Philippines to support food security and disaster response measures.

In an announcement on Tuesday, the Korean Embassy said it will donate 2,016 metric tons of rice to the Philippines "to support swift responses to humanitarian crises and persistent rice shortages in vulnerable communities."

Romualdez said Seoul's timely support to Manila is a testament to the robust alliance between the two countries, especially as many parts of the country are reeling from recent disturbances weather and flooding triggered by heavy monsoon rains.

"South Korea's donation heartwarming is proof of its strong ties

with the Philippines and its selflessness to look out for its neighbors in Asia - a reflection of Asian values of unity and community," he said in a statement.

"The Philippines and its people are truly grateful for the helping hand that Seoul extended to us in our time of need. It would boost our government's efforts to extend assistance to many of our kababayans (countrymen) affected by the floods."

He assured the Korean government that the Philippine government, under the leadership of President Ferdinand R. Marcos Jr., would utilize the donated rice judiciously and in line with its intended purpose.

"This donated rice will be used as intended: deliver aid to disaster victims and provide access to affordable food in our most vulnerable communities. This is how the Philippines repays the kindness of its allies and neighbors - by bringing the aid it receives to people and places that need it the most," Romualdez said.

The turnover ceremony for the donated rice is scheduled for August in Manila. Of the 2,016 metric tons of rice, 1,616 will go to the Department of Social Welfare and Development, while 400 metric tons will go to the Bangsamoro Autonomous Region in Muslim Mindanao.

### DMW VOWS AID FORAILING OFWS IN QATAR, PUSHES FASTER REPATRIATION

**MANILA** – The Department of Migrant Workers (DMW) has committed to providing full support for ailing overseas Filipino workers (OFWs) in Qatar as it pushes for faster medical repatriation.

The initiative is in line with President Ferdinand R. Marcos Jr.'s directive to strengthen support to overseas Filipino workers (OFWs) with medical conditions.

In a news release on Thursday evening, the DMW said Undersecretary Jainal Rasul, Assistant Secretary Venecio Legaspi, and Qatar Labor Attaché Eduard Ferrer visited four ailing OFWs currently admitted at the Rumailah Hospital in Doha, in need of urgent medical attention and repatriation.

They also visited was a female patient who suffered a severe stroke and has been confined to the hospital since May.

The patient's sibling was repatriated earlier, while preparations for her repatriation are in process. During the visit, the DMW officials also conducted consultations with hospital staff, as well as with the Repatriation Medical Coordinator for Filipinos in Qatar, Alma Balanon, on the conditions and arrangements for patient transfers.

Balanon sought various forms of support, including

processing hospital acceptance in the Philippines, as vital steps to ensure a smooth transfer and continuity of care once patients are repatriated to the country.

She said that aside from the visited patients, there are remaining patients being evaluated possible transfer.

Ferrer, meanwhile, emphasized the importance of complete documentation and a structured referral system ensure successful medical transfers.

He also noted the high cost of medical evacuations as well as the expensive medical costs in Qatar.

### DEPED CHIEF VOWS SWIFT AID FOR STORM-HIT SCHOOLS

MANILA - Education Secretary Sonny Angara Thursday pledged immediate support for schools affected by recent storms and monsoon rains.

After his visit to damaged schools in Navotas and Malabon, Angara said the Department of Education (DepEd) is prioritizing the safety and welfare of learners and educators amid class disruptions caused by tropical cyclones Emong, Dante, and Crising, and the enhanced southwest monsoon.

"We will not abandon our schools, teachers, students during calamities," he said in a statement. "We will everything to help them recover quickly and continue providing education."

He noted that the DepEd's Disaster Risk Reduction and Management Service (DRRMS) has released funds to immediately roll out cleaning and clearing operations in affected schools.

As of Wednesday, about 1,876 classrooms sustained minor damage; 562 sustained major damage; 531 were destroyed; and 232 classrooms have damaged hygiene facilities, according to the DepEd.

To address infrastructure damage, DepEd is working the Department of Public Works and Highways to utilize Quick Response Funds for the rehabilitation and recovery of affected schools, as well as the National Indemnity Insurance Program, a comprehensive insurance protection for public schools against lightning, and other natural calamities, in partnership the Government Service Insurance System (GSIS) and the Bureau of the Treasury.

### 6 TRANSMISSION LINES DOWN IN NORTHERN LUZON DUE TO 'EMONG'

MANILA – Six transmission lines in Northern Luzon are unavailable as of 9 a.m. Friday due to the effects of Typhoon Emong (international name Co-May).

The National Grid Corp. of the Philippines (NGCP), in an advisory, said these are the Labrador-Bolinao 69-kilovolt (kV) line, which became unavailable at about 12:20 a.m., affecting customers of the Central Pangasinan Electric Cooperative (CENPELCO) and Pangasinan 1 Electric Cooperative (PANELCO

1).
The Bauang-San Fabian 69kV line became unavailable at about 1:01 a.m., and the Bauang-Naguilian 69kV line went down at about 1:52 a.m., affecting customers of the La Union Electric Cooperative (LUELCO).

The Bauang-San Fernando 115kV line also encountered a problem at about 1:41 a.m., while the Bacnotan-Bulala 69kV line became unavailable at about 2:34 a.m., affecting LUELCO customers.

A 230kV line is also unavailable but NGCP did not give specific details.

The power transmission operator said "inspection and restoration of lines in the affected areas will be in full swing once the weather allows."

"Please note that loss of power may be caused by affected transmission facilities of NGCP distribution facilities of local distribution utilities or electric cooperatives. Specific cities municipalities affected by the power interruptions are determined by concerned Distribution Utilities, unless the outage affects the entire franchise area," it added.

Based on the 8 a.m. bulletin of the weather bureau, Emong has weakened into a severe tropical storm as it passes the Cordillera region.

Its center was last estimated in San Isidro, Abra, moving north-northeastward at 25 kph. Tropical Cyclone Wind Signal No. 3 is currently raised over llocos Norte, Ilocos Sur, the northern portion of La

### HOSPITALS, EVACUATION CENTERS PRIORITIES FOR POWER RESTORATION: DOE

MANILA – The Department of Energy (DOE) has ordered the prioritization of power restoration and maintenance activities in critical areas such as hospitals and evacuation centers as Tropical Depression Dante intensifies rains brought by the southwest monsoon (habagat).

During the meeting of the

inter-agency Task Force on Energy Resiliency (TFER) Tuesday afternoon, Energy Secretary Sharon Garin directed the Manila Electric Company (Meralco) to help ensure power supply, especially in four hospitals identified as vulnerable to severe flooding.

These hospitals were identified as the San Lorenzo Ruiz General Hospital in Malabon, Tondo Medical Center in Manila, Valenzuela Medical Center, and Amang Rodriguez Memorial Medical Center in Marikina, the DOE said in news release Tuesday night.

DOE's Electric Power Industry Management Bureau (EPIMB) was also ordered to coordinate with Meralco "to conduct site inspections of the four highrisk hospitals and provide technical assistance to improve their flood-related electrical resiliency."

electrical resiliency." Meralco was also tasked to help provide necessary power supply to the Roman Tantiongco Memorial Elementary School in Sitio Wawa, Barangay San Juan in Morong, Rizal, which is now being used as an evacuation center and needs a generator set.

To ensure sufficient fuel supply in Metro Manila, the Toll Regulatory Board was tapped to help ensure that tollways are unhampered for delivery of the needed supplies from the storage facilities in Subic in Zambales and Bataan.

The National Electrification Administration (NEA) was also tapped to closely monitor and validate power status in areas affected by the weather disturbances.

"Off-grid areas were also checked and are continuously being monitored, including small communities that may face limited access to emergency services," the press release reads.

The National Power Corporation's (Napocor) dam operations unit was also reminded to have "proof of its compliance with existing dam spilling protocols, including but not limited to visual documentation that upholds safety thresholds."

"It's not just a greeting but a way of life; speak with kindness, walk with humility, and build a future where no one is left behind," she said.

Balaba, who heads the Committee on Tourism, has proposed an ordinance to adopt local traditional and indigenous customs in government bureaucracy.

"Maayad" is a greeting commonly used by the Higaonon, one of

Northern Mindanao's main indigenous groups, meaning good, peaceful, and beautiful, conveying well-being and positive intent.

Councilor Roberto Cabaring, the Indigenous Peoples' Mandatory Representative, welcomed the move, stating it would help promote indigenous culture in the mainstream.

Alongside the cultural greeting, Balaba is also advocating for the official recognition of "Kolon," the local term for clay, as a unique product identity of Cagayan de Oro, specifically from the village of Bulua.

Bulua has a history of pottery-making spanning over five decades. It is home to rich clay deposits found in three of its sitios, making it the only known source of natural pottery clay in Northern Mindanao. (PNA) BY ERCEL MAANDIG

#### MINDANAO GROUPS SEEK RENEWABLE ENERGY GROWTH

In an interview Thursday, Ben Cyrus Ellorin, head of the Consumers for Renewable Energy Action in Mindanao (Cream), cited the importance of accelerating the energy transition as crucial for developing resilient communities, especially as climate change impacts become more frequent and intense.

"There are low-hanging fruits in Mindanao's energy transition," Ellorin said, explaining that the island's dependence on clean and affordable hydropower shifted to coal and diesel only in the past nine years. He pointed out that the current energy situation forces industries and businesses in resourcerich Mindanao to pay high electricity rates, with energy costs accounting for 20 percent to 50 percent of their operating

expenses due to excessive

reliance on imported fossil

fuels like coal.

One proposed solution is the rehabilitation and uprating of the Agus-Pulangi Hydropower Complex (APHC). The generation cost at the APHC is projected to be less than PHP2 per kilowatt-hour, making it a viable "low-hanging fruit" for the energy transition.

David Tauli, director of the Institute of Power Sector Economics who is also with the Konsumanteng Kagayanon, noted that some groups are aiming for renewable energy parity by 2030 and implementing Electricity Decarbonization Programs (EDPs).

Tauli explained that EDPs aim to "democratize" renewable energy, allowing consumers to shift some of their current supply from coal power plants to rooftop solar systems. He added that they aim for at least 10 million households to participate by 2030.

In a policy brief released earlier this month, Konsumanteng Kagayanon stated its goal of achieving a 50 percent to 60 percent share of renewable energy by 2030, advocating for green energy to become as affordable as conventional sources.

### DA-CORDILLERA TO DEPLOY KADIWA TRUCKS TO AID FARMERS AMID FLOOD IMPACT

BAGUIO CITY – The Department of Agriculture (DA) in the Cordillera region said it is ready to deploy Kadiwa trucks to assist farmers in transporting unsold vegetables, as trading activity in Benguet remains low due to flooding in Metro Manila and other lowland provinces.

"We are prepared to dispatch our Kadiwa trucks to deliver vegetables directly to buyers and prevent spoilage, which could cause heavy losses for farmers. If rescue operations are needed, we will act," DA-Cordillera Director Jennilyn Dawayan said in a phone interview with the Philippine News Agency on Thursday.

The Benguet Agripinoy Trading Center in La Trinidad, Benguet, a government trading facility, recorded 115 farmers' trucks that arrived on Thursday, carrying assorted vegetables, with 38 traders' trucks ready

"As long as farmers coordinate with us, we are willing to help, just as we've done in the past by linking them to buyers and deploying Kadiwa trucks," she added.

So far, the DA-Cordillera has not received reports of farmers unable to sell their produce.

Meanwhile, Dawayan said the department is also working on acquiring equipment for drying, processing, and dehydrating vegetables and other farm products to help address dumping caused by oversupply or lack of buyers.

"That's the direction we're heading. We just need the right machines for specific products so we can provide farmers with another option for unsold produce," she said. (PNA) BY LIZA AGOOT

### DAR TO AWARD INDIVIDUAL LAND TITLES TO 93 FORMER REBELS IN NEGOR

DUMAGUETE CITY – The Department of Agrarian Reform (DAR) will award individual land titles to 93 former rebels (FRs) of the New People's Army (NPA) in Negros Oriental after proper documentation and compliance with local government requirements, an official said Thursday.

In an interview, DAR-Negros Oriental Provincial Agrarian Reform Program Manuel Officer Galon told the Philippine News Agency that the land titles cover part of a 13-hectare property under government's land reform Barangay program in Bongalonan in Basay town. The property is the site of a housing project for FRs, funded by the provincial government through the Task Force to End Local Communist Armed Conflict (TF-ELCAC) with an initial budget of PHP60 million.

The housing project intends to build 100 housing units in 200 square meter lots, with a communal farm to be shared by the FRs.

Galon said the awarding

of the land titles to the FRs was initially set on June 3, but was deferred due to a resolution issued by the Basay town council.

The resolution requested provincial the TF-ELCAC, the Department of the Interior and Local Government (DILG), and the DAR to cease the implementation of the housing project until after a memorandum of agreement has been signed with Basay's local government, citing security concerns and other "risks" of disagreement in the community.

"Their reason was that the FRs might cause trouble and disturbance of peace and order in Basay, given their backgrounds and history," Galon said.

"But these FRs have been properly documented and are now peace-loving people."

The DAR official said the TF-ELCAC, project stakeholders, and Basay officials met with Governor Manuel Sagarbarria on Wednesday to resolve the issue

Galon said the Basay officials promised to facilitate a meeting to assure their constituents that it is necessary to support the FRs in implementing Executive Order (EO) 75.

EO 75 directs all departments, bureaus, offices, and instrumentalities of the government to identify lands owned by the government devoted to or suitable for agriculture for distribution to qualified beneficiaries.

He said Sagarbarria also promised to allocate additional funds for the housing project.

"It should be a whole-ofnation approach to give the FRs a chance to integrate into mainstream society. This is just a temporary snag, but the project will be implemented," Galon said, adding that the awarding of individual titles would be held within the year. (PNA) BY MARY JUDALINE PARTLOW

# TARIFF ISSUES REVERSE PSEI'S RISE BUT PESO KEEPS FOOTING

MANILA - The Philippine peso sustained its strength against the US dollar but concerns on tariff on Philippine exports to the US continue to impact investors' sentiments, resulting in the negative close of the main equities index Thursday.

The local currency ended the day at 56.65, way better than its 56.88 close against the greenback a day ago.

Its strength showed early on after opening the trade at 56.68, from the previous session's 56.85.

It traded between 56.73 and 56.6, resulting to a 56.66 average for the day. Volume reached USD1.37 billion, lower than dayago's USD1.51 billion.

On the other hand, the Philippine Stock Exchange index (PSEi) shed 0.28 percent to 6,444.16 points, but the broader All Shares managed to end with a 0.03 percent increase to 3,808.39 points.

Only the Services index tracked the main gauge after it slipped by 1.13 percent

Mining and Oil, meanwhile rose by 1.36 percent, and was followed by the Financials, 0.40 percent; Property, 0.29 percent; Firms, 0.05 Holding percent, and Industrial, 0.003 percent.

Volume reached 1.1 million shares amounting to PHP6.35 billion.

Decliners surpassed advancers at 99 to 97 while 56 shares were unchanged.

Luis Limlingan, Regina Development Capital Corporation head of sales, said investors remain worried on global trade developments after trade officials on Thursday said talks will continue with their US counterparts, and waitand-see stance remains for the effects of similar issues in other countries. # PH RECORDS P215-B GROSS GAMING REVENUE IN 1H 2025 – PAGCOR

**MANILA** – The Philippines' gaming industry recorded PHP215 billion in gross revenues during the first half of 2025, the Philippine Amusement and Gaming Corp. (PAGCOR) disclosed Thursday.

Speaking at the Philippine Hotel Connect 2025 in Pasay City, PAGCOR Chairman and CEO Alejandro Tengco said licensed casinos within the so-called integrated resorts or IRs across the country generated PHP93.36 billion out of the total gross

gaming revenues (GGR).
Of this, PHP16 billion was remitted to PAGCOR as license fees, helping fund government social programs and economic initiatives.

Integrated resorts are properties multi-use consisting of hotel, retail, dining, and recreation facilities, including casinos licensed by PAGCOR.

generating Beyond for revenue government, Tengco said, IRs are a vital component in positioning the Philippines as a competitive tourism destination.

In the same forum, PAGCOR Assistant Vice President Ma. Vina Claudette Oca said more IR projects are set for completion in the next five years in Metro Manila, Clark, Cebu, and Boracay. "With these projects, more non-gaming and hospitality facilities will further boost tourism and economic growth," she said.

Kevin Tan, president and CEO of Alliance Global Group, said Megaworld Corp. intends to invest "almost USD2 billion" in expanding its integrated resort developments, with two underway in Boracay and Cebu.

"In any integrated resort, one of the biggest requirements of PAGCOR is for us to build luxury hotel rooms. So. we're committed to doing that. Part of our investments also will be going to other components of tourism, like entertainment," he said.

Alongside strengthening the industry, PAGCOR would ensure that gaming in the country is conducted "ethically, transparently, and responsibly," Tengco said.

Earlier this month. were gambling ads removed from areas with minors, and a ban on prime-time TV gaming ads between 5:30 p.m. and 8 p.m. is forthcoming.

"These are all part of a broader effort to reposition gaming within the proper boundaries so that it becomes regulated entertainment and not a reckless distraction," he said. (PNA) BY JOYCE ANN L. ROCAMORA

"As the operator of the National Registry of Scripless Securities, or we all know as NROSS, which is the Central Securities Depository and Security Settlement System for all government securities and BSP securities, the Bureau of the Treasury recognizes the vital role we play in ensuring the integrity of our system and maintaining financial market confidence and stability," said National Treasurer Sharon Almanza.

Almanza said NROSS and the BSP's Peso RTGS form the backbone of the country's financial market infrastructure.

"Through this arrangement, we will collaborate to address critical challenges in the operation and maintenance of systems, ensuring that this remains strategically aligned, adequately secured, and operationally sound," she said.

"We also commit to work together on whole-ofmarket initiatives and third-party assessments to maintain our alignment with international standards and best practices."

BSP Governor Remolona Jr. said the BSP is closely working with the BTr to deepen the capital markets.

"We're also, of course, working with Sharon on deepening our capital markets, and this initiative of G-bonds is part of that, extending the deepening of capital markets to the retail level," Remolona said.

The BTr earlier partnered with GCash for the sale of government bonds, making government securities more accessible to the investing public.

"I think this MOU is not just a document. It's to tell us that we have work to do. And we have to work together to do that work." Remolona said. (PNA) BY ANNA LEAH GONZALES

MANILA National coaches athletes and will receive a PHP5,000 increase in their monthly allowances starting next month, the Philippine Sports Commission (PSC) announced Thursday.

Chairman John Patrick Gregorio had informed the athletes, coaches, and representatives of the various national sports associations (NSAs) of the increase during a general assembly at the Ninoy Aguino Stadium on July 8. The former PBA chairman said it's about time the athletes and coaches get an increase in their allowances

"Why? Because we realized that so many athletes still get PHP10,000 per month, which is lower than the minimum wage," Gregorio said.

Together Commissioner Edward Hayco, the PSC chief athletes visited and coaches from baseball, softball, wushu, wrestling, and hockey, staying at the Rizal Memorial Sports Complex on Wednesday. "We distributed food for

the athletes who can't leave the complex due to flooding," Gregorio said. The PSC officials also listened to the athletes' "kwentong buhay" (life stories) and their dreams of pursuing higher education. Gregorio said the "kumustahan" (casual conversation) with the athletes only strengthened the PSC's commitment plot to academic sponsorships for national through the athletes Philippine Sports Institute. Meanwhile, national team members are no longer required to sign and submit a daily time record together with a comprehensive activity report.

"In place of these documents, the NSAs are now required to submit the newly adopted monthly training attendance certification," said PSC acting Executive Director Guillermo Iroy Jr., who issued the advisory on July

"This certification must be duly signed by the NSA president or secretary general and notarized, and shall serve as the official basis for qualified members of the national training pool to receive their allowance for the particular month," he explained.

The move "aims to efficiency, enhance streamline administrative requirements, maintaining accountability in the disbursement of government support."

"It's a blessing considering the rising cost of living," said Henry Lopez, a member of the Philippine para-chess team. (PNA) BY JEAN MALANUM
