#### YOUTH KEY TO SHAPING SUSTAINABLE GOVERNANCE —DLSU PROFESSOR

— Young voters remain a key force in shaping grassroots leadership and barangay governance

CALAMBA CITY (PIA)

barangay governance, a professor from De La Salle University-Dasmariñas (DLSU-D) has emphasized.

In an interview with the Philippine Information Agency, Dr. Rommel Mazo, director of the DLSU-D's School of Governance, Public Service & Leadership, Corporate highlighted the role of the Sangguniang Barangay Sangguniang Kabataan in promoting participatory governance and training future techsavvy leaders.

"In itself, the youth is a political force and they should actively participate public governance and political decisionmaking processes. Their voices should be heard, especially during the time of AI (artificial intelligence) and Information and Communications Technology (ICT), because their access to this information affords them the insights only they could have."

As the youth's first foray to participative governance and policymaking, the Sangguniang Kabataan provides a platform for translating national policies and goals affecting grassroots communities into local legislature.

"The Sangguniang Kabataan will create the ordinances that will implement government policies and the goals set by the UN [United These Nations]. goals must be translated into ordinances. and and implemented in the barangay."

Formalized under the Sangguniang Kabataan Reform Act of 2015, the Sangguniang Kabataan

acts as the highest policymaking body on matters affecting the youth in the barangay wherein all its programs, plans and activities are decided with the consent of representatives, known as the Katipunan ng Kabataan.

To achieve this, Mazo emphasized the importance of providing a platform for the youth to give their collective opinions and perspectives, especially on policies that will affect their community. "The stability of our republic relies on the stability of our barangays, so we expect our officials be competent and honest. Our expectations from our barangays should be the same as what we expect from our national government."

Describing it as 'repository the of knowledge', Mazo noted the academe's role in sustainable promoting governance, where programs policies and the government are anchored from the United Sustainable Nations Development Goals.

It serves as the global blueprint to achieving balance between а growth. economic inclusion, and environmental protection by addressing critical global challenges such as poverty, inequality, climate change, environmental degradation, peace, and iustice.

In its 2024 Philippine Statistical Yearbook, the Philippine Statistics Authority (PSA) noted that the CALABARZON is home to some 4,420,311 Filipinos aged between 15 to 29 years who are qualified to vote for the Sangguniang Kabataan. (PB/PIA4A) BY PATRICIA BERMUDEZ

## AFP REPORTS INCREASED PRESENCE OF CHINESE VESSELS IN AYUNGIN SHOAL

#### MANILA - An increased presence of Chinese vessels, including rubber boats armed with crewserved weapons, was monitored in Ayungin Shoal in the West Philippine Sea (WPS) where the BRP Madre (LS-57) Sierra stands watch, the Armed

In a statement, the AFP said the increase had been observed on Aug. maritime through domain awareness (MDA) monitoring activities.

Forces of the Philippines

(AFP) said Thursday.

"In total, five CCG (Chinese Coast Guard) vessels were present, supported by 11 RHIBs (rigid-hull inflatable boat)/fast boats and nine Chinese maritime militia vessels. Aerial assets were also monitored during the deployment, including one rotary aircraft and one unmanned aerial vehicle," it said.

Several of the CCG's fast boats were also observed to have been upgraded with mounted weapons, including heavy crewserved weapons.

"China Coast Guard vessels have been seen conducting maneuvers and drills involving the use of water cannons at sea. while a number of smaller craft, such as rigid-hulled inflatable boats and fast boats, were also deployed inside the shoal," it added. The AFP said it would continue to monitor developments in the WPS.

In a separate message to reporters, AFP public affairs office chief, Col. Xerxes Trinidad. said the military has ready contingency measures.

"We affirm our commitment in performing our mandate to protect our sovereignty and sovereign rights in the WPS," he said.

Trinidad said the AFP's monitoring continuous activities provide clear picture of the operational environment" and awareness of the situation." (PNA) BY PRIAM NEPOMUĆENO

#### BOC CONDEMNS 5 CONTAINERS LOADED WITH FORFEITED AGRI **PRODUCTS IN SUBIC**

MANILA - The Bureau of Customs (BOC), through the Port of Subic, has destroyed five containers of smuggled agricultural products through proper dumping.

statement on In a Thursday, the BOC said the shipments contained assorted frozen meat. fish, preserved fruits, vegetables, and other perishable items that were condemned in a facility in Subic, Zambales on Aug.

The products were forfeited in favor of the government for lack of a phytosanitary certificate, in violation of a Department of Agriculture administrative order and a department circular in relation to Section 1113(f) of Republic Act 10863, the Customs

Modernization and Tariff Act (CMTA).

"By condemning these illegal imports, the bureau reaffirms its commitment to protecting the health and safety of Filipino citizens. Smuggled agricultural products pose serious risks, and we will continue to act decisively against these threats, **BOC Commissioner Ariel** Nepomuceno said.

As mandated under Memorandum Customs Order 24-2021, the condemnation ensures that agricultural goods deemed hazardous or unfit for human consumption are properly disposed of.

P2.3-M 'HOT MEAT' SEIZED IN BULACAN, 7 PERSONS ARRESTED MANILA - At least 12,500.8 kg. of "hot meat" worth PHP2.3 million were confiscated in Marilao, Bulacan, resulting in the arrest of seven persons, the Police Regional Office

(PRO) 3 (Central Luzon) said on Thursday.

In a statement, Central Luzon Police chief, Brig. Gen. Ponce Rogelio Peñones Jr., said the operation was carried out after barangay peacekeepers on patrol discovered the illicit transfer of suspected double-dead meat from a wing van to a refrigerated truck in Barangay Sta. Rosa 1 in Marilao at about 10:30 p.m. on Wednesday. He said the incident was immediately reported to the National Meat Inspection Service (NMIS) and Marilao Police Station, resulting in the arrest of seven individuals.

"This successful operation shows the strong partnership of the PNP (Philippine National Police) with local government and regulatory agencies in safeguarding the welfare

of our people. PRO-3 will remain vigilant against illegal practices endanger public health and undermine consumer protection," Peñones said.

The confiscated meat was turned over to the NMIS for proper disposition, while charges for violation of Republic Act (RA) 9296, or The Meat Inspection Code of the Philippines, are being prepared against the suspects before the Office of the Provincial Prosecutor in Malolos, Bulacan.

Meanwhile, Peñones said operatives of the Station Drug Enforcement Unit (SDEU) of Balanga City Police Station seized at least 1 kg. of suspected shabu with an estimated street value of PHP6.8 million during a buy-bust operation in Barangay Bagong Silang, Balanga City at about 10:45 a.m. Thursday.

The operation led to the arrest of a high-value individual and the recovery of a bag containing several sachets of suspected genuine and shabu. counterfeit peso bills used as buy-bust money, and other drug paraphernalia.

"This operation, guided by actionable intelligence, shows that PRO-3 remains firm and uncompromising in its fight against illegal drugs. We will continue to pursue high-value targets and dismantle drug networks to protect our communities," Peñones said.

The arrested suspect and the confiscated evidence were brought to the Balanga City Police Station for proper documentation and filing of charges for violation of RA 9165 or the Dangerous Drugs Act of 2002. (PNA) BY CHRISTOPHER LLOYD CALIWAN

#### DA CHIEF URGES HOUSE SUPPORT FOR RICE TARIFFICATION LAW CHANGES

# MANILA – Agriculture Secretary Francisco Tiu-Laurel Jr. has appealed to lawmakers to back proposed amendments to the Rice Tariffication Law (RTL), saying the current version has failed to protect local farmers and left the industry exposed to market volatility.

In a news release on Thursday, the Department of Agriculture (DA) reported that Tiu-Laurel made a presentation before the Committee House Agriculture and Food, chaired by Quezon Rep. Wilfrido Mark Enverga, describing the RTL as "well-meaning policy" with provisions that had unintended consequences, particularly on the welfare of Filipino rice farmers.

"Rice is more than just a staple. It fuels our workforce, sustains our families, and symbolizes food security for over 112 million Filipinos," he said. Tiu-Laurel said the RTL's full liberalization of rice.

Tiu-Laurel said the RTL's full liberalization of rice imports stripped the National Food Authority (NFA) of its mandate to regulate supply, stabilize prices, and intervene during crises —effectively placing farmers at the mercy of market forces.

The result, he warned, has been unsustainable palay prices, driven down by a flood of cheap, high-quality imported rice.

Last month, farmgate prices reportedly fell to as low as PHP8 per kilo, well below the cost of production, even for the most efficient growers.

Tiu-Laurel also refuted claims that the government's PHP20 rice program caused the price drop, calling those assertions "absurd and simply untrue."

He cited NFA data showing palay prices began to rebound following President Ferdinand R. Marcos Jr.'s announcement of a temporary rice import suspension, which will take effect on Sept. 1.

"That rebound happened even as the PHP20 program continued. This proves that market control, not subsidies, is the decisive factor," Tiu-Laurel

He said the core problem lies in the law itself.

"The real issue lies in the RTL. As currently written, it does not reform the rice industry —it threatens to kill it," he added.

Citing that the NFA is uniquely positioned to balance public interest with market dynamics due to its logistics network and long-standing experience, Tiu-Laurel called for datadriven policy reform, better regulation, and the restoration of a stronger role for the NFA.

"We must regain control of the rice industry. This is an industry too critical to be left entirely to the private sector," he said.

Tiu-Laurel also expressed support for House Bill 1, which seeks to revise the RTL and reestablish the government's authority to act during price or supply disruptions. (PNA) BY MA. TERESA MONTEMAYOR

#### CA AFFIRMS CONVICTION OF 2 VIETNAMESE NATIONALS FOR KIDNAPPING

MANILA – The Court of Appeals has affirmed the decision of the Pasay Regional Trial Court Branch 115 convicting two Vietnamese nationals for their involvement in the kidnapping for ransom of a Vietnamese woman three years ago.

In its 10-page decision dated Aug. 18, the CA "dismissed for lack of merit" the appeal filed by Nguyen Chi Trung, 30, and Phan Minh Viet, 32.

The two men were charged for the kidnap for ransom of their compatriot Nguyen Thi Ben Van, also known as "Miss Ann," whom they detained at two different safehouses on orders of their Chinese bosses for a total of 18 days in November 2022.

On Oct. 29, 2022, the victim had left a hotpot restaurant at the Aseana Business Park near the corner of Macapagal Boulevard and Aseana Avenue in Parañaque City to meet someone in a bar and did not return.

At around 9 p.m. on the same day, the victim's boyfriend received messages and video of the victim being beaten by the alleged kidnappers through Telegram and demanded PHP50 million from him

in exchange for her safe release.

In the course of negotiation, the ransom was reduced and was transferred in two tranches to a bank account given by the suspects for the victim's safe release. The victim was then abandoned by her captors at Blue Mountain, Sumulong Highway, Antipolo City where she

On Nov. 17, 2022, a follow-up operation was conducted authorities, resulting in the arrest of Viet at around 7 p.m. in his condominium at La Verti Residences, Pasay City, while Trung was arrested at around 3:30 p.m. on Nov. 18 at a karaoke bar in Barangay Tambo, Parañaque City.

was rescued.

The suspects were sentenced by the RTC to up to 40 years in prison.

#### PCG BOOSTS MARITIME SECURITY WITH UAV MODERNIZATION PROGRAM

MANILA – The Philippine Coast Guard (PCG) is expanding the use of unmanned aerial vehicles (UAVs) to bolster maritime surveillance, coastal monitoring, and emergency response as part of its modernization program.

In a Bagong Pilipinas Ngayon interview on Thursday, PCG spokesperson Capt. Noemie Cayabyab said the UAVs were recently tested in a flying exercise in La Union to assess their capabilities in aerial surveillance and rescue support.

The drones are already in use for operations, including search-andrescue, and are expected to play a greater role in enhancing maritime domain awareness.

"Ang UAV po natin ay may kakayahan po na lumipad hanggang 40 to 60 minutes... ang kakayahan po nito is iyong GPS navigation and live video feed transmission po. Maganda rin po itong automatic flight path programming at saka object tracking UAVs can fly for 40 to 60 minutes... equipped with GPS navigation and live video feed transmission. They also have automatic flight path programming and object tracking)," Cayabyab said.

She said the Coast Guard follows its "10/30 doctrine," requiring small vessels to deploy within 10 minutes and larger ships or aircraft within 30 minutes of receiving UAV reports.

"So, ang kagandahan rin po nitong UAV po natin, later on 'no, we can use this data para magamit po na ebidensiya sa pagsasampa po ng mga kaso sa mga tao na lumalabag po sa ating batas (The advantage of these UAVs is that their data can later be used as evidence in filing cases against violators of maritime laws)," Cayabyab said.

The UAV program is operated under the Coast Guard Aviation Command, which also maintains the drones.

Personnel undergo training in basic drone operations, flight planning, aerial mapping, sensor handling, troubleshooting, and advanced courses in data analysis and mission planning.

"Target po talaga natin na bigyan po ng pangunahing UAV units iyong ating mga command areas... para pantay-pantay ang surveillance capability at maabot po natin iyong mga malalayong lugar (Our target is to equip all command areas with UAV units... to ensure equal surveillance capability and reach remote areas)," Cayabyab said.

She added that the initiative is supported by allied countries and will ensure more effective coastal patrols and emergency response.

Cayabyab assured the public that PCG continues to work closely with other government agencies, emphasizing that its singular mission is to deliver genuine service to the Filipino people.

On the other hand, the PCG is also preparing 1,300 of its personnel to serve as election board members in the upcoming Bangsamoro Autonomous Region in Muslim Mindanao parliamentary elections.

The deployment, according to Cayabyab, is part of the agency's broader support for national initiatives while maintaining its primary maritime security duties. (PNA) BY WILNARD BACELONIA

#### DIOKNO FILES BILL TOBREAK LANGUAGE BARRIERS IN PH LAWS

MANILA – Akbayan Partylist Rep. Chel Diokno has filed a bill requiring the translation of Philippine laws with penal provisions into Filipino, Bisaya, and Ilokano to break the language barriers.

House Bill No. 3863 or the "Batas sa Sariling Wika" Act seeks to amend the Revised Administrative Code of 1987 to require translations into the three major Philippine languages representing the country's four largest ethnolinguistic groups: Tagalog (26)Bisaya (14.3 percent), percent), Ilokano percent), and Cebuano (8 percent).

If enacted, the law will require all new laws with penal provisions to be translated within 90 days, and all existing laws with penal provisions --including the Revised Penal Code.

Labor Code, RA 7610 (Special Protection of Children Against Child Abuse, Exploitation and Discrimination Act), Anti-Violence Against Women and Their Children Act, Safe Spaces Act, and the Magna Carta of Filipino Seafarers, among others --to be translated within five years.

Komisyon The sa Wikang Filipino (KWF) will serve as the lead translating authority, Presidential while the Communications Office (PCO) will be tasked with publishing the translations in the Official Gazette and making them available online.

"How can we expect ordinary citizens to follow the law if it's written in a language they can't understand? A worker in Mindanao shouldn't need a lawyer or translator to understand the Labor Code; a mother in Ilocos should be able to read the Anti-VAWC law in her native tongue," Diokno said in a statement on Thursday.

"By translating laws with penalties into terms that are easily understandable by ordinary citizens in their local language, we minimize the risk of misunderstanding and misinterpretation."

Diokno said the proposal brings the Philippines in line with its Southeast Asian neighbors.

"In countries like Indonesia, Thailand, Vietnam, Cambodia, Laos, Myanmar, and Timor-Leste, laws are written and enforced in their own languages," he said. (PNA) BY JOSE CIELITO REGANIT

Through this initiative, PhilHealth intends to register school learners and their parents who are already members, ensuring their access to National Health Insurance Program (NHIP) services and benefits.

For parents who are not yet members, PhilHealth will first facilitate their membership registration, after which they must also register in the YAKAP program to avail of the expanded services.

Parent of a learner Ragie Mae Casuyon from Barangay Matab-ang expressed her gratitude, saying the program's free medical services and medicines would benefit not only her but also her child.

"Gapasalamat gid ko nga may ara nga program nga YAKAP kay makabulig gid bala sa amon kay libre na lang ang bulong kag check-up," Cayuson said. (I'm thankful that there's a program like YAKAP because it will truly help us since the medicines and check-ups are already free.)

Formerly known as Konsultasyong Sulit at Tama (KonSulTa), YAKAP is PhilHealth's flagship expanded primary healthcare program under the Universal Health Care (UHC) Law.

The program offers a wider range of free primary care services, including access to 75 essential medicines (up from 21 previously) with a maximum benefit limit of ₱20,000 per patient per year.

The expanded benefits also cover 20 laboratory tests, cancer screenings for colorectal, lung, liver, and breast cancers, and other outpatient treatments at no cost.

In partnership with the Department of Education (DepEd) and the Talisay City Government, PhilHealth targeted 479 students from Tayabas Elementary School for its first patient encounter (FPE).

PhilHealth Bacolod City head Edgar Yocariza reported that Talisay City recorded the highest number of registered PhilHealth members and dependents in the province as of June 30, 2025, and the second highest in Western Visayas.

"The LGU [local government unit] of Talisay amu ang pinakataas nga performing LGU sa bilog nga probinsiya when it comes sa PhilHealth registration, with outstanding 105 percent [coverage] in registration rate, kag number two sa bilog nga Western Visayas," Yocariza said.

#### SURVEY ON 'WHITE HYDROGEN' IN PALAWAN SHOWS PROMISING RESULTS —DOE

# MANILA — The survey held from Aug. 12 to 15 this year aimed to discover potential sources of native hydrogen sources in Palawan showed "promising indicators", the Department of Energy (DOE) said Wednesday.

In a news release, the DOE said the survey was held at several areas that include Kay's Hot Spring in Brgy. Sta. Lourdes, Puerto Princesa City, and Bato-Bato Hot Spring in Brgy. Calategas, municipality of Narra, and in Puerto Princesa City.

These studies, which are part of the second part of the nationwide check on the country's potential for low-carbon energy source termed "white hydrogen", revealed indicators "promising of naturally occurring hydrogen, underscoring potential to Palawan's further contribute to the Philippines' clean energy transition, apart from the Malampaya project."

The joint technical team from the Energy Resource Development Bureau (ERDB) and the Energy Research and Testing Laboratory Services (ERTLS) gathered critical water, gas, and rock samples from hot springs and outcrops in the municipalities of Sofronio Española and Narra, and

the City of Puerto Princesa, the DOE said.

"The samples will undergo laboratory analysis by the DOE to determine their potential and to guide the country's broader strategy for harnessing indigenous clean energy resources. This effort forms part of the DOE's mission to enhance national energy security, diversify the energy mix, and accelerate the transition toward a low-carbon and sustainable energy future," it said.

The first reconnaissance survey was held from June 30 to July 4 at the Botolan Hot Spring and Nagsasa Seeps in Zambales and the Mangatarem Hot Spring in Pangasinan, among the nine areas being considered for native hydrogen exploration, a world first since the Philippines is the first to have the framework for such activity.

The other areas are the Casiguran Ophiolite belt in Aurora province; Angat Ophiolite Belt in Bulacan; Eastern Bicol-Eastern Mindanao Ophiolite Belt; Antique Ophiolite Belt; Western Bicol-Eastern Leyte Ophiolite Belt; Zamboanga-Sulu Ophiolite Belt; and Central Mindanao Ophiolite Belt. ## RECTO WELCOMES R&I'S AFFIRMATION OF PH INVESTMENT-GRADE RATING

# The R&I on Wednesday affirmed the Philippines' "A-" investment-grade rating with a stable outlook. An 'A-' rating reflects strong macroeconomic stability and robust

creditworthiness.

This translates to lower interest rates on borrowings of the national government and the private sector, and helps attract more foreign direct investments.

In reaffirming its rating, R&I cited that the Philippine economy continues to grow at a relatively high rate among major countries in Southeast Asia.

In the second quarter of 2025, the Philippines' Gross Domestic Product growth of 5.5 percent outperformed its regional peers, including China (5.2 percent), Indonesia (5.1 percent), Malaysia (4.5 percent), Singapore (4.3 percent), and Thailand (2.8 percent).

R&I reaffirmed the Philippines' steady fiscal consolidation, highlighting the government's progress in reducing the fiscal deficit and improving debt metrics in line with its fiscal strategy. (PNA) BY ANNA LEAH GONZALES

#### JAPAN DEBT WATCHER AFFIRMS PH'S INVESTMENT-GRADE RATING

MANILA — Japanese credit watcher Rating and Investment Information, Inc. (R&I) affirmed on Wednesday the Philippines' "A-" investment-grade rating with a stable outlook. An investment-grade rating signals low credit risk, thereby helping reduce borrowing costs.

This enables a country to allocate more funds to socially beneficial initiatives and programs.

"The economy of the Philippines continues to grow at a relatively high rate among major countries in Southeast Asia," R&I said in a report.

R&I said the Philippines is expected to realize stable economic growth as well as higher income level against the backdrop of robust public and private investments, development of domestic business such as Information Technology and Business Process Management (IT-BPM) industry, and population growth, among other factors.

It also cited the country's inflation rate, which fell to a six-year low of 0.9 percent in July 2025.

The rating agency added that the impact of the 19-percent US reciprocal tariffs is expected to be limited, citing the Philippine

economy's relatively low reliance on exports to the US.

R&I said the Philippines' manageable current account deficit and debt levels, as well as sufficient foreign exchange reserves, underpin the country's robust external position.

"The National Government's outstanding debt for 2024 was 60.7% of GDP. R&I believes that the government debt ratio will remain within manageable level with the progress in reducing fiscal deficits," it said.

"The government meets its funding requirements through the mainly issuance of government bonds in the domestic financial market. The country has a certain level of debt affordability, given a manageable interest payment burden," it added. The agency also cited stability of the banking sector as a key rating driver.

In a separate statement, the Bangko Sentral ng Pilipinas (BSP) welcomed the affirmation

"The low inflation environment is thanks to the agile and evidence-based monetary policy. This environment supports an investment climate that is conducive to economic growth," BSP Governor Eli Remolona Jr. said.

"In line with its financial stability mandate, the BSP continues to strengthen the Philippine banking system through policies that underscore strong capitalization, prudent risk management, and sound governance. These enable banks to finance productive economic activities while navigating a fast-evolving global economic landscape," he added. (PNA) BY ANNA **LEAH GONZALES** 

#### CHEMREZ'S SECONDBIODIESEL PLANT STILL IN PLANNING STAGE — EXEC

MANILA – The plan to build a second Chemrez cocodiesel plant remains on the table and will push through once the government lifts the suspension on the implementation of the 4 percent and 5 percent biodiesel blends.

Chemrez Technology Inc. (CTI), a subsidiary of D&L Industries Inc., currently has a biodiesel plant in Batangas. It is currently the largest manufacturer of biodiesel in the domestic market.

"I would say it's probably a matter of when, not if. Meaning, there's a high probability we will make a second plant. But, in terms of when, how big, how much we'll spend, we still do not have that information since we are still in the planning stage," D&L Industries Inc. president and chief executive officer Alvin Lao said in a statement Thursday.

"We believe, for many reasons, it makes sense for us to consider a second plant even if the increase in the mandated blend has been postponed."

The National Biofuels Board, in an advisory on July 17, announced the suspension of the implementation of the 4 percent (B4) and 5 percent (B5) biodiesel

blends supposedly set for implementation by Oct. 1, 2025 and Oct. 1, 2026, respectively.

The decision, it said, was made "in view of the anticipated significant impact on pump prices and the potential inflationary effects on the national economy" as coconut oil prices remain high due to supply challenges faced by coconut farmers.

D&L earlier said it remains optimistic on the long-term outlook of the country's biodiesel sector, due to its benefits to the economy, environment, and consumers. (PNA) BY JOANN VILLANUEVA

## ALEGARBES, BEJINO JOIN PH SQUAD FOR WORLD PARA SWIMMING TOURNEY

MANILA – Ariel Joseph Alegarbes and Gary Bejino have been added to the five-member national team roster for the World Para Swimming Championships scheduled from Sept. 16 to 27 in Singapore.

Alegarbes will compete in the S14 100m backstroke and 100m butterfly, while Bejino is entered in the S6 50m butterfly, and the 50m and 100m freestyle events.

Both swimmers received direct invitations from World Para Swimming.

At the 2023 ASEAN Para Games in Cambodia, Alegarbes set a new Games record of 2:18.19 in the men's 200m Individual Medley, breaking the 2022 mark of Malaysian Ethan Yin Jun Khoo.

Bejino, meanwhile, won

two gold medals in the 200m and 400m freestyle and added three silvers in shorter events (50m butterfly, 50m and 100m freestyle).

Two-time Asian Para Games champion Ernie Gawilan, Angel Mae Otom and Marco Tinamisan made it to the World Championships after earning slots at the World Para Swimming (WPS) World Series in Fuji, Japan last May.

Gawilan, who competed at the Tokyo (2020) and Paris (2024) Paralympics, qualified in the S7 men's 400m freestyle and SM7 200m Individual Medley events.

Otom, a triple gold medalist at the 2022 ASEAN Para Games, earned her spots in the women's 50m freestyle, backstroke, and butterfly, while Marco Tinamisan, who hails from Quezon, qualified in the S3/SB3/SM3 men's 50m, 100m and 200m freestyle events.

"This is part of their journey going to the 2028 Paralympic Games in Los Angeles," head coach Tony Ong said in an interview Thursday.

Other members of the coaching staff are Brian Micael Ong, Majonie Pulumbarit and Leo Ramos.

The national team is also preparing for next year's ASEAN Para Games in Thailand and Asian Para Games in Aichi-Nagoya, Japan. (PNA) BY JEAN MALANUM

### PH GEARS UP FOR FIFA FUTSAL WOMEN'S WORLD CUP HOSTING

MANILA – The Philippines hopes to make an impact as host as well as on the field in the inaugural FIFA Futsal Women's World Cup.

A total of 16 countries will see action from Nov. 21 to Dec. 7 in Pasig City and Victorias City, Negros Occidental.

These are Spain, Italy, Poland, Portugal (Europe); Iran, Japan, Thailand, Philippines (Asia); Morocco, Tanzania (Africa); Canada, Panama (North America); Argentina, Brazil, Colombia (South America); and New

Zealand (Oceania).

The top two teams from each group will advance to the knockout phase, comprising the quarterfinals, semifinals, a third-place playoff and finals.

Spain, Brazil, Italy, Thailand and Canada will be the toughest teams to beat, according Philippine Football to Federation (PFF) president John Gutierrez during weekly Philippine Sportswriters Association Forum at Rizal Memorial Sports Complex in Manila on Tuesday.

"And if we look at ourselves as mediocre to these powerhouses, then what's the point of us participating" Realistically, we will be very competitive," Gutierrez said.

Coach Rafa Merino has a 20-women pool led by skippers Inday Tolentino and Isabella Flanigan. The team will be trimmed to 16, before the final 14 players. Gutierrez said the hosting preparations are right on schedule.

"We've been having meetings almost every day, updates on certain developments like venues getting them up to par with FIFA standards. It's looking good for us," Gutierrez said.

The PFF expects some
