DEPED CALABARZON CITES GROWING CLASSROOM

CALAMBA CITY, Laguna (PIA) — The Department of Education (DepEd) in Calabarzon has raised concerns over the growing challenges in classrooms, particularly the impact of technology, bullying, and mental health on students and teachers, as the nation observes National Teachers' Month.

According to Ariel M. Zuelo, Unit Head - Public Affairs Unit and Regional Information Officer the DepEd Calabarzon, these issues make this year's National Teachers' Month a timely occasion to recognize the vital role of educators in shaping the country's future.

He added that the environment classroom today is far different from that of the 1970s and 1980s, largely due to the rise of gadgets and online platforms. While technology has opened new learning opportunities, it has also created new distractions.

"Young learners today already know how to manipulate gadgets like cellphones, tablets, and laptops at an early age. That is why teachers cannot afford to be left behind. We must advance technology, alongside especially for veteran educators who need to adapt to these changes," Zuelo emphasized.

Another pressing issue, he added, is the alarming rise in cases of bullying. This includes not only verbal bullying but also physical harm, with some cases linked to mental health struggles among students. **Teachers** themselves also face mental health challenges due to the growing demands of the profession.

"Students are still in the process of developing their identity and character. Teachers must serve as guides in shaping them responsible and compassionate citizens," Zuelo said.

As these challenges persist, the nation takes time to honor teachers through the National Teachers' Month, celebrated from September 5 to October 5. Dr. Eduarda M. Zapanta, Chief of the Education Support Services Division, highlighted that this monthlong celebration is meant to give recognition to the heroism and invaluable contributions of teachers. "Teachers spend more time with children than parents do. their The quality, character, values of our students reflect the dedication of their teachers. Education is the great equalizer. and teachers are second parents who shape not just students but future citizens of our country," Dr. Zapanta said.

Region CALABARZON alone, she noted, there are 3.7 million enrolled learners for School Year 2025, supported by 111,248 teachers across 6,007 schools—including 2,502 private institutions and 17 state universities and colleges. The region continues to have the largest school population in the Philippines.

Dr. Zapanta also highlighted that with over one million personnel, remains DepEd the largest country's government workforce—its reach extending to millions of Filipino families.

For Zuelo, the role of teachers goes beyond textbooks and classrooms.

7 NABBED IN QC JOINT ANTI-ILLEGAL ONLINE GAMBLING RAID

MANILA - Seven suspects were arrested for illegal online gambling during a joint operation of the Cybercrime Investigation Coordinating Center (CICC), the Sweepstakes Philippine Office (PCSO), and the Philippine National Police Thursday. (PNP) on In a press conference at Station 14 of the Quezon City Police District (QCPD), PCSO Shield Chair Orlando Malaca said the operation started when an authorized agent of the PCSO was caught continuing gambling operations despite the end of its contract with the agency in July. Malaca said such illegal activities affect PCSO's revenues and the charity activities provided by the agency to the public.

"Kung may mawawala na papasok dapat sa kaban ng bayan, ito po ay magiging losses din po sa mga nangangailangan din po ng tulong na umaasa sa PCSO. In particular yung mga medical assistance (If revenue to the government ceases, this will also be a loss for those who rely on the PCSO. In particular those who need medical assistance)," he said. In response, the PCSO reached out to the CICC, who coordinated with the PNP for a joint investigation and raid carried out by the QCPD Station 14. The raid resulted in

the arrest of seven suspects, the confiscation of mobile devices, and other equipment used in the illegal online gambling operation.

These suspects face charges under the

These suspects face charges under the Cybercrime Prevention Act (RA 10175), Presidential Decree 1602 (Prescribing No. Stiffer Penalties on Illegal Gambling), and related statutes.

The suspects are now undergoing inquest proceedings, while the seized digital devices will undergo forensic analysis by the CICC to identify the broader network behind the operation.

During the event,
Department of Information
and Communications
Technology (DICT)
Secretary Henry Aguda
said the operation is in
fulfillment of President
Ferdinand R. Marcos Jr.'s
marching order to cleanse
the country's cyberspace
of illegal activities.

"We hope to bring more cases like this within the year, especially interagency cases such as this, which show how much stronger we are when we work together," Aguda said.

On the other hand, CICC Acting Executive Director Renato "Aboy" Paraiso said such operations are carried out to protect the most vulnerable sectors of society.

"These illegal operators may seem small at first glance, but over time, their impact is significant. That is why we are relentless in pursuing them," Paraiso said.

FPJ Panday Bayanihan Party-list Rep. Brian Poe Llamanzares witnessed the operation and lauded its success.

"This event is a clear demonstration of strong collaboration across government agencies, and a strong case for capacitating agencies with adequate resources they need to sustain these victories against illegal online gambling," the lawmaker said. (PNA) BY RAYMOND CARL DELA

E-GOVERNANCE LAW TO BRING MORE TRANSPARENT SERVICES - CAYETANO

MANILA – Senate
Minority Leader Alan
Peter Cayetano on Friday
said the newly signed
E-Governance Law
streamlines systems and
improves government
services.

Cayetano said the law would make government more transparent, accessible, and connected, which would translate into "more time, more trust, and more dignity" for Filipinos. "Technology can

"Technology can modernize government, but guided by purpose, it can truly uplift lives," he said in a statement.

The senator said the measure, together with the Konektadong Pinoy Law, would ensure that progress reaches communities by integrating digital transformation with inclusivity.

President Ferdinand R. Marcos Jr. signed the law earlier this week as part of efforts to digitalize public services.

The measure mandates the establishment of an integrated digital platform where citizens can transact with government agencies online, reducing paperwork and improving efficiency.

The Department of Information and C o m m u n i c a t i o n s Technology (DICT) will take the lead in implementing the law, working with other agencies and local government units to build and maintain the digital infrastructure.

It will also be tasked to ensure interoperability of platforms, protect data privacy, and strengthen cybersecurity.

The law is a consolidation of bills principally authored by Senator Christopher Lawrence Go and House Speaker Ferdinand

Martin Romualdez, with various senators, including Cayetano, supporting its swift passage.

The Senate and House of Representatives ratified the bicameral conference committee report on the measure in June before transmitting it to Malacañang for the President's signature.

The law had been filed in previous Congresses but failed to hurdle both chambers until the 19th Congress, when digitalization became a top government priority following the lessons of the Covid-19 pandemic.

Senator Sherwin Gatchalian also welcomed the law, saying it will revolutionize the delivery of government services through a secure digital system.

Gatchalian, a co-author of the law, said the measure would make government services more accessible, especially for citizens in remote areas and persons with disabilities.

The chair of the Senate Committee on Finance added that the law would streamline processes, cut costs, and minimize corruption by ensuring projects are undertaken openly. (PNA) BY WILNARD BACELONIA

DMW RECALLS LABOR ATTACHÉ TO FACE FLOOD CONTROL PROBE IN PH

MANILA – Migrant Workers Secretary Hans Leo Cacdac has ordered the immediate recall of Labor Attaché Macy Monique Maglanque, currently stationed in Los Angeles, United States, to face an official investigation back home.

Maglanque was recently named in a privilege speech on the anomalous flood control projects by Senate Blue Ribbon Committee Chair, Senator Panfilo Lacson, on Tuesday, prompting the Department of Migrant Workers' (DMWs) swift action.

He said the move reflects the agency's adherence to accountability and transparency, as mandated by President Ferdinand R. Marcos Jr.'s Executive Order 94, which upholds integrity and good governance in public service.

PBBM INSTITUTIONALIZES SHIFT TO E-GOVERNANCE

MANILA President Ferdinand R. Marcos Jr. has signed law а the institutionalizing transition to e-governance digitally foster а empowered and integrated government through secure, regulated, robust information and communications technology (ICT).

Republic Act (RA) 12254, inked by Marcos on Sept. 5, applies to all executive, legislative, judicial, and constitutional offices, including local government (LGUs), state universities and colleges government-(SUCs), owned or -controlled corporations (GOCCs).

The new law also covers government instrumentalities located in the Philippines and abroad, which provide services covering business- and non-business-related transactions.

RA 12254 encompasses back-end operations within and between government agencies, including data sharing and coordination for policy-making, planning, and decision-making, as well as other inter-agency functions.

"Nothing in this Act shall be construed to derogate from the fiscal and administrative autonomy and independence of government entities," the law read.

Department The Information and Communications (DICT), Technology designated as the lead implementing body and administrator of RA 12254. is mandated to ensure that all ICT projects in the Philippines will be done in accordance with the National ICT Development Agenda and E-Government Master Plan, as provided under RA 10844 or the Department of Information Communications and Technology Act of 2015.

The law directs DICT to ensure that all ICT projects in the Philippines, whether national or local, are harmonized with the

overall ICT plans and in compliance with applicable standards.

Within a year of RA 12254's implementation, the government will establish a unified E-Governance Project Management Office (EGov UPMO) to oversee portfolio, program, and project management across agencies.

The EGov UPMO is

tasked to ensure effective handling of ICT projects in line with international best practices and standards. Under RA 12254, the DICT will formulate and promote an E-Government Master Plan (EGMP) or equivalent that will serve as a blueprint for development the and enhancement government electronic service processes and workforce to achieve digital transformation in the bureaucracy, taking consideration the into Philippine Development

The DICT, in coordination with relevant government agencies, will also develop E-Government Programs (EGPs) that will be regularly updated in consultation with stakeholders.

EGPs include the Citizen Frontline Delivery Services Platform; Electronic Local Government Unit (eLGU) System; Government Digital Payment Systems; Government Public Key Infrastructure Program; Online Public Service Philippine Portal: and Digital Health System.

The DICT will conduct a mandatory Privacy Impact Assessment, according to relevant National Privacy guidelines, Commission on the proposed systems for processing personal data included in the EGMP before its publication, to identify privacy risks and establish the appropriate framework control line with existing data privacy and cybersecurity standards

The DICT will also prescribe and implement minimum information security standard for

E-Government, aligned internationally with accepted standards, relevant laws, rules, and regulations, including its own policies, to ensure the security of all ICT systems. The DICT, in coordination with relevant government agencies and stakeholders, will issue guidelines for the protection of the government's critical information infrastructure identified in the EGMP.

Subject to compliance with existing laws, rules, and regulations, the free public Internet access program utilize the Free will Public Internet Access Fund (FPIAF) to provide computer necessary systems. programs, databases, management and information systems, core transmission and distribution networks facilitate knowledgebuilding among citizens.

According to RA 12254, national and local governments are not prohibited from entering into contracts, agreements, or partnerships with the private sector to provide various resources, assets, and services.

Any and all contracts or agreements with the private sector within the context of the law will be subject to the laws and rules on public accountability,

UNIFIED 911 EMERGENCY HOTLINE PROMISES FASTER RESPONSE NATIONWIDE

MANILA – The Philippine government launched Thursday the unified 911 emergency hotline that would provide faster and more coordinated responses to emergencies nationwide.

Department of the Interior and Local Government (DILG) Secretary Jonvic Remulla said the hotline, which replaces multiple local emergency numbers, would serve as the central point of contact for police, fire, medical, and disaster response services.

"We had 35 LGUs [local government units] with their own numbers, we had the PNP (Philippine National Police), we had the BFP (Bureau of Fire Protection). We have the other 200 numbers then we have 40,000 barangays, where the constituents would call first the barangay captain to call

transparency, and good governance.

"To ensure inclusivity, public telecommunications entities (PTEs) and noninternet service providers (ISPs) be allowed to enter into contracts with government agencies at the national and local levels to build and operate networks to provide internet connections in support of E-Government Programs, especially in the underserved and unserved areas," RA 12254 said.

The DICT is instructed to reorganize and restructure its ICT Literacy and Competency Development Bureau, to develop rules and policies for the operations of the ICT Academy for E-Governance.

RA 12254, made public on Thursday, takes effect 15 days after its publication in the Official Gazette or in a newspaper of general circulation. "Today, we have one number and that is 911," he added.

The 911 hotline is toll-free for all landline and mobile calls, making it accessible to both urban and rural communities.

Remulla said the initial phase would soon be expanded, targeting getting on board about 240 operators in 120 days.

He warned bogus and prank callers that their numbers would be blocked, making it difficult for them to ask for help when an emergency arises.

"Sa mga mag-bo-bogus call dito sa 911, baka pagsisihan niyo 'yan sa dulo. Dahil kung kayo may tunay na emergency, baka hindi na kayo puntahan. Hindi na tatanggapin ang tawag ninyo. So, huwag niyo 'yun subukan kasi kung kamag-anak magka problema, pamilya mo may problema, hindi ka na papansin ng 911 system (To those who make bogus calls to 911, you might regret it in the end. Because if you have a real emergency, they might not come to you. Your call will not be answered. So, don't try that because if your relative has a problem, your family has a problem, the 911 system will ignore you)," Remulla said.

The unified 911 is a joint initiative of the DILG, the Bureau of Fire Protection (BFP), telecoms firm PLDT Inc. (PLDT), and NGA 911 Philippines, the local arm of US-based NGA 911 LLC. It introduces next-generation emergency

c o m m u n i c a t i o n s technology already proven in the United States and Europe.

The system comes with advanced features designed to strengthen public safety, including GPS-based location tracking that allows faster and more precise dispatch of emergency teams.

It also uses internet protocol to transmit voice, text, and video between callers and responders, providing real-time data that enhances situational awareness.

Don Ferguson, co-founder and CEO of NGA 911 LLC, said the system "will help the DILG save more lives and empower more communities now that all systems have been unified into one nationwide system".

PNP acting chief Lt. Gen. Jose Melencio Nartatez Jr. said the unified hotline ensures immediate help to the public wherever they are in the country.

He said a single hotline number would eliminate confusion to the public and saves time.

PSA PRAISES LGUS, COMMUNITY EFFORTS FOR DROP IN ADOLESCENT BIRTHS IN NEGROS ORIENT

DUMAGUETE CITY. Negros Oriental (PIA) —The Philippine Statistics Authority (PSA) has commended local government units (LGUs) and partner agencies for their initiatives to curb teenage pregnancy, after data showed a slight decline in adolescent births in the province last year.

Teenage pregnancy in Negros Oriental dropped from 11.3% in 2022 to 10.9% in 2023, said PSA Negros Oriental Chief Engr. Ariel Fortuito.

"A decline in the number of babies born to adolescent mothers indicates the success of the initiatives run by the (LGUs)and other relevant organizations," said Fortuito.

He added socioeconomic factors like education, employment, and family environment also play an important role. In 2023, the PSA recorded 2,189 babies born to mothers younger than 20 years old, or 10.9 % of total registered live births in the province

Of these, 47 were born to mothers under 15 years old, while 2,142 were born to mothers aged 15 to 19. Fortuito encouraged LGUs to sustain programs addressing adolescent pregnancies, particularly in marginalized communities. "I firmly believe that LGUs should keep up their initiatives and strategies to address teenage pregnancy, especially in marginalized communities," he said.

PSA data identified the top five cities and towns with the highest number of adolescent births: Bayawan City with 268, Guihulngan City with 182, Siaton with 155, Sta. Catalina with 144, and Mabinay with 117.

For very young mothers

under 15 years old, the highest numbers were reported in Siaton with eight, Bayawan City with seven, Sta. Catalina with five, Mabinay with four, and three each in Ayungon, San Jose, and Tayasan.

The PSA noted that adolescent births in the province have been steadily declining: 2,254 in 2021 (11.4%), 2,211 in 2022 (11.3%), and 2,189 in 2023 (10.9%).

Fortuito also emphasized that parents must take the lead in promoting responsible behavior among adolescents to reduce risks.

Under the Parent Effectiveness Service (PES) Program (Republic Act No. 11908), Department the of Education or the LGUs are mandated to work Parent-Teacher Associations to develop activities that strengthen parenting skills and support child development.

The law requires implementation of the PES program in every city and municipality nationwide.

The program aims to support all parents and guardians in strengthening their parenting skills, promote children's rights, and encourage positive early childhood development.

In the Philippines for the year 2023, adolescent mothers. particularly those under 15 years old, recorded the highest proportion of non-marital births, with 96.5% of their total births classified as non-marital.

This was followed by mothers aged 15-19 years old at 91.1% and aged 20-24 years old at 78.3%. (JCT/PIA-NIR Negros Oriental) BY MARIA JENIFER C. TILOS

DAVAO CITY EXTENDS AID TO 84 OFWS AND FAMILIES IN FIRST HALF OF 2025

DAVAO CITY—The Davao City local government unit through its City Social Welfare and Development Office's (CSWDO) OFW Crisis Center has provided assistance to 84 overseas Filipino workers (OFWs) and their families in Davao City from January to June this year.

OFW Families Welfare and Crisis Center (OFWCC) Coordinator Rosevic Joey M. Jayme reported that 51 of the cases involved distressed OFWs facing labor-related issues such contract disputes, maltreatment, and the ongoing conflict in Israel. The remaining 33 cases involved family members in

crisis situations who were given immediate support. Jayme said the OFWCC caters to both OFWs and their families, offering a range of services including psychosocial intervention, livelihood programs, assistance, educational protective custody. rescue operations, and financial aid worth ₱5,000 for individuals in crisis situations, subject to assessment.

She said that in partnership with agencies such as the Overseas Workers Welfare Administration (OWWA) and the Department of Migrant Workers (DMW), the CSWDO participates in service caravans to

inform OFWs and their families about available Victims of programs. TIP are also provided with legal assistance through partner agencies, while the DMW extends both legal and financial support for case filing. The Department of Social Welfare and Development (DSWD) likewise offers recovery and rehabilitation aid, including financial assistance for TIP victims and their families.

MERALCO RATES DOWN IN SEPTEMBER DUE TO LOWER GENERATION CHARGES

MANILA Lower generation charge allowed Electric Manila Company (Meralco) to reduce power rates this September by PHP0.1852 per kilowatt hour (kWh), to PHP13.0851/kWh.

In a briefing Wednesday, Meralco vice president and head of corporate c o m m u n i c a t i o n s Joe Zaldarriaga said charge generation charge declined by PHP0.2603/ kWh due to lower cost from Independent Power Producers (IPPs) and the Power Supply Agreements (PSAs).

The factors are, however, counted by the higher prices in the Wholesale Electricity Spot Market and the higher contract price set by some of their producers -- Sual Power Inc. (SPI) and the South Premiere Power Corporation (SPPC), with the latter based on an earlier Supreme Court

decision allowing power producers to adjust prices to cover additional fuel costs.

Citing the SC decision. the Energy Regulatory Commission (ERC) has approved the collection of a total of PHP5.1 billion over a period of six months. starting this September. PSAs account for the

largest source of Meralco's supply, at 65 percent, followed by IPPs, 29 percent, and WESM, 6

percent. With these residential changes, customers consuming 200 kWh per month will get PHP37 lower power expenses this month.

"We're hoping to hit the magic 100 within the year," she said.

Paul traced her optimism to the strong rise of their customer base, which to date numbers around 12.2 million

She said partnerships for product offerings have increased to around 18,000 stores nationwide, up from about 16,000 stores at the end of last year.

Sales force has also improved, she said, noting that they already have around 10,000 agents so far this year.

She said these staff, along with those from the partner stores, boost growth in utilization of their financial offerings.

Even with the rise in customers and receivables, Paul said non-performing loans (NPLs) remain below their 10 percent threshold, but declined to give specifics.

MANILA – Alas Pilipinas is in potentially strong hands with the young guns providing energy and determination to step up for a once-in-a-lifetime opportunity of playing in the FIVB Volleyball Men's World Championship that starts Friday at the SM Mall of Asia Arena.

Italian coach Angiolino Frigoni put his trust in younger players from the UAAP-Michaelo "Buds" Buddin, Jade Disquitado, Louie Ramirez, and Eco Adajar-as well as Josh Ybañez, Leo Ordiales and Peng Taguibolos, and Louie Ramirez, representing the NCAA as a two-time MVP out of the University of Perpetual Help, to prove that the future is bright for Philippine volleyball.

Buddin, who was once a kid from Palawan dreaming of playing in Manila, believes that making it to the historic Alas Pilipinas batch would mean the world to him after being a late call-up last year, stepping up in the Philippines' back-to-back bronze medals in the SEA V.League 2024, where he also won a pair of Best Outside Hitters.

"Honestly, this is a dream come true. I couldn't ask for more. Coming from the province, I just dreamed of making it to Palarong Pambansa, then I played for NU in the UAAP, and now the national team. It just feels like everything's been falling into place, especially if I end up getting lined up for the World Championship," said the 24-year-old Buddin.

"It's a once in a lifetime opportunity to play and represent the country. That would be a huge honor and probably the biggest moment of my career so far."

For the 25-year-old Ramirez, who has shown versatility at Alas as an outside or opposite hitter, he is also carrying the pride of the NCAA if he makes it to the final roster and debuts on opening day against Tunisia at 7 p.m. after an electrifying kick-off ceremony featuring K-Pop group BOYNEXTDOOR and Cebuana singersongwriter Karencitta.

"I'm proud that wherever I go, I still carry the NCAA with me. It means a lot to come from there," said Ramirez, who is now playing for Cignal in the Spikers' Turf. "This will definitely be one of the best moments of my volleyball career. It's the world championship.'

Disquitado, who received a call-up in the 2023 Southeast Asian Games when he was 19, has been the spark plug of the team, giving the much-needed energy from the bench.

And for an outside spiker, who was discovered in Santa Rosa, Laguna, it's all about inspiring the next generation of volleyball players.

"Honestly, I never expected to reach this level. I'm really proud of myself for making it this far. It's not easy to get here," said the 21-year-old Disquitado, who was part of National University's five-peat team in the UAAP with Taguibolos, Ordiales and Buddin.

"This means a lot to me, especially for the experience. And for the younger players coming after us. I hope they work hard in training, listen to their coaches, and keep pushing so they can also

reach this level someday." Adajar, the La Salle setter, is facing a tall order of running the plays with Owa Retamar on the world stage. But he vows not to disappoint with his teammates and coaches and the whole Philippine volleyball community rallying behind the team.

"As a rookie and one of the youngest members of Alas, being a setter is definitely one of the toughest roles in volleyball and to top it off, I'm playing on the world stage. But with the guidance of our older teammates, the role doesn't feel too heavy because they're always there to lead us," said the 24-year-old Adajar.

"As a setter working alongside Owa, it's been a great learning experience. We constantly exchange knowledge during training and games. Plus, with the support of the home crowd, I think we'll feel lighter and more confident on the court knowing the Filipino fans are cheering us on."

These up-and-coming Filipino aces may be coming from different programs and have been competing against each other in their respective leagues. But all of them are on the same page, promising to stay ready and contribute when they get a chance to play - if not, they will be showing the same energy cheering for their team.

Alas also battles the No. 23 Egypt on Sept. 16 before taking on Asian powerhouse Iran on Sept.

The final 14 will be known after the preliminary inquiry on Thursday.

AYALA FOUNDATION, MVPSF TO DEVELOP WORLD-CLASS ATHLET!

MANILA Ayala (AFI) Inc. Foundation and the MVP Sports Foundation Inc. (MVPSF) agreed to develop more Filipino athletes who can compete on the global stage.

The first initiative created

Once the initial pool of

players is formed, he would call for practices every Monday and prior to departure for Thailand. The team will then practice eight to nine straight days. He said winning the gold this time would be far different than 14 years ago in the Indonesian capital.

"It's a lot different now. Things have changed at how teams are recruiting players now. Things are different in the sense that everybody has improved in Southeast Asia," he said. "But the goal will definitely be to win the gold. There's a lot of work to be done."
