CITY OF BACOOR, Cavite (PIA) — The City Government of Bacoor recently conducted a comprehensive Skill Enhancement Training for barangay tanods from various communities across the city.

The training initiative, which was organized by the Barangay Affairs Office, aimed to equip barangay tanods with the necessary skills to effectively maintain peace and order in their respective areas.

The simultaneous sessions were held at Villar Hall for tanods from Aniban 1 & 2, Bayanan, Dulong Bayan, and Molino 1 to 4, while Gawaran Hall hosted participants from Habay 1 & 2, Ligas 1, Kaingin Digman, Niog, and Molino 5 to 7.

The event also drew support from key including officials, LnB Vice President Randy Francisco, Bacoor Chief Prosecutor Fiscal Johnny Ompong, and Bacoor PNP Chief PLtCol Alexie Desamito, along with representatives from partner agencies.

In his message, Mayor Revilla emphasized the crucial role of barangay tanods as the "first line of defense" in community security, especially amid the city's limited law enforcement manpower.

He announced plans to

issue an executive order to formally deputize tanods, providing them with greater authority to enforce local ordinances.

"Law enforcement must be impartial," the mayor stressed, urging tanods to uphold their duties without bias. "Kung mali, mali-regardless if they're your relative, friend, or kumpare," he firmly stated. In recognition of their vital role, Mayor Revilla also announced a ₱2,000 monthly allowance increase for all tanods, with hopes of further adjustments as the city's financial capacity improves.

The training underscores the city's continued commitment to building a safer Bacoor by empowering its community-based peacekeepers.

#### PNR ON TRACK FIXING RIGHT-OF-WAY ISSUES FOR SOUTH LONG HAUL RAIL PROJECT

SAN PABLO CITY, Laguna (PIA) — The Philippine National Railways (PNR) continues to fast-track addressing right-of-way issues that have caused delays in the completion of the South Long Haul Project.

A priority railway project of the Marcos administration, the 577-kilometer and 33-station rail connection from Metro Manila to Batangas and Bicol, the Calamba-Legazpi route of the SLH project is expected to be operational by 2026. PNR General Manager Deovanni Miranda said that the railway project has faced issues involving land

that the railway project has faced issues involving land acquisition, relocation of project-affected persons such as informal settler families, utility relocation and coordination with local government units (LGUs).

"Currently, what we are doing for this project is preimplementation, most of it is right-of-way activities, including (resettlement of) the informal settlers," he said.

Miranda said right-ofway activities include the purchase of additional land for the ROW project, for the informal settlers, and utility relocation.

The PNR official assured stakeholders of faster project implementation once issues with the right-of-way are resolved and implementation funding has been allocated.

The rail agency is working closely with the Department of Human Settlements and Urban Development (DHSUD), **National Housing Authority** (NHA) and concerned LGUs in the province to fast-track expropriation proceedings and ensure affected families are properly compensated and relocated.

The PNR together with

DHSUD and NHA turned over last Monday 1,099 housing units in St. Barts Southville Heights, San Pablo City, Laguna to families affected by the railway development.

Once completed, the rail line will reduce travel time from Manila to Legazpi from the present 14 to 18 hours to six hours, using regular commuter trains and 4.5 hours, using the line's express trains. (AM/PIA 4A) BY ANNA MOLE

### SSS INCREASES MONTHLY SENIOR PENSION

SAN PABLO CITY, Laguna (PIA) – The Social Security System (SSS) South Luzon I Division marked its regional celebration of Pensioners' Day in San Pablo City on September 12 by highlighting the agency's pension reform program and the recent increase in monthly senior citizen pension benefits.

The event forms part of the 68th Anniversary of SSS, which highlights the agency's commitment to recognizing the contributions of pensioners while ensuring they remain informed about new reforms and services.

SSS South Luzon I Vice

President Engr. Edwin Igharas emphasized the importance of the annual celebration as a platform to engage with pensioners and address their concerns.

"This is our way of giving back to our pensioners who have been part of the system's growth. We want to assure them that SSS continues to improve our programs for their benefit and we now have a SSS Pension Reform program where they can enjoy a 10 percent percent increase on their pension for three years from the government," Igharas said. SSS said that the reform is designed to strike a balance between providing adequate pensions to retirees and ensuring that future generations of members will continue to enjoy the same security.

64 year-old Benita Jonos Catahan of Nagcarlan, Laguna, expressed her appreciation for the reforms being implemented by the SSS which directly benefits her in easing financial burden amid rising healthcare costs and daily expenses.

"We are grateful for the 10 percent increase in our pension because us seniors already have maintenance. We already have many needs. This is additional help with our need to buy medicine, so thank you very much," she said.

Other topics discussed during the program was the SSS Pension Reform Program, which seeks to secure the long-term sustainability of the Social Security Fund by introducing enhancements in benefits for members.

Participants were treated to a series of activities, including free health checks, financial literacy sessions, and forums where they could raise inquiries directly to SSS officials.

### CONSUMER RIGHTS, FAIR TRADE LAWS

CITY OF CARMONA, Cavite (PIA) — The Department of Trade and Industry (DTI) continues to strengthen consumer protection and promote responsible business practices as its Cavite Provincial Office recently held an orientation on fair trade laws for merchants operating at Davilan Food Park in this city.

The activity formed part of the "Seminar on Consumer Protection Awareness with Focus on Food Safety and Public Health" spearheaded by the City Government of Carmona through its Local Economic Development and Investment Promotion Office (LEDIPO).

DTI-Cavite's Consumer Protection Division OIC, Mr. Rexel Amparo, and Trade and Industry Development Specialist, Mr. Arner P. Olayres, served as resource speakers.

The discussion highlighted the essential provisions of Republic Act No. 7394, or the Consumer Act of the Philippines, including the roles of various implementing agencies, and the consumer rights and responsibilities.

The orientation also tackled recent policy updates directly impacting

daily business operations. Among these were the revised guidelines on granting mandatory discounts to Senior Citizens and Persons with Disabilities, as outlined in the DTI-DA-DOE Joint Administrative Order No. 24-02.

Additionally, merchants were briefed on the continued enforcement of Republic Act No. 10909, also known as the No Shortchanging Act of 2016, which prohibits giving insufficient change to consumers.

According to Amparo, these discussions aimed to ensure that local entrepreneurs remain informed and compliant with current trade and consumer protection laws. Through this initiative, DTI-Cavite reaffirmed commitment supporting local micro and small enterprises while prioritizing consumer protection.

Amparo added that by promoting greater awareness and compliance with fair trade laws, the agency seeks to cultivate a more ethical, responsible, and sustainable business environment across the province. (RBF/DTI-Cavite)

# DSWD: STRICT MONITORING OF PRIVATE CARE FACILITIES ENSURES COMPLIANCE

#### MANILA The Department of Social Welfare and Development (DSWD) has assured the 921 accredited social welfare and development agencies (SWDAs) that there is no cause for alarm on the agency's semestral monitoring visits as these inspections are aimed at ensuring their compliance to the existing standards.

Director Megan Therese Manahan of the DSWD's Standards Bureau (SB) said that with stronger monitoring measures in place, there is a prevailing apprehension among the 921 SWDAs that agency visits might result in the closure of their facilities following recent incidents of violations which led to the shutdown of two private facilities in Pampanga and Zambales.

"We want to guarantee the non-government organizations (NGOs). the SWDAs, hindi naman abrupt yung pagpapasara natin. And kung maayos naman ang operations maayos niyo, kung naman ang pakikitungo sa beneficiaries niyo, wala kayong dapat ikabahala (there will be no abrupt closure. And If your operations are compliant, you have good relationship with your beneficiaries, there's nothing to worry about)," Manahan said during a media forum Thursday at the DSWD Central Office in Quezon

As part of its statutory function, the DSWD issues a registration, license to operate, and accreditation certification (RLA) to organizations and facilities implementing social welfare and development programs and services.

The department enforces quality standards that must be complied with by the SWDAs. Non-compliance and violations are met with sanctions and corrective measures.

The monitoring visits to two facilities in Central Luzon led to the issuance of cease-and-desist orders (CDO) by Secretary Rex Gatchalian due to noncompliance with standards and reports of abuses against children under their care.

Manahan said the issuance of the CDO goes through a review process and is not an abrupt measure unless the complaint submitted to the DSWD is substantiated with testimonies and other evidence of abuse which put the vulnerable clients in danger.

"May due process po tayo dito (We have due process here). I don't want the public to think that it's okay to issue cease-anddesist order even if there is an unverified complaint. We have a vetting process, review committee composed of social workers, lawyers, and even SWDA members," she said.

Manahan said the DSWD immediately acts on any report of non-compliance or complaint which is sufficient in form and in substance.

The grounds for the filing of complaint include the mismanagement of funds, improper case management, various abuses, use of SWDAs for immoral or illegal purposes, falsification of documents, injury or death of a beneficiary due to poor management, and the presence of hazards to the SWDAs clients.

"The CDO is a mere preventive measure pending resolution of a complaint and shall be immediately effective once served and the SWDA is ordered to cease and desist from further operations for a maximum period of 30 days. The residents of the facility will be placed under the protective custody of DSWD," Manahan said.

From February to September this year, the DSWD has issued eight CDOs.

# DOTR BEGINS DEMOLITION OF OLD PNR STATIONS TO FAST-TRACK NSCR SOUTH

MANILA - The Department Transportation (DOTr) on Thursday began the demolition of Philippine National Railways (PNR) stations from Santa Mesa, Manila to Cabuyao, Laguna as part of the construction of the southern part of the North South Commuter Railway (NSCR).

In an interview at the PNR Cabuyao Station, acting DOTr Secretary Giovanni Lopez said the simultaneous demolition of these stations is in line with President Ferdinand R. Marcos Jr.'s order to accelerate the construction of big-ticket transportation projects for the benefit of commuters.

He said the demolition works include 10 stations that would help complete the NSCR South viaduct. include Santa These stations Cabuyao, Alabang, Bicutan, Blumentritt, Sucat, Muntinlupa, Biñan, San Pedro, and Mamatid Stations.

"Ito lang ang isang paraan para matuloy na ang ating proyekto. At hindi rin po natin magagawa ito kapag wala ang tulong ng lokal na pamahalaan (This is one way for us to continue the project. And we can't do this without the help of the local government)," Lopez

### GSIS REMOVES PENSION CAP, WIDOWS TO GET BIGGER BENEFITS

**MANILA**-The Government Service Insurance System (GSIS) has lifted the cap on survivorship pensions, ensuring that widows and widowers of government workers will now receive bigger benefits.

In a resolution issued recently, the GSIS Board ceiling removed the that previously limited survivorship pensions, granting surviving spouses the full entitlement under Republic Act 8291, or the GSIS Act of 1997.

Survivors will now receive 50 percent of the pension of the deceased member pensioner without or restriction.

"This policy shift was made to follow the law under Republic Act No. 8291. By lifting the cap, GSIS ensures that surviving spouses will receive what they are rightfully entitled to, while staying true to our duty of providing fair and adequate benefits," GSIS officer in charge President and General Manager Juliet Bautista said in a news release Friday.

Under the old policy, survivorship pensions were capped at 50 percent of the salary of an undersecretary (Step 8), limiting the amount that survivors amount could claim.

With the reform, pensions will be automatically recomputed for those affected by the previous cap, while future survivors will likewise receive the full entitlement.

The GSIS assured its 1.8 million active members and nearly 450,000 pensioners that its fund remains stable financially capable of supporting the policy change. (PNA) BY WILNARD BACELONIA

#### NAPOLCOM FILES RAPS VS. COPS LINKED TO BRIBERY, RAPE, MISCONDUCT

MANILA – The National Police Commission (Napolcom) filed administrative charges on Thursday against several cops involved in three separate incidents of alleged grave misconduct.

At a press briefing at the Napolcom main office in Quezon City, Napolcom Vice Chairperson and Executive Officer Rafael Calinisan said the IMIS (Inspection, Monitoring and Investigation Service) filed formal charges for grave misconduct and conduct unbecoming of a police officer against Col. Rommel Estolano, former chief of the Highway Patrol **Group Special Operations** Division (HPG SOD), for allegedly accepting PHP7 million in bribes from an arrested suspect.

The case stemmed from a June 13 operation in Parañaque City, in which HPG personnel flagged a certain "JJ Javier" initially for traffic violations, then discovered firearms in his vehicle.

Five of the HPG officers alleged that Estolano accepted bribes for special treatment for the suspect while in detention and for him to fix his case.

However, when asked to comment, Estolano accused the HPG officers of arresting the suspect over a warrant that had already been recalled by a Pasay City court in July 2024.

Meanwhile, Calinisan said another complaint of grave misconduct and conduct unbecoming of a police officer was filed against two Marikina City cops for allegedly raping a patrolwoman.

"Ang IMIS ay nakakita ng probable cause para sila ay kasuhan (Our IMIS saw probable cause to charge them)," he said.

According to reports, the suspects – a patrolman and a staff sergeant – allegedly picked up the victim on Aug. 17 while she was on duty and invited her for coffee.

She was then allegedly molested inside a police

mobile along a jogging lane in the city.

The two suspects are now confined at the Eastern Police District (EPD) Personnel Holding and Accounting Unit (PHAU) and will be facing administrative charges, as well as acts of lasciviousness and violation of Republic Act 8353, or the Anti-Rape Law.

The third administrative charge involved seven police officers from the Caloocan City police who were implicated in the death of Dion Angelo Dela Rosa, a 20-year-old student who died of leptospirosis in July.

The legal complaint, endorsed by Cardinal Pablo Virgilio David, accuses seven police officers of grave misconduct, grave dishonesty, incompetence, oppression, and conduct unbecoming of an officer.

"Kakasuhan sila ng grave misconduct, grave dishonesty, incompetence, oppression, and conduct unbecoming of a police officer (They will be charged grave with misconduct, grave dishonesty, incompetence, oppression, and conduct unbecoming of a police Čalinisan said officer)," without identifying the officers being charged.

The three charges were brought by the IMIS to the Napolcom Legal Affairs Service for the assignment of a hearing officer and the serving of summons to the officers being charged.

Manila cops charged anew Meanwhile, Calinisan also presented to the media another delivery rider, Nicole Owen Solleza, who filed a complaint before the Napolcom on Thursday against 11 Manila Police District Drug Enforcement Unit (MPD DEU) personnel for allegedly abducting him and a fellow delivery rider last week.

Solleza accused the officers of forcibly taking him and fellow delivery rider Chester Dumaran into a vehicle and driving them around Rizal province

for hours on Sept. 9 over allegedly fabricated drug charges.

Solleza said he and Dumaran knew each other from their delivery app and were meeting to catch up when the group of officers supposedly accosted them.

Calinisan said that Solleza was released pending further investigation by the Manila city prosecutor on Sept. 11.

Solleza said he was not involved in illegal drugs, claiming that he only underwent a general medication examination and not a drug test while in police custody.

IMIS Chief Edman Pares did not name the 11 respondents but said the group comprised four staff sergeants, two master sergeants, two patrolmen, a major, a corporal, and a senior master sergeant.

Calinisan said regarding Dumaran's and Solleza's complaints, the agency received information that some of the 11 police officers accused were also part of an allegedly anomalous June 20 antidrug operation in Tondo, Manila.

He said the Napolcom had already opened a motu proprio investigation into that supposed incident.

On Sept. 12., Dumaran filed his complaint with the IMIS against a police major, two master sergeants, two staff sergeants, one corporal, and one patrol officer for grave misconduct, grave irregularities in the performance of duty, and conduct unbecoming of a police officer.

"Gumugulong na po 'yung administratibo nila na kaso at binibigyan po natin ng pagkakataon 'yung both parties dito sa due process (Their administrative case is rolling and we are giving both parties a chance for due process)," he said during a press briefing at Camp Crame in Quezon City. ### PDEA: P87.19-B NARCOTICS SEIZED SINCE START OF MARCOS ADMIN

MANILA - The Marcos administration's antidrug campaign has so far netted PHP87.19 billion worth of narcotics since July 2022, the Philippine Drug Enforcement Agency (PDEA) reported on Thursday.

The amount included 11,680.81 kilograms of shabu; 100.57 kg. of cocaine; 144,927 kg. of eestasy tablets and 7,767.16 kg. of dried marijuana leaves and bricks seized from July 2022 to August this year.

The PDEA also said it conducted 120,787 operations across the country during this period which resulted in the arrest of 162,597 drug suspects, 10,342 of whom were high-value targets.

"This is not just a tally of arrests and seizures, it is a testament to our unwavering commitment to dismantle the drug menace at every level," PDEA Director General, Undersecretary Isagani Nerez said.

A total of 1,582 drug dens and three clandestine shabu laboratories were dismantled during the same period.

Meanwhile, 29,633 out of 42,000 villages have been declared "drug-cleared," while 6,193 barangays

declared drug-free.
During his fourth State of the Nation Address (SONA) last July, President Ferdinand R. Marcos Jr. vowed that the government would remain relentless in its fight against the illegal drugs trade in the country. NCRPO operations

Meanwhile, the National Capital Region Police Office (NCRPO) has confiscated PHP7.6 million worth of illegal drugs and arrested 872 individuals in a weeklong police operation from Sept. 8 to 14.

In a statement on Thursday, acting chief PNP Jose Melencio Nartatez Jr. said among those arrested were 119 most wanted persons and 198 other wanted individuals.

He said the police also conducted 140 anti-illegal gambling operations, resulting in 295 arrests and the confiscation of around PHP75,000 in bet money while 41 individuals were also apprehended for carrying unlicensed firearms.

"These operations are proof of our commitment to law and order. We are not only enforcing the law but also building trust with the communities we serve," Nartatez added.

Southern police district

Southern Police District (SPD) Director Brig. Gen. Randy Arceo, meanwhile, said SPD operatives arrested a total of 15 wanted persons during a series of law enforcement operations from Sept. 16 (5:59 a.m.) to Sept.17 (6 a.m.).

He added the 13 other wanted persons were arrested for various offenses, including Unjust Vexation in relation to Republic Act 10175, Qualified Theft, and Serious Physical Injuries.

In Taguig City, 13 individuals - five minors and eight adults - were rescued from an alleged human trafficking scheme inside a spa disguised as a wellness center in New Lower Bicutan, Taguig City on Wednesday.

Col. Byron Allatog, Taguig police officer-in-City charge, said the two suspects identified as Rafael, 39, spa owner, and Riza, 35, co-owner and massage therapist, will face charges for violating RA 9208 (Anti-Trafficking in Persons Act of 2003), as amended by RA 10364 and RA 11862 (Expanded Anti-Trafficking in Persons Act). said the rescue stemmed from intelligence information received by the Station Intelligence Section regarding alleged illicit sexual services being offered by both minor and adult therapists. Philippines is prepared transformation leverages artificial intelligence (AI) in pursuit of national development and a better quality of life for Filipinos, Department of Economy, Planning and Development (DEPDev) Secretary Arsenió Balisacan said Thursday. In his keynote address at the 11th Annual Public Policy Conference of the Philippine Institute Development Studies (PIDS) in Makati City, Balisacan touted the gains of the country's digital

transformation efforts. He said the country's digital economy grew to PHP2.1 trillion in 2024, from PHP1.6 trillion in 2018

The Philippines has also ranked 56th in the Oxford Government AI Readiness Index 2024 with a score of 58.5, up nine places from the previous year's rank of 65 with a score of 51.98.

"These gains affirm that Filipinos are not only adopting technology. We are shaping it to secure our future [and] much has already been achieved," the DEPDev chief added.

Balisacan said the government is committed to expanding inclusive infrastructure connect every strengthening Filipino, human capital through education, reskilling, and partnerships, enhancing governance frameworks rooted in ethics and trust, fostering collaboration government, across academe, private sector, and civil society, and with foresight governing and equity.

He said the National Innovation Agenda and Strategy Development, aligned with the Philippine Development Plan 2023 to 2028, positions innovation as a central driver of growth.

Efforts anchored to this agenda include the Department of Trade and Industry's AI Strategy Roadmap 2.0, which establishes the Center for AI Research, while the Department of Education ensures that AI knowledge flows into schools.

The Department of Science and Technology's Democratized Intelligent Model Exchange Repository (DIMER)

project, meanwhile, makes ready-to-use Al models available for agriculture, disaster response, and industry, lowering barriers for local stakeholders.

The Department of Information and C o m m u n i c a t i o n s Technology (DICT), through its Strengthening the Philippine Workforce through Adaptive and Responsive Digital Knowledge (SPARK) initiative, has partnered with Google and other institutions to ramp up free Al training.

Among efforts undertaken by the government is the eGov PH app, which features a wide array of services, and the digital national ID, which can now be accessed by 88.5 million Filipinos.

Balisacan also said 55 million physical national ID cards have already been delivered.

He also said the National Fiber Backbone connects six regions and over 17 million people, while the newly enacted Konektadong Pinoy Act introduces reforms to "increase competition in telecommunications, reduce costs and expand access."

Citing the need to uphold integrity and ethics in innovation, he said the DICT and the Civil Service Commission have released joint guidelines on "ethical and trustworthy Al" in government aimed at safeguarding transparency. He also said harnessing Al must be combined with "green standards" geared toward the responsible use of energy.

"Consider good governance. Al can detect anomalies in procurement, reduce bureaucratic friction, and prevent fraud," he added.

He said Al would help develop assistive technologies that can enhance healthcare services and social inclusion, as the Philippines is forecast to have a significantly older population by 2030.

"Through subsidizing Alenabled health services, reskilling older workers, and ensuring no one is excluded from the digital economy. The opportunities are clear, and the gaps are evident. The challenge is to translate

The latest GII report, released by the World Intellectual Property Organization (WIPO) on Tuesday, showed that the Philippines climbed to 50th place out of 139 economies in 2025.

It was the highest ranking achieved by the Philippines to date and also exceeded the government's 2025 target of 52nd place under the

#### JAPAN CREDIT RATING AGENCY CITES PH'S GROWTH, SOUND BANKING SYSTEM

MANILA – Japan Credit Rating Agency (JCR) highlighted the sustainable economic growth and soundness of the Philippine banking system.

In its latest Thursday, JCR noted that the country's high and sustainable economic growth, supported solid domestic demand. low-level external debt and resilience to external shocks, supported by accumulated ' foreign exchange reserves, and stable financial system as some of the key factors behind the Philippines' sustained investmentgrade credit rating.

"Through government-led infrastructure projects, the economy has maintained strong growth driven by solid private consumption and fixed capital formation. High growth is expected to be retained over the medium term," JCR said.

"The Marcos Jr. administration is implementing a range of policies aimed at fiscal consolidation, infrastructure development, poverty reduction, and other objectives, with steady progress achieved so far," it added.

In June, JCR affirmed the Philippines' investment-grade credit rating of "A-" with a "stable" outlook.

An investment-grade rating reflects low credit risk, which helps lower

Outputs, which DEPDev said reflects the country's ability to translate limited resources into meaningful innovation outcomes.

To sustain this momentum, DEPDev said the NIC, chaired by President Ferdinand R. Marcos Jr., is implementing the National Innovation Agenda and Strategy Document 2023-2032.

JČR cited strong loan growth, lower non-performing loans ratio, and capital adequacy ratios that are "well above" both Philippine and international standards.

Latest data showed that the capital adequacy ratio of universal and commercial banks stood at 16.5 percent on a consolidated basis.

The banks also maintained strong asset quality.

Non-performing loan ratio declined to 3.1 percent as of end-July 2025 from 3.6 percent in 2021.

In a statement, the Bangko Sentral Pilipinas (BSP) welcomed JCR's assessment on the strength and stability of the Philippine banking system. BSP "The continues to implement policies that promote robust capitalization and sound risk management among banks. These support financial stability and further build confidence in the domestic financial system," BSP Governor Eli Remolona Jr. said.

JCR's report also noted the country's easing inflation and robust gross international reserves (GIR).

Inflation averaged 1.7 percent during the first eight months of the year while GIR reached USD 105.9 billion in end-August 2025.

The GIR is equivalent to 7.2 months' worth of imports and 3.4 times the country's short-term external debt.

JCR also said the country's "solid foreign currency liquidity position" will allow it to stay "remarkably resilient" against external shocks.

JCR said the attainment of government targets, including higher per capita income, lower poverty rate, expanded domestic employment opportunities, continued infrastructure investment, and structural reforms would have a positive impact on the credit rating.

MANILA - The historic victory of Alas Pilipinas at the FIVB Men's World Championship on Tuesday night will elevate the landscape of Philippine volleyball.

"It's all about setting goals and working very hard to achieve those goals. It was a long shot, we never aimed that high for Alas Pilipinas in this world championship, but they overachieved," he said.

Tolentino commended the Philippine National Volleyball Federation "for this achievement and the support of the entire sports community in this success."

"To build champions, it takes the entire community the government, Philippine Sports the Commission, the private sector, the Filipino fans," he added.
