

BACCOOR SEEKS MALACAÑANG'S HELP IN ADDRESSING FLOODING WOES

CITY OF BACCOOR (PIA)

— The city government of Bacoor has sought the national government's intervention in addressing the city's flooding problem, citing clogged waterways and outdated drainage infrastructures as behind the flooding.

In a letter to Malacañang, Bacoor Mayor Strike B. Revilla requested funding support for the city's drainage and flood control plan through foreign-assisted programs such as the Japan International Cooperation Agency (JICA) or the National Disaster Risk Reduction and Management Fund (NDRRMF). Direct intervention by the Department of Public Works and Highways (DPWH), the National Irrigation Administration (NIA), and the Department of Environment and Natural

Resources (DENR) for large-scale dredging were among the assistance sought.

"The dams and rivers that once protected us are now clogged with silt and debris. Without immediate support from the national government, thousands of lives and homes remain at risk," Revilla said in a statement.

The appeal also includes the immediate desilting of rivers and canals in Bacoor, especially in flood-prone barangays according to the City Engineering Office

Under the Bacoor Drainage Plan, the city government proposed main strategies that include: the JICA Master Plan (2022), developed with assistance from JICA, and a supplementary plan from the DPWH, including the Draft Final Master Plan Report from Certeza

Infosys Corporation and a feasibility study for the Bacoor River Improvement Project.

"Despite our ongoing requests to agencies such as the NIA for the transfer of the Molino dams, there has been no clear response. The delays in administrative processes have significantly hampered our ability to act," Revilla added.

The city expressed its readiness to implement and take responsibility for any assistance provided by the national government, in close coordination with relevant agencies.

Revilla stressed the urgency for immediate action, warning that every day of delay increases the risks to residents and property. (RBF/Bacoor CIO) **BY RUEL FRANCISCO**

BIR COMMITS TO GOOD GOVERNANCE, TRANSPARENCY THROUGH GUIDING PILLARS

SAN PABLO CITY, Laguna (PIA) – The Bureau of Internal Revenue (BIR) Revenue Region 9B LaQueMar reaffirmed its commitment to good governance and transparency by upholding the “Four Pillars of Good Governance” as the foundation of its operations and reforms.

BIR LaQueMar Regional Director Atty. Michael Remir Macatangay said personnel are guided by the principles introduced by BIR Commissioner Romeo Lumagui Jr., which include: Fearless and Aggressive Enforcement Activities; Excellent Taxpayer Service; Integrity and Professionalism of the Institution and its Employees; and Digitalization.

Macatangay stressed that these pillars are crucial in curbing corruption, noting that digitalization minimizes red tape and reduces reliance on the “palakasan” system in government transactions. “Through those four pillars, the chances of corruption are reduced, because in the past corruption or red tape only happened when the system was not efficient and sufficient.” He added that the bureau is pursuing international audit certifications to further ensure efficiency and effectiveness in its processes.

“It is not yet perfect, but we are working to improve our digitalization until it becomes almost perfect, because with less or no

human intervention, the process becomes faster and the opportunity for corruption is eliminated.”

On enforcement, BIR LaQueMar reported a total collection of Php1.4 billion from operations this year, including Php26.8 million under the 48-Hour Notice and 5-Day VAT Compliance Notice of the Oplan Kandado program. 36 cases have also been filed under the Run After Tax Evaders campaign.

“Our approach is to assist, educate, and monitor businesses before we enforce. We help them comply rather than immediately resort to closure or penalties,” Macatangay explained.

To strengthen taxpayer service, the BIR continues to promote digital platforms such as the Electronic Filing and Payment System (eFPS), eBIRForms, and other accredited online payment channels. E-Lounges have also been established in various offices to assist taxpayers with digital transactions and provide guidance in adapting to online systems.

Macatangay reiterated that taxpayers and the BIR are not enemies but partners in ensuring compliance, emphasizing that the real challenge lies with tax evaders. He stressed that tax collection is a shared national responsibility for the benefit of all Filipinos. (CH/PIA - Laguna)

COMMUNITY LEADERS IN QUEZON EMPOWERED TO MONITOR FARM-TO-MARKET ROAD PROJECTS

The Department of Agriculture – Philippine Rural Development Project trained community leaders in Catanauan, Quezon on monitoring infrastructure projects as part of its sustainability efforts for its ongoing farm-to-market road subproject in the area.

The DA-PRDP Project Support Office South Luzon and the Regional Project Coordination Office CALABARZON trained leaders from seven barangays within the influence area of the 12.46 km-road: Doongan Ilaya, Doongan Ibaba, Milagrosa, San Antonio Magcopa, San Roque, San Pablo Suha, and Sta. Maria Dao.

They discussed the following: Citizens Monitoring framework, engineering standards, using applied geomapping technology for documentation, social and environmental safeguards, and the roles of the Barangay Implementing Team in monitoring the subproject.

After the discussions, the DA-PRDP and the participants inspected the implementation site of the farm-to-market road. Using the DA-PRDP Citizens Monitoring Notebook, the participants evaluated the compliance of the subproject and contractors to the topics discussed earlier.

Using the PRDP GeoCamera, they geotagged their observations, which can help them locate and track concerns/changes on the subproject easier.

Participants showed great

interest and participated actively in the activity. Moving forward, they plan to hold a joint session to discuss ordinances on weight and speed limit to prevent damages and accidents on the road.

“Napakahalaga po ng aktibidad na ito para po ma-implement nang maayos ‘yung ating proyekto. Sa tulong ng mga itinuro, alam na namin ang tama at mali o kung naaayon ang proyekto sa mga pamantayan ng PRDP. Mas matutugunan at mabibigyang paliwanag na rin namin ang mga komento o pahayag ng mga kabarangay namin tungkol sa proyekto,” said Rolando Conde, barangay kagawad of San Pablo Suha.

The Construction of San Roque-San Antonio Magcopa-San Pablo Suha-Doongan Ilaya Farm-to-Market Road with 2 Bridge Component was approved for funding under the DA-PRDP Scale-Up last August 2024.

To facilitate sustainability, the DA-PRDP conducts CMT which strengthens subproject monitoring efforts, increases the community’s capacities and participation, and promotes community ownership of the subproject.

Currently, the CMT is also being mainstreamed to the DA Regional Field Office IV-A CALABARZON as representatives from the Planning Monitoring and Evaluation Division also participated in the activity. (DA-PRDP CALABARZON) **BY**

PCSO DELIVERS 1,297 PATIENT TRANSPORT VEHICLES, NEARS FULL COVERAGE

MANILA – The Philippine Charity Sweepstakes Office (PCSO) has distributed 1,297 patient transport vehicles (PTVs) nationwide under its Medical Transport Vehicle Donation Program, reaching 75.23 percent of the country's 1,724 local government units (LGUs). PCSO General Manager Melquiades Robles, speaking at the PCSO Charity Summit 2025 on Friday at the Manila Hotel, said the PHP2.5-billion investment ensures that more Filipinos, especially in remote and underserved areas, have access to safe, timely, and life-saving medical transport.

"This marks a significant leap toward achieving universal access to medical transport," he said in his speech, adding that the agency has committed PHP1 billion for the procurement of 375 more PTVs to achieve the 100 percent target coverage by year-end.

"This will mark a new chapter in our nation's healthcare journey, one where no Filipino is left behind in moments of medical emergency," he added.

Each PTV is equipped with a stretcher, oxygen tank, wheelchair, first aid kit, blood pressure monitor, and medicine cabinet.

Robles also shared the agency's major milestones, including the PHP7.97 billion worth of medical assistance extended since 2022, benefitting nearly one million patients nationwide.

These numbers, he explained, represent lives saved, families given hope, and communities better served.

"Behind these figures are stories of lives saved. Lives of patients who were able to undergo bypass and other critical heart surgeries, and

families who no longer had to wonder how they could possibly afford the next hospital bill. Every peso we release is not only financial assistance—it is hope," he stressed.

The agency, he said, also released PHP68.28 million to 122 institutions caring for vulnerable groups under the Institutional Partnership Program.

"Through our Institutional Partnership Program, we help organizations that care for children, orphans, indigent patients, and persons with special needs. This is a powerful reminder that our collaboration multiplies impact, allowing us to reach places and people we could never reach alone," Robles noted.

Under its Medical Equipment Donation Program, PCSO has also delivered PHP103 million worth of medical equipment to 14 hospitals since 2022. In the first quarter of 2025 alone, nearly PHP22 million worth of equipment was turned over to hospitals, strengthening their capacity to serve patients in need.

Amid these accomplishments, Robles said PCSO also plans to expand its reach through new initiatives, including a medical equipment program in partnership with government hospitals, mobile health and dental clinic units, and sea-based patient transport vehicles for island and last-mile communities.

These efforts are aligned with President Ferdinand R. Marcos Jr.'s directive, as highlighted in his latest State of the Nation Address, to modernize the country's healthcare system.

The summit gathered government, civil society, and private sector partners,

DMW HIGHLIGHTS GAINS IN OFW PROTECTION DURING CALAMITY AID ROLLOUT

MANILA – The Department of Migrant Workers (DMW) underscored progress in enhancing the protection and welfare of overseas Filipino workers (OFWs) as it awarded calamity assistance fund under the Quick AKSYON Fund in Bulacan on Thursday.

In a news release on Friday, the DMW said Migrant Workers Secretary Hans Leo Cacdac presented the agency's accomplishments, including its achievements in curbing illegal recruitment, extending legal and financial aid to distressed OFWs, and providing expanded welfare and health services to their families. He said that through the leadership of Undersecretary Bernard Olalia, the number of illegal recruitment agencies shut down by the DMW has tripled this year, from six closed in 2023; 15 in 2024; and 28 firms as of Aug. 1 this year.

Meanwhile, around 71,000 online illegal recruitment sites from different social media platforms were taken down in 2024 as part of the government's efforts against human trafficking. DMW data shows that as of Aug. 18, the agency has already provided assistance to 1,259 victims of illegal recruitment and human trafficking from Laos, Myanmar and Cambodia, and were given immediate financial assistance through the DMW AKSYON Fund.

Cacdac also highlighted the DMW's direct interventions abroad, citing his visits to detained OFWs in Jordan and Japan where he personally delivered financial aid and ensured access to legal representation.

"Tinutulungan sila ng ating mga abogado sa abroad—may mga hina-hire tayong legal experts para sa mga OFWs na may kaso. Binibigyan din sila ng tulong pinansyal para makabili ng mga pangunahing pangangailangan sa loob ng kulungan (Our lawyers abroad are helping them—we hire legal experts for OFWs with cases. They are also given financial assistance to buy basic necessities inside the prison)," he said.

He also pledged support for children of detained migrant workers, particularly minors in Japan, in line with President Ferdinand R. Marcos Jr.'s directive to secure their future.

Cacdac said the Quick AKSYON Fund was introduced as a safety net for OFWs in crisis situations, providing legal, medical, financial, and humanitarian assistance to those affected by conflict, abuse, or emergencies.

DA: SUCCESSIVE STORMS PUSH VEGGIE, FISH PRICES UP

MANILA – Successive weather disturbances have driven up the prices of vegetables and fish, contributing to a faster overall inflation rate in August, the Department of Agriculture (DA) said Friday.

The agency issued the statement after inflation rose to 1.5 percent in August from 0.9 percent in July, with food inflation logged at 0.6 percent, according to the Philippine Statistics Authority (PSA). DA spokesperson Assistant Secretary Arnel de Mesa explained that heavy rains disrupted fishing activities and flooded vegetable farms, pushing prices higher.

"Dahil iyon sa sunud-sunod na pag-ulan na nakakaapekto talaga sa presyo ng gulay atsaka isda (That's because of the consecutive rains which have affected the prices of vegetables and fish)," he

He also highlighted the OFW Hospital in Pampanga, which provides free medical care to OFWs and their dependents.

Cacdac reaffirmed the DMW's pledge to stand with OFWs and their families.

"Kayo po ang patunay na anuman ang hirap, anuman ang hamon—kakayanin ninyo. Babangon tayong sama-sama. Tayo ay isang pamilya, pinagbuklod ng watawat at ng Diyos. Kahit saan man tayo naroroon, Pilipino ang dugo, ang kulay, ang puso, at ang diwa. Kaya nararapat lamang na kami sa Department of Migrant Workers ay tumulong at magmahal sa inyo (You are proof that no matter the hardship, no matter the challenge—you can do it. We will rise together. We are one family, united by the flag and by God. No matter where we are, our blood, our color, our heart, and our spirit are Filipino. That is why it is only right that we at the Department of Migrant Workers help and support you)," Cacdac said. (PNA) **BY MARITA MOAJE**

said in a phone interview. In particular, vegetable inflation accelerated to 10 percent in August from 4.7 percent deflation in July, while fish inflation increased to 9.5 percent from 6.3 percent.

"Syempre kapag may bagyo, titigil 'yung pangangisda. Sa gulay naman, mabilis naman bahain (Of course, when there's a storm, the fishing is halted. For vegetables, it's easily flooded)," De Mesa said.

Despite a slight decline, meat prices remain elevated and may face renewed "price pressures" during the "ber" months due to higher demand, along with eggs, De Mesa said.

Filipino consumers, meanwhile, will continue to enjoy stable prices of rice amid the 60-day rice importation halt as the country enters the onset of harvest season, the agriculture official assured. In August, rice plummeted further at 17 percent deflation from 15.9 percent in July.

"Dahil sa laki ng production sa ibang bansa, especially India, ganun din sa Vietnam, at other ASEAN countries, tayo rin we are expecting a record-harvest, patuloy na ma-expect natin na bababa ang presyo ng bigas (Because of the huge production internationally, especially in India, as well as in Vietnam, and other ASEAN countries, we are also expecting a record-harvest, we can expect a continuous decline in prices of rice) until next year," de Mesa said.

For the wet harvest season, the DA projected at least 11 million metric tons of palay (unhusked rice) output.

The DA earlier said the Philippines may "easily surpass" last year's record-palay production at 20.06 million metric tons (MT).

It also maintained optimism to hit the 20.4 million MT target output, considering the historic-high harvest of palay of 9.08 million MT for the first half of 2025. (PNA) **BY STEPHANIE SEVILLANO**

SANDIGANBAYAN JUNKS RAPS VS. NGO EXEC TAGGED IN 2008 PDAF CASE

MANILA — The Sandiganbayan has dismissed cases for graft and malversation against an NGO (non-government organization) official who was a co-accused in a case involving the alleged misuse of the priority development assistance fund (PDAF) of a former La Union lawmaker in 2008.

In a 22-page decision promulgated Sept. 2, the anti-graft court's First Division dismissed the four cases against Kabuhayan at Kalusugan Alay sa Masa Foundation, Inc. (KKAMFI) corporate secretary Marilou Ferrer who was co-accused in the alleged misuse of PHP400,000 of the PDAF of former La Union 2nd District Rep. Thomas Dumpit Jr.

The cases against Dumpit and other co-accused

were dismissed by the graft court in 2023. However, Ferrer remained at large at the time and was only arrested in 2024.

In clearing her, the court noted that "the only evidence of Ferrer's supposed participation in the transactions in question is that she noted KKAMFI's project proposal and work and financial plan."

"The act of 'noting' both documents, however, does not convey her approval thereof, nor can it be considered as proof that she had any participation in KKAMFI's selection to implement the projects in question, in the falsification of documents, or in the failure to implement the projects," the court said. PROPOSED INDEPENDENT FLOOD CONTROL PROBE BODY DRAWS SUPPORT

MANILA — Lawmakers on Friday supported President Ferdinand R. Marcos Jr.'s plan to create an independent commission that will investigate anomalous flood control projects.

Senator Erwin Tulfo said an independent body would be more appropriate amid allegations that some lawmakers might have benefited from the flood control program by the Department of Public Works and Highways (DPWH).

"Hindi naman pinapadalan ang mga mambabatas. Kasi po meron tinatawag tayo na interparliamentary courtesy, kaya hindi natin ma-iwasan na magduda ang ating mga kababayan (The legislators are not sent [invitations]. Because we have something called interparliamentary courtesy, so we cannot

avoid our countrymen being suspicious)," Tulfo said in a media interview.

Tulfo also agreed that the commission must have the authority to issue subpoenas to everyone involved in the controversy. Senator Francis Pangilinan also supports the creation of the independent commission, urging Filipinos to be vigilant. He said the ultimate power rests in the hands of the people.

"Keep our elected officials, including myself, on their toes. Hold us to account and organize activities to voice your grievances peacefully," Pangilinan said in a statement.

On Thursday, Malacañang said the issuance of an executive order establishing the independent body on flood control probe is being finalized. (PNA) **BY LEONEL ABASOLA**

MARCOS INAUGURATES NEW IRRIGATION PROJECT IN BOHOL

MANILA — President Ferdinand R. Marcos Jr. on Friday inaugurated the Calunasan Small Reservoir Irrigation Project (SRIP) in Barangay Calunasan, Calape, Bohol, a key infrastructure expected to irrigate up to 300 hectares of farmland in the province. The President unveiled the project marker together with National Irrigation Administration (NIA) Administrator Eduardo Guillen.

In his remarks, Marcos said the irrigation system is part of the government's broader effort to expand irrigated agricultural lands nationwide.

"[P]ara sa ating mga magsasaka ay gagawin namin ang lahat para tulungan kayo na 'yung production ninyo at maging mas mataas, at ang kita ninyo ay magiging mas mataas (To our farmers, we will do everything we can to help you increase your production and increase your income)," he said.

"Kaya we are continuing at patuloy nating ginagawa ito para pagandahin ang agrikultura natin, para pagandahin natin ang

hanapbuhay ng ating mga magsasaka (This is why we are continuing to do this to improve our agriculture, to improve the livelihoods of our farmers)," he added. The project is designed to provide consistent, year-round irrigation to at least four barangays in Calape—Calunasan, Abucayan Sur, Lucob, and Bentig—benefiting around 400 farmers.

The infrastructure, primarily aimed at improving farm productivity, also supports aquaculture and flood management.

NIA-Region 7 Acting Manager for Engineering and Operations Division Nelson Doliente said the dam and irrigation facilities are already fully operational and have been serving local farmers since the system's test run on Aug. 20.

The project, amounting PHP813 million, is currently 97.94 percent complete. The remaining works, including slope protection and the construction of a view deck, are scheduled for completion by Nov. 23, 2025. (PNA) **BY JOYCE ANN L. ROCAMORA**

P15K WAGE HIKE, MEDICAL DISCOUNT, PENSION FOR TEACHERS PUSHED

MANILA — Senator Risa Hontiveros joined the commemoration of National Teachers' Month by stressing the need for a PHP15,000 across-the-board monthly wage hike for public school teachers and employees, in addition to medical discounts, other benefits and the protection of their pension contributions.

Hontiveros is pushing for the passage of her Dagdag Sahod for Public Basic Education Teachers and Employees Act (Senate Bill 211) and Healthy Buhay at Hanapbuhay Para sa Guro Act (Senate Bill 575) to increase salaries and benefits of teaching and non-teaching personnel.

"Ang mga guro natin, araw-araw nagbubuhos ng oras, pagod, at pagmamahal para sa ating kabataan. Kaya bilang pasasalamat sa kanila, gusto kong mabigyan sila ng umento sa sahod para naman mas guminhawa ang buhay nila (Our teachers, each day, pour in their time, effort and love for our children.

So to thank them, I would like to give them a salary increase so that their lives can be more comfortable)," Hontiveros said in a news release on Friday.

Under Senate Bill (SB) 211, all public school teachers and personnel will receive a PHP15,000 salary increase to be given in three tranches, starting with a PHP6,000 hike in the first year, followed by PHP5,000 and finally PHP4,000.

In addition to proposing a salary increase, Hontiveros also filed SB 575 that would grant all teachers a 10-percent discount and value-added tax exemption on medicines and other essential health products, along with other health benefits.

Hontiveros' bill will provide for teachers' health centers, special wards in Department of Health (DOH) hospitals, government-paid Philippine Health Insurance Corp. contributions, and medical assistance from DOH, Department of Social Welfare and Development, and Department of Education, as well as five days of annual mental health and wellness leave.

Hontiveros likewise expressed her worry over the integrity of public school teachers' pensions, saying that it is crucial that they be assured a comfortable future when they retire from government service.

"Sa pagbibigay umento sa kanilang sahod, pagdadagdag ng kanilang benepisyo at pagbabantay sa kanilang pensyon, mapapakita natin na ang mga guro natin ay pinapahalagahan, hindi lang tuwing Teachers' Day, kundi everyday (By increasing their salaries, increasing their benefits, and safeguarding their pensions, we can show that our teachers are valued, not just on Teachers' Day, but everyday)," she said. LA UNION OPENS FIRST TOWN HALL FOR STRONGER CITIZEN VOICES

PDIC Vice President Jose G. Villaret, Jr. explained that the increase in coverage, which took effect on March 15, 2025, is part of the agency's continuing effort to safeguard the hard-earned savings of Filipinos and strengthen public trust in the banking sector.

He also underscored the advantages of keeping funds in the banks, noting that deposits are protected from physical risks such as theft, fire or deterioration, unlike cash kept at home.

"Kapag meron tayong pera sa banko, alam natin na may deposit insurance. We know our money is protected, hindi ito pwedeng kainin ng anyo manakaw ng tao. And if the bank fails, there's protection for you," he said. (When we place our money in the bank, we are assured that it is covered by deposit insurance. This means our funds are protected—they cannot be damaged by termites, stolen, or lost. Moreover, in the event of bank failure, there is a safeguard in place to ensure our financial security).

Villaret assured that in the rare event of a bank closure, PDIC guarantees deposit insurance coverage of up to 1 million pesos per depositor, per bank, providing both financial security to account holders.

The Davao City leg of the PDIC 101 marks the third run of the program in 2025, following sessions in Naga City in May and Cebu City in July. The initiative aims to raise public awareness on deposit insurance and clarify PDIC's roles as the state deposit insurer, co-regulator of banks, while giving media a platform to engage directly with the agency. DREDGING OF LAHAR-FILLED WATERWAYS IN NEGROCC TOWN TO PROCEED

NEGROS OCCIDENTAL (PIA)—The provincial government here is expected to send heavy equipment into La Castellana town to extract hardened lahar from waterways, which has caused water levels to rise quickly during periods of heavy rainfall.

Provincial Administrator lawyer Rayfrando Diaz told the media, September 1, that dredging of lahar-filled waterways is critical to prevent further flooding in communities, especially amid the monsoon season. Diaz said the provincial government will bring in

backhoes, dump trucks, and an engineering team for dredging and clearing operations in creeks and other water channels in La Castellana.

"We will start with the clearing of the roads then dredge the creek," the official assured, after downpour on August 31 led to the evacuation of many families in La Castellana due to overflowing of waterways.

The capacity of these waterways to hold water has greatly reduced in recent months due to accumulated volcanic materials brought about by

previous Kanlaon Volcano eruptions.

Diaz emphasized, however, that the removed materials will be transported to a nearby Mt. Kanlaon Natural Park (MKNP) facility for stockpiling, as resources from within the Natural Park cannot be sold for commercial use nor hauled outside the protected area. In March, in anticipation of this year's La Niña, the MKNP Protected Area Management Board approved a resolution allowing La Castellana to clear waterways of debris obstructing the natural flow

of water.

The resolution emphasizes, however, that any material removed shall remain within the MKNP to mitigate any potential abuse of the natural park's resources.

AMENDED INVESTORS LEASE ACT TO BOOST EMPLOYMENT OPPORTUNITIES

MANILA – Investments and employment opportunities in the agriculture and industry sectors, among others, are seen to be bolstered by the amended Investors' Lease Act, which extends the lease of private lands to up to 99 years.

Republic Act (RA) 12252, which was signed into law by President Ferdinand R. Marcos Jr. on Sept. 3, 2025, is an amendment of the 1993 law Investors' Lease Act, otherwise known as RA 7652, that allowed for a 50-year term, renewable once for up to 25 years.

The new law states that it provides for "a flexible and dynamic policy" to allow foreign investors to establish "industrial

factories, assembly or processing plants, agro-industrial enterprises, land development for industrial or commercial use, tourism, agriculture, agro-forestry, ecological conservation, and other similar priority productive endeavors."

It, however, stressed that only investors who have approved and registered investments under the Foreign Investments Act, the Corporate Recovery and Tax Incentives for Enterprises (CREATE) Act, the CREATE More Act, and similar measures are qualified for the longer-term lease.

It also requires the lease contracts to be registered with the Registry of Deeds where the property is located.

Special Assistant to the President for Investment and Economic Affairs Frederick Go said the new law "is a catalyst for agriculture, industrialization, technology transfer, and investment-led growth."

"We have been uncompetitive relative to regional peers for too long because of short-term land leases and land ownership restrictions. This law opens doors for sustainable, long-term investments and affirms that the Philippines is ready to compete globally," he said in a statement.

GOV'T STEPS UP MEASURES TO MAINTAIN STABLE INFLATION

MANILA – The government is intensifying efforts to ensure sufficient supply and keep the prices of key commodities affordable despite recent weather disturbances, the Department of Economy, Planning, and Development (DEPDev) said.

DEPDev made the assurance after the Philippine Statistics Authority (PSA) reported on Friday that headline inflation picked up to 1.5 percent in August from 0.9 percent in July.

In a briefing, National Statistician Dennis Mapa said the latest data brought the year-to-date average inflation to 1.7 percent, still below the lower end of the government's 2 percent to 4 percent target range.

Mapa said weather disturbances contributed to the increase in food prices last month.

While rice continued to post a deflation of 17 percent in August, fish inflation accelerated to 9.5 percent from 6.3 percent, emerging as the top contributor to overall inflation in August. This was driven by slow import arrivals, adverse weather, and above-normal rainfall that disrupted fishing activities in key areas.

Vegetable inflation also rose to 10 percent from a 4.7 percent deflation in the previous month.

On the other hand, meat inflation decreased to 7.1 percent from 8.8 percent but continued to be a major contributor to inflation.

The PSA reported that the overall inflation rate for the bottom 30 percent of income households at the national level recorded a slower annual decrease of 0.6 percent in August compared to 0.8 percent in the previous month.

This brings the national average inflation rate for this income group from January to August to 0.4 percent.

"While inflation remains

broadly manageable, the recent figures highlight how adverse weather conditions directly impact prices," DEPDev Secretary Arsenio Balisacan said. Balisacan cited the importance of closely monitoring the country's weather outlook due to its potential impact on agricultural production.

The Philippine Atmospheric, Geophysical, and Astronomical Services Administration (PAGASA) has forecast seven to 15 tropical cyclones between September 2025 and February 2026.

He also cited how La Niña conditions, which may develop from September to December, could lead to flooding and crop damage in high-risk areas.

"In anticipation of these weather shocks, we must ramp up preparatory activities and proactively ensure sufficient food supply to protect Filipino consumers from price volatility," he said.

To support production and recovery, the Department of Agriculture's (DA) Disaster Risk Reduction and Management Center allocated agricultural inputs to regional field offices.

These include rice, corn, high-value crop seeds, drugs and biologics for livestock and poultry, and fish stocks with the necessary aquaculture equipment.

Registered farmers affected by extreme weather may also access financial and insurance assistance through the Survival and Recovery Loan Program of the Agricultural Credit Policy Council, indemnification under the Philippine Crop Insurance Corp., and rehabilitation funding through the Quick Response Fund.

"We also welcome the Department of Agriculture's upcoming soft launch of a command center in November that will enhance data-driven management of the food supply chain and improve supply-demand forecasting.

Initially focused on the rice value chain, the system will eventually cover high-value crops, livestock, poultry, and fisheries. It will also establish a central registry of food and cold storage facilities and dry

warehouses, including their stock levels," Balisacan said.

The Food and Drug Administration also approved the commercial use of Volvac BEST (Baculovirus Expressed System Technology) AI plus ND, the country's first avian influenza vaccine.

The vaccine provides immunity against the highly pathogenic avian influenza (HPAI) subtype H5N1 and velogenic Newcastle disease, both of which pose serious threats to poultry, public health, and food security.

"We remain committed to implementing strategic policies that ease supply constraints and improve market efficiency. Our priority is to protect Filipinos, especially the most vulnerable, from the impact of rising prices while building resilience in our production systems to ensure stable and affordable food commodities for every household," Balisacan said.

Within-target inflation until 2027

In a separate statement, the Bangko Sentral ng Pilipinas (BSP) said inflation is projected to average below the low end of the target range in 2025, primarily due to the continued easing of rice prices.

"The outlook for inflation is broadly unchanged. For 2026 and 2027, inflation is expected to trend higher but will remain firmly within the 3 percent + 1.0 ppt (percentage point) target range," it said.

The BSP said inflation expectations also remain firmly anchored to the target.

Possible electricity rate adjustments and higher rice tariffs could raise inflationary pressures over the policy horizon.

"Emerging risks will continue to require close monitoring. The Monetary Board will determine the monetary policy response based on the evolving outlook for inflation and growth," the BSP said.

"Going forward, the BSP will safeguard price stability by ensuring monetary policy settings are conducive to sustainable economic growth and employment." (PNA) **BY ANNA LEAH GONZALES**

PSEI TAKES A BREATH, PHP GAINS VS. USD

MANILA – Bargain hunting eventually lifted the Philippine Stock Exchange index (PSEi) on Thursday, and the peso closed sideways at the 56-level against the greenback. After several days of slide, the local bourse's main index rose by 0.39 percent to 6,106.92 points, and the All Shares by 0.39 percent to 3,677.92 points.

All the sectoral indices also finished with gains, led by the Property and the Mining and Oil, which both rose by 1.08 percent.

Services increased by 0.78 percent, Financials, 0.27 percent; Holding Firms, 0.10 percent; and Industrial, 0.06 percent. Volume reached 1.06 billion shares, amounting

to PHP4.8 billion. Advancers led decliners at 111 to 88 while 53 shares were unchanged.

"The market saw a slight relief as investors engaged in bargain hunting, taking advantage of cheaper stock prices," Luis Limlingan, Regina Capital Development Corporation head of sales, said.

"Moreover, the upcoming inflation report, expected tomorrow, could serve as a key catalyst that may influence how the stock market performs in the coming weeks," he added. The Philippine Statistics Authority (PSA) is scheduled to report the domestic economy's August 2025 inflation report on Friday, and consensus

is a rate of 1.5 percent, partly on the impact of weather disturbances since last month.

Last July, the rate of price increases slipped to 0.9 percent from month-ago's 1.4 percent, bringing the seven-month average to 1.7 percent.

The local currency also ended on a positive note, finishing at 56.98 to a dollar from its 57.3 close on Wednesday.

It opened the day at 57.3, better than its 57.51 start in the previous session. It traded between 57.32 and 56.98, bringing the average to 57.21.

NU LEADS 16 TEAMS IN SHAKEY'S PRESEASON UNITY CUP

MANILA – Defending champion National University (NU) will be facing a strong challenge in the 2025 Shakey's Super League (SSL) Preseason Unity Cup, which unfolds at the Playtime FilOil Center in San Juan City on Sept. 20.

A total of 16 teams, six from UAAP and all 10 from the NCAA, will fight for the crown in the fourth edition of the league's centerpiece event.

De La Salle University, last year's runner-up, and the University of the East are skipping the tournament as both squads are still rebuilding their core after the departure of some key players.

"Even though we only have 16 teams, we still have a good lineup of

up-and-coming teams with new players on their rosters. We want to showcase, for the very first time, how these players play with each other and against their respective opponents in their respective leagues," said Dr. Ian Laurel, chairperson of SSL organizer Athletic Events and Sports Management, Inc. (ACES), during Wednesday's press conference at the Shakey's Buendia branch.

Also present were Shakey's Pizza Asia Ventures, Inc. (SPAVI) president and chief executive officer Vic Gregorio, SPAVI general manager Oliver Sicam, SPAVI marketing head Regina Asa, PLDT and Smart Communications head of sports Jude

Turcuato, ACES director Ariel Paredes, as well as coaches and key players of participating teams.

The 16 squads will be divided into four groups to play in a single-round robin format in the preliminaries. Four-time champion NU is in Pool A together with Emilio Aguinaldo College, San Beda University, and Lyceum of the Philippines University.

"We will do our best and try to defend the title," said NU head coach Regine Diego.

Pool B is composed of Far Eastern University, Arellano University, Adamson University, and Jose Rizal University. University of Santo Tomas, University of the Philippines, Mapua University, and Letran are

in Pool C, while College of Saint Benilde, Ateneo de Manila University, San Sebastian College, and University of Perpetual Help System Dalta are in Pool D.

The top two teams in each pool will advance to the next round, where they will be divided into two groups for another round-robin play to determine their rankings in the quarterfinals.

The top two squads after the round will be armed with a twice-to-beat advantage in the crossover quarterfinals. The semifinals and battle for bronze are knockout affairs, while the championship round is a best-of-three series.

All players listed in a team's roster will be fielded under the tournament's

unique all-to-play format.

"The all-to-play rule will be in effect because that's the trademark of our preseason," Laurel said. "This is what the coaches are also looking out for. These will be the combinations they can use in preparation for their mother leagues. And we're excited to have this competition again."

The preseason Unity Cup is the culmination of another successful SSL season. SSL started the year with the record-setting staging of the Shakey's Girls Volleyball Invitational League, which saw the participation of 30 high school squads.

The league then brought elite collegiate volleyball action closer to fans with the three-leg National
