A total of 450 residents from Brgy. Panungyanan, General Trias City benefited from a medical and dental mission conducted by Provincial Government of Cavite on

## DMW: DEATH OF FILIPINO CREW MEMBER OF CRUISE SHIP UNDER INVESTIGATION

**MANILA** – The Department of Migrant Workers (DMW) assured that the death of a Filipino crew member of MV Arvia, a cruise ship operated by P&O Cruises, is now under investigation. In a statement on Thursday, the DMW confirmed the death of the Filipino seafarer whose identity is still on hold, as it expressed deep condolences to the bereaved family.

"The licensed manning agency that deployed the seafarer reported that the circumstances surrounding the crew member's death are still under investigation and that they are in ongoing coordination with the vessel owner to ensure a thorough and transparent process," the DMW said.

"We join the family in mourning and send our heartfelt sympathies. May our kababayan's (compatriot's) soul rest in peace."

Reports stated that the Filipino crew member died while on board the vessel

on Sunday during its voyage from Southampton to Tenerife.

The cruise ship is on a 14-night transatlantic crossing to the Caribbean after leaving Southampton on Friday and is scheduled to arrive in Barbados on Nov. 7.

The DMW said all necessary support is provided to the seafarer's family, including regular updates on every development of the case.

"This loss is profoundly mourned throughout the maritime community. Our seafarers serve with dedication and bravery in international waters, and we honor their service, professionalism, and sacrifice. The department remains committed to protecting the welfare, safety, and dignity of every Filipino worker abroad, especially during times of grief and hardship," it said. (PNA) **BY MARITA MOAJE**

## DEPED MULLS LEASING CLOSED PRIVATE SCHOOLS TO EASE CLASSROOM SHORTAGE

**MANILA** – The Department of Education (DepEd) is exploring the feasibility of leasing closed private schools and other underutilized private properties as part of its innovative approach to ease the country's classroom shortage, which reached over 165,000 in 2022.

In collaboration with the Student First Coalition (SFC) and various government agencies, DepEd recently conducted a Classroom Market Scoping Activity to assess available properties and potential partnership models with the private sector.

The initiative aims to make classroom leasing a scalable and cost-effective strategy nationwide.

"We need to think creatively if we want to move fast," DepEd Secretary Sonny

Angara said in a statement on Thursday.

"If there are schools or buildings sitting idle that can be used, let's open them for the benefit of our learners who need classrooms now."

The market scoping activity presented DepEd's Standard Classroom Specifications, current classroom needs, and details of its Leasing Pilot Program, followed by a forum with property developers and government partners.

Among those who participated were major real estate firms including Colliers, Santos Knight Frank, Leechiu, Jones Lang LaSalle Inc., Lobien Realty Group and REBAP Inc.

Key government agencies such as the Department of Human Settlements and Urban Development, Bases Conversion and Development Authority, Department of the Interior and Local Government and the Armed Forces of the Philippines Corps of Engineers also took part in the discussion.

"This effort turns the classroom shortage crisis into an opportunity for collaboration and innovation," DepEd

Undersecretary for Strategic Management Ronald Mendoza said.

"Instead of waiting two to three years for new classrooms to be constructed, we are identifying existing facilities that can be adapted within six months to meet students' needs."

One of the first properties being considered for lease is the Pita Property, formerly the Rainbow Institute of Learning, Inc., in Laguna. The 1,385-square-meter campus, closed since 2020, sits only two kilometers from Don Manuel Rivera Memorial Integrated National High School, which currently lacks 22 classrooms.

The property includes seven classrooms, cafeteria, an office and a covered court with a stage

## 2 FIRMS PARTNER TO OFFER MALL-TO-MALL TRAVEL TO COMMUTERS

**MANILA** – The commuting public will have an alternative mode of travel to and from the city/province they plan to visit, especially during holidays, such as Undas, and school and Christmas breaks.

Two private companies, Park-Solutions, Inc. (PSI) and Del Monte Land Transport Bus Co., Inc. (DLTB), partnered through a memorandum of agreement (MOA) to provide an efficient, reliable, and organized travel experience for the public.

Under the partnership, mall-to-mall travel from the National Capital Region (NCR) to some parts of Luzon will be made available.

"This is a game-changer with regard to the riding public. It's a mall-to-mall operation between SM Malls in Metro Manila and SM Malls at the outskirts of Metro Manila," Don Morales, DLTB Co. executive vice president, said during the recent signing of the MOA in Pasay City.

The PSI operates public transport terminals in all SM malls nationwide. Morales said they are operating at SM North EDSA, going to Batangas, and in the coming days, they will start operations at

— facilities that DepEd believes could be quickly repurposed for immediate use.

DepEd clarified that the leasing initiative will complement, not replace, its ongoing infrastructure programs such as the Flexible School Building Implementation Plan and public-private partnerships for school construction.

Insights gathered from the market scoping activity will be presented at the upcoming Classroom Summit, where DepEd aims to consolidate reform proposals and design new models for school infrastructure delivery. (PNA) **BY MA. TERESA MONTEMAYOR**

SM Fairview, going to SM Lucena.

He also said that under the partnership, they are planning to expand operations in the first quarter of next year, with routes from Metro Manila to Southern Luzon and Northern Luzon and vice versa.

"And furthermore, going to the north, SM North EDSA going to SM Clark, and SM Fairview going to the south, going to SM Naga and SM Legaspi," the DLTB Co. official said.

He also said there are plans to acquire about 100 new buses and those with comfort rooms for long trips.

"This is very convenient for the passengers. Instead of going to bus terminals, they would rather go to SM malls and, in return, increase the foot traffic of mall goers," Morales said.

"This is very new for the landscape of the transport industry. We're looking forward and rest assured that we will give the best and efficient service to the riding public."

According to Ferdinand Oroza, PSI chief executive officer/president, aside from providing the facility, they will also operate the automated purse system.

"We will handle the automated purse system where they can book a mall-to-mall ride. It will be very convenient to the public since they will only have one stop – they can go to the mall, and wait for their ride," he said.

"For example, if they are at SM MOA and decide to go to Baguio. They can utilize the mall, go malling while waiting for their scheduled trip."

During peak seasons, such as Undas, or the All Saints' Day and All Souls' Day, summer vacation, and the Christmas and New Year holidays, bus terminals, airports, and seaports in the National Capital Region are packed with people going home to their provinces to celebrate the occasions. ## DHSUD ORDERS PRIVATE DEVELOPERS TO COMPLY WITH BALANCED HOUSING LAW

**MANILA** – The Department of Human Settlements and Urban Development (DHSUD) on Thursday directed private real estate developers to strictly comply with the Balanced Housing Development Program (BHDP), as mandated under Republic Act 10884.

DHSUD gave the order after it found out that around 600 private development projects are non-compliant with the law's requirement on balanced housing over the past four years.

DHSUD Secretary Jose Ramon Aliling said the violations were uncovered amid the agency's ongoing Zero Backlog Program, which reviews pending and existing projects across all regional offices.

"We discovered these alleged violations recently as we pursue the department-wide Zero Backlog Program. We intend to correct this soonest to enhance production of socialized housing projects for the benefit of underprivileged Filipinos," Aliling said.

Under RA 10884, which amended the Urban Development and Housing Act of 1992 (RA 7279), developers of new residential subdivision and condominium projects are required to provide socialized housing, equivalent to at least 15 percent for subdivisions and 5 percent for condominiums.

Developers may comply through onsite construction, development of new socialized housing settlements, joint ventures or contributions to the socialized housing fund under the incentivized compliance scheme.

The law also imposes penalties for violations, including a fine of up to PHP500,000 for the first offense and the issuance of cease-and-desist orders (CDOs) against non-compliant developers.

"In compliance with the law and existing rules, we already started sending orders against these developers for them to start complying," Aliling said. He added that on average,

erring developers face around PHP600,000 in penalties aside from the CDOs, which suspend the sale of housing units until the orders are lifted.

DHSUD Senior Undersecretary Sharon Faith Paquiz, who leads the Zero Backlog Program and oversees the Housing and Real Estate Development Regulation Bureau, said non-compliance cases surfaced during the backtracking of pending regulatory processes in regional offices.

"We need to strictly implement the law and our guidelines. We will continue to issue the necessary orders to the concerned developers for their compliance," Paquiz said.

To further strengthen coordination, Aliling is set to meet with leaders of major real estate developer groups for a dialogue aimed at reinforcing awareness and cooperation in implementing the balanced housing program. (PNA)

## SOTTO VOWS PRUDENCE AS ICI SEEKS CHARGES VS. SENATORS

**MANILA** – Senate President Vicente Sotto III on Wednesday said the chamber would prudently act and uphold due process after the Independent Commission for Infrastructure (ICI) recommended the filing of cases against Senators Jinggoy Ejercito Estrada and Joel Villanueva before the Office of the Ombudsman over alleged irregularities in flood control projects.

The ICI's referral — its second since starting its investigation on Sept. 19 — also named former Department of Public Works and Highways Undersecretary Roberto Bernardo, former Representatives Zaldy Co and Mitch Cajayon-Uy, and Commission on Audit Commissioner Mario Lipana among those recommended for prosecution.

"There are constitutional, legal, and political issues to these investigations. And there will be as many opinions as there are lawyers," Sotto said in a Viber message to reporters. He said the Senate would adhere to the rule of law and avoid prejudging any of its members while the Ombudsman and Sandiganbayan evaluate the ICI findings.

"I would rather be prudent and follow the rule of law and avoid putting the Senate in the line of fire. We have due process in law and a system of

check and balance in the government to balance and protect the rights of individuals and institutions as well," he added.

Estrada, meanwhile, denied receiving any funds for the questioned flood control projects, saying the allegations against him were unfounded.

"Wala akong tinanggap na anumang pondong nakalaan para sa mga flood control projects, at kaya kong patunayan ito sa hukuman. Ang mga paratang laban sa akin ay pawang hearsay o batay lamang sa sabi-sabi (I did not receive any funds intended for flood control projects, and I can prove this in court. The allegations against me are mere hearsay or based on gossip)," Estrada said in a statement.

He said he is ready to defend himself in the proper forum and vowed to clear his name through due process.

"Justice must be served not through speculation, but through truth and due process," Estrada said.

Villanueva, meanwhile, said he has yet to receive a copy of the ICI referral and would let his lawyers study the basis of his inclusion.

"Records of the Senate will show that I have been against flood control projects from the very beginning. I was the one who exposed and questioned these projects that have not been implemented," he said. (PNA) **BY WILNARD BACELONIA**

## DA TO TAKE OVER FARM-TO-MARKET ROADS CONSTRUCTION STARTING NEXT YEAR

**MANILA** – The Department of Agriculture (DA) will assume responsibility for the development of farm-to-market roads (FMRs) starting 2026, taking over from the Department of Public Works and Highways (DPWH) to ensure a more focused, agriculture-centered approach in building rural infrastructure.

In a news release on Wednesday, the agency disclosed that DA Secretary Francisco Tiu Laurel Jr. and Department of Public Works and Highways (DPWH) Secretary Vince Dizon met on Tuesday to review audit results of completed FMR projects and discuss pending constructions scheduled for 2025.

The DPWH has proposed a catch-up plan to finish about 1,000 kilometers of remaining FMRs before the

transition.

"These roads are badly needed by our farmers and fisherfolk. They will ease livelihoods, lower production costs, and give farmers more time with their families," Tiu Laurel said.

Meanwhile, Dizon said innovative measures will be adopted to expedite completion.

"We must think outside the box to ensure these roads are completed as quickly as possible. Local government units will be engaged, similar to our approach with classrooms," he said.

The shift follows President Ferdinand R. Marcos Jr.'s directive to deliver infrastructure projects efficiently and cost-effectively. The 2025 catch-up plan will serve as the template for DA's implementation once the turnover is completed.

At a recent Senate hearing, Tiu Laurel noted that the country faces a backlog of about 60,000 kilometers of FMRs, an undertaking that could take six decades to complete at the current pace.

He said the DA is exploring new construction technologies that could significantly reduce costs and accelerate development.

The DA also plans to collaborate with the Department of National Defense to enlist the support of the Army Corps of Engineers for road construction and rehabilitation.

Dizon, meanwhile, noted that 4,000 kilometers of FMRs have been built in recent years. Of which, almost 1,000 kilometers include short stretches that may be subject to administrative and legal action. (PNA) **BY MA. TERESA MONTEMAYOR**

## NEVER TOO LATE, TOO EARLY FOR INLIFE RETIREMENT PLANS

**MANILA** – Either you die early or you live long -- that's the reality of life.

Another reality: Most Filipinos do not plan for a comfortable life after retirement, either because they are not aware how or due to factors beyond their control.

A recent survey by mutual life insurance company InLife showed Generation X (aged 45 to 60) scored the highest at 54 out of 100 in the retirement index, although it is still deemed far from ideal as they may not have enough to last them through their advanced years.

The younger, single or childless groups have lower retirement preparedness, with Gen Z (13 to 28 years) understandably scoring the lowest at 36 because of a different set of priorities. Some also face financial constraints because they support parents, siblings or other family members.

Gen Z and millennials (29 to 44), however, are more open to and aware about what they must do post-retirement.

A total of 1,000 respondents aged 18 to 59 participated in the InLife retirement index survey that took into consideration life stage, personal finances, health, pension program participation, retirement sentiment and social support.

"The Retirement Index shows us that Filipinos need to see retirement in a new light. It's not just a financial milestone. It's an emotional, social, and even cultural journey," InLife chief marketing officer Gae Martinez said during a media briefing in Quezon City on Tuesday.

"If we only focus on money, we miss out on the other pillars that make retirement truly secure and meaningful."

To help Filipinos plan their retirement, InLife has come up with Retire Assure, which it calls the "first true retirement insurance product in the country."

Retire Assure provides a guaranteed monthly income from age 60 or 65, until age 100. It is payable in five or 10 years, or until the age of 59 or 64, depending on one's

preference.

It is further enhanced by cash dividends that have the potential to increase over the years to keep up with the increases in living expenses.

Another option is Retire Assure 2, a two-pay variant recommended for professionals who are transitioning to senior positions in their careers and who want a lasting security instead of market-driven uncertainty.

It is for individuals aged 48 to 73 years old and is payable in two annual installments. The insured will start receiving a monthly income until age 100, after the second premium is paid.

Upon death, the insured's beneficiaries receive the higher of either 110 percent of premiums paid (less payouts already received) or the guaranteed cash value, whichever is greater. Brokerage company secretary "Lucy," 58, is retiring in two years.

Her husband retired five years earlier and their three children are already working, with the two younger ones still living with them.

"We have just enough but I hope we don't get sick because it might deplete our savings," she told the Philippine News Agency. "I don't want to burden our children."

She said they have insurance plans, which are "death" benefits for their children. Aside from her company's retirement payout, she will rely on the monthly pension from the state's Social Security System.

"I can still work, given the chance. Companies are more open to hiring senior citizens these days," she said.

Lucy's mindset is what InLife advocates for: Real love.

"The kind of love that breaks intergenerational dependence. Many Filipinos say, 'my family loves me. I can rely on my children when I retire. But true love means ensuring your children's financial freedom by taking care of yourself first," Martinez said.

## PH SEEKS HIKE IN GEOTHERMAL ENERGY CAPACITY – GARIN

**SINGAPORE** – Use of new technologies and government support will further bolster the Philippines' geothermal energy production and help meet the government's bid to increase the share of renewable energy (RE) in the total mix.

To date, geothermal energy accounts for only around 8.5 percent of the country's power generation mix, the bulk of which is accounted for by coal, at over 60 percent.

Energy Secretary Sharon Garin, in an interview with journalists on the sidelines of the Singapore International Energy Week (SIEW) earlier in the week, underscored the need to support geothermal energy exposure as part of the move to increase the share of RE in the country's energy mix.

Under the Philippine Energy Plan (2023-2050), the share of RE is targeted to increase to 35 percent by 2030 and 50 percent by 2040.

Last June, the Department of Energy (DOE) announced that under the third green energy auction (GEA-3), a total of 27.218 MW of geothermal energy was awarded.

Amidst the low level of share of geothermal energy in the country, to date, industry data show that the Philippines is the third largest producer of geothermal energy in the world, with an installed capacity of around 1,935 megawatts (MW), next to the U.S. and Indonesia.

Garin said measures are being put in place

She said officials of DOE have proposed higher funding for the gradiometric survey in the Visayas and Mindanao to determine what areas have the capacity to produce geothermal power.

"We are really pushing for it. It's a very expensive endeavor, but the returns are big," she said.

Future investments are seen to be encouraged by the derisking facility to be provided with the help of the Land Bank of the Philippines (Landbank) that will likely be in place by December this year, she added.

The said facility, earlier, reported to be managed by the Asian Development Bank (ADB) and is said to amount to around USD250 million, will provide funding for geothermal energy exploration in way of a grant if the project is deemed unsuitable, or a loan once it is proven to be viable.

Jay Joel Soriano, First Gen Corporation vice president and head of Strategy and Planning, said the derisking facility is an assurance that the government is committed to support the sector.

Asked for a projection on the untapped geothermal capacity of the country, he said this probably runs to "a few thousand megawatts" but stressed that this depends on what technology will be used for the power plant's operation.

"If we just simply look at high enthalpy, the traditional ones, I suspect the number will be quite limited. But if we start opening up to new technologies - low enthalpy wells, closed loop cycles, (and) all of these other technologies, I suspect the number will be much bigger. I just don't have the firm number right now," he said.

"But to expand, to retain our leadership position, I think we need to start looking at other technologies. Technologies

**MANILA** – Publicly-listed Aboitiz Power Corp. announced Thursday its purchase of a 25 percent stake in Vietnam's Van Phong Power Co. Ltd. (VPCL) from the shares of Sumitomo Corp.

The 1,320-megawatt (MW) high-efficiency, low-emission coal-fired power plant is located in Khan Hoa province and began operations in 2024. It has a 25-year power purchase agreement with Vietnam Electricity.

It is the power plant in the Van Phong Special Economic Zone that has the biggest foreign investment.

AboitizPower did not mention how much it spent for this acquisition but said "it represents the company's first significant investment outside of the

Philippines."

"With this venture, AboitizPower remains on track to deliver sustainable returns to its shareholders, maintaining a well-balanced portfolio of energy technologies. This investment is in parallel with our renewable investment program and is aligned with our aspiration to ensure a balanced long-term energy transition, contributing to reliable and affordable energy systems," the disclosure said.

The power producer added that the "closing of the transaction is subject to customary closing conditions, including securing the necessary regulatory approvals." (With a report from Joann Villanueva/PNA) **BY JOANN VILLANUEVA**

## PSEI SLIPS, PHP ENDS WEAKER AHEAD OF ECONOMIC REPORTS

**MANILA** – Both the Philippine peso and the Philippine Stock Exchange index ended Thursday weaker ahead of some economic reports.

The local currency finished the day at 58.85 against the U.S. dollar from 58.69 Wednesday.

It opened the day stronger at 58.73 from 59.15 a day ago. It traded between 58.98 and 58.58, bringing the day's average to 58.77. Volume rose to USD2.22 billion from the previous session's USD2 billion.

On the other hand, the local bourse's main index shed 0.57 percent to 5,929.68 points, and the All Shares by 0.33 percent to 3,593.28 points.

Only the Mining and Oil index gained during the day after rising by 0.99 percent.

The Financials index, in turn, posted the biggest drop at 0.99 percent, and was followed by the

Property, 0.72 percent; Holding Firms, 0.53 percent; Industrial, 0.30 percent; and Services, 0.16 percent.

Volume thinned to 655.71 million, amounting to PHP4.97 billion.


Decliners led advancers at 95 to 82, while 64 shares were unchanged.

"The Philippine market slipped lower as selling pressure persisted throughout the session," said Luis Limlingan, Regina Capital Development Corporation head of sales. He explained that "traders remained cautious as they are waiting the release of GDP (gross domestic product) and inflation data next week."

"Moreover, corporate earnings are also being closely monitored by investors, as these could determine the market's next direction," he added.

Shiblon Montero clocked 2:01.60 to prevail over Sta. Rosa City's Ashton Clyde Jose (2:01.93) and San Fernando City's Anton Paulo Dominick Della (2:03.46) in the boys' 16-17 200m freestyle event. Jordane Porche Sales, Aoki McKenzie Teng, Elyzah Shayne Son and Aesha Sharine Pesy topped the girls' 12-13 4x50m medley relay with a time of 2:15.69, while Kristine Jane Uy,

Naomi Sy, Patricia Mae Santor and Eliana Isabel Rodriguez dominated the girls' 14-17 4x50m medley relay event in 2:08.86.

As of 6 p.m., Manila has amassed 32 gold, 28 silver and 24 bronze medals in the tournament organized by the Philippine Sports Commission.

The boys' 14-17 4x50m medley relay team of Roland Aaron Seprado, Kaden Gabriel Sy, Antonio Joaquin Reyes and Gabbriel Medenilla won the gold medal for defending champion Pasig, which slid to second with 29 golds, 17 silvers and 24 bronzes. Baguio City kept the third spot with 29 golds, 17 silvers, and 22 bronzes. Baguio City's Chass Mhagiven Colas claimed his fourth gold in archery after ruling the boys'

**MANILA** – Sarah Ababa fired a 65 to post a one-stroke victory over hometown ace Florence Bisera in the ICTSI South Pacific Classic in Davao City Thursday.

Ababa, who edged out Chanelle Avaricio in two playoff holes to win the Del Monte leg two weeks ago, trailed by three shots with nine holes to play.

Bisera seemed to have the tournament all wrapped up with a blistering seven-under 29 built on five straight birdies from No. 5. "I also started to have a little self-doubt after her front nine. But Dad said,

'No one wins after nine holes. There are still plenty of chances to make up for it.' So I just held on with it," said the daughter of veteran tour player Edgar Ababa.

On the 17th, after splitting the fairway with a laser drive, Ababa stood 70 yards out. She lofted a wedge that landed inches past the cup, spun back, and nearly dropped for eagle. A tap-in birdie tied her with Bisera at 10-under, setting up a heart-stopping

finish.

"The match was very tight, but my yardage on the last two holes was great. The 70 yards on 17 and 110 yards on 18 – those are really my comfort distances. I'm confident in that," said Ababa.

She played the par-5 18th like a champion. Another precise approach shot – this time from 110 yards – landed softly and stopped inches from the hole. She calmly tapped in her second straight birdie to take the outright lead at 11-under.

**MANILA** – Alas Pilipinas lost to Thailand, 24-26, 20-25, 24-26, in the Asian Youth Games girls' volleyball battle for the bronze medal Wednesday night at the Isa Sports City-Hall C in Bahrain.

Rhose Almendralejo had a match-high 15 points to lead the Philippines, while Harlyn Serneche and Samantha Cantada had eight points apiece.

Natthawan Phatthaisong scored 13 points followed by Sasithorn Jatta with 12, while Nattharika Wasan and Wisaruta Sengna chipped in 11 and 10 points, respectively, as Thailand claimed victory after one hour and 29 minutes.

"As we can see, we were close, but in the end, the situation happened again and again where we let go. Our lapses and our errors are visible, these are coming out in the end," said Jai Adrao, who had five points, including two blocks.

Despite the loss, Adrao said the team remained proud of its effort and thankful for the opportunity

to compete.

"I'm grateful to the Philippine National Volleyball Federation, the Philippine Sports Commission, and the Philippine Olympic Committee, and of course, to the management of the National University because we also prepared for this league, and to my teammates and to the Lord because we worked together on this," she added.

Saudi Arabia's Taha Alkhalifah was third after crossing the finish line 10 seconds off.
