## FINANCIAL LITERACY KEY AGAINST INVESTMENT SCAMS, SEC OFFICIAL SAYS

**CALAMBA CITY, Laguna (PIA)** – The Securities and Exchange Commission (SEC) is bringing financial literacy lessons in schools to help Filipinos make better financial choices and protect them against investment scams that are often “too good to be true”. Lawyer Eretzsel Valle, Director of SEC Lipa Extension Office, warned the public to be wary of unrealistic investment offerings circulating online, especially those offering high returns with little to no risk.

“As the saying goes, if it’s too good to be true, it probably is. We are advising the public to look into the firm’s SEC primary registration and secondary registration to spot [if it’s] an investment scam.”

Primary licenses allow businesses, such as investment companies, to legally operate in a specific area and conduct business under the control of the SEC, while a secondary registration allows them to offer investment products legally.

Despite being registered as a corporation, Valle noted that an SEC Registration is not a license for companies to solicit investments.

“We should watch out for companies that may be registered as a corporation but have no secondary

licenses allowing them to offer investments to the public.”

Between January until October this year, the SEC has logged around 528 investment scam cases reported in the CALABARZON region.

Should they fall prey to investment scams, Valle assured that the SEC is ready to provide free legal assistance to punish fraudulent companies.

“If you ever fall victim to these schemes, screenshot all your conversations and contact numbers related to the case. We will advise [the public] on the legal actions they can take.”

Valle added, “We have filed criminal cases for [scams] and have had them punished.”

The SEC is further strengthening its campaign against investment scams by bringing their financial literacy programs to colleges and universities, in a bid to teach youngsters about making smart financial and investment choices.

“We are working with all colleges and universities in CALABARZON and MIMAROPA to host financial literacy seminars, to teach kids how to handle their finances.” (PB-PIA4A)

## GSIS CITES MEMBER FEEDBACK AS KEY DRIVER OF REFORMS IN NCR FORUM

**MANILA**—The Government Service Insurance System (GSIS) on Friday highlighted the critical role of direct member feedback in shaping institutional reforms, following its 2025 NCR Stakeholders' Dialogue held this week in Quezon City.

The dialogue, conducted on Nov. 19 at the VS Hotel and Convention Center, gathered hundreds of members, pensioners, and government agency representatives for a full-day discussion on GSIS programs, services, and ongoing reforms.

"We are here to listen so we can better understand how to make your transactions with GSIS easier and more convenient," GSIS President and General Manager Wick Veloso said in a news release, noting that many of the agency's improvements began as suggestions from members.

"Every improvement you see started with someone speaking up in a dialogue like this one. Your feedback is the trigger for real change."

Veloso cited recent policy changes, including the removal of the required down payment for members purchasing the GSIS housing units they currently rent.

"Your monthly rent will now be treated as part of your amortization. That change came from you," he said.

Much of the program was dedicated to an open forum where members raised concerns on loan policies, pension processing, digital services, and other frontline programs.

GSIS officials responded directly, noting that such exchanges provide the agency with essential and unfiltered insights on member needs.

UP Diliman Chancellor Edgardo Carlo Vistan II, keynote speaker at the event, lauded the GSIS for grounding its reforms on collaboration and institutional alignment.

"Your theme, 'Basta sama-sama, tuloy-tuloy ang ginhawa,' is more than a slogan. It captures a truth that both GSIS and UP Diliman hold dear: that meaningful progress happens when institutions work together, when systems are aligned, and

when public service is strengthened by shared purpose," he said.

"Your continued efforts to modernize member services, strengthen records management, and enhance digital security directly contribute to nation-building."

The dialogue also featured updates on digital innovation and fraud prevention.

Scam Watch Pilipinas co-founder Jocel De Guzman discussed increasing threats of digital fraud targeting government employees, while GSIS presented enhancements to its mobile app and online platforms, including strengthened security features and improved user experience.

A key segment of the event honored top-performing government agencies for excellence in loan and premium collections, reduced past-due rates, and digital collaboration.

Among the awardees were CHED Region 4-B (Mimaropa), the University of the Philippines System, Quirino Memorial Medical Center, the House of Representatives, the National Kidney and Transplant Institute, the Philippine National Police, the Anti-Red Tape Authority, the Public Attorney's Office, the National Housing Authority, the Department of Transportation—MRT 3, and the Commission on Audit.

Representing the awardees, acting Philippine National Police chief, Lt. Gen. Jose Melencio Nartatez Jr., thanked GSIS for recognizing agency performance.

"These awards remind us that accountability and good governance matter and that public service improves when every agency does its part," he said, adding that GSIS reforms are making systems "clearer, faster, and more reliable" for government workers.

Veloso, joined by GSIS Trustees Beatriz Torno, lawyer Garry De Guzman, and Gilbert Sadsad, said the GSIS will continue holding regional dialogues to reinforce transparency and accountability. (PNA)

## IMO COMMENDS PCG OFFICERS FOR WOMEN EMPOWERMENT

**MANILA** — Two officers of the Philippine Coast Guard (PCG) received letters of commendation from the International Maritime Organization (IMO) for their efforts in women empowerment in the maritime sector.

In a statement on Friday, PCG Spokesperson Capt. Noemie Cayabyab said Rear Admiral Mitzie Silva-Campo and Commodore Christine Pauline Bergaño-Diciano received commendations under the IMO Gender Equality Award.

The recognitions, she said, highlighted the Philippines' growing leadership in promoting inclusivity and excellence in the global maritime community.

## DA: ASF ACTIONS IN '3RD QUARTER STORM' WERE EFFECTIVELY MANAGED

**MANILA**—The Department of Agriculture (DA) on Friday assured that the country's actions against African swine fever (ASF) during the "third quarter storm" were managed well. In a media interview, DA spokesperson Assistant Secretary Arnel de Mesa said there's a significant downward trend in the ASF cases in the Philippines compared to last year.

"Patuloy na nama-manage well ng department at patuloy na bumababa 'yung kaso ng (The department has been continuously managing it well, and there's a continuous decline in cases of) ASF," he told the Philippine News Agency (PNA) Headline.

The government has been rolling out its government-controlled vaccination program among healthy and ASF-negative hogs alongside stringent border measures across the country.

De Mesa said the difference in the third quarter ASF incidents poses a "very significant" downtrend from last year's total figure.

The "third quarter storm" refers to the seasonal

uptick of cases among the livestock sector, which is not exclusive to ASF.

"Yung kabuuang naital nating insidente nasa (The sum of logged incidents is) almost 5,000 (or) 4,979. Ngayong third quarter ng taong kasalukuyan nasa 657 lang (this year's third quarter is only pegged at 657)," he added.

The department official stressed that there's no resurgence of ASF cases in the Philippines to date. Based on the Nov. 18 update of the Bureau of Animal Industry (BAI), only 27 barangays across the country have reported active cases of ASF by the end of October.

On Thursday, De Mesa said the incidents of ASF in stock farms in La Loma, Quezon City, remain isolated.

"Magkakaroon ng affidavit of undertaking sa mga lechoneros, BAI, at QC local government unit (LGU) bago sila uli payagang magbukas (There will be an affidavit of undertaking between the lechoneros, BAI, and the QC LGU before they will be allowed to resume operations)," he said.

## DBM VOWS TO PUSH FOR STRONGER DIGITAL PROCUREMENT REFORMS

**MANILA** — The Department of Budget and Management (DBM) on Friday reaffirmed its commitment to accelerate procurement modernization and strengthen transparency as it marked the 25th anniversary of the Philippine Government Electronic Procurement System (PhilGEPS).

During PhilGEPS' silver anniversary celebration at the Philippine International Convention Center in Pasay City, DBM Officer-in-Charge Secretary Rolando "Rolly" Toledo said the agency remains resolute in advancing reforms that will make public procurement faster, more efficient, and more transparent.

"Procurement is not paperwork—it is public trust in motion. Every transparent transaction is a Filipino family protected," Toledo said, noting that PhilGEPS' silver milestone underscores both the progress achieved and the urgency of sustaining reforms.

Toledo emphasized the administration's commitment to deepen the modernization efforts initiated under former DBM Secretary Amenah Pangandaman, whose leadership championed open government, digital transformation, and procurement reforms.

At the center of these continuing efforts is the proposed New Government Procurement Act (NGPA), which seeks to overhaul procurement rules to align the country with global standards.

The measure mandates digital-by-default processes, tamper-proof documentation, broader competition, and stronger anti-corruption safeguards. Complementing the NGPA is the full digital modernization of

PhilGEPS, including enhancements to the Open Data Portal that make procurement information—from planning to implementation—fully accessible to the public. Toledo said these tools empower citizens and watchdogs to scrutinize government spending in real time.

In a video message shared at the event, Pangandaman highlighted PhilGEPS' importance, crediting the platform for enabling the Procurement Service-DBM to deliver its mandate efficiently through tools such as the Virtual Store, eMarketplace, eBidding facility, ePayment system, merchant registry, and the Open Data Portal.

Toledo also cited strengthened interoperability features, expanded e-bidding capabilities, improved protest and review mechanisms, and a wider capacity-building program across agencies as key components of the evolving reform agenda.

He lauded the Philippines' recent recognition at the 2025 Open Government Partnership Global Summit in Spain, where the country won both the Anti-Corruption Category and the Asia-Pacific Regional Award—achievements he said reflect the credibility of ongoing transparency initiatives.

"If the next 25 years of governance are to be defined by transparency, trust, and integrity, it will be because you chose to stay, you chose to serve, and you chose to stand as one," he told Procurement Service (PS)-DBM and PhilGEPS personnel.

PS-DBM Executive Director Genmaries Entredicho-Caong thanked former Pangandaman for her support and expressed confidence in Toledo's stewardship.

"We are certain that under the leadership of our DBM OIC-Secretary Rolly, the transformative reforms we initiated will not only continue but strengthen. Public procurement is in good hands," she said. (PNA) **BY RUTH ABBEY GITA-CARLOS**

## SOTTO PUSHES JAIL DECONGESTION, BETTER PDL SUPPORT IN 2026 BUDGET

**MANILA** – Senate President Vicente Sotto III on Friday raised alarm over severe overcrowding in the country's prison facilities, urging immediate reforms and adequate funding to improve conditions for persons deprived of liberty (PDLs).

During the plenary deliberation on the Department of Justice's (DOJ) 2026 budget, Sotto cited Bureau of Corrections (BuCor) data showing a 293-percent congestion rate as of Oct. 31.

The New Bilibid Prison (NBP), with a capacity of 5,678, currently holds 21,996 PDLs—or an occupancy rate of 387 percent.

Sotto said other facilities face a similar strain, including the Correctional Institution for Women (CIW), which has a capacity of 1,280 but a population of 2,940; the Iwahig Prison and Penal Farm in Palawan, with a capacity of 766 but housing 4,491 PDLs; and the Davao Prison and Penal Farm, with a capacity of 2,898 but holding 9,717 PDLs.

"These are just some examples, but all our prison facilities are severely overpopulated," Sotto said as he pressed BuCor to clarify how many new facilities are needed and how much funding must be allocated to significantly ease congestion.

Budget sponsor Senator Sherwin Gatchalian acknowledged the magnitude of the crisis, noting that improved management helped reduce congestion from 293 percent to 214 percent. He said BuCor would need around PHP55 billion to fully decongest jails through the construction of regional prison facilities.

BuCor's proposed 2026 budget is only PHP10 billion, including PHP676 million for buildings and structures.

Sotto emphasized the urgency of regionalizing prison facilities to distribute PDLs across Luzon, Visayas, and Mindanao. He noted that inmate visitation plays a crucial role in rehabilitation, saying

behavioral issues often arise when PDLs are too far from their families.

The Senate leader also highlighted Republic Act 11928, the Separate Facility for Heinous Crimes Act, which he authored to ensure heinous crime convicts are isolated from the general PDL population.

"The reason we pushed for this law was to ensure that heinous criminals are kept separately, for the safety of other PDLs and the efficiency of our correctional system," he said.

Gatchalian reported a hike in the daily medical allowance of PDLs from PHP15 to PHP20 and said BuCor has affirmed that inmates are covered by PhilHealth.

Sotto also inquired whether PDLs could access the Department of Health's Medical Assistance to Indigent Patients (MAIP) or the Department of Social Welfare and Development's Assistance to Individuals in Crisis Situations (AICS).

Sotto cited initiatives such as the exhibit of PDL artworks at EVIA Mall and Letran Calamba's year-long jail ministry.

He encouraged BuCor to strengthen livelihood programs that help PDLs support their families legally and productively.

Gatchalian said BuCor promotes such livelihood activities because the income earned directly benefits PDLs.

He added that skills training and livelihood programs with the Technical Education and Skills Development Authority (TESDA) prepare PDLs for employment or small business opportunities once released.

BuCor also runs readiness and orientation activities for Persons Restored of Liberty (PRLs).

While reintegration is not among BuCor's mandates, Gatchalian said reformation programs ensure that PDLs are physically and mentally ready to return to society. (PNA) **BY WILNARD BACELONIA**

## LTFRB TO LAUNCH ONLINE SERVICES IN DECEMBER

**MANILA** – The Land Transportation Franchising and Regulatory Board (LTFRB) will launch the digitalization of its frontline services beginning next month as part of President Ferdinand R. Marcos Jr.'s directive for the immediate shift of government services to digital.

In a statement on Friday, LTFRB Chair Vigor Mendoza II said information technology (IT) experts are already finalizing the development of a system that would pave the way for online transactions with the LTFRB, beginning with the confirmation of vehicles for public transportation.

"There is a sense of urgency to make all the transactions of the LTFRB fast and comfortable to all our tens of thousands of clients in the public land transportation sector," Mendoza said.

The LTFRB's full digitalization has come less than two months after Mendoza assumed

leadership of the office.

"This sense of urgency to improve our services will eventually benefit the millions of Filipino commuters," he said.

All LTFRB services will gradually be improved and brought to the digital platform.

"I am personally monitoring the update on the LTFRB full digitalization efforts, and by next month, we will launch the first phase, which is the online transaction of all our frontline offices nationwide," he said.

The digitalization efforts are one of the results of the LTFRB's series of consultations with various transport groups to discuss their primary concerns, including pending petitions and motions.

The LTFRB has begun consolidating the 37,000 pending motions and petitions that go as far back as two years to address them before the year ends. (PNA) **BY RAYMOND CARL DELA CRUZ**

## PNP, CGHMC INK DEAL FOR MEDICAL AID FOR COPS

"Every day, our men and women in uniform face risk and uncertainty in protecting our communities. They deserve timely, quality, and compassionate medical

care that acknowledges their sacrifice and strengthens their capacity to serve," Chinayog said. PNP spokesperson and public information chief Brig. Gen. Randolph Tuaño thanked the Philippine Chinese Charitable Association, Inc., which owns the CGHMC, for its ongoing commitment to the welfare of the police force. The partnership represents a sustained effort to strengthen the morale, resilience, and readiness of police officers who risk their lives to maintain peace, order, and public safety, he said.

"When our police officers are assured that their health and recovery needs are well taken care of, they can serve the public with greater confidence and dedication," he added.

## DOT TO TIGHTEN AIRFARE RULES AS GOV'T BOOSTS AIRPORT UPGRADES

**MANILA** – The Department of Tourism (DOT) is finalizing measures to promote airfare transparency and strengthen consumer protection, even as lawmakers push for the upgrade of key provincial airports and highlight gains from newly opened international and domestic routes.

During Friday's plenary debates defending the proposed 2026 budget of the DOT, Senator Loren Legarda said high domestic airfare remains a major deterrent to local travel, prompting the agency to coordinate closely with transport and competition regulators.

Legarda said the DOT, in consultation with the Department of Transportation (DOTr), Civil Aeronautics Board, Department of Trade and Industry, and the Philippine Competition Commission, is finalizing a code of conduct for online travel agencies to ensure fair pricing and transparency in airfares.

She said the initiative is aligned with the Internet Transactions Act and ongoing PCC investigations into possible non-competitive airline practices.

Alongside this, the DOT and DOTr will launch a public information campaign to help travelers access clearer fare information and identify cost-efficient travel options. Interpellating Legarda, Senator Joseph Victor "JV" Ejercito reported

that a large portion of the reallocation from flood control items will be directed toward airport improvement, particularly in tourism-centric areas.

He said Siargao, Mati, Legazpi, Bohol, and several other airports will undergo upgrades to expand capacity, improve runways, and support increased flight frequency.

"Para hindi masayang (So that nothing goes to waste), we still need construction to drive the economy," Ejercito said, noting that airport modernization will open more gateways for tourism and stimulate regional growth.

Legarda also highlighted gains from recent DOT-DOTr collaboration, pointing to new international routes launched under Tourism Secretary Christina Frasco's term.

These include flights by Air Canada from Vancouver; Philippine Airlines from Da Nang and Sapporo; United Airlines from San Francisco; Jetstar from Perth; Air India from New Delhi; and VietJet from Ho Chi Minh.

New domestic links have also been opened, including Manila-Cauayan, Cebu-Catarman, and multiple daily flights from Clark to El Nido, Coron, Masbate, and Siargao.

Legarda said the expanded route network demonstrates strong coordination between the DOT and DOTr, and provides opportunities to counter high domestic airfare by offering more travel choices to the public. Senator Erwin Tulfo, who raised concerns about the impact of steep airfares on local tourism, expressed support for the DOT budget after receiving assurance that the agency is pursuing reforms.

## DENR AWARDS 116 LAND PATENTS TO FARMERS, SCHOOLS, AGENCIES IN NEGOR

**DUMAGUETE CITY, Negros Oriental (PIA)** — More than 100 farmers and institutions in Negros Oriental have received land titles under the Department of Environment and Natural Resources' (DENR) Handog Titulo Program, granting them legal ownership of the lands they have long cultivated or occupied.

Provincial Environment and Natural Resources Officer Jimmy Panebio said the program is a free land-titling initiative that speeds up the processing and issuance of public land patents to qualified beneficiaries.

A total of 116 titles have been distributed in the province—104 agricultural and 12 special free patents—covering more than 16 hectares of public land.

Panebio said the initiative supports government efforts to promote social justice, reduce rural poverty, and bring government services closer to communities.

"This is done to alleviate poverty, bolster economic development, and bring government services closer to the people," said Panebio.

He added that the patents secure beneficiaries' tenure and allow them to fully develop and utilize their land.

Agricultural patents were awarded to beneficiaries in several towns, including 29 titles in Barangay Mansagaban, Bais City; 35 titles in Boloc-Boloc, Baslay, and Tugawe in Dauin; 14 titles in Valencia; 25 titles in Tayasan; and one title in Ayungon.

Special patents were also issued to the Department of Education for elementary schools in Guihulngan City, Vallehermoso, Bindoy, Ayungon, and Bayawan City to support continued school operations and future expansions.

Additional patents were granted to the Bureau of Fire Protection in Vallehermoso and the Municipal Trial Court in Siaton.

Tequila Ubag, 81, from

Barangay Bongbong, Valencia, expressed gratitude after finally receiving the title her family had pursued since 1995.

"Among dakong pasalamat sa gobyerno niining among nadawat na titulo sa dugay'ng katuigan nga among gipangandoy ug ang akong Mama pay nag-apply niini niadtung 1995 pa," said Ubag.

(Our deepest thanks to the government for this land title we have long hoped for, which my mother first applied for back in 1995.) Valencia Mayor Edgar Z. Teves also welcomed the distribution, saying the joint efforts of the LGU and DENR helped provide beneficiaries with stability, security, and pride.

## DSWD CONTINUES TO BRING IMMEDIATE ASSISTANCE TO UWAN-AFFECTED POPULATION IN CAR

**BAGUIO CITY (PIA)** — The Department of Social Welfare and Development-Cordillera continues its monitoring and delivery of immediate assistance to the tropical cyclone Uwan-affected population in the region.

DSWD-CAR Regional Director Maria Catbagan Aplatén, in a press conference on November 14, shared that as of their latest data, there were 45,020 families composed of 154,154 persons in 831 barangays across the region who were affected by the super typhoon. Of these, 51 families (176 persons) remain in eight active evacuation centers while 895 families (2,915 persons) are being served outside ECs or those who seek refuge in houses of relatives or friends.

As per reporting period, there were also 3,890 partially damaged and 230 totally damaged houses recorded in Cordillera.

There were also reported 32 injured, two missing (one each in Kalinga and Mountain Province)

and 19 deaths (three in Benguet, 10 in Ifugao, four in Kalinga and two in Mountain Province).

In terms of immediate assistance, Aplatén shared that the DSWD-CAR already distributed 54,354 family food packs amounting to around P37.44 million and 19,985 assorted non-food items worth P44.88 million.

The DSWD-CAR has also disbursed around P9.98 million under its Assistance to Individuals in Crisis (AICS) program that include P10,000 for families with damaged houses, P5,000 for injured individuals, and P10,000 for the families of those who died due to Uwan.

Aplatén assured that the local social welfare and development officers continue to monitor and gather information down to the remote barangays in every province to ensure that all individuals and families that were affected by Uwan are accounted for and provided with immediate assistance.

The DSWD-CAR continues with the replenishment of family food packs (FFPs) in the different local government units in the region.

As of Nov. 16, a total of 28,069 FFPs are prepositioned at LGU storage facilities through the Disaster Relief Prepositioning Agreement (DRPA) while 12,488 more are prepositioned across provinces through DSWD-managed warehouses.

Aplatén is encouraging LGUs with no DRPA with DSWD-CAR to allocate a storage area or warehouse for strategic prepositioning of FFPs and non-food items.

She said the DSWD is also ready to move into the early recovery phase through its cash-for-work, food-for-work, and the Sustainable Livelihood Program, depending on the assessment and recommendations of the local SWAD officers. (JDP/CCD-PIA CAR) **BY CARLITO DAR**

## DPWH FULLY SUPPORTS ICI'S ONGOING PROBE

**DAVAO CITY** — The Department of Public Works and Highways fully supports, and will cooperate with the Independent Commission on Infrastructure (ICI) investigation.

"Sa pamumuno ni Secretary Vince Dizon, patuloy na tutulong at susuporta ang DPWH sa imbestigasyong isinasagawa ng ICI," DPWH Undersecretary Arthur Bisnar has said. (Under the leadership of Secretary Vince Dizon, DPWH will continue to assist and support the investigations conducted by the ICI.)

The combined team is visiting various project sites nationwide as part of their inspection of government infrastructure projects.

On Nov. 5, the ICI led by Special Adviser Gen. Rodolfo Azurin Jr. and a

DPWH delegation led by Usec. Bisnar, together with former ICI special adviser and Baguio City Mayor Benjamin Magalong, visited and inspected infrastructure and flood-control projects in Davao City.

The team first inspected the road slope protection structure and the installed rockfall netting at the Junction Shrine Hills along the Diversion Road.

Members of the DPWH and ICI climbed the steep hillside to take samples of materials such as cyclone wire and netting for further laboratory testing, amid reports of possible irregularities in the project.

The group also visited the damaged portion of the flood-control structure near Governor Generoso Bridge in Gravahan, Matina. The P93-million project, which began in 2022 and was

completed in May 2023, partially collapsed just 8 months after completion due to strong river currents and heavy debris.

Azurin said the investigation will focus on determining whether the materials used complied with project specifications. "Possible defects or substandard materials might have been used instead of those stated in the DPWH contract specifications signed by the contractors," Azurin said.

Residents affected by the damage had to build an improvised wooden bridge to cross the area.

Belinda Valerio, a resident of Gravahan, shared that few people had fallen while crossing the improvised wooden bridge.

## DOE EXEC CITES GAINS OF UTILIZING HYBRID POWER SOURCES IN SPUG AREAS

**MANILA** – An official of the Department of Energy (DOE) on Thursday emphasized the benefits to power consumers of utilizing renewable energy (RE) in areas being serviced by Small Power Utilities Group (SPUG), which sources power through diesel power plants.

DOE Undersecretary Rowena Cristina Guevara, in her speech during the focused discussion aimed to advance hybridization efforts in off-grid and missionary areas served by SPUG in Taguig City, said “hybridization of SPUG areas through the integration of RE can bring cleaner, reliable, and more affordable electricity in the long run for the Filipinos who need it most.”

She, however, pointed out that for this to happen, “we need to address and deal with one major challenge -- financing.”

“We are here to explore a bold possibility of enabling low-interest financing for renewable energy developers without sovereign guarantees and without the usual required power supply agreements. As we enter retail competition and open access, where contracts are shorter, this might seem ambitious -- but it is possible and would surely help transform how we scale RE in the Philippines,” she said, as quoted in a DOE press release.

The meeting was attended by officials and representatives of the DOE, National Power Corporation (NPC), Philippine Solar and Storage Energy Alliance (PSSEA), Philippine Hydro, Inc. (Phil Hydro), Wind Energy Development Association of the Philippines (WEDAP), multilateral banks and RE developers.

To date, the true cost of generation (TCGR) in SPUG areas averages about PHP18 per kilowatt-hour (kWh), with the maximum amount pegged

at around PHP62/kWh in some areas.

Guevara, however, said power consumers in SPUG areas pay only around PHP7 to PHP8/kWh since electricity in these areas is subsidized based on the rates approved by the Energy Regulatory Commission (ERC), and paid through the subsidies collected from all electricity consumers nationwide.

Thus, the need to look for ways to encourage more RE players to operate in these areas to help provide power supply at lower cost, without the need for them to secure sovereign guarantees for low-interest financing, and without the need to first secure power supply agreements with distribution utilities.

“With our partners from the government and financial institutions, we aim to identify viable financing structures and determine new potential collaborations so that we can collectively bring RE solutions to SPUG areas and accelerate our energy transition goals,” Guevara added. ## 2 SOUTH KOREAN FIRMS PARTNER FOR SUSTAINABLE AVIATION FUEL PRODUCTION

**MANILA** – South Korea’s flag carrier Korean Air (KE) and engineering firm Samsung E&A have teamed up to build a reliable, large-scale sustainable aviation fuel (SAF) production and supply ecosystem.

SAF lessens the carbon footprint in flight operations as this is made up of renewable waste and raw materials.

“This partnership will further contribute to the aviation industry’s Net Zero 2050 goal and enhance our ability to effectively navigate evolving global environmental regulations, including SAF mandates,” KE said in a statement on Friday.

Through its partnership with Samsung E&A, the two will develop a SAF production and supply chain originating in the United States.

A memorandum of understanding (MOU) was signed by KE Vice Chair Keehong Woo and Samsung E&A chief executive officer Namkoong Hong at the KE’s headquarters in Seoul on Nov. 20.

KE and Samsung E&A will identify and evaluate overseas SAF production

projects, and review long-term SAF opportunities.

They will also explore investments in SAF-related technologies and projects.

According to KE, the US was chosen as first target market since it has an abundant feedstock, advanced technology, and strong infrastructure.

Samsung E&A is currently reviewing participation in a US SAF project that will use gasification Fischer-Tropsch (FT) technology to convert woody waste into synthetic liquid fuel.

This next-generation approach expands the range of usable feedstocks beyond the limitations of first-generation SAF, which depends on restricted materials such as used cooking oil.

FT-based production can process non-edible and waste biomass such as wood residues, while offering significantly greater carbon-reduction benefits, KE said.

The airline said it is reviewing its participation as an offtaker of the SAF produced through the project.

“Through proactive project participation and continuous cooperation, we aim to accelerate

## UNIFIED PRIVATE SECTOR STAND NEEDED FOR CRAFTING GOV’T POLICIES

**MANILA** – An official of Ayala Corp. on Wednesday cited the need for a unified position from the private sector to help the government craft policies that will benefit all sectors.

Citing his experience in government service, Ayala Corp. Managing Director Karl Chua, a former director general of the National Economic and Development Authority (NEDA) and undersecretary of the Department of Finance, said private sector groups have made countless policy suggestions but not all have materialized since many of these were aimed towards the sector that the groups represent.

“What the government needs is one voice from the private sector,” he said during the panel discussion of the Makati Business Club’s year-end review and 2026 outlook dubbed “Beyond the Numbers” held in Makati City.

Chua noted the need for business groups to “come together, fix it among

global SAF adoption and advance our commitment to sustainable aviation and ESG (environmental, social and governance) management,” KE said.

To recall, KE is the first Korean carrier to operate a SAF-blended flight in 2017. In 2024, KE began using domestically produced SAF for select flights departing from Incheon International Airport and later expanded its use in flights via Gimpo International Airport.

KE has been using a 1 percent SAF blend on flights from Incheon to Kobe, and Gimpo to Osaka from Sept. 19, 2025 to Dec. 31, 2026. This will cover around 90 flights on the Kobe route and 26 flights on the Osaka route.

themselves, balance the trade-offs, and come to the government with one recommendation where we can help, not go in different avenues, trying to up each other with their own agenda, whether good or self-serving.”

“So, I think that is really what we need to do next. It is a critical juncture today not to be misused,” he said.

Chua said what the economy needs now is to boost productivity by ensuring the development of human capital.

This factor, he said, does not depend on the government alone but with the help of the private sector.

The need for enhanced programs on human capital was also raised by Gonzalo Varela, World Bank Group lead economist for Philippines, Malaysia and Brunei, during the same event.

He said labor force participation in the Philippines is low compared to other countries in the region, with women participation even lower despite their higher educational attainment compared to men.

“So in a way, what you have when females don’t work is that there’s talent misallocation. They get education, but they don’t all participate in productive employment. So ensuring that there are equal opportunities for females to participate in the labor market is going to be a source for faster growth of economies in East Asia, particularly in the Philippines,” he said.

The economist said what would help bolster the economy is the presence of policies that support human capital, creation of opportunities by having old firms embrace technological advancements without cutting the number of their personnel, entry of new firms due to absence of issues about market contestability, and having business regulations that are easy to follow.

“So that’s the challenge ahead — ensuring you get into a virtuous cycle of opportunity creation and capability. You have to take advantage of technologies that are coming our way really fast,” Varela said. (PNA) **BY JOANN VILLANUEVA**

made affordable so that even those who are 18 years old can purchase it, with a minimum annual amount of PHP859 for the basic coverage.

“For too long, critical illness insurance has felt complex and out of reach. We wanted to change that. BPI Kaya Care is more than a policy—it’s a partner that helps families focus on recovery without financial strain, support that truly matters when it matters most,” she said.

Account holders or clients diagnosed at an early stage will receive 50 percent of the benefit, while late-stage or major diagnoses receive the full amount.

Go said the funding will

help clients address the cost of medications and therapy, if needed.

Citing her experience with family members who suffered from cancer, she said, “the fear is not the diagnosis itself but the potential inability to secure the necessary treatment that they need.”

“This worry highlights why insurance is nice to have. It is essential to peace of mind. A critical ailment brings enough pain. The family should be able to focus completely on recovery and well-being, not on financial calculations and stress,” she added.

**MANILA** – China banked on standouts Yang Lanbin, Wang Chengcheng and Zheng Ao, to win its first men's team title in the 3rd FIG Artistic Gymnastics Junior World Championships at the Manila Marriott Hotel, Newport World Resorts in Pasay City Thursday night. China tallied 163.095 points while Japan (162.429) and USA (162.329) settled for the silver and bronze medals.

"We just had the National Games in China a week ago and I got to do that, and now I've experienced the World Championships too, which is a big event for our junior teams. I've been a little tired from that, but team and country come first," Wang was quoted as

saying on the International Gymnastics Federation official website.

Japan, the 2023 champion, was led by team captain Ojima Nao, Yasui Eijun and Kakutani Taiki.

"We come from different clubs and haven't done many competitions, so I was a bit nervous. But we all practiced and worked together, and I think we played a good match. I was pretty apprehensive during my first routine, but I think I was able to switch gears and do well afterwards," commented 17-year-old Ojima.
